Ontario Further Extending Temporary Wage Increase for Personal Support Workers

Government Continuing to Support Health Care Workforce as Part of COVID-19 Response

TORONTO — The Ontario government is investing an additional \$169 million to extend the temporary wage increase for personal support workers and direct support workers for the third time since its initial investment last year. This increase will continue until October 31, 2021 and will help stabilize staffing levels and support our frontline health care workers to ensure the province is prepared to respond to any scenario as the COVID-19 pandemic continues to evolve.

"Since the outset of the pandemic, personal support workers and direct support workers have been critical in supporting some of our most vulnerable patients," said Christine Elliott, Deputy Premier and Minister of Health. "As we head into the fall, ensuring Ontario's personal support workers are supported will ensure patients continue to receive the high-quality care they need."

The government is extending the wage enhancement for over 158,000 workers who deliver publicly funded personal support services or direct support services in hospitals, long-term care, home and community care and social services until October 31, 2021. This includes:

- \$3 per hour for approximately 38,000 eligible workers in home and community care;
- \$3 per hour for approximately 50,000 eligible workers in long-term care;
- \$2 per hour for approximately 10,000 eligible workers in public hospitals; and
- \$3 per hour for approximately 60,000 eligible workers in children, community and social services providing personal direct support services for the activities of daily living.

This latest temporary wage increase builds on the government's previous wage enhancement extension on June 11, 2021, which was set to expire on August 23, 2021. Since October 2020, Ontario has invested \$841 million and, with this additional \$169 million, will have invested over \$1 billion for personal support workers and direct support workers. The province will continue to review the wage increase to inform its next steps to ensure this important investment will bring the greatest stability and support for Ontario's personal support workers and direct support workers.

"This wage enhancement extension recognizes the vital work and significant sacrifices that personal support workers and direct support workers continue to make to keep Ontarians, including our most vulnerable, safe and healthy," said Prabmeet Sarkaria, President of the Treasury Board. "We will continue to make historic investments to improve home and community care, long-term care, public hospitals and the social services sector throughout the province as part of our fight against COVID-19."

"Our government is committed to rebuilding and repairing long-term care in Ontario," said Rod Phillips, Minister of Long-Term Care. "Further extending the wage increase will help us continue to attract and retain personal support workers who provide residents with the care they need and deserve everyday."

To protect vulnerable patients and staff in settings where the risk of contracting and transmitting COVID-19 and the Delta variant is higher, on August 17th the Chief Medical Officer of Health issued a directive mandating hospitals and home and community care service providers to have a COVID-19 vaccination policy for employees, staff, contractors, students and volunteers, including personal support workers. This is similar to the vaccination policy requirements currently in place for long-term care homes. Vaccination policies will also be implemented in other higher-risk settings where personal support workers and direct support workers provide care, including licensed retirement homes, congregate group homes and day programs for adults with developmental disabilities, children's treatment centres and other services for children with special needs, and licensed children's residential settings.

"We remain grateful for support workers who, throughout the pandemic, have continued to provide vital services to individuals with developmental disabilities and complex needs," said Dr. Merrilee Fullerton, Minister of Children, Community and Social Services. "Personal and direct support workers across the province have been instrumental to ensuring our loved ones receive the quality care they need, and the temporary wage increase is meant to recognize and celebrate their important work."

Quick Facts

- Personal support workers provide a wide range of services in home and community care, which also reduces or delays the need for more costly care in hospitals and long-term care homes.
- In October 2020, Ontario provided <u>\$461 million</u> to temporarily enhance wages for personal support workers and direct support workers. This was followed by an extension of the temporary wage increase on March 18 and June 11, 2021.
- Through the <u>COVID-19 Fall Preparedness Plan</u>, the government invested \$52.5 million to recruit, retain and support over 3,700 more frontline health care workers and caregivers. It is one of the largest health care recruiting and training programs in Ontario history. To date, more than 600 personal support workers, 500 nurses and 130 supportive care workers have been added across the province through this plan.
- The temporary wage increase will be reviewed on a regular basis and is intended to be extended until October 31, 2021, in connection with regulations made under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020.

Ontario Deploying Last Mile Strategy to Further Increase Vaccination Rates

75 per cent of Ontarians aged 12 and over are fully vaccinated

August 24, 2021

TORONTO — With over 82 per cent of eligible Ontarians aged 12 and over having received one dose of the vaccine and 75 per cent having received both doses, the government is continuing its last mile strategy to reach eligible individuals who have yet to receive a first or second dose. These latest efforts continue to make vaccines readily and conveniently available, especially in lower-vaccinated areas, and include proactively contacting individuals who have not booked their accelerated second dose appointment.

"Vaccines are the best protection against COVID-19 and the Delta variant," said Christine Elliott, Deputy Premier and Minister of Health. "Working with our public health partners we are continuing make it easier and more convenient to receive the vaccine. If you haven't been vaccinated yet and have questions, I encourage you to reach out to your pharmacy, family doctor or primary care provider."

To support the province's last mile strategy, the province and public health units are focusing on smaller, community-based and easy-to-access settings for vaccinations. This includes mobile clinics and community-based pop-ups, dedicated clinic days for families with people with disabilities, and townhall meetings in multiple languages. In addition, the province is working with public health units to target areas with low vaccination rates, as identified by postal codes, to support localized vaccination strategies as well as targeted marketing by the province in these areas.

To ensure all eligible Ontarians benefit from the strong protection offered by both doses of the vaccine as soon as possible, the provincial call centre is calling Ontarians to remind them to rebook their accelerated second dose appointments. Over 110,000 second dose appointments have been successfully booked or rebooked through this initiative.

A key component of Ontario's last mile strategy is bringing the vaccines directly to people, where they are located. To date, Ontario's GO-VAXX bus clinic has administered 1,100 vaccine doses, 42 per cent of which were first doses.

"Ontario's COVID-19 vaccination campaign has been a collective success. While we can certainly take pride in our immunization achievements, there is still work to be done to ensure everyone is protected," said Solicitor General Sylvia Jones. "That's why we are shifting focus in this last mile, from mass vaccination clinics to community-based settings using strategies such as mobile clinics and GO-VAXX buses to reach Ontarians who have yet to receive a first or second dose of a COVID-19 vaccine."

Public health units are also partnering with elementary and secondary school boards, colleges and universities to <u>make</u> <u>vaccines readily available</u> for all students returning to school. This includes youth who were born in <u>2009</u> and will turn 12 this year.

"This is my call to arms," said Dr. Kieran Moore, Chief Medical Officer of Health. "It is vital for everyone who can to receive both doses of a COVID-19 vaccine. We are implementing many community-based initiatives so everyone can easily receive their vaccine, especially those who live in areas with lower vaccination rates. We will continue to monitor data to determine when it is safe to exit the Roadmap and get life back to normal."

The success of Ontario's vaccine rollout, which has resulted in one of the highest vaccination rates in the world, is having an impact and continues to protect Ontarians against the virus. Between December 14, 2020 and August 7, 2021, unvaccinated or partially vaccinated cases accounted for the majority (99.4 per cent) of COVID-19 cases reported. Similarly, unvaccinated or partially vaccinated cases accounted for 99.2 per cent of hospitalizations, and 98.8 per cent of deaths during the same time period.

In response to evolving data around the transmissibility of the Delta variant and based on the recent experiences of other jurisdictions, recently the government, in consultation with the Chief Medical Officer of Health, paused exiting the <u>Roadmap</u> to <u>Reopen</u>. This additional time will allow the province to further increase immunization rates by engaging in targeted strategies to make it easier and more convenient for individuals to get vaccinated.

Individuals who have a red and white health care or who do not have a health card can contact the Provincial Vaccine Booking Line at 1-833-943-3900 for a call centre agent to email them a copy of their first and second dose receipts.
- The federal government has announced its plan to implement a national vaccine passport for international travel. In addition to the official proof of vaccination provided by the Ministry of Health, a vaccine passport provided by the federal government can be used domestically as proof of immunization, once available, should it be required by a business or organization.

Ontario to Require Proof of Vaccination in Select Settings

Province to launch enhanced vaccine certificate and verification app to stop the spread of COVID-19

September 01, 2021

TORONTO — To further protect Ontarians as the province continues to confront the Delta-driven fourth wave of the COVID-19, the government, in consultation with the Chief Medical Officer of Health, will require people to be fully vaccinated and provide proof of their vaccination status to access certain businesses and settings starting September 22, 2021. Requiring proof of vaccination in these settings reduces risk and is an important step to encourage every last eligible Ontarian to get their shot, which is critical to protecting the province's hospital capacity, while also supporting businesses with the tools they need to keep customers safe, stay open and minimize disruptions.

"As the world continues its fight against the Delta variant, our government will never waver in our commitment to do what's necessary to keep people safe, protect our hospitals and minimize disruptions to businesses," said Premier Ford. "Based on the latest evidence and best advice, COVID-19 vaccine certificates give us the best chance to slow the spread of this virus while helping us to avoid further lockdowns. If you haven't received your first or second dose of the COVID-19 vaccine, please do so today."

As of September 22, 2021, Ontarians will need to be fully vaccinated (two doses plus 14 days) and provide their proof of vaccination along with photo ID to access certain public settings and facilities. This approach focuses on higher-risk indoor public settings where face coverings cannot always be worn and includes:

- Restaurants and bars (excluding outdoor patios, as well as delivery and takeout);
- Nightclubs (including outdoor areas of the establishment);
- Meeting and event spaces, such as banquet halls and conference/convention centres;
- Facilities used for sports and fitness activities and personal fitness training, such as gyms, fitness and recreational facilities with the exception of youth recreational sport;
- Sporting events;
- Casinos, bingo halls and gaming establishments;
- Concerts, music festivals, theatres and cinemas;
- Strip clubs, bathhouses and sex clubs;
- Racing venues (e.g., horse racing).

These mandatory requirements would not apply to outdoor settings where the risk of transmission is lower, including patios, with the exception of outdoor nightclub spaces given the risk associated with the setting. In addition, these requirements will not apply to settings where people receive medical care, food from grocery stores, medical supplies and the like. Aligned with public health measures currently in place, indoor masking policies will continue to remain in place.

"We know vaccines provide the best protection against COVID-19 and the Delta variant," said Christine Elliott, Deputy Premier and Minister of Health. "To protect the health and well-being of Ontarians, our government will offer one more tool to encourage even more Ontarians to receive the vaccine and provide further protection to fully vaccinated Ontarians as they safely enjoy activities with their loved ones and support their local businesses."

Individuals who cannot receive the vaccine due to medical exemptions will be permitted entry with a doctor's note until recognized medical exemptions can be integrated as part of a digital vaccine certificate. Children who are 11 years of age and younger and unable to be vaccinated will also be exempted from these requirements.

For the period between September 22 and October 12, 2021, it is intended that people attending wedding or funeral receptions at meeting or event spaces will be able to provide a negative rapid antigen COVID-19 test from no more than 48 hours before the event as an alternative to proof of vaccination. These rapid antigen tests would have to be privately purchased.

Ontario will develop and provide additional tools to improve user experience, efficiency and business supports in the coming weeks, including establishing alternative tools for people with no email, health card or ID. The government will work to support implementation of vaccine certificates for Indigenous communities whether or not they have opted to enter their data into COVaxON, while maintaining Indigenous data governance, control, access and possession principles.

Ontarians currently have access to a paper or PDF vaccine receipt that includes all relevant information to prove that they are fully vaccinated. As of September 22, Ontarians will be required to show their vaccine receipt when entering designated settings along with another piece of photo identification, such as a driver's licence or health card. This is similar initial implementation approach announced in British Columbia.

Ontario will also introduce an enhanced digital vaccine receipt that features a QR code, which is safe, more secure and with you wherever you go. This digital vaccine receipt can be kept on a phone and easily used to show that you've been vaccinated if you need to. In addition, the province will launch a new app to make it easier and more convenient for businesses and organizations to read and verify that a digital vaccine receipt is valid, while protecting your privacy.

As the 2021-22 school year begins, it is critical to keep Ontario schools safe and students learning in-person. The province will work with trusted public health units to use the existing COVaxON system to safely and securely confirm the vaccination status of students. The province is committed to keeping parents informed about how their child's COVID-19 vaccine information and enrollment data is being used to keep schools safe. This will equip local public health units with the information they need to ensure rapid case and contact management if required to limit disruptions in the event of cases or outbreaks and keep kids in class.

"We are already seeing a rise in the number of cases of COVID-19 as we head into the fall," said Dr. Kieran Moore, Chief Medical Officer of Health. "As we enter the last mile push to increase vaccination rates, the introduction of a vaccine certificate is an important step to give people the tools to limit further spread of the virus so that we can ensure the safety of all Ontarians while keeping the province open and operational."

"Combining the use of a QR code with a trusted, made in Ontario verifier app will help support the province's health measures," said Kaleed Rasheed, Associate Minister of Digital Government. "These tools will provide a simpler, faster, and better way to prove vaccination status that is both convenient and secure – while also supporting businesses with an easy validation process."

New Requirement for Proof of Vaccination in Certain Settings: Frequently Asked Questions

TORONTO — Beginning September 22, 2021, Ontario will require proof of vaccination focused on indoor public settings. All Ontarians who registered their vaccines are encouraged to <u>download their vaccine receipt</u> as proof of their vaccine status until an enhanced vaccine certificate with a QR code is available.

Who is considered fully vaccinated?

People are considered fully vaccinated after receiving the full series of a COVID 19 vaccine or combination of COVID-19 vaccines approved by World Health Organization (e.g., two doses of a two-dose vaccine series, or one dose of a single-dose vaccine series).

Does a previous COVID-19 infection allow you to attend these settings?

No, a previous infection is not a substitute for being fully vaccinated.

How can I get my proof of vaccination?

Currently, vaccine receipts are available in PDF form to be downloaded or printed to your computer, phone or tablet. Ontarians who received their first or second dose of the COVID-19 vaccine out of province should contact their local public health unit to record their information and receive proper documentation. Both proof of identity along with proof of vaccination will be required. Individuals can provide proof of immunization by downloading or printing their vaccine receipt from the <u>provincial booking portal</u>, or by calling the Provincial Vaccine Booking Line at 1-833-943-3900.

What if a person has a red or white health card or does not have health card?

If a person has a red and white health card, they can call the Provincial Vaccine Booking Line at <u>1-833-943-3900</u>. The call centre agent can email you a copy of your receipt. If they don't have an OHIP number at all, they should contact their local public health unit, and they can help you obtain the receipt.

What if they don't have a phone or a computer?

Ontario will develop and provide additional tools to improve user experience, efficiency and business supports in the coming weeks, including establishing alternative tools for people with no email, health card or ID.

How do I prove I am fully vaccinated if I am from out of province or out of country?

Individuals visiting from outside the province or the country will be required to show their full vaccination status and identification to enter prescribed settings.

Ontario will develop and provide additional tools to improve user experience, efficiency, and business supports in the coming weeks, including ensuring verification of fully vaccinated individuals from outside of province or country.

How does an individual prove they are fully vaccinated if they are an Indigenous person and haven't consented to providing their data to COVAX?

In the coming weeks Ontario will support implementation of vaccine certificates for Indigenous communities whether or not they have opted to enter their data into COVax, while maintaining Indigenous data governance, control, access and possession principles.

How does a person correct or change information on their vaccine credential?

Individuals should contact their local <u>public health unit</u> to make any changes to their vaccination record.

What will happen on September 22nd? What will happen on October 22nd?

As of September 22, 2021, Ontarians will need to be fully vaccinated (two doses plus 14 days) and provide their proof of vaccination as well as proof of identity (such a driver's licence or health card) to access certain public settings and facilities.

An enhanced vaccine certificate, as well as a verification app to allow businesses to read the QR code, will be available beginning October 22.

What will the digital vaccine certificate look like?

Ontario will develop and implement an enhanced vaccine certificate with unique QR code and accompanying verification app that will allow users to securely and safely verify their vaccination status when scanned. This could be stored on a mobile device, such as Apple Wallet. The enhanced vaccine certificate, as well as a verification app to allow businesses to read the QR code, will be available beginning October 22.

What if I don't want to disclose my vaccination status?

It is the discretion of the individual to determine whether they would like to disclose their vaccination status. Should they make the decision not to divulge this information, they will not be permitted to access settings that require proof of vaccination.

In settings where you have to be vaccinated to attend, is recent negative test sufficient to attend if you are unvaccinated?

A negative COVID-19 test or recent COVID-19 infection will not entitle a person to enter these settings, with narrow time-limited exceptions for testing. For the period between September 22 and October 12, 2021, it is intended that people attending wedding or funeral receptions at meeting or event spaces will be able to provide a negative rapid antigen COVID-19 test from no more than 48 hours before the event as an alternative to proof of vaccination. These rapid antigen tests would have to be privately purchased. The only exemptions are for unvaccinated people with medical exemptions and people under 12 years old will also be permitted to enter these settings.

Will people with medical exemptions be allowed to access settings requiring proof of vaccination?

The only exemptions permitted to enter these settings are for unvaccinated people with medical exemptions and people under 12 years old. Individuals who cannot receive the vaccine due to medical exemptions will be permitted with a doctor's note until the medical exemption can be integrated as part of a digital vaccine certificate.

Will individuals aged 11 and under be allowed to access settings requiring proof of vaccination?

Individuals aged 11 and under will be eligible to access these settings. If they are accompanied by an adult, the adult must be vaccinated.

Will proof of vaccination be required to attend weddings and other organized events?

For the period between September 22nd and October 12th, 2021, people attending indoor wedding and funeral receptions at indoor meeting or event spaces will be able to provide a negative rapid antigen COVID-19 test from no more than 48 hours before the event, as an alternative to the vaccine certificate showing they are fully vaccinated. These rapid antigen tests must be privately purchased.

Will people need a phone to be able to access businesses that require proof of vaccination?

A vaccination certificate is a PDF that can be downloaded online or received in paper copy. It includes the same information in both printed and digital form. These certificates will be required to access certain businesses and settings starting on September 22, 2021 as part of the Ontario government's efforts to stop the spread of the COVID-19 virus. By October 22, an enhanced vaccination certificate will be available in a new digital format that will offer increased accessibility and privacy protection.

How will businesses verify digital vaccination certificates?

Ontario will develop and implement an enhanced vaccine certificate with unique QR code and accompanying verification app that will allow users to securely and safely verify their vaccination status when scanned. The enhanced vaccine certificate, as well as a verification app to allow businesses to read the QR code, will be available beginning October 22. Guidance will be provided to business ahead of September 22 to ensure they are prepared.

How long will a vaccine credential be in place?

Vaccine credentials are a temporary measure to address health and safety in the COVID-19 pandemic. How long they are necessary will be monitored and evaluated based on data and the advice of the Chief Medical Officer of Health.

How will the government enforce the requirement for proof of vaccination?

Consistent with current practices under the Reopening Ontario Act, enforcement will be conducted by by-law officers. Ministry of Labour, Training and Skills Development inspectors will begin with education and warnings visits.

Why isn't the province increasing capacity limits for the settings where proof of vaccination is required?

As Ontario continues to confront the Delta-driven fourth wave, the province has taken a cautious approach. This has included some of the highest vaccine thresholds required for re-opening, as well as maintaining indoor masking, a policy that other provinces are now re-introducing.

To avoid future lockdowns and protect hospitals, Ontario is maintaining this cautious approach. This includes not expanding capacity limits in any setting at this time. As we monitor the impact of opening schools and the growing number of people returning to workplaces, we will evaluate when it may be safe to consider expanding capacity limits in settings that are captured by the new vaccine certificate policy.

Ontario Reinstating Renewal Requirements for Driver's Licences, Licence Plate Stickers and Health Cards

Ontarians are strongly encouraged to renew their documents online at ServiceOntario.ca

TORONTO – The Ontario government is reinstating renewal requirements for driver's licences, licence plate stickers, Ontario Photo Cards, Ontario health cards, and other products that would have expired on or after March 1, 2020, but were extended to provide immediate relief to Ontarians during the COVID-19 pandemic. Those needing to renew their provincial documents are encouraged to use ServiceOntario's convenient and easy-to-use online option.

To ensure everyone has enough time to renew, Ontario has extended the renewal deadlines for most driver's licences, licence plate stickers, and Ontario Photo Cards and health cards until February 28, 2022.

"The majority of Ontarians have continued to renew their documents during the pandemic, despite unprecedented challenges," said Caroline Mulroney, Minister of Transportation. "It's critical that drivers and vehicle owners have up-to-date documents for work, access to services and travel, and to keep our roads safe. I strongly encourage those who have deferred their renewals – approximately 17 per cent of Ontarians – to plan ahead and renew their documents online."

Heavy commercial vehicle owners will need to renew their vehicle validations by December 31, 2021. Novice licence holders (class G1, G2, M1 or M2) will have until December 31, 2022, to requalify for or upgrade their novice driver's licence. People who have not renewed their products during the Extended Validity period will be required to pay the fee for previous years, in addition to the current year renewal fee.

To make it easier for people to renew their driver's licences online, Ontario has temporarily waived requirements for people to renew their driver's licences in person, including those for senior drivers. Eligible drivers can renew their driver's licence online at ServiceOntario.ca, including those aged 80 and over.

As part of the government's commitment to developing convenient and accessible services for Ontarians, ServiceOntario now offers more than 40 services online. To reduce wait times, we are encouraging all eligible Ontarians to skip the line and easily and quickly renew products online. Products will be mailed directly with an ability to print proof of renewal.

"Our government is making life easier and more convenient for Ontarians through simple and fast online renewal options available 24/7," said Ross Romano, Minister of Government and Consumer Services. "Customers can skip the lines by renewing their documents through ServiceOntario's easy-to-use and secure online services right from the comfort and safety of their home."

"From the outset of the COVID-19 pandemic, our government's top priority has been ensuring the health and well-being of Ontarians," said Christine Elliott, Deputy Premier and Minister of Health. "As more people continue to get vaccinated to protect against COVID-19 and the Delta variant, it is important that people renew their health cards so they can continue to quickly access the high-quality health care services that they need, when they need them."

If you need to visit in-person, enhanced health and safety measures are in place at ServiceOntario centres. More than 40 ServiceOntario centres offer appointment booking to reduce wait times and ensure speedy service. You can book an appointment in advance by visiting Ontario.ca/Appointment.

Deadlines for Renewing Your Driver and Vehicle Products

September 01, 2021

Transportation

Ontario is reinstating the renewal requirements for driver's licences, licence plate stickers and other driver and vehicle products, as well as Ontario Photo Cards and Ontario health cards that were temporarily extended due to the COVID-19 pandemic. People with products that would have expired on or after March 1, 2020, are now required to renew their documents.

We strongly encourage Ontarians to renew their driver's licences, licence plate stickers, Ontario Photo Cards, and Ontario health cards from the comfort and safety of their home or office by visiting <u>ServiceOntario.ca</u>. ServiceOntario's online services are easy-to-use, fast, and convenient. Over 40 services are available online 24/7, and products are mailed directly to you. For more information, please visit <u>ServiceOntario.ca/Services</u>.

To renew your driver's licence and health card together online, please visit Ontario.ca/renew.

For your driver and vehicle products, Ontario Photo Card, and Ontario health card to remain valid, you must renew your documents and <u>pay all applicable fees</u> by the following deadlines:

Drivers under age 80 (Class G/M)

- Class G/M drivers under 80 years of age with driver's licences that would otherwise have expired between March 1, 2020, and February 28, 2022, must <u>renew their driver's licence</u> or Enhanced Driver's Licence (EDL) by February 28, 2022.
- Ontario has waived the requirement to update the driver's licence photo for people whose driver's licences would have expired between March 1, 2020, and February 28, 2022, to allow these drivers to <u>renew their licences online</u>.
- Regular driver's licence renewals will resume March 1, 2022.

Senior drivers aged 80 and over (Class G/M)

- Senior drivers aged 80 and over with driver's licences that would otherwise have expired between March 1, 2020, and February 28, 2022, must renew their driver's licences by February 28, 2022.
- Ontario has paused the Senior Driver's Group Education Session program and has waived the requirement for drivers aged 80 and older to visit a ServiceOntario centre in person to renew their licences. These drivers may now renew their licences online.
- Regular driver's licence renewals for senior drivers aged 80 and above will resume March 1, 2022.

Novice drivers (Class G1, G2, M1, or M2)

- Novice drivers with licences expiring between March 1, 2020, and December 31, 2022, will have until December 31, 2022, to complete testing to maintain or upgrade their licence.
- Regular expiry dates for Class G1 and G2 novice driver's licences will resume January 1, 2023.
- Novice drivers who enrolled in a Beginner Driver Education (BDE) course between March 1, 2019, and December 31, 2021, will have until December 31, 2022, to complete their course.

Driving Instructor and Beginner Driver Education course providers

- Individuals who applied for Driving Instructor certification between March 1, 2019, and December 31, 2021, will have until December 31, 2022, to complete all requirements.
- Driving Instructor licences that expired after March 1, 2020, must be renewed by February 28, 2022.

Commercial Drivers (class A, B, C, D, E and F)

- Commercial driver's licences with expiry dates between March 1, 2020, and February 28, 2022, must be renewed by February 28, 2022.
- Regular commercial driver's licence renewals will resume March 1, 2022.

• Class B and E driver's licence holders that completed their road test up to December 31, 2021, will have until June 30, 2022, to complete their School Bus Driver Improvement Course (SBDIC).

Carrier Products

- Ontario has reinstated the renewal requirements for certain carrier products that expired on or after March 1, 2020. As of June 1, 2021, if you have not renewed the following products, you must do so in order to continue operating in Ontario:
 - Commercial Vehicle Operator's Registration (CVOR) certificates
 - o Annual and semi-annual vehicle inspection certificates
 - Annual oversize/overweight permits
 - Garage licences.

Licence plate stickers

- Licence plate stickers for heavy commercial vehicles (HCV), including <u>International Registration Plan (IRP) cab cards</u>, must be renewed by December 31, 2021.
 - For more information on HCV fees, please visit http://www.mto.gov.on.ca/english/trucks/payment-plan-for-heavy-commercial-vehicle-licence-plate-stickers.shtml.
- Licence plate stickers for all other vehicles must be renewed by February 28, 2022.
 - People who have not renewed their products during the Extended Validity period will be required to pay the fee for previous years, in addition to the current year renewal fee.
- Online validation receipts for licence plate stickers are still valid for 14 days.
 - If you have not received your sticker after 14 days or it has arrived damaged, please call 416-235-2999 or 1-800-387-3445 (toll free).

Vehicle registration and safety inspections

- Safety Standard Certificates that expired between March 1, 2020, and before September 1, 2021, will be valid until October 6, 2021.
- Temporary registrations and special permits that expired March 1, 2020, to October 5, 2021, will be valid until October 6, 2021.
- Vehicles owners who moved to Ontario after March 1, 2020, and before September 1, 2021, must register their vehicle in Ontario by October 6, 2021.
- Vehicle owners who purchased a used vehicle on or after March 1, 2020, and before September 1, 2021, must transfer the vehicle into their name and attach plates by October 6, 2021.
- Individuals requiring name and/or address changes, or vehicle modifications on their vehicle ownership must update their vehicle registration by February 28, 2022.
- All motorized snow vehicle registrations, name and/or address changes, or vehicle modification requests must be completed by February 28, 2022.

Ontario Photo Card holders

• Ontario Photo Card holders with photo cards with expiry dates between March 1, 2020, and February 28, 2022, must renew their cards by February 28, 2022.

Ontario Health Cards

• People must ensure they hold a non-expired Ontario photo health card by February 28, 2022.

Accessible Parking Permit holders

All eligible accessible parking permits with expiry dates between March 17, 2020, and February 28, 2022, must be renewed before March 1, 2022.

Students Head Back to Class in Safer Schools

September 07, 2021

Education

TORONTO — Today, Stephen Lecce, Minister of Education, issued the following statement as students head back to class:

"I am proud of all Ontario students heading back to class, be it in-person or online. In keeping with the expert advice of Ontario's pediatric hospitals and the Chief Medical Officer of Health, we have invested heavily in ventilation improvements to support safer schools. We have deployed standalone HEPA units into every kindergarten class, into every learning space without mechanical ventilation, and some school boards have gone even further by placing HEPA units in every classroom.

Our cautious plan is designed to minimize disruption and maximize safety — with a focus on ventilation improvements — so that your children can continue learning through the year.

While Ontario's plan is cautious to protect students and staff, it also prioritizes learning recovery in reading and math. New supports for students from our youngest learners to those who will graduate this school year will help unlock their potential and bridge the gaps that arose last year.

To Ontario's intelligent and kind student community, please continue to remain vigilant as we navigate this pandemic and know that your families, educators and government are proud of you."

BACKGROUND

In the 2021-22 school year, Ontario's plan allows for:

- Return to in-person learning for the full school day, though synchronous remote learning will remain an option;
- Learning in classrooms supported by physical distancing, and enhanced cleaning; and,
- Student participation in extracurricular activities, clubs, music and the arts, both within the school and through interschool sport. Public health units may recommend or direct additional measures or modifications based on local context.

Ontario's safer return to school is supported by significant investments, and the province is making available more than \$1.6 billion in targeted COVID-19 resources. Supported by the province's COVID-19 strategy, as well as other provincial funding, \$80 million in funding is being provided for mental health supports to protect students, teachers, and school staff this coming school year.

In preparation for the return of in-person learning, the province has also invested substantially in improvements to air ventilation at schools. These improvements mean that:

- 99.8% of the systems have been assessed;
- 99% of schools are using higher grade filters and/or have increased frequency of filter changes;
- 99% of schools are running ventilation systems longer;
- 99% of schools have increased fresh air intake; and
- Over 70,000 standalone HEPA filter units and other devices are now in place in schools across the province, including JK/SK classrooms, all classrooms and learning environments without mechanical ventilation.

These improvements to school ventilation build on the \$1.4 billion the Ontario government invests every year to maintain and renew school facilities across the province.



Ontario Releases Technology and Standards for Digital Identity

Province welcomes and encourages private-sector market innovation

September 08, 2021

TORONTO — The Ontario government is publicly launching the <u>technology and standards</u> that will build Ontario's digital identity ecosystem, which will empower simpler, faster and better access to more convenient and secure online services. As one of the first jurisdictions in North America to publish this information, Ontario continues to demonstrate its commitment to digital and data transparency, and is making progress on becoming a world-leading digital jurisdiction.

When fully launched, Ontario's <u>Digital ID</u> (identification) will allow people and businesses to prove who they are both online and in person with built-in safety features that protect users' privacy and personal information. It will be a convenient and easy identification solution that is made with the security and encryption necessary for today's highly digitized world, which protects personal data while performing secure transactions and accessing online services.

Over time, Ontario's Digital ID will open up more opportunities for individuals and businesses across all business sectors. This initiative is yet <u>another way</u> that the government is working with the marketplace to support economic growth, new investments and technological innovation.

Today, Kaleed Rasheed, Associate Minister of Digital Government, shared an update on the government's plan in a virtual conversation with the Council of Canadian Innovators on Ontario's digital future.

"Openly sharing our technology approach to digital identity is an essential step in our plan to provide more convenient, private and secure ways to prove who you are," said Minister Rasheed. "Today's announcement responds directly to what we continue to hear from sector partners, stakeholders and the public – Ontario's approach to technology needs to be ambitious, innovative and transparent."

Ontario's Digital ID will use emerging technology standards and, wherever possible, publicly available open source solutions. Key principles that will underpin Ontario's digital identity program include compliance with current industry standards and laws, including <u>Ontario's Digital Service Standard</u> and <u>Anti-Racism Data Standards</u>.

"Our <u>Ontario Onwards: Action Plan</u> first announced our government's goal to make Ontario the most advanced digital jurisdiction in the world – all in the service of the people of this province," said Peter Bethlenfalvy, Minister of Finance. "The release of Ontario's Digital ID later this year will be an exciting step towards transforming and modernizing government services in an increasingly digital world."

Quick Facts

- Ontario will launch a Digital ID for Ontarians later this fall, the first step towards safer, more secure ways to prove who you are online.
- When fully mature, the digital ID ecosystem of Ontario is estimated to be worth \$20 billion. This estimate is calculated from about 35 value drivers and hundreds of data points from various sources such as DIACC, McKinsey Global Institute and World Economic Forum.
- Over the past nine months, the Province consulted with 68 organizations, more than 100 industry experts and held five two-hour roundtable discussions on digital identity.
- To develop its digital identity strategy in a way that allows for cross-Canadian standards, Ontario is working collaboratively across the public sector to ensure alignment to standards and interoperability.
- Privacy is a core principle of Ontario's Digital ID and is being considered in all aspects of the program and technology.

 Ontario's Information and Privacy Commissioner continues to be engaged to help inform and guide this work.

COVID-19 Vaccine Frequently Asked Questions (FAQs): What You Need to Know About a Third Dose

Eligibility and Timing

1. Who is required to have mandatory COVID-19 vaccination policies at this time?

To protect vulnerable patients and staff in settings where the risk of contracting and transmitting COVID-19 and the Delta variant is higher, the Chief Medical Officer of Health has issued a directive mandating hospitals and home and community care service providers to have a COVID-19 vaccination policy for employees, staff, contractors, students and volunteers, and for ambulance services to have a COVID-19 vaccination policy for paramedics. The vaccination policy must be effective no later than September 7, 2021, and at a minimum will require these individuals to provide proof of one of three things:

- Full vaccination against COVID-19;
- A medical reason for not being vaccinated against COVID-19; or
- Completion of a COVID-19 vaccination educational session.

The Ministry of Education intends to introduce a vaccination disclosure policy for all publicly-funded school board employees, and staff in private schools as well as for all staff in licensed child care settings for the 2021-22 school year, with rapid antigen testing requirements for staff who are not immunized against COVID-19.

Vaccination policies will also be implemented in other higher-risk settings such as:

- Post-secondary institutions;
- Licensed retirement homes:
- Women's shelters; and
- Congregate group homes and day programs for adults with developmental disabilities, children's treatment centres and other services for children with special needs, and licensed children's residential settings.

2. Who is currently eligible to receive a third dose of the COVID-19 vaccine?

The Ontario Government has begun offering third doses of the COVID-19 vaccine to the most vulnerable Ontarians. This includes:

- Transplant recipients (including solid organ transplant and hematopoietic stem cell transplants);
- Patients with hematological cancers (examples include lymphoma, myeloma, leukemia) on active treatment (chemotherapy, targeted therapies, immunotherapy);
- Recipients of an anti-CD20 agent (e.g., rituximab, ocrelizumab, ofatumumab); and
- Residents of high-risk congregate settings including long-term care homes, higher-risk licensed retirement homes and First Nations elder care lodges.

Individuals who are eligible (immunocompromised) should receive their third dose at least 2

months after their second dose. However, exact timing should be decided with their HCP. Vulnerable Elderly in High-Risk congregate settings should allow at least 5 months between their second and third dose.

3. What if I am an employee, staff member, contractor, student, volunteer, or paramedic, and not fully vaccinated?

Individuals who do not provide proof of full vaccination against COVID-19 will be required to undertake regular antigen testing.

4. How do I prove I am fully vaccinated?

Individuals can prove they are fully vaccinated by showing the physical or emailed receipt that was provided to them at the time of vaccination. <u>Vaccination receipts can also be downloaded or printed through the provincial portal</u> or by calling the Provincial Vaccine Booking Line at 1-833-943-3900. This version of the vaccine receipt contains a watermark and a digital signature to deter forgery.

5. What do I need to confirm proof of eligibility for specific high-risk populations?

Vaccination appointments will be made using a trust model. High-risk populations who are eligible for a third dose are recommended to get the same vaccine as their second dose if possible.

6. How will I know when/if it is my turn to receive a third dose?

Please continue to monitor the <u>RCDHU COVID-19 vaccine rollout webpage</u> for future updates and/or RCDHU's Facebook or Twitter.

Booking an Appointment

7. Do I need to book an appointment to get a third dose?

Currently, residents who are eligible to receive a third dose do not need to book an appointment. Residents are asked to attend one of the walk-in or pop-up clinics across Renfrew County and District. Clinic schedules can be found on RCDHU's COVID-19 vaccine rollout webpage and/or RCDHU's Facebook or Twitter.

8. Do we get to choose which vaccine we get?

Some clinics will allow residents to choose which vaccine they get. This will be based on provincial distribution, availability to local regions and supply. Remember "the best vaccine, is the one that is available to you".

Precautions to take after receiving a vaccination

9. What are the side effects of the COVID-19 vaccines?

Some people may experience moderate side effects from the vaccine that will likely resolve after a few days. Some of the symptoms are part of the body's response to developing immunity and indicate that the vaccine is working.

Common side effects include one or more of the following symptoms: pain where the needle was given, redness and swelling, tiredness, headache, muscle pain, joint pain, chills, mild fever, swollen glands (less frequently). These types of side effects are expected and indicate that the vaccine is working to produce protection. These side effects are more likely to occur after your second dose.

As with any medicines and vaccines, allergic reactions are rare but can occur after receiving a vaccine. If you are concerned about any reactions you experience after receiving the vaccine, contact your health care provider. You can also contact Renfrew County and District Health Unit (RCDHU) to ask questions or report an adverse reaction. COVID-19 Vaccine Eligibility Update

As of August 18, 2021, all residents born in 2009 or earlier (must be turning 12 years of age as of the end of 2021) are eligible for the COVID-19 vaccine.

Note: Second dose appointments must be booked at least 28 days after the first dose, per the recommended interval. Youth born in 2009 or earlier and up 17 years of age are only eligible to receive the Pfizer vaccine.

It is important to be fully vaccinated as quickly as possible to protect yourself from COVID-19 and variants of concern.

COVID-19 Third Dose Information

RCDHU FAQ: <u>What You Need to Know About a Third</u> <u>Dose</u> Approximately **16,000** residents across RCD are still eligible to receive their COVID-19 vaccine.

REMINDER: Residents are encouraged to take advantage of COVID-19 vaccine appointments as soon as possible, as mass immunization clinics will be decreasing in number and frequency over the next month.

- Pop up clinics will be open to all residents born in 2009 or earlier for first or second doses of the COVID-19 vaccine. No appointment necessary.


Local Update

As of 8:00 a.m. August 23, 142,788 doses of COVID-19 vaccine have been administered through one of several COVID-19 vaccination clinics across Renfrew County and District (RCD) with 82.9% of RCDHU adults (including youth born in 2009 or earlier, and Canadian Armed Forces Members) having received at least 1 dose (76.8% have received 2 doses).

Remember: Even if you have been vaccinated, it is important to continue following public health measures, such as physical distancing, wearing a mask and hand hygiene.



Crisis Of Conscience For Small Business Decree to refuse entry conflicts with values for some

In an interview with CTV News on July 15, Ontario Premier Doug Ford said Ontario would not invoke a vaccine passport system.

"The answer is no, we're not gonna do it. We're not gonna have a split society," he was quoted as saying. Further, Ford said that Ontario's Chief Medical Officer of Health Dr. Kieran Moore was not in favour of such as system either, saying there was no reason for it.

On September 1, Ford announced a vaccine passport requirement in Ontario, saying that "based on the latest evidence and best advice, COVID-19 vaccine certificates give us the best chance to slow the spread of this virus while helping us to avoid further lockdowns."

The decision has caused mixed feelings with businesses - some welcome the passport option and some find it forces business owners in a position of gatekeeper for someone's



personal choice. The Canadian Civil Liberties Association (CCLA) notes that "socially sorting people based on personal decisions about their health, which they are legally entitled to make, runs the risk of creating different levels of freedom for different "categories" of people, a risk that is likely to intersect with other systemic inequalities and affect some groups more than others."

A Facebook group called "Ontario Businesses Against Health Pass" has provided a venue for small business owners to share their concerns about social separating based on the vaccination status of their customers. The group does not permit anti-vaccination rants or negative comments, but rather allows businesses who feel similarly about the passport to unite with like-minded individuals. Some local businesses in Renfrew and Lanark counties, along with others across Ontario, have voiced their disagreement with the vaccine passports and their support to treat all people the same. Some have even announced they will be losing their jobs.

Mandatory Vaccinations For Employees

The Canadian Press reported on September 6 that Prime Minister Justin Trudeau is "promising legal protection for businesses asking for proof of COVID-19 vaccination from staff and customers. He says his party will table legislation if reelected that will ensure organizations can require immunization without fear of legal challenges."

In December 2020, the discussion of a vaccine passport was already happening in Canada, even before vaccines were widely available. The discussion was led by businesses who were wondering if they could require immunization for employees.

In a CBC News article, Neena Gupta, a labour lawyer at Gowlings in Waterloo, Ontario said that if a provincial or local medical officer of health implemented a vaccine mandate, it could be easier for businesses.



Algonquin Offers Free Forestry Program



"That takes the responsibility away from every individual employer having to fight this out with their employees or with their workers, and puts the responsibility for a public health measure where it belongs, which is on public health," she said.

The article continues that "The authorities could then allow accommodations for people who, for whatever reason, can't get a shot, or for those who refuse vaccination on religious or moral grounds."

"Those people will have to be accommodated because there's an absolute right of accommodation under the human rights code," Gupta said."

In 2002, CUPE Local 778 grieved a decision of the St. Peter's Health System to enforce a requirement that hospital staff be vaccinated in the event of a flu outbreak among patients. If not vaccinated, employees would be suspended without pay until the end of the outbreak.

In arguing for workers not choosing to be vaccinated, the union noted "That there is a right to choose how one's body will be dealt with, even in the context of beneficial medical treatment, has long been recognized by the common law. To impose medical treatment on one who refuses it constitutes battery, and our common law has recognized the right to demand that medical treatment which would extend life be withheld or withdrawn."

The employer argued it was for the common good to protect a high-risk population.

The union argument succeeded.

A February 2021 article by several lawyers at Osler noted that "Employers who are considering a mandatory vaccination policy will need to balance workplace safety against their workers' contractual and privacy rights and human rights legislation. Unfortunately, there is currently no governmental or public health guidance that will assist employers in achieving

and maintaining this balance."

The article concluded that
"Absent government and
medical directives for employers
to require all employees to be
vaccinated, or even strongly
recommend that all employees
be vaccinated, even a carefully
drafted mandatory vaccination
policy that addresses both
human rights and privacy
concerns for employees outside
the healthcare context could be
subject to a legal challenge."

Mandatory Vaccination For Customers

In July 2021, Tory's LLP issued a statement that "Requiring proof of vaccination from customers is likely lower risk than doing so for employees (assuming privacy legislation is equally applicable) because the consequences of refusal are, on balance, less significant for customers. Many businesses also offer goods and services through online or no-contact channels as alternatives, which reduces the risk that such a requirement is truly a condition of service."

Further, Tory's LLP states that "Human rights legislation also affords individuals protection from discrimination in the area of goods, services and facilities. Accordingly, if a proof of vaccination program will result in differential treatment of unvaccinated customers, businesses will need to consider how to accommodate customers who cannot or choose not to be vaccinated on the basis of a prohibited ground of discrimination."

Quebec's vaccine passport is in effect as of September 1. Ontario's will begin September 22, 2021. There is currently no end date for either province's passport.

Quebec Vaccine Passport Rules

Ontarians visiting Quebec follow same rules with additional ID

As of September 1, Quebec requires a vaccine passport to access certain venues and participate in certain activities. The vaccination passport is required for ages 13 and older.

An Overview

As an overview, places and activities that will be requiring the vaccine passport include the following:

- Outdoor events and festivals with more than 50 people
- Performance venues, movie theatres, sports venues

- Bars, restaurants and patios
- Casino, gambling halls, bingo
- Arcades, pool halls, bowling alleys, indoor/outdoor activities at theme parks, amusement parks and centres, fun and recreation centres, water parks, zoos
 - Cruises and conventions
- Outdoor team sports or activities involving frequent or prolonged contact
- All indoor sports and physical activities

Vaccine Passport Required

Student-athletes will be required to present a vaccination passport to participate in activities with other schools.

Vaccination passports will be required for outdoor events of more than 50 people, golf tournaments, festivals, outdoor musical events, agricultural fairs, craft shows and walking tours.

Vaccine Passport Not Required

Teachers, students, and chaperones are exempt from a vaccination passport while on a school trip.

Vaccination passports will not be required for some outdoor activities including golf, tennis, horseback riding, road and mountain biking, hiking, paddle boarding and more.

Vaccination passports will not be required for drive-through services and takeout counters.

Homeless people are exempt from the requirement to present a vaccination passport to access restaurant dining rooms and patios and food courts in shopping malls.

Vaccination passports will not be required for libraries and museums.

Vaccination passports will not be required for private

gatherings, weddings and funerals, places of worship, spas and saunas, beauty care businesses, massage therapy, dog training, driving school, accommodations, hunting and fishing.

Travellers To Quebec

To gain entry to locations that require a vaccine passport, people who do not reside in Quebec must show photo ID with an address outside Quebec and proof issued by their country or Canadian province that they have had a COVID-19 vaccine

As of September 22, 2021, Ontarians will need to be fully vaccinated and provide their proof of vaccination along with photo ID to access certain public settings and facilities. A previous infection is not a substitute for being fully vaccinated. This approach focuses on higher-risk indoor public settings where face coverings cannot always be worn and includes:

- Restaurants and bars (excluding outdoor patios, delivery and takeout);
- Nightclubs (including outdoor areas);

- Meeting and event spaces, banquet halls and conference centres;
- Facilities used for sports, fitness activities and personal fitness training, such as gyms, fitness and recreational facilities (youth recreational sport is exempt);
 - Sporting events;
 - Casinos, bingo, gaming halls;
- Concerts, music festivals, theatres, cinemas;
- Strip clubs, bathhouses and sex clubs;
- Racing venues (e.g., horse racing).

A negative COVID-19 test or recent COVID-19 infection will not entitle a person to enter these settings.

Vaccine Passport Not Required

These mandatory requirements would not apply to outdoor settings where the risk of

transmission is lower, including patios, with the exception of outdoor nightclub spaces given the risk associated with the setting. In addition, these requirements will not apply to settings where people receive medical care, food from grocery stores, medical supplies and the like.

Children who are 11 years of age and younger and unable to be vaccinated will also be exempted from these requirements.

September 22-October 12 For the period between September 22 and October 12, 2021, it is intended that people attending wedding or funeral receptions at meeting or event spaces will be able to provide a negative rapid antigen COVID-19 test from no more than 48 hours before the event as an alternative to proof of vaccination. These rapid antigen tests would have to be privately purchased.

Getting Proof Of Immunization

Individuals can provide proof of immunization by downloading or printing their vaccine receipt from the provincial booking portal, or by calling the Provincial Vaccine Booking Line at 1-833-943-3900.

Travellers To Ontario

Individuals visiting from outside the province or the country will be required to show their full vaccination status and identification to enter prescribed settings.

Stop Pivoting: Keep Moving Forward

Use people and resources to your advantage

One of the things I have learned in the past two years of the COVID-19 situation is to ask for help. It took me a while because when I compared my situation to other business owners, I thought, "Well, they're having a much harder time than I am so I better not complain." I was grateful I wasn't a restaurant owner, a fitness club, a hairstylist or any number of other businesses that had seemingly impossible restrictions placed on them. But comparing my situation to others didn't relieve my anxiety, in fact, it only added to it. So, I learned to ask for help.

In my weekly business course Zoom meeting, I asked my colleagues for some help on a project I had been stalled on for a few weeks. A few of the women had been in a similar situation and were able to suggest a few ideas to get me restarted. The other women had some suggestions about how I could reframe how I was thinking about the project to put my focus more on its achievement than its challenges. It only took a few days before I was un-stalled and moving forward.

Asking for help is not an easy thing for most people to do, especially people who run a business and are used to being the problem-solver for everyone else. But when challenging situations arise, learning from others can vault you to a solution faster than plodding through it yourself. There are people available to help you in business, but they aren't clairvoyants – you have to tell them that you need their assistance.

For businesses that are short-staffed, are there services you can temporarily contract out? Is there a new way to get your recruiting message out? If your supplier cancelled a contract, is there a different way you can fill that void? Does it open up new partnerships that you hadn't considered before?

When you ask someone else for help, they are looking at the situation as it is. They see the elements of the situation impartially. When you look at the same issue, while you see it as how it is impacting you and that can skew your viewpoint to some degree. In addition, others also have a network that can include people you do not know or skilled professionals to whom you are not yet connected. You never know the resources someone can bring to the table when presented with your situation.

You may not have control over restrictions that are imposed on your business - in the name of COVID-19 or for any other situation – but you do have choices. You are still in control of how you run your business, and that includes choosing the resources to help you do that.

This is not about "pivoting." The goal here is not to abandon the course and go in another direction. Rather, the goal here is to keep moving forward by using different options than you might have originally had planned, to get you where you want to go.

You can do it, and there are people who can help.
