And Further Resolved That the Every Child Matters flag be flown at the Town Hall on September 30th, 2021 as a symbol of support and recognition for those affected by the harms of the residential school dark legacy.

The Deputy Clerk read the proclamation:

Whereas the Terry Fox Run is inspired by a dream as big as our country, which began in 1980 with Terry Fox and his Marathon of Hope. The run is now entirely volunteer driven, and grounded in traditions with events held annually around the world to foster research in the fight against cancer; and

Whereas it has become a tradition in Canada to gather friends and family to participate in a volunteer fundraiser to raise public awareness and financial support for cancer research; and

Whereas we recognize the importance of cancer research as part of the aims and objectives of the Terry Fox Run on behalf of the people of Canada, of the Province of Ontario, and of the Town of Arnprior; and

Whereas Terry once said "Anything is possible if you try." He was an innovator, attempting to run across Canada on one leg on a humanitarian mission we had never seen before; and

Whereas our local residents have taken the initiative to organize a Terry Fox Run for the past 41 years on the second Sunday following Labour Day.

Therefore, be it resolved that, I, Walter Stack, Mayor, do hereby proclaim September 19, 2021 as "**Terry Fox Day**" in the Town of Arnprior and call upon all residents to participate in the virtual Terry Fox Run (http://terryfox.org/run/) to raise money for cancer research.

14. County Councillor's Report from County Council

County Councillor Lynch noted the following information from the County of Renfrew:

- The Township of McNab/Braeside has been authorized to utilize a photo radar machine on County roads within their municipality.
- The County now has a policy dealing with the Renaming of Streets. The first step is a resolution from the local Municipality requesting renaming of the road.
- Rehabilitation of Elgin Street West, Madawaska Street, and Usborne Street is to be completed by the end of September 2021.
- The Petawawa Air Quality Monitoring Station is now closed.

- The Virtual Taste of the Valley is now live and active. This event will foster increased awareness and sales of locally grown and produced foods. The map and directory of over 130 producers will help residents and tourists find fresh, healthy and unique truly local foods and products for daily use, gifts and for special occasions.
- Shop the Valley, has been maintained by, Jackie Stott, Economic Development Coordinator, who was in Arnprior a week ago last Thursday visiting Arnprior's new businesses.
- Alex Benzie will be joining the County of Renfrew's Planning Division as a Junior Planner effective early 2022. Alex has been with the County from the beginning of May as a Planning Intern.
- The County of Renfrew Official Plan (OP) 31, Public Meeting was held on August 19, 2021, with five public submissions. This OP should be "Carried" at the next Council meeting
- If you are planning on building a house or cottage within the County, the County is
 offering a Renfrew County Wildland Fire Hazard Guideline\Checklist. As well, this
 will be provided to all development applicants when they submit a General Inquiry
 or application to the County.
- The Association for Municipalities of Ontario (AMO) announced that this year's prestigious PJ Marshall Award for Municipal Innovation was being presented to the County of Renfrew and Partners for the Renfrew County Virtual Triage and Assessment Centre (RCVTAC). Kudo's to Mike Nolan and Doctor Fitzsimmons for their hard work in making this a reality.

Of note the Province has recognized this program, and at the end of August, the Province will be funding the County directly. Previously this program was being funded by the Province through Amprior Regional Health, and then to the County. Special thanks to Eric Hanna and Doctor Fitzsimmons for ensuring this program was sustained during these trying times.

- On August 25, 2021, the County Council meeting will be in person which will be followed by the "Opening of Renovated County Headquarters".
- Thanks to the Rotary Club, two bicycle repair stations have been installed in Arnprior. These repair stations are located on the Algonquin Trail and beside the Library.
- Reminder about our submission for September 1st, 2021 dealing with Development Funding.

On question of Mayor Stack, County Councillor Lynch noted he would be bringing the issues resulting from the median installation on Daniel Street at the entrance to the Fairgrounds Subdivision under New Business at the next County Council meeting.

- Page 6 The Federal and Provincial Governments are investing \$364 million into providing high-speed internet to 90,124 residents of Eastern Ontario, and by 2025 to all residents of Ontario.
- Page 8 The Federal and Provincial Governments are investing \$2.1 Million into Active Transportation Infrastructure.
- Page 12 The Federal and Provincial Governments are investing over \$2 million to Improve Community, Culture and Recreational Infrastructure. Of note McNab/Braeside ball diamonds will have a new a support building with washrooms and more storage space.

In response to County Councillor Lynch, the CAO noted the Town of Arnprior did make a submission for this grant around growing outdoor play, and we were successful. An announcement will be imminent.

- Page 17 Ontario supports the Manufacturing Sector in McNab\Braeside, which will help create 600 jobs in the area. The site for this employment sector is Highway 17 and Campbell Drive
 - Mayor Walter Stack congratulated Mayor Peckett and his team on this new business.
- Page 19 Service Ontario is making it easier to renew your documents, Drivers Licence, Stickers, etc. by means of email, text or voicemail.
- Page 40 The Victim of Crimes is hosting a Fundraising Golf Tournament on 24 September at the Oaks of Cobden.
- Page 45 Virtual Terry Fox Run is scheduled for September 19, 2021.
- Page 48 Thank you to student David Chen, who received a Town of Arnprior Secondary School Bursary this year for his card of thanks.
- Page 67 AMCTO has submitted a document with 11 recommendations dealing with the Strengthening of Municipal Codes of Conduct.
- Page 85 Renfrew County District Health Unit is considering going door to door to unvaccinated homes to encourage vaccination.

Resolution Number 308-21 Moved by Tom Burnette Seconded by Dan Lynch **Whereas** Municipalities in Ontario have been made responsible for abandoned cemeteries within their boundaries, and are required by the Funeral, Burial and Cremation Services Act, 2002 "to ensure that the cemetery grounds, including all lots, structures, and markers, are maintained to ensure the safety of the public and to preserve the dignity of the cemetery; and

Whereas cemeteries are not only symbols of respect, preserving the memory of families, prominent citizens, and local history; some cemeteries are landmarks in themselves and hold great historical value worldwide; and

Whereas preservation repairs to older cemeteries are very costly, requiring the specialized services of stonemasons and archeologists; and

Whereas the care and maintenance funds of abandoned cemeteries are generally non-existent or so small as to produce insufficient annual interest to cover even the cost of lawn care at the site.

Therefore Be It Resolved That Council of the Corporation of the Town of Arnprior hereby urges the Government of Ontario to immediately provide funding sources for municipalities for the ongoing maintenance and preservation repair of abandoned cemeteries in their care; and

Further That this resolution be forwarded to the Bereavement Authority of Ontario (BAO), the Minister of Government and Consumer Affairs, the Rural Ontario Municipal Association (ROMA), the Association of Municipalities of Ontario (AMO), local MPP, John Yakabuski, and the Municipality of Chatham-Kent.

Resolution Number 309-21 Moved by Tom Burnette Seconded by Dan Lynch **That** Council of the Corporation of the Town of Arnprior receive the request from the Arnprior Public Library, dated July 29, 2021; and **That** Council approve providing \$3,500.00 of Development Charge funding to the Arnprior Public Library, to pay for the purchase and installation of additional shelving units. Resolution Carried

Resolution Number 310-21 Moved by Tom Burnette Seconded by Dan Lynch **Whereas** primary residences are currently exempt from a capital gains tax, and

Whereas currently secondary and additional non—primary properties are subject to capital gains, and

Whereas the Federal Government is currently looking into a primary residence capital gains tax as they have recognized that affordable housing has become a serious issue in Canada; and

Whereas smaller communities including the Town of Arnprior are seeing unprecedented higher selling prices that are outpacing prices in larger cities, and

Whereas many hard—working Canadians who have only a primary residence with no additional non—primary homes count on their home equity as financial aid to apply to upsizing or downsizing their home depending on their personal situation, and

Whereas a change in taxation to primary residences would be a significant financial blow to Canadians and would create an unfair, two-tiered taxation, which could lead to depleted savings, inter—generational disparities, disparities among diverse groups, such as seniors, who may have a significant portion of their savings vested in their primary residence, as well as, reducing the ability of home ownership, thereby a further, higher need for rentals; and

Whereas the Federal government could look at other means to slow down the rapidly escalating housing costs to improve housing affordability.

Therefore Be It Resolved That the Council of the Town of Arnprior request the Federal Government cease further consideration of eliminating capital gains tax exemptions on primary residences; and

Further That a copy of this resolution be forwarded to the Right Honorable Justin Trudeau, Prime Minister, The Honorable Doug Ford, Premier of Ontario, MP, Cheryl Gallant, MPP John Yakabuski, and the municipality of Fort Erie.

Resolution Number 311-21 Moved by Tom Burnette Seconded by Dan Lynch **Whereas** Bill C-6 an Act to amend the Criminal Code of Canada (Conversion Therapy) would prohibit certain activities that relate to "conversion therapy", which is defined as practices, treatment or services designed to change an individual's sexual orientation to heterosexual or gender identity to cisgender or to reduce non-heterosexual sexual attraction or sexual behavior; and

Whereas Bill C-6 would enact new offences to prohibit:

- Causing an individual to undergo conversion therapy against their will;
- Causing a child to undergo conversion therapy;
- Removing a child from Canada to undergo conversion therapy abroad;
- Receiving a financial or other material benefit from the provision of
- conversion therapy; and
- Advertising an offer to provide conversion therapy; and

Whereas Bill C-6 would also authorize courts to order the seizure and forfeiture of advertisements for conversion therapy or order their removal from computer systems; and

Whereas overall Bill C-6 would promote the human dignity and equality of all Canadians, including those members of the LGBTQ2 community; and

Whereas Bill C-6 would discourage and denounce practices and treatments that cause psychological harm to LGBTQ2 people.

Therefore Be It Resolved That Council of the Corporation of the Town of Arnprior supports Bill C-6 an Act to amend the Criminal Code, regarding Conversion Therapy; and

Further That this resolution be forwarded to the County of Renfrew, MP, Cheryl Gallant, MPP John Yakabuski, and the Town of Cobourg.

Recommendations:

That staff report Number 21-09-13-01 regarding the 2021 Green and Inclusive Community Buildings (GICB) Grant Application be received; and

That Council direct staff to make an application to the Green and Inclusive Community Buildings Program for the proposed Nick Smith Centre Accessibility Upgrades Project as presented to improve accessibility and lower Greenhouse Gas (GHG) emissions while demonstrating good asset management practices for the Nick Smith Centre.

Background:

The Green and Inclusive Community Buildings (GICB) Program is a Federal program providing \$1.5 billion in funding to cost share in projects under the following two streams:

- Retrofits, repairs and upgrades to existing community buildings; and
- Construction of new community buildings;

The GICB program will continuously be accepting applications for a five year period beginning in 2021 for small and medium retrofit projects ranging from \$100,000 to \$3 million. Up to \$860 million is available for retrofit projects across Canada and will cover up to 80% of selected project costs.

The objective of the GICB program is to improve the availability and condition of community buildings while simultaneously stimulating the economy and making environmentally conscious improvements more practical. This program seeks to achieve this goal by supporting projects that improve accessibility and lower environmental impacts in new-build and existing community facilities.

Eligible projects must include a capital component that is owned by an eligible entity (Municipalities, First Nations, Non-Profit Organizations, etc.). *In order for Infrastructure Canada to provide funding, projects must be duly authorized or endorsed by a resolution of Council, Band or Board of Directors, as applicable. The resolution must be received before a grant or contribution agreement can be executed.*

Proposed projects must improve overall accessibility and/or safety of the facility and contain a green retrofit measure as a component.

Retrofit projects that impact or intend to include improved accessibility measures must meet or exceed the requirement of the highest published accessibility standard in the jurisdiction, defined as the requirements in the Canadian Standards Association's Accessible Design for the Built Environment (CAN/CSA B651-18), or the most recent standard, in addition to applicable provincial or territorial building codes, and relevant municipal by-laws.

Eligible asset types include the following:

- Community, Culture and Recreation Facilities;
- Mobile Community Structures;
- Community Health & Wellness Facilities;
- Indigenous Health and Social Infrastructure Facilities; and
- Indigenous Education Facilities.

Additional criteria include:

- Projects must be substantially complete by March 31, 2026;
- The facility must be accessible to the public and be non-commercially community oriented;
- The facility must be located in an area with underserved populations experiencing higher needs and be the site of programming that serve these populations;
- Facility structural information, energy profile, and GHG emissions must be submitted using the RETScreen® Expert software
- Climate change impacts have been assessed and the project will not lead to an increase in the building's operational GHG emissions

- The applicant must attest to the manner in which the project will meet relevant building and construction laws and regulations, including completion (or planned completion) of environmental assessment and consultation as may be required by federal and provincial/territorial governments.
- The applicant must attest to the manner in which the project will align to the building standards and codes that apply to the jurisdiction of the existing building and, as applicable, those set out in the section entitled "What are the required construction standards for new buildings?".
- Retrofit projects that intend to improve accessibility, as well as all new builds, must meet or exceed the highest published accessibility standard as defined by the requirements in the Canadian Standards Association's Technical Standard Accessible Design for the Built Environment (CAN/CSA B651-18) or the most recent standard, in addition to provincial or territorial building codes, and relevant municipal by-laws.

It is noted that the following factors increase the score of an application:

- Projects that begin sooner
- Projects that provide greater benefits to high need communities
- Projects that exceed rather than meet the highest standards for accessibility
- Projects that greater reduce GHG emissions relative to the building's baseline
- Projects that achieve at least 25% in energy efficiency improvements
- Projects that demonstrate strong climate resiliency measures; with reasonable explanation to this being irrelevant to a specific case, this becomes invalid
- Projects that demonstrate strong risk assessment and mitigation

Discussion:

The Nick Smith Centre (NSC) was originally constructed in 1977. The multi-purpose complex includes two arenas, a swimming pool and an event hall complete with office space, change rooms, and support spaces. The facility, a centre of community, is significant to the Town of Arnprior as a hub for sports, recreation and culture and must continue to be the flagship recreational facility in Arnprior.

The Town's proposed GICB Grant funded project will focus on the facility and property as a whole aimed at improving accessibility and functionality while implementing good and well-informed asset management practices.

The proposed project will include the following four work areas:

- Pool Change Rooms;
- Community Hall Lobby;
- Arena A Dressing Rooms; and
- Heating, Ventilation & Air Conditioning (HVAC) systems.

Pool Change Rooms

The existing pool change rooms consist of both men's and women's public, men's and women's staff and a multi-purpose room that serves as storage, space for birthday parties and additional changing space, as needed. The existing layout is restrictive to users with accessible/mobility needs. Although accessible components, such as automatic door operators, toilets and sinks, are in place, the spaces are not officially accessible per the Accessibility for Ontarians with Disabilities Act (AODA).

The contemplated project would include a full renovation of all existing staff and public change rooms in addition to creation of new change room space dedicated to families and users with accessible/mobility needs. The work may include relocation of the pool office, creation of additional storage space and improved facility flow and functionality.

The Arnprior Accessibility Advisory committee, the Nick Smith Centre Working Group, facility users/user groups and the Public have all identified the need for an accessible/family change room for the pool. The Arnprior 2018-2023 Multi-Year Accessibility Plan lists making all change rooms and washrooms at the NSC fully accessible as a top priority for the facility.

Community Hall Lobby

The Community Hall is a unique multi-use space, able to host a wide variety of community functions and events. The space includes a fully functional commercial kitchen, a bar and storage space. A Community Hall-dedicated lobby at the front of the building is home to men's and women's public washrooms. Previous review of the existing washrooms found that in order to achieve AODA compliance for these washrooms a reduction to the total number of available lavatories would result due to AODA clearance requirements. A reduction to the number of lavatories would result in a lower maximum allowable occupant load for the Community Hall.

Staff proposes construction of a stand-alone, AODA-compliant accessible washroom in the north corner of the Community Hall lobby. Installation of which would provide an accessible option to not only users of the Community Hall but conceivably would capture traffic from the main lobby as well. The total number of available lavatories would be increased, allowing the Town to maintain current occupant loads in the Community Hall. Additionally, a new build, within the existing space, reduces the need for large scale and costly modifications to the existing washrooms that may or may not meet the needs of facility users.

Arena A Dressing Rooms

Arena A, also known as the Bert Hall Arena, is served by four dressing rooms located at the rear of the facility. Built in the 1980s these dressing rooms, although well maintained, are in need of a refresh, specifically in respect to the shower and washroom spaces.

The dressing rooms each house separate two-piece washrooms, and shower space, which is shared with the adjacent dressing room. The project would include a full renovation of the existing washroom and shower spaces, widening of all doorways and installation of necessary accessible components, including seating and grab bars within the showers and universal washrooms systems for all new washroom spaces.

HVAC Improvements

The climate in the pool and pool change rooms is controlled by a Reznor Rooftop Unit (RTU) installed in 1993. This HVAC unit (RTU #1, Section 3) was planned for replacement in 2021 but the project had to be postponed due to the neighbouring unit, a 2003 Engineered Air RTU (RTU#3, Section 5), experiencing chronic maintenance issues forcing its premature replacement. The estimated useful life of HVAC RTUs is typically 20-25 years. A modern RTU will be much more efficient than one installed in 1993 and this unit has also exceeded its estimated useful life thus justifying its lifecycle replacement.

Climate control within the facility has been an ongoing issue for many years, partially due to factors relating to changing area uses, newly constructed walls and ventilation zoning being based on heating equipment at the time of initial construction. A mechanical engineering consultant was invited to tour the Nick Smith Centre in April of 2021 to provide a quotation to investigate and provide solutions to climate zone issues, efficiency improvements and future equipment recommendations. Prior to design costs this quotation value was \$23,840. As well as improving the existing system, the desired outcome is to have recommended equipment replacement specifications to utilize as units reach the end of their estimated useful life.

As per the LRCF, the pool boiler system which was installed in 1997 is scheduled for replacement in 2024. The estimated replacement cost of this unit is \$50,000.

As per the LRCF, the Dectron pool dehumidifier which was installed in 2004 is also scheduled for replacement in 2024. This unit has required frequent repair over the last year and is quickly approaching the end of its estimated useful life. The estimated replacement cost of this unit is \$300,000. It is anticipated that both pieces of pool equipment will be replaced with more energy efficient units.

Concepts and Costs

In 2019, staff retained Ottawa-based architectural firm Architects DCA (DCA) to develop concept floorplans and budgetary estimates for the pool change rooms, Community Hall accessible washrooms and Arena A Dressing Room works. After touring the facility in October of 2019, DCA issued conceptual floorplans as well as Class D estimates of project costs being approximately \$500,000 to \$850,000.

The total HVAC improvements as outlined above are estimated by staff to cost approximately \$600,000.

Timelines

Important GICB timelines are as follows:

- Applications accepted until 2026 however projects that start sooner are more likely to be successful in getting funding;
- Project Completion: March 31, 2026.

Options:

Council may choose:

- Not to endorse the project as presented.
- To endorse a modified version of the presented scope of work.

Neither of these options are recommended for reasons outlined within this report

Policy Considerations:

The work proposed, on an individual basis and as a group are aligned with the following Town of Arnprior plans and policies:

- Asset Management Plan;
- Asset Management Policy;
- Multi-Year Accessibility Plan;
- Tangible Capital Asset Policy;
- Recreation Master Plan;
- Strategic Plan; and
- Official Plan.

Financial Considerations:

Staff estimates the total project, inclusive of all identified work areas to cost in the range of \$1,100,000 to \$1,450,000. This value is based on previously submitted estimates for the pool change rooms, community hall lobby accessible washroom and Arena A Dressing Rooms submitted by DCA in early November 2019 and an approximation of proposed HVAC improvements.

Using Staff's estimates, Arnprior's cost sharing portion would range as follows:

Recommendations:

That Council authorize staff to bring forward at the September 27, 2021 meeting, a by-law to adopt a new lease agreement with Rafka El-Hachache for the Nick Smith Centre canteen with terms as outlined within this report.

Background:

Following renovations to the Nick Smith Centre canteen throughout the summer of 2019 and the previous canteen operator not renewing the lease, the Town of Arnprior entered into a lease agreement with Rafka El-Hachache for the operation of the Nick Smith Centre Canteen. The lease of the 360 square foot space was for one year beginning October 1, 2019 through September 30, 2020 with a gross rent of \$6,480.00 payable in monthly instalments of \$540.00. While the agreement was only for the one year, there was a clause in the contract that should an extended term be granted, a 2% annual increase would be added each year to the gross rent.

With positive momentum building for the new canteen operators through the Fall of 2019 and into 2020, the facility was closed on March 13, 2020 due to COVID-19 which did come at a cost to the operators with no opportunity to generate revenue and taking a loss on previously purchased inventory. With the mandated facility closures, the Town of Arnprior did not charge rent at any time during the COVID-19 lockdown.

When the Nick Smith Centre re-opened in August 2020, while the tenants were open to discussing a lease renewal, the canteen did not re-open as the Nick Smith Centre operated in a fashion that would not allow for users to access the lobby where the canteen is located, major tournaments and events were cancelled and eventually food and beverage consumption was not permitted in the facility in order to adhere to all public health guidelines.

Discussion:

The canteen tenants from 2019-2020 are keen to return for the upcoming winter ice season running October 1, 2021 to April 30, 2022 – a seven-month period.

Anticipating less volume of activities and less patrons in the facility due to public health restrictions, the tenants have requested a reduced rent for the proposed rental period. The proposed rate for the rental period is \$3900.00 payable in monthly instalments of \$325.00.

This proposed rate represents a reduction of forty (40) percent per month and almost thirtyseven (37) percent overall.

Conversations have been had with our health inspector since July regarding the opening of the canteen and consumption of food and beverages in the facility. The canteen operator, consumers and Town of Arnprior must adhere to the restrictions currently in place for restaurant and bars as outlined in O. Reg. 364/20 Schedule 2. Consumers can only remove their mask when seated to consume their food and must maintain six (6) feet distance from others.

At present, the winter ice and pool schedule are expected to operate near typical operational numbers including the return of tournaments, the Amprior Packers (EOJHL), the West Carleton Rivermen (EOSHL) and the Ontario Winter Games (February 2022).

Options:

Council could choose to amend the lease terms to another timeframe or rental rate.

Council could choose to decline the opening of the canteen in its entirety.

Staff do not recommend either of these options as discussions with the health inspector demonstrate, a canteen can be safely run within the current public health guidelines and proceeding with canteen services will provide residents and visitors with these onsite services.

Policy Considerations:

This report has been completed in accordance with the Town's Strategic Plan vision for embracing a Sustainable Financial Model and effective Service Delivery.

Financial Considerations:

The recommended changes are intended to ensure we have a canteen operator that can deliver this service to our facility users. While lease revenues for 2021 will be less than estimated due to the extended facility closures, entering into the recommended lease agreement for the canteen will provide some revenues in the fourth quarter of 2021 to help reduce these impacts.

Whereas the municipality has now entered into a Subdivision Agreement with the owner;


Therefore the Council of the Town of Arnprior enacts as follows:

A by-law to appoint Rubab Nadeem as a Deputy Treasurer with signing authority for the Corporation of the Town of Arnprior.

Whereas Section 8 of the Municipal Act, 2001, S.O., c.25 as amended states that the municipality has the capacity, rights, powers and privileges of a natural person for the purposes of exercising its authority; and

Whereas Section 11 of the Municipal Act, S.O. 2001, as amended allows the municipality to provide any service or thing that the municipality considers necessary or desirable for the public, including the passing of by-laws pertaining to governance structure of the municipality; and

Whereas Section 23 (1) of the Municipal Act, S.O. 2001, as amended authorizes a municipality to delegate its powers and duties under this or any other Act to a person; and

Whereas subsection 286(2) of the Municipal Act, S.O. 2001, c.25 as amended, provides that a municipality may appoint Deputy Treasurers who shall have all the powers and duties of the Treasurer under the Municipal Act 2001, and any other act; and

Whereas the Council of the Town of Arnprior deems it necessary to enact a by-law to provide for a Deputy Treasurer, who in the absence of the Treasurer shall carry out the duties of the Treasurer; and

Whereas the Council of the Corporation of the Town of Arnprior deems it expedient to appoint Rubab Nadeem as Deputy Treasurer, effective September 7, 2021.

Therefore the Council of the Town of Arnprior enacts as follows:

1. **That** Rubab Nadeem is hereby appointed as Deputy Treasurer of the Town of Arnprior, effective September 7, 2021 and shall have the title of Manager of Finance for Town Business; and

- 2. **That** Rubab Nadeem as Deputy Treasurer shall have all authority granted through all pertinent Town of Arnprior By-laws and all applicable law; and
- 3. **That** effective September 7, 2021 Rubab Nadeem shall be an authorized signing authority for banking purposes for the Corporation of the Town of Arnprior; and
- That By-law Number 6809-18 and any by-law as they existed prior to September 7, 2021 are repealed insofar as they apply to the appointment of a Deputy Treasurer.
- 5. That this By-law shall come into force and effect on the day of its passing.
