# Budget Consultations

## a) Physician Recruitment Committee

Chair Mark Nibourg of the Physician Recruitment Committee provided a presentation outlining the past years' initiatives and achievements of the Physician Recruitment Committee, attached as Appendix A and forming part of these minutes.

The Physician Recruitment Committee requested \$20,000 from the Town of Arnprior.

# b) Seniors Active Living Centre (SALC)

Judy Cobus, representative of the Seniors Active Living Centre, provided a presentation outlining the past years' initiatives and achievements, attached as Appendix B and forming part of these minutes.

The Seniors Active Living Centre (SALC) requested \$5,000 of in-kind services and \$10,000 of funding from the Town of Arnprior.

### c) Arnprior Airport Commission

Board Member of the Arnprior Airport Commission, Councillor Ted Strike, provided a brief overview of the Arnprior Airport Budget Submission, attached as Appendix C and forming part of these minutes.

The Arnprior Airport Commission requested a decrease of \$5,000 from the previous year, equalling \$55,000.

### d) Arnprior & McNab/Braeside Archives

Brian Gilhully, representing Arnprior & McNab/Braeside Archives provided a presentation outlining the past year's initiatives and achievements, attached as Appendix D and forming part of these minutes.

The Arnprior & McNab/Braeside Archives requested an increase of \$6,000 in funding from the previous year, equalling \$27,000.

### e) Arnprior Public Library

Josee Scott, of the Arnprior Public Library Board, provided a presentation outlining the past years initiatives and achievements, attached as Appendix E and forming part of these minutes.

The Arnprior Public Library requested total funding of \$298,051 in funding from the Town of Arnprior.

### f) Kevin Hayes, Municipal Marina

Kevin Hayes provided a verbal presentation summarizing a letter he submitted regarding various requests for changes to the Municipal Marina Operations and requested Council to consider the following:

# g) Renfrew County 2022 Ontario Winter Games

Ontario Winter Games requested the use of the Nick Smith Centre free of charge or at a reduced fee for the duration of the event. This equates to a value of approximately \$10,000.
