#### 6. Presentations - Budget Consultations

#### a) Arnprior Public Library Board

Chief Librarian Karen DeLuca and Chair Josie Scott provided a PowerPoint presentation, attached as Appendix A and forming part of these minutes.

The Arnprior Public Library Board requested 2023 funding in the amount of \$336,848 for the addition of a full-time position for Programming and Community Outreach – pilot project from April 2023-December 2023, due to a steady increase in patrons and succession planning.

#### b) Arnprior McNab/Braeside Archives (AMBA)

Brian Gilhuly, Board Member AMBA provided a PowerPoint presentation, attached as Appendix B and forming part of these minutes. Mr. Gilhuly noted AMBA is a community institution established by local volunteers as a non-profit, charitable organization serving the greater Arnprior area.Mr. Gilhuly outlined AMBA's 2022 initiatives and achievements.

Arnprior McNab/Braeside Archives requested 2023 funding in the amount of \$35,000, an increase of \$3,000 over the 2022 funding.

#### c) Arnprior & Area Physician Recruitment Committee

Mark Nibourg, Chair of the Arnprior & Area Physician Recruitment Committee explained Arnprior & Area Physician Recruitment Committee is a collaborative community effort between the Town of Arnprior, Township of McNab/Braeside, Arnprior Regional Health and the Arnprior Family Health Team dedicated to ensuring that every local resident has access to a local family physician. Nibourg provided a PowerPoint Presentation outlining the past year's initiatives and achievements of the Physician Recruitment Committee, attached as Appendix C and forming part of these minutes

The Arnprior & Area Physician Recruitment Committee requested \$20,000 from the Town of Arnprior.

#### d) Arnprior Regional Health Foundation – CT Scan Campaign

Ben Gardiner, Executive Director of Arnprior Regional Health Foundation provided a PowerPoint presentation attached as Appendix D and forming part of these minutes

Arnprior Regional Health requested \$200,000 over four years (\$50,000/year) from the Town of Arnprior for the CT Scan Campaign.

#### e) Arnprior Airport Commission

John Constantinesco, Chair of the Arnprior Airport Commission provided a PowerPoint presentation attached as Appendix E and forming part of these minutes,

The Arnprior Airport Commission requested a \$55,000 grant from the Town of Arnprior.

#### f) Ontario Winter Games

Peter Emon, Warden, County of Renfrew and Cindy Burwell, Games Manager 2023 Winter Games provided a PowerPoint presentation, attached as Appendix F and forming part of these minutes, on the 2023 Ontario Winter Games.

# **Minutes of Special Council Meeting**

Ms. Burwell highlighted the County of Renfrew is hosting young athletes from across the province, at the 2023 Games February 2- 5, and February 9 - 12, 2023. Ms. Burwell further highlighted Ringette is taking place at the Nick Smith Centre February 2-5 and Wushu is being held at Arnprior District High School between February 9-12.

The Renfrew County Ontario Winter Games requested an in-kind sponsorship for ice time and community hall use at the Nick Smith Centre (value \$8,510) to host the Ringette Event of the Winter Games being held in Arnprior and further possible in-kind support closer to the event date for equipment, transportation and setup support (value not specified).

# g) Seniors Active Living Centre

Judy Cobus, Manager of Community Programs, Arnprior Regional Health provided a PowerPoint presentation on Arnprior Regional Health's Seniors Active Living Centre, which offers social, cultural, learning and recreational programs for seniors that promote health, well-being and social connection, attached as appendix G and forming part of these minutes.

Arnprior Regional Health requested maintaining in-kind funding of \$5,000 and increasing funding dollars from \$10,000 to \$15,000 for a total ask of \$20,000.

# 13. County Councillor's Report from County Council

- On 03 November, County Councillor Lynch attended Queen's Park for the purpose of showcasing businesses in the Valley and the Ontario Winter Games. Of note, Arnprior was represented by David Watson, President of Plaintree Systems Inc.
- The County of Renfrew held its Inaugural meeting, 23 November 2022 with Councillor Peter Emon being acclaimed Warden. A Striking Committee was formed, and as a result, County Councillor Lynch is a member of Operations Committee, Development & Property Committee, Algonquin Trail Advisory Committee, Ottawa Valley Trail Advisory Committee and the Canadian Nuclear Laboratories Stewardship.
- On the morning of 7 December 2022 County Councillor Lynch had the opportunity to attend Canadian Nuclear Laboratories, Chalk River to be part of the ground-breaking of the Advanced Nuclear Materials Research Centre (ANMRC).
- Two Special Meeting's of Council were held today, December 12. The first dealt with Orientation of Departments (video) followed by an Orientation of Integrity Training by Tony Fleming, Senior Legal Counsel, of Cunningham Swan.

# a) Correspondence Package – I-22-December-18

**That** the Correspondence Package Number I-22-December-18 be received as information and filed accordingly.

County Councillor Dan Lynch noted the following:

- Page 7 Important Information for Seniors Of note to seniors living in our community, beginning in July 2022, the Old Age Security Pension increased by 10 percent, for seniors 75 years of age and older, providing more than \$800 in new support over the first year.
- Page 47 Consistent with prior years, Transitional Assistance will continue to ensure that municipalities in northern Ontario receive a least 90% of their 2022 OMPF allocation, and municipalities in southern Ontario receive at least 85%. Municipalities in all regions of the province with the most challenging fiscal circumstances will continue to have their funding enhanced up to 100% of the prior years allocation.
  - On question of County Councillor Lynch the GMCS, Treasurer advised the municipality is considered Southern Ontario. The Town's calculation does include a calculation under the Northern and Rural Municipal Fiscal Circumstances Index (MFCI). On a scale of 0 to 10 with 0 being positive circumstances and 10 being challenging circumstances we received an MFCI of 6.1.
- Page 132 Ottawa Valley Business, Municipal Election Results: Renfrew County, Congratulations to our Election Staff and the residents of Arnprior who were the number one urban voter turnout percentage with 47.29%; Renfrew 43.16%; Pembroke 34.75 % and Petawawa with 27.06%.
- Page 144 Ottawa Valley Business, Competition Includes Canada and U.S. The Royal Agricultural Winter Fair took place November 4-13, 2022 at Exhibition Place in Toronto. This year marked the 100th anniversary of the event. Agricultural farms and owners from across Canada and into the United States took part in a variety of competitions. Of note, the Arnprior area was well represented in the category Holstein Winter Heifer - Sarah Dean placed 13<sup>th</sup>; and in the TD Canadian 4-H Dairy Classic – Jersey - John Potter placed 10<sup>th</sup>. Other local competitors, from McNab/Braeside, category Senior Calf – Katie Cox and Intermediate Calf – Double H Cattle.
- Page 174 Watson & Associates, the 2031 Municipal Housing Targets the Province has identified that an additional 1.5 million new housing units are required to be built over the next decade to meet Ontario's current and forecast housing needs. Further, the Province has assigned municipal housing targets, identifying the number of new housing units needed by 2031, impacting 29 of Ontario's largest and many of the fastest growing single/lower tier municipalities. Arnprior is not one of the communities identified as fastest growing.
- Page 207 AMO Watchfile the LAS Road and Sidewalk Assessment service uses modern technology to manage your surface assets. Better data ensures maintenance budgets are spent as efficiently as possible, and customized quotes for a 2023 survey are available.
  - On question of County Councillor Lynch the CAO advised that staff will research the services being offered.
- Page 209 AMO Watchfile The Enabling Change Funding Program provides grants for projects that show the value and benefits of accessibility through tools and educational resources.
  - On question of County Councillor Lynch the GMCS, Treasurer advised staff is looking at the funding program as there are a number of accessibility projects staff has that may fit the criteria.

# The Corporation of the Town of Amprior

# **By-law Number 7346-23**

A by-law to provide for a 2023 interim tax levy and to provide for the collection thereof and further to provide for penalty and interest in default of payment thereof.

**Whereas** section 317 of the *Municipal Act 2001*, S.O. 2001, c.25 provides that the Council of a local municipality, before the adoption of the estimates for the year under Section 290, may pass a by-law levying amounts on the assessment of property in the local municipality ratable for local municipality purposes and the amount to be raised from any property must not exceed the 50 percent of the amount raised or would have been raised in the previous year from that property; and

**Whereas** Section 345 of the *Municipal Act 2001*, S.O. 2001, provides that a local municipality may pass by-laws to impose late payment charges for the non-payment of taxes or any instalment by the due date.

**Therefore**, the Council of the Town of Arnprior enacts as follows:

- 1. **That** for all properties in all property classes there shall be imposed and collected an interim tax levy of 50 percent of the total taxes for municipal, county and school purposes levied or would have been levied on the property in 2022.
- 2. **That** the interim tax levy at 50 percent rounded upwards to the next whole dollar shall become due and payable on the 28<sup>th</sup> day of February, 2023; the remaining 50 percent shall become due and payable on the 31<sup>st</sup> day of May, 2023 and non-payment of the amount, as noted, on the dates stated in accordance with this section shall constitute default.
- 3. **That** on all taxes of the interim levy which are in default on the first day after the due date, a penalty of 1.25 percent shall be added and thereafter interest of 1.25 percent per month will be added on the 1<sup>st</sup> day of each and every month the default continues.
- 4. **That** the Treasurer shall send a tax bill to the taxpayer's residence or place of business or to the premises in respect of which the taxes are payable unless the taxpayer directs the Treasurer in writing to send the bill to another address, in which case it shall be sent to that address.

5.	<b>That</b> taxes are payable to the Corporation of the Town of Arnprior.
6.	That this By-law shall come into force and effect on the day of its passing.

The Corporation of the Town of Arnprior

By-law No. 7347-23

Being a By-law to appoint an alternate member to the County of Renfrew Council

**Whereas** the *Municipal Act, 2001*, as amended (the "Municipal Act") provides that the powers of a municipal corporation are to be exercised by its Council through the adoption of by-laws; and

**Whereas** Section 268 of the Municipal Act authorizes, the council of a local municipality may appoint one of its members as an alternate member of the upper-tier council, to act in place of a person who is a member of the councils of the local municipality and its upper-tier municipality, when the person is unable to attend a meeting of the upper-tier council for any reason;

# Therefore the Council of the Town of Arnprior enacts as follows:

- 1. **That** Mayor Lisa McGee is hereby appointed as the Alternate Member to the County of Renfrew Council for a term of the Council that appointed her, or until her appointment by-law is rescinded, or November 14<sup>th</sup> in the year of a Regular Election, or until such time as the Alternate Member's seat is declared vacant in accordance with section 259 of the Act.
- 2. **That** the appointed Alternate Member shall not sit on behalf of the County Councillor at an Inaugural Meeting of County Council or any board or agency to which the County Council appoints members.
- 3. **That** the Alternate Member shall abide by the alternate members policy as may be established by the County of Renfrew, and as may be amended from time to time.
- 4. **That** this By-law shall come into full force and take effect upon the date of final passing, at which time all by-laws and/or resolutions that are inconsistent with the provisions of this By-law and the same are hereby repealed or rescinded insofar as it is necessary to give effect to the provisions of this By-law.

  - Ian Bartlett, Arnprior representative
  - Ying Ji, Arnprior representative,
  - Josie Scott, Amprior representative
  - Steve Roberts, Councillor Lanark Highlands representative
- 2. That this By-law shall come into full force and take effect upon the date of its passing, at which time all by-laws and/or resolutions that are inconsistent with the provisions of this By-law and the same are hereby repealed or rescinded insofar as it is necessary to give effect to the provisions of this By-law.
