As Canadians, we place a lot of value in our universal, public health care system. Unfortunately, it hasn't been living up to expectations. Across the country, patients seeking emergency care are finding their emergency rooms overwhelmed or even closed. People are waiting for surgeries that are postponed or cancelled. The health care system and the workers who uphold it are under enormous strain, a situation that was exacerbated by the pandemic, and needs immediate action to deliver better health care for Canadians.

Today, the Prime Minister, Justin Trudeau, and his provincial and territorial counterparts met to work together on improving Canada's health care system. Prime Minister Trudeau and premiers discussed shared health priorities to deliver real results for Canadians as well as the importance to uphold the *Canada Health Act* to protect Canada's publicly funded health care system. Canadians must have equitable access to medical care based on their needs, not their ability to pay.

At the working meeting with premiers, the federal government announced it will increase health funding to provinces and territories by \$196.1 billion over 10 years, including \$46.2 billion in new funding. This funding includes the following elements:

- An immediate, unconditional \$2 billion Canada Health Transfer (CHT) top-up to address immediate pressures on the health care system, especially in pediatric hospitals and emergency rooms, and long wait times for surgeries. This builds on previous CHT top-ups that total \$6.5 billion provided throughout the pandemic.
- A 5 per cent CHT guarantee for the next five years, which will be provided through annual top-up payments as required. This is projected to provide an additional \$17.3 billion over 10 years in new support. The last top-up payment will be rolled into the CHT base at the end of the five years to ensure a permanent funding increase, providing certainty and sustainability to provinces and territories. With this guarantee, the CHT is projected to grow by 33 per cent over the next five years, and 61 per cent over the next 10 years.
- \$25 billion over 10 years to advance shared health priorities through tailored bilateral agreements that will support the needs of people in each province and territory in four areas of shared priority:
 - family health services;
 - health workers and backlogs;
 - mental health and substance use; and
 - a modernized health system.

These additional federal investments will be contingent on continued health care investments by provinces and territories. This funding builds on the \$7.8 billion over five years that has yet to flow to provinces and territories for mental health and substance use, home and community care, and long-term care.

- \$1.7 billion over five years to support hourly wage increases for personal support workers and related professions, as federal, provincial, and territorial governments work together on how best to support recruitment and retention.
- \$175 million over five years for the Territorial Health Investment Fund in recognition of medical travel and the cost of delivering health care in the territories.

In addition, the government will work with Indigenous partners to provide additional support for Indigenous health priorities:

 \$2 billion over 10 years to address the unique challenges Indigenous Peoples face when it comes to fair and equitable access to quality and culturally safe health care services. The government will work with Indigenous partners to prioritize investments.

These investments, on top of already significant funding, will help build a health care system that includes:

- access to high-quality family health services when they need them, including in rural and remote areas, and for underserved communities;
- a resilient and supported health care workforce that provides high-quality, effective, and safe health care services;
- access to timely, equitable, and quality mental health, substance use, and addictions services to support Canadians' well-being;
- access to a patient's own electronic health information that is shared between the health professionals they consult; and
- access to home care and safe long-term care so Canadians can age safely and live in dignity.

While provinces and territories are already taking steps to advance work on these shared priorities, Canadians expect more concrete actions to improve health care services. The funding announced today can help accelerate progress.

Canadians deserve to know what progress is being made. That is why to access their share of the federal funding, including the 5 per cent CHT guarantee, provincial and territorial governments are asked to commit to improving how health information is collected, shared, used, and reported to Canadians to promote greater transparency on results, and to help manage public health emergencies. Canadians should be able

to access their own health information and benefit from it being shared between health workers, across health settings, and across jurisdictions. That is why provinces and territories are also asked to agree to adopt common standards and policies related to data.

The Government of Canada recognizes that provinces and territories have their own unique circumstances. As such, bilateral agreements are intended to be flexible, and provinces and territories will have options to tailor these agreements to address the unique needs of their populations and geography. As part of these agreements, provincial and territorial governments are asked to develop action plans that will outline how funds will be spent and how progress will be measured. Investments are to be centered around the following four shared health priorities: family health care; health workforce and backlogs; mental health and substance use; and modernizing the health care system with standardized information and digital tools. Each province and territory will have flexibility in designing their action plans, including the addition of targeted results with indicators that are tailored to their realities.

During the COVID-19 pandemic, we showed that we can work together to tackle big challenges. The Government of Canada will continue to work in collaboration with provinces and territories on next steps, in the best interest of Canadians, their families, and health care workers. We will work to deliver concrete outcomes for Canadians and improve the health care system that Canadians value and depend on.

Quick Facts

• The Canada Health Transfer (CHT) is the largest major federal transfer to provinces and territories. It provides long-term, predictable funding for health care and supports the principles of the *Canada Health Act*. CHT payments are made on an equal per capita basis to provide comparable treatment for all Canadians, regardless of where they live. The CHT grows in line with a three-year moving average of nominal gross domestic product, with total funding guaranteed to increase by at least 3 per cent per year. In 2023-24, the federal government will

provide a total of \$49.4 billion to provinces and territories under the CHT, an increase of 9.3 per cent, or \$4.2 billion, from 2022-23.

- The funding outlined today is in addition to \$11 billion in existing funding (\$4.8 billion remaining) through the 2017 bilateral agreements on Home Care and Mental Health (to 2026-27), and \$3 billion for long-term care provided in Budget 2021.
- As part of today's announcement, the Government of Canada will provide \$505 million over five years to the Canadian Institute for Health Information, Canada Health Infoway, and federal data partners to work with provinces and territories on developing new health data indicators, and to support the creation of a Centre of Excellence on health workforce data and underpin efforts to use data to improve health care.
- The CHT, along with historical tax point transfers for health to provinces and territories dating back to the 1970s, accounts for nearly one third of all the money provinces and territories spend on health care. The value of these tax points is \$25 billion in 2022-23.
- In addition to the CHT, the Government of Canada has made significant targeted investments to support health systems, including more than \$72 billion over the course of the COVID-19 pandemic to protect the health and safety of Canadians. More than eight out of every 10 dollars provided to fight COVID-19 and support Canadians was provided by the federal government.
- The federal government works collaboratively and in partnership with Indigenous partners and communities to support improved access to high quality, culturally appropriate health services, greater Indigenous control of health services, and improved health outcomes. Each year, the government invests approximately \$5 billion in Indigenous health. This includes important new investments announced since 2021 to support further progress, including:
 - \$354 million over five years to increase the number of nurses and other medical professionals in remote and isolated First Nations communities;
 - \$250 million over five years to further support recruitment and retention of health professionals on reserve;
 - \$825 million over three years for distinctions-based mental health and wellness strategies;
 - \$127 million over three years to foster health systems free from racism and discrimination; and
 - \$107 million over three years to continue efforts to transform how health services are designed and delivered by First Nations communities.

Tax season has officially kicked off and many Canadians will turn to the Canada Revenue Agency (CRA) for guidance. We are ready to answer your questions and provide you with services to make it easier and quicker to file your 2022 income tax and benefit return, whichever way you choose to do it.

For most Canadians, the deadline to pay their taxes and file their return for 2022 is April 30, 2023. Because this date is a Sunday, a return will be considered filed on time if the CRA receives it, or it is postmarked, on or before May 1, 2023. A payment will be considered made on time if the CRA receives it, or a Canadian financial institution processes it, on or before May 1, 2023.

Helpful information and resources for taxpayers

Looking for the best way to file your taxes? – Check out our <u>Ways to do</u> <u>your taxes</u> page and pick the option that best suits your needs. Some options are free!

Over 28 million income tax and benefit returns were filed online in 2022. Electronic returns filed on time are generally processed within two weeks. If you are registered for <u>direct deposit</u> and you <u>file online</u>, you may be able to get your refund in as little as eight business days.

My Account – <u>My Account</u> is our online portal for individuals where you can find your tax information and access many of the slips you need to file your income tax and benefit return.

You can also:

- change your personal information, such as your address, phone number, and marital status
- register for direct deposit
- make a payment
- track the status of your return
- apply for child benefits
- receive mail and email notifications
- view uncashed cheques
- and so much more!

You will also be able to access digital services such as <u>Auto-fill my</u> <u>return</u> and <u>Express NOA</u> in certified tax-filing software. If you own a business, you can also sign up for <u>My Business Account</u>.

Steps to get ready for filing – Not sure where to start? Visit our <u>Get ready to</u> <u>do your taxes</u> page for the latest tax information. We have eight steps that will help you prepare to file.

Quick and helpful tax tips – Our <u>Tax tips</u> can provide you with quick and helpful information to address your tax questions.

Learn about your taxes – The CRA has launched a <u>free online learning tool</u> to help you do your taxes on your own. This tool provides you with lessons that help you understand what taxes are, why we pay them, how to understand your paycheques, pay stubs and income tax slips, and finally, how to do your taxes for the first time.

Community Volunteer Income Tax Program (CVITP) – If you have a modest income, a simple tax situation, and require assistance, a CVITP volunteer may be able to do your taxes for free. To find a clinic, please visit our <u>Free tax clinics</u> page. If you live in Quebec, please visit the <u>Income Tax Assistance – Volunteer</u> <u>Program</u> page for more information.

Payment arrangements – If you cannot pay an existing debt in full, you may be eligible for a <u>payment arrangement</u>. Payment arrangement options have been expanded to reflect current realities. The <u>Payment Arrangement</u> <u>Calculator</u> has also been added to My Account and My Business Account. This self-service tool allows you to submit a potential payment arrangement without having to contact the CRA. If the proposed payment arrangement does not meet the CRA payment policy, a CRA officer will reach out to complete the arrangement.

New benefits, credits and services

Simplified Northern Residents Travel Deduction – The CRA is launching the Simplified Northern Residents Travel Deduction, a pilot project to make it easier for northern residents to determine the lowest return airfare, one of the three amounts required to claim the travel deduction come tax time. Available the week of February 20, 2023, on <u>canada.ca/lowest-return-airfare</u>, the simplified version features tables that identify the lowest return airfare amount found from airports with regularly scheduled commercial flights to a designated city. The airfare tables contain more than 135 airports, almost all of which are located in the <u>prescribed zones</u>.

Canada Dental Benefit – The new interim Canada Dental Benefit is available to eligible families earning less than \$90,000 per year. It provides financial support for parents and guardians of children under 12 years old if they receive dental care in Canada and do not have access to private dental insurance. In order to receive this benefit, you need to have filed your 2021 tax return. The CRA's online application <u>My Account</u> is the fastest way to apply for this benefit. For more information, go to <u>Canada Dental Benefit</u>.

One-time top-up to the Canada Housing Benefit – The government introduced a one-time \$500 payment to help lower-income renters facing housing affordability challenges. Applications are open until March 31, 2023. To obtain the one-time payment, you need to have filed your 2021 tax return. For more information on the eligibility requirements and how to apply, go to <u>One-time top-up to the Canada Housing Benefit</u>.

First-time home buyers' tax credit – The amount used to calculate the <u>first-time home buyers'tax credit</u> has increased to \$10,000 for a qualifying home purchased after December 31, 2021.

Home accessibility tax credit – For 2022 and later tax years, the annual expense limit of the <u>home accessibility tax credit</u> has increased to \$20,000.

Disability tax credit – For 2021 and later tax years, an individual diagnosed with type 1 diabetes is considered to have met the two times and 14 hours per week requirements for life-sustaining therapy. For more information, go to <u>Disability tax credit</u>.

You may be eligible for other benefits and credits. You can find more information on our <u>Tax credits and benefits for individuals</u> page.

ServiceOntario improvements saving people time and money

TORONTO — The Ontario government is making it faster, easier and more convenient for people and businesses to access driver's licences, health cards, birth certificates and other services.

An enhanced appointment booking system at ServiceOntario is now available at 64 of its busiest centres. Customers requiring in-person visits can book multiple services in a single appointment on their smartphone or computer or book a single appointment for the whole family. Ontarians will also have the option to identify accessibility needs ahead of the appointment so services can be provided to meet their individual needs efficiently and effectively.

"We're making it easier for people and businesses to connect with ServiceOntario, putting customers first and saving people time and money," said Premier Doug Ford. "Across our government, we're making it less complicated and more convenient for people to interact with government. We'll never stop working to improve the services we offer people."

ServiceOntario is also enhancing the customer experience through a number of pilot programs including virtual services. Eligible Ontarians who may find it difficult to visit a ServiceOntario centre in person can <u>book virtual appointments</u> to have their health cards renewed through live video calls. For those phoning the Contact Centre, new technology is rolling out to cut down the time callers spend on the line with quicker interactive responses or call-backs.

"Our government continues to modernize the way we deliver services, using data and technology to design programs that put customers first," said Kaleed Rasheed, Minister of Public and Business Service Delivery. "Ontarians are already benefiting from our improved services that are easy-to-use, more accessible and digitally enabled. They can choose to access services in person, by phone, or online – taking advantage of more than 55 online services available anywhere, anytime, any day." New online services are being added regularly and these include renewal of health cards, licence plates and other government identification and permits. Convenient renewal reminders by email, text or phone call help Ontarians keep their important documents up to date. Almost all transactions related to <u>Accessible Parking Permits</u> are online.

As part of the work to provide customers with more online delivery options, in the coming months, soon-to-be-married couples can apply for a marriage licence online through a new secure portal in participating municipalities. As well, by spring, digital dealership registration — providing on-site registration of vehicle purchases at dealerships — will be expanding to trade-ins and used cars.

Now more than ever, Ontarians expect improved, consistent and safe services designed for them by their government. Ontario will continue to deliver simpler, faster and better services to hard-working Ontarians.

Ontario Preparing People and Communities for Future Emergencies

First-ever action plan will support quick response to natural disasters and other emergencies

TORONTO — Today, the Ontario government released its first-ever <u>Provincial</u> <u>Emergency Management Strategy and Action Plan</u>, helping to ensure Ontarians are prepared for and safe during future emergencies like cyber security threats, pandemics or natural disasters.

The plan, the first of its kind in Canada, sets a foundation for emergency management in Ontario and builds on lessons learned from past emergencies including the COVID-19 pandemic, which represented the single largest provincial emergency in decades.

"With an increase in wildfires, floods, and other potential emergencies that threaten the safety of Ontario's communities, it's vitally important that we have a plan in place to respond to crises quickly, efficiently and in close coordination with partners on the ground," said Prabmeet Sarkaria, President of the Treasury Board and Minister responsible for Emergency Management in Ontario. "This strategic and action-oriented plan outlines a comprehensive vision for all of Ontario to be safe, practiced, and prepared at all times. Our commitment to communities across the province is to ensure we are as emergency ready and resilient as possible both now and into the future."

Developed in partnership with emergency management partners, including municipalities, First Nations partners and provincial ministries, the plan highlights key actions the province is taking to keep Ontario in a state of constant readiness and preparedness. It also outlines initiatives to augment and support municipal and First Nations emergency strategies.

Highlights of the plan include the following:

- A strengthened provincial governance and accountability framework that includes Emergency Management Ontario as the provincial lead for emergency management coordination.
- A one window for all Ontarians approach to proactively coordinate with emergency management partners on preparedness and information sharing.
- Increased local supports for municipalities and Indigenous partners, including a doubling of regional field services staff, in 2022, to better support all regions of the province.
- Proactive planning and monitoring, including enhanced flood mapping, a cyber security strategy, and increased resources for emergency management partners.
- Programs to improve community preparedness, including tabletop and priority exercises and a strengthened Ontario Corps.
- A commitment to annual reports detailing the progress made on the strategy and action plan.

The plan will be further strengthened through ongoing engagement with partners to ensure Ontarians are prepared for future emergencies.

Quick Facts

- In 2022, 58 community and provincial emergencies were declared in Ontario and more than 1,900 members from four First Nations communities in Ontario were evacuated due to the threat of floods.
- To support Ontario's 444 municipalities and 133 First Nations communities, of which over 30 are remote fly-in communities, there were over 4,000 enrollments in emergency management training courses in the province, with over 300 courses run in 2022.
- In 2022, the Ontario Corps transferred from the Ministry of Citizenship and Multiculturalism to Treasury Board Secretariat. The program registers, screens and trains volunteers so Ontario is better prepared to mobilize volunteers and safely respond to emergencies, from public health crises to natural disasters.
 Plans are underway to strengthen the support available to communities by leveraging the existing capacity and expertise of partners to ensure predictable volunteer and specialized technical capacity is available to support communities.

- In 2022, Emergency Management Ontario participated in 35 emergency exercises and drills to test emergency plans and procedures. This includes participating in Exercise Huron Endeavour in October 2022 which tested Ontario's nuclear emergency response plans, alongside Bruce Power, municipalities, 40 agencies and 1,400 participants.
- The Provincial Emergency Management Strategy and Action Plan builds on the government's <u>A Plan to Stay Open</u> to protect the safety of Ontarians.

TORONTO — The Ontario government has taken another step to improve policing in the province by appointing Ryan Teschner as the new Inspector General of Policing. Mr. Teschner is an experienced leader in community safety, police governance and public administration. He will be responsible for the Inspectorate of Policing, an independent organization to monitor police and police board performance as well as promote improvements to public safety.

"I am delighted to welcome Mr. Teschner as Ontario's Inspector General of Policing – the first and only role of its kind in Canada," said Solicitor General Michael Kerzner. "He is a nationally recognized expert who has worked throughout his career to help enhance public safety, modernize police governance and oversight, and build public trust."

Mr. Teschner begins his new position on March 27, 2023. Ken Weatherill, who has been serving in the role on an interim basis, will continue to serve as the Deputy Inspector General.

Ontario Strengthening Supports for Survivors of Violence and their Children

\$6.5 million investment helping women and children access services they need to be safe and supported in their communities

February 07, 2023

<u>Children, Community and Social Services</u> <u>Women's Social and Economic Opportunity</u>

TORONTO, ON — The Ontario government is investing up to \$6.5 million to help women and children who have experienced violence and are survivors of human trafficking access the supports and services they need to stay safe and rebuild their lives. This funding will also help children and youth get the early intervention supports they need to heal from the harmful effects of experiencing and witnessing violence.

"Our government is breaking down barriers so women who have experienced violence can receive the help they need no matter where they are in the province," said Charmaine Williams, Associate Minister of Women's Social and Economic Opportunity. "This investment will ensure women and children have access to timely and effective care, whether they live in a rural community or are concerned about the care their children will receive once they arrive at a shelter."

The \$6.5 million investment includes:

• Up to \$3.6 million for frontline agencies in rural and remote communities to strengthen culturally responsive supports for Indigenous women and reduce

barriers for survivors of violence and human trafficking – for example, by providing transportation to and from counselling and legal appointments.

• Up to \$2.9 million to increase access to stable and ongoing prevention and early intervention supports for children and youth entering a shelter who have been exposed to violence. These supports are delivered by frontline service providers, such as child and youth workers, early childhood educators, and culturally specific service providers.

"Our government feels strongly that women and children who are victims of violence and human trafficking must be supported and feel safe in their communities. We are investing in culturally relevant support services that will help address trauma and enhance the healing process," said Greg Rickford, Minister of Indigenous Affairs and Northern Development. "By expanding funding, we are removing barriers and improving access to meaningful supports in northern, rural and remote communities."

Ontario is working to prevent and address violence against women in all forms, including human trafficking. This \$6.5 million additional investment will help ensure survivors and their children have the foundation they need to stay safe and begin their healing process. This funding builds on Ontario's ongoing investments in prevention initiatives, community services and supports for women and children who have experienced violence, as well as survivors of human trafficking.

Quick Facts

- Arrival at emergency shelters presents a critical point at which to intervene with children and youth exposed to violence. For many children and youth, shelters are a highly stressful transition environment, and they require child-appropriate trauma-informed supports to confront the difficulties they are experiencing.
- <u>Ontario's Anti-Human Trafficking Strategy</u> represents the largest total investment dedicated to anti-human trafficking supports and services in Canada.

Ontario Connecting More People to Care at Home

Investments are helping more people connect to care at home and in the community

February 08, 2023

TORONTO — As part of <u>Your Health: A Plan for Connected and Convenient Care</u>, Ontario is connecting people to convenient care at home and in their community so more Ontarians can choose to stay in their homes for longer as they age or are able to receive care closer to home. Delivering convenient care at home provides a better experience for people and frees up more space in hospitals, long-term care homes and doctors' offices.

"The only thing better than having care close to home is having care in your own home," said Sylvia Jones, Deputy Premier and Minister of Health. "We've heard loud and clear that you and your family want better and faster access to home care services and our investments will provide you more choice to connect to convenient care in your own home and in your community, instead of in a hospital or long-term care home."

Last year, the government invested \$1 billion to expand the delivery of home and community care services to help more people connect to the care they need in the comfort of their own home. From more caregiver supports and respite services, bereavement and behavioural programs to assisted living services for people with brain injuries, work is underway to provide faster and more convenient access to the care they need.

The province is also working with Ontario Health Teams and home and community care providers to create new and innovative programs for people wanting to connect to care at home, including more virtual care options and connecting home care services with other care providers such as a family doctor to ensure personal medical records follow people as they move between care providers. These investments will help nearly 700,000 families who rely on home care annually to connect to care more conveniently.

With the help of paramedics, those living with chronic health conditions can now live at home more independently and avoid regular visits to the hospital waiting room. Ontario's expanded community paramedicine program is already in place in 55 communities and has connected more than 30,000 people to 24/7 non-emergency support at home. The initiative allows paramedics to use their training and expertise to provide home visits for a range of services, including making sure medication is taken as prescribed, educating people on how to properly manage their chronic conditions and providing assessments and referrals to local community care services, such as home care.

Ontario is also expanding palliative care services by adding 23 new hospice beds to the 500 beds already available across the province to connect Ontarians with comfortable and dignified end-of-life care near their communities and loved ones. Ensuring Ontarians have a choice about where they spend their final days is an important part of ensuring Ontarians can connect to the care they need throughout their entire life.

With <u>Your Health: A Plan for Connected and Convenient Care</u>, the province is making it easier for people and their families to connect to the care they need, whether that's by expanding access to services in their home or community or giving them the choice to book or take an appointment virtually, to ensure hospital and long-term beds are available when it is needed most.

Ontario Protecting Walleye from Illegal Angling

February 10, 2023 Natural Resources and Forestry

The Ontario government is safeguarding walleye from illegal fishing practices by ensuring anglers are only keeping fish of a legal size.

Sylvester Gutkowski of Winnipeg, Manitoba pleaded guilty to possessing fish of a prohibited size. He was fined \$2,700 and was also suspended from fishing in Ontario for one year.

James Morrissette and Lorrie Morrissette both of Winnipeg, Manitoba pleaded guilty to fishing without a licence. Each was fined \$200.

The court heard that on evening of September 3, 2022, conservation officers were conducting a patrol of Caribou Falls north of Kenora and observed a group of people camping. During the contact it was determined that the group had been angling on the Winnipeg River and Gutkowski had nine illegally sized walleye. Both James and Lorrie Morrissette had been angling and neither had a valid licence.

Justice of the Peace Daphne Armstrong heard the case in the Ontario Court of Justice, Kenora, on December 6, 2022.

Ontario Connecting Youth Leaving Care with Supports to Succeed

New program focusing on life skills and post-secondary education, training and employment

February 15, 2023

Children, Community and Social Services

OTTAWA — The Ontario government is investing \$68 million in a new program that connects youth in the child welfare system with additional services and supports they need to prepare for and succeed after leaving care. The Ready, Set, Go program, launching on April 1, 2023, will provide youth transitioning out of care with life skills and supports they need to pursue post secondary education, skilled trades training and employment opportunities.

"Children and youth in the child welfare system face additional barriers throughout their lives," said Dr. Merrilee Fullerton, Minister of Children, Community and Social Services. "Our government is enhancing the way youth leaving care are supported so they can access the same opportunities as their peers. The Ready, Set, Go program will help youth get the skills they need to build a brighter future for themselves."

Under the new program, children's aid societies will begin focusing on helping children plan for the future at an earlier age. Starting at age 13, they will begin learning practical life skills and planning educational goals. At age 15, the emphasis will expand to financial literacy and preparing for the workforce, including managing personal finances, setting up a bank account, grocery shopping, resumé

building, and how to access social services and other supports.

The Ready, Set, Go program will also allow youth to remain in care until the age of 23, up from age 21. Monthly financial support will also increase to provide youth better quality of life and safer housing opportunities so they can focus on their studies or working.

Funding is increasing from \$850 per month to:

• Age 18 - \$1,800

- Age 19 \$1,500
- Age 20 \$1,000

Youth who will remain in care at age 21 will now receive \$1,000 per month. Youth in care at age 22 will receive \$500 per month. Youth will also be able to work up to 40 hours per week at Ontario's minimum wage without affecting their financial supports. Those pursuing a post-secondary program or training in skilled trades and apprenticeships, will receive an additional \$500 per month starting at age 20.

The Ready, Set, Go program was developed with input and advice from former youth in care, child welfare advocates, partners and is informed by research. These changes are part of <u>Ontario's plan to transform the child welfare system</u> and hold children's aid societies accountable to better prepare youth leaving care.

Quick Facts

- The ministry is seeking further feedback and advice from sector partners and the public on the new Ready, Set, Go program through a posting on <u>Ontario's</u> <u>Regulatory Registry</u>. The regulatory posting will be open until March 1, 2023.
- About 12,000 children and youth are in the care of children's aid societies in Ontario.
- Children and youth leaving the child welfare system are more likely to experience a range of negative outcomes, such as homelessness, mental health concerns, unemployment, lack of education and involvement in the justice system.
- Currently, youth transitioning from care are provided with financial and nonfinancial supports up to their 21st birthday through the Continued Care and Support for Youth program. Youth leaving care also have access to the Youth-in-Transition Workers program, the Aftercare Benefits Initiative, the Postsecondary Application Fee Reimbursement program and the Living and Learning Grant.
- While Ontario has been developing the new youth leaving care policy and program, the province has extended a moratorium on youth aging out of their

care arrangements with children's aid societies to March 31, 2023.

Ontario Releases 2022-23 Third Quarter Finances

Latest fiscal update demonstrates Ontario's economy remains resilient amid global challenges

February 15, 2023 <u>Finance</u>

TORONTO — Today, the government released the <u>2022-23 Third Quarter Finances</u>, to provide an update on Ontario's economic and fiscal outlook since the release of the 2022 Ontario Economic Outlook and Fiscal Review.

Overall, the report shows that despite global geopolitical conflict, high inflation, rising interest rates and ongoing supply chain challenges, Ontario's economy continues to be resilient, with real gross domestic product (GDP) estimated to have increased by 3.7 per cent in calendar year 2022.

"While today's update is positive, Ontario and the rest of the world continue to face ongoing economic and geopolitical uncertainty," said Peter Bethlenfalvy, Minister of Finance. "Though the road ahead may not be easy, our government's *Plan to Build* is a responsible and prudent approach to getting Ontario through the challenges of today while planning for tomorrow."

The 2022-23 Third Quarter Finances show the government is projecting a deficit of \$6.5 billion in 2022-23, an improvement of \$6.4 billion compared to the Province's last published fiscal update. Revenues in 2022–23 are projected to be \$9.6 billion higher than forecast, mainly reflecting stronger than expected taxation revenues as a result of higher net tax assessments for 2021 and prior years, based on new information from the Canada Devenue Agency (CDA) received since the 2022

information from the Canada Revenue Agency (CRA) received since the 2022

Ontario Economic Outlook and Fiscal Review. Ontario, similar to other provinces, incorporates updated information received from the CRA in its regular financial updates.

Overall program expense in 2022–23 is projected to be \$188.6 billion, \$3.4 billion higher than forecast in both the *2022 Budget* and the *2022 Ontario Economic Outlook and Fiscal Review*. Increases in program expense are primarily due to significant one-time costs associated with ongoing land and land-related claims with Indigenous communities where Ontario is in active negotiations, claims are accepted for negotiation or are under review. This additional spending has been partially offset by existing contingences within the fiscal plan, and savings.

"Our government is taking a targeted approach to deliver on our *Plan to Build* while laying a strong fiscal foundation for the province's future generations," said Minister Bethlenfalvy. "We will continue to be transparent with the people of Ontario by providing regular updates on the province's economic and fiscal situation."

The government plans to provide its next update as part of the *2023 Budget* on or before March 31, 2023.

Quick Facts

- Other program expense increases since the release of the 2022 Ontario Economic Outlook and Fiscal Review include spending related to reopening of colleges following the easing of public health restrictions and resulting additional on-campus activity, the government's commitment to support the City of Toronto to address a portion of its 2022 operating deficit with up to onethird of the city's projected COVID-19 pressures, and additional funding for prevention and containment of COVID-19 at long-term care homes. These expenses have been partially offset by additional third-party revenues from colleges, savings and the drawdown of existing contingencies within the fiscal plan.
- Interest on debt expense is projected to \$13.4 billion, slightly lower than the \$13.5 billion forecast in the 2022 Budget and approximately \$0.2 billion lower than the \$13.6 billion projection in the 2022 Ontario Economic Outlook and Fiscal Review. Due to rising interest rates, Ontario's cost of borrowing has, however, increased to 4.0 per cent, which is higher than the 3.4 per cent forecast in the 2022 Budget but lower than the 4.2 per cent forecast in the 2022 Ontario Economic Outlook and Fiscal Review.

The hospitality, generosity and volunteer spirit of Renfrew County residents were on full display during the past two weeks, as the County of Renfrew hosted thousands of participants and visitors to the 2023 Ontario Winter Games.

Eight days of fierce competition in 22 sports over two weekends wrapped up February 12 as athletes demonstrated sportsmanship, skill and resilience throughout the Games and went home with memories that will last a lifetime.

Highlights of the second weekend of competition included Chadd Stoppa, 15, of Barry's Bay contributing to the offence in a number of games during the weekend helping his team to win a bronze medal in sledge hockey with the Niagara Thunderbolts. Down the road in Arnprior, hometown hero Madelyn Cazabon, just 10 years old, finished eighth in the Wushu competition. Over the three days, Cazabon completed 10 different challenges and finished with a huge smile on her face as she beamed with pride for her accomplishments.

Through these Games, two venues – Ma-te-Way Park in Renfrew and the Calabogie Highlands Golf Club – hosted major winter events for the first time as trails were groomed for cross-country and para cross-country skiing and a biathlon course was created at the respective venues. AMO Focuses on Housing and Homelessness in Pre-Budget Advice to Ontario Legislature

February 13, 2023

Increasing the supply of housing and tackling the homelessness crisis in Ontario, brought on by decades of failed provincial social and economic policies, are the top priorities for municipalities across Ontario. That was the message from the Association of Municipalities of Ontario presenting its <u>2023 Pre-Budget</u> <u>Submission</u> to the Standing Committee on Finance and Economic Affairs.

Increasing the supply of housing is a priority for municipalities across Ontario. AMO repeated concerns that the *More Homes Built Faster Act 2022* (formerly Bill 23) may undermine this goal because it is based on false assumptions.

"The provincial government's belief that the housing supply crisis can be solved by limiting municipal access to infrastructure financing, eliminating environmental protections or changes to municipal governance is unsound," said AMO President Colin Best. "Unless the costs of Bill 23 are fully offset by the province, it will cost Ontario property taxpayers \$1 billion a year."

The submission calls on the government for collaboration with the municipal sector, clarity about the province's commitment to offset the cost impacts of the legislation on property taxpayers and a commitment to reverse legislative measures that are creating unintended consequences.

AMO's submission also illustrates that the Government of Ontario's per capita spending on programming is the lowest in Canada at \$2,000 less per person than the national average. It states the homelessness crisis in Ontario is a direct result of decades of provincial underinvestment in areas such as affordable housing, community mental health and income assistance programs.

"This is a made-in-Ontario crisis resulting from provincial underinvestment and poor policy choices made by the government of Ontario," Best said. "The Government of Ontario has the tools and resources to end the homelessness crisis it has created over decades. It must surely possess the leadership, capability and political will to get the job done."

AMO's submission calls for the Ontario Government to commit to ending homelessness:

- Increase the supply of deeply affordable housing through a variety of approaches from rent subsidies to property acquisitions.
- Increase financial assistance to individuals and families and fulfill the government's promise to transform its social assistance system.
- Invest in health services, community-based mental health services, supportive housing and addictions services.

Ontario's homelessness crisis is apparent and in every part of the province, including big cities and small towns, and in rural and northern communities.

Overdose Alert for Renfrew County and District

Further to the Overdose Alert that was issued on January 02, 2023, Renfrew County and District Health Unit (RCDHU) and local Ontario Provincial Police (OPP) are alerting residents about a small cluster of suspected overdose-related deaths that have occurred over the last week in Renfrew County and District.

Although specific substance(s) related to the overdoses have not been confirmed, it is important to remember *that all* street drugs must be considered highly toxic and potentially fatal.

Friends, family members and individuals who use street drugs can work together to reduce the risk of an overdose by putting the following measures in place:

- Don't use alone If you overdose and are with someone, they can get urgent help.
- **Carry naloxone (Narcan®)** Naloxone can temporarily reverse an opioid overdose and kits are available for free throughout RCD at local pharmacies and other locations. For more information on where to get a kit please visit <u>this link</u>.
- **Don't mix drugs** Don't mix drugs with other drugs or alcohol, as it puts you at higher risk of overdosing.
- **Go slow** Quality of street drugs is unpredictable. If you are using street drugs, start by using in small amounts (testers or test doses) to check the strength of what you are using.
- **Know your tolerance** Risk of overdose increases if you are a new user or have not used in 3 or more days.
- If you have no other choice than to use alone, always call the Overdose Prevention Hotline 1-888-688-6677 (National Overdose Response Service) to have someone standing by to call for help if needed. A volunteer will check in periodically and call 911 if there's no response.

Understanding the signs of an overdose can help to save a life. These signs can include, but are not limited to:

• Person can't be woken up.

- Breathing is slow or has stopped.
- Snoring or gurgling sounds.
- Fingernails and lips turn blue or purple.
- Pupils are tiny or eyes are rolled back.
- Body is limp.

All overdoses are a medical emergency and calling 911 is an important step in saving someone's life.

We ask that people who are aware of overdoses assist us by completing RCDHU's anonymous online <u>Overdose Reporting Form</u>, which is used to support tracking overdoses within the community. The Overdose Reporting Form does not ask for any identifying information and can be completed directly on RCDHU's website.

Support is available; the <u>Renfrew County Addiction Treatment System</u> delivers assessment, counselling and treatment programs to individuals who use substances.

At the Council meeting held on January 31, 2023, the Council of the Municipality of Shuniah passed the attached resolution # 45-23 supporting the Town of Cobourg (Resolution 406-22) and the Municipality of Greenstone (resolution 22-396) regarding Bill 3 and further opposing the changes that Bill 3 makes to the Municipal Act, 2001 and Municipal Conflict of Interest Act.
