1. Call to Order

Mayor Lisa McGee called the Regular Council Meeting to order at 6:30 PM and welcomed those present.

Stacy Howard, Stacey Mullins-Campbell and Katie Cox, representatives from the Arnprior Agricultural Society provided an overview presentation on their organization's work, the Valley Agricultural Festival, and the importance of farming in the local community. Howard noted the Agricultural Society wishes to work with the Town on their next mission "The Farm Comes to Town". The free event, ideally at the Nick Smith Centre, will introduce students to where their food comes from, showcase how farming benefits the community, and the environment, supports local farmers, and will include games, entertainment, farm animals and machinery. Following a question and answer period the Agricultural Society was advised to further consult with the Recreation Director and submit a grant application for consideration of Council.

Resolution Number 104-23 Moved by Chris Couper Seconded by Lynn Grinstead Whereas the Renfrew County Virtual Triage and Assessment Centre (RCVTAC) has been operating since March 2020 providing residents of the County of Renfrew with an invaluable medical response option for our residents, many of whom are without a regular primary care physician; and

Whereas RCVTAC has provided over 73,000 family physician virtual assessments, over 69,000 paramedic onsite assessments and over 55,000 paramedic home visits since its inception; and

Whereas every month, RCVTAC currently handles 5,000 calls, 3,000 assessments and 1,000 avoidable emergency department visits; and

Whereas RCVTAC provides an effective and efficient medical care option that helps to relieve stress on our local emergency departments; and

Whereas 86% of RCVTAC users have reported that their health care concern was dealt with at their first virtual encounter and 93% of RCVTAC users have reported being happy or very happy with the service; and

Whereas funding from the Government of Ontario for RCVTAC is scheduled to conclude in March 2023;

Now Therefore Be It Resolved That the Council of the Corporation of the Town of Arnprior resolves as follows:

- 1. That the Town of Arnprior fully and strongly supports the Renfrew County Virtual Triage and Assessment Centre (RCVTAC) as a valuable, innovative proven model for the delivery of certain non-emergent health care needs as one part of our overall health care system;
- That the Town of Arnprior strongly calls upon the Government of Ontario to continue funding the Renfrew County Virtual Triage and Assessment Centre (RCVTAC) at current funding levels, as a permanent health care option for residents across the County of Renfrew; and
- 3. That a copy of this resolution be forwarded to Sylvia Jones, Deputy Premier and Minister of Health; John Yakabuski, MPP for Renfrew-Nipissing-Pembroke; and Peter Emon, Warden of the County of Renfrew.

13. Council Committee Reports and Minutes

a) Mayors Report

Mayor McGee reported on the following:

- Meeting with Lions Club Members regarding an exciting fundraiser project they will propose at a future meeting of Council. Of interest post, COVID Lions Club Membership swelled to 32.
- Presented at the Mayor's Breakfast on March 9th Great to hear from Mayor Mackenzie from McNab/Braeside and Leah Levesque from Arnprior Regional Health. Thanks to the Greater Arnprior Chamber of Commerce for organizing the annual event and the Legion for hosting breakfast.
- March 17th Council and staff spent a full day in a facilitated discussion on strategic planning.
- Attended three information sessions with Ontario Power Generation, the Madawaska River, and the Upper and Lower Ottawa River, followed by two tours including Chenaux Dam and the Arnprior Generating Station. These were great learning opportunities, especially in advance of the spring freshet.
- On March 19, the Disco Bus came to Town, a collaboration between private and small businesses.
- Attended a recent meeting with Darrel O'Shaughnessy and discussed his latest energy and efforts with the Men's Shed, SALC, and Affordable Housing.
- Attended a meeting with Dana at the SALC to discuss programming and space challenges. The timing was perfect, as a class was in session with regards to computer training, an initiative of the Arnprior Public Library.
- Recent get-to-know one another dinner with McNab/Braeside Deputy Mayor Hoddinott.
- Attended a meeting with Eastern Ontario Bell Executives to discuss plans for the rural high-speed roll out.

b) County Councillors Report

County Councillor Lynch reported the following from Renfrew County Council:

- On March 24 at the Renfrew Paramedic Base, Renfrew-Nipissing-Pembroke MPP John Yakabuski announced an investment of \$3.2 million in 2023-34 from the provincial government for the Renfrew County Virtual Triage and Assessment Centre (RCVTAC) to ensure residents have access to healthcare services close to home.
- Resolutions to tabled at the March 28, County Council Meeting include:
 - Reeve Glenn Doncaster as the Renfrew County Representative at Federation of Canadian Municipalities better known as FCM.

 As discussed at the Eastern Ontario Warden Caucus meeting a motion to endorse the "7 in 7" Regional Housing Plan was carried. This plan will deliver 7,000 new affordable community rental units over 7 years, in addition to incentivizing an additional 21,000 attainable market rate units from the private and non-profit sectors for a total of 28,000 housing units. At present Renfrew County has needs for 1,369 units.

c) Committee Reports and Minutes

- Councillor Couper noted the following from the Arnprior Public Library Board Meetings in February and March:
 - Josie Scott was elected Chair and Shane Kramer was elected Vice Chair of the Library Board.
 - The Board received an expansion update on the new library programming space currently under construction.
 - The Library will be hosting 150 people at the Little Branches Rural Roots Library Conference May 4, 5, 6 at the Amprior Public Library. Kudos to the Chief Librarian and staff for organizing.
 - The Board was informed that their grant was approved by the Town of Arnprior, and expressed their thanks to Council.
 - The Library ran successful March break programming, fully funded by the generous contribution of the Scharf Family Charitable Trust.
 - At future strategic planning sessions there may be opportunities to talk about types of programming being offered, including more familyoriented programs.
 - As previously mentioned the Library partnered with SALC to offer computer training for seniors. The Library purchased eight chrome books and eight Wi-Fi hot spots through grant funding. The equipment will be hosted at the Library and available for loan.
 - CEO investigated guidelines on the community fridge project, the only drawback being there was only funding available for the fridge. The grant opportunity was not pursued at this time.
 - Library bridge club is making a weekly donation in support of youth in need at the high school, and has collected over \$1000 to date.
 - The Library continues to offers a full range of programming, including chess club, Lego lounge, mah-jong, knitting, English as a second language book club. The photography of Tracy Jeror is currently displayed in the art corridor.
 - The CEO is gathering quotes for strategic plan process that will set the goals of the library for the next couple of years. Costs are anticipated to be paid thanks to the support of the Neuman bequest. The Library Board will be establishing a public input process into the strategic plan process.
 - Chair Josie Scott floated the idea of a volunteer portal through the library website. Opportunities where an organization looking for volunteers to go when needing assistance at specific events.
 - Galilee Centre is holding a family games night to support the library, a pasta dinner and scrabble tournament in support of the Library.

- Councillor Toner noted his attendance at the Arnprior McNab Braeside Archives Meeting on March 23rd highlighting:
 - His privilege to participate in his first AMBA board meeting, meet the dedicated group who make up the AMBA Board and acknowledge the commitment and contributions of his predecessor, Ted Strike.
 - Highlights of the evening included: the need for IT support, preferably a volunteer, who can assist the AMBA when needed, opportunities to get involved in more community outreach activities through in-person events and social media, the planning going into the AGM and Archives in Your Attic, an event to celebrate the AMBA 30th anniversary in 2023.
 - The AGM and the Archives in Your Attic are scheduled for April 15th at the Arnprior Public Library.
 - o 2023 is also the start of the 200th Anniversary of McNab Township
- Councillor Toner noted his attendance at the Arnprior and District Museum Meeting of March 14th, highlighting:
 - Many exciting changes and initiatives, including new programming for adults with disabilities, newly developed sensory kits, are now complete and outreach to organizations for museum tours has begun.
 - There are scheduled Saturday theatre workshops for young people, starting after Easter, with Ottawa Valley Theatre Kids.
 - An after-school Learn to Sew program is underway and registration has begun, special thank you to the Opportunity Shop and their volunteers for helping with this programming initiative.
 - The Osborne Store exhibit is being revamped and the museum meeting room is getting a make over to create a more user/rental friendly space.
 - Staffing requirements are nearly complete for the three Digitization Project positions as well as the three summer student positions for the full day summer camps under the title: Museum Experimentation Station.
- County Councillor Lynch noted the Committee of Adjustment/Property Standards Committee met on March 9, 2023 to consider three minor variances dealing with the property known as 375 Daniel Street South (Canadian Tire). The adjustments included the following:
 - To permit a drive-through stacking lane within 0.5 m of the side lot line where the zoning does not permit a drive-through stacking lane within the minimum required 3 m side yard setback;
 - To permit a drive-through stacking lane within 1.61 m of the front lot line where the zoning does not permit a drive-through stacking lane within the minimum required 6 m front yard setback;
 - To permit a reduction in the minimum distance between a front lot line and a drive-through service facility component, including wall openings and order boxes, from 10.0 m to 7.25 m which were all approved.

Request for Support – AMO Ending Homelessness in the 2023 Provincial Budget

Resolution Number 113-23 Moved by Chris Couper Seconded by Chris Toner

Whereas the homeless crisis is taking a devastating toll on families and communities, undermining a healthy and prosperous Ontario;

Whereas the homelessness crisis is the result of the underinvestment and poor policy choices of successive provincial governments;

Whereas homelessness requires a range of housing, social service and health solutions from government;

Whereas homelessness is felt most at the level of local government and the residents that they serve;

Whereas municipalities and District Social Administration Boards are doing their part, but do not have the resources, capacity or tools to address this complex challenge;

Whereas leadership and urgent action is needed from the provincial government on an emergency basis to develop, resource, and implement a comprehensive plan to prevent, reduce and ultimately end homelessness in Ontario;

Therefore Be It Resolved That the Council of the Corporation of the Town of Arnprior calls on the Provincial Government to urgently:

- a) Acknowledge that homelessness in Ontario is a social, economic, and health crisis;
- b) Commit to ending homelessness in Ontario;
- c) Work with AMO and a broad range of community, health, Indigenous and economic partner

Further That a copy of this motion be sent to the Minister of Municipal Affairs and Housing; the Minister of Children, Community and Social Services; the Minister of Health; the Association of Municipalities of Ontario and all local municipalities within the County of Renfrew.
