Ontario Launches Plan to Boost Math, Writing and Reading Skills

New initiatives will raise standards, ensure consistency and focus students' time in the classroom on building life, job and critical thinking skills

April 16, 2023 Education

TORONTO — The Ontario government is investing more than \$180 million in targeted supports in the classroom and at home to help students build the math and reading skills and knowledge they need to succeed in the workforce. This investment will support nearly 1000 more educators to help students develop these important skills.

"We are getting back to the basics, because that's what matters most when it comes to students' skills with reading, writing and math," said Stephen Lecce, Minister of Education. "I am proud to unveil Ontario's plan to boost literacy and math skills, designed to deliver better schools, jobs and outcomes for students. This plan will up our game and send a signal across the province: we will do better to improve the skills that actually matter to the success of your child, from the classroom to the workforce. Ontario's plan will help ensure students graduate with a competitive advantage that will lead them to a good-paying job, a home and a life of opportunity."

Ontario is investing more than \$71 million in 2023-24 in a new math plan, supported by the recently introduced modernized math curriculum that mandates financial literacy and coding in every grade.

The province's plan to boost math skills will:

- Support more than 300 educators to support student learning in math
- Double the number of school math coaches in classrooms to provide direct support to teachers and students
- Introduce one math lead per board to spearhead math curriculum implementation and standardize training, and provide additional supports for math coaches in the classrooms

- Expand access to digital math tools that students and parents can access anytime
- Continue live teacher-led virtual tutoring services focused on math
- Enhance skills of new teachers through dedicated training and covering costs of additional math qualification courses to enhance math fluency and competency.

To further support students facing challenges with math, the government is deploying Math Action Teams to school boards or schools to raise standards, training and student outcomes. Teams will work with school boards to identify and recommend targeted, evidence-based responses to improve math achievement for Ontario students.

To help more young students build stronger reading skills, the province is investing \$109 million in 2023-24 to boost literacy rates, which will:

- Introduce new, Canada-leading, early reading screening requirements for all students in Year 2 of Kindergarten to Grade 2, along with a standardized and fully funded screening tool and training for educators, to ensure students receive the necessary foundational skills and early interventions in reading that are critical to future success
- Fund additional specialist teachers who can work one-on-one or in small groups to help students who need additional support in reading
- Invest in almost 700 educators to support development and excellence in literacy for Ontario students
- Introduce an overhauled language curriculum in September of 2023 with an emphasis on ensuring students at an early age can master basic literacy.

"This investment is an investment in our kids' futures. Supporting them to develop strong, life-long skills in important areas like reading, writing and math will set our kids up for success in the long run," said Patrice Barnes, Parliamentary Assistant to the Minister of Education. "I am proud this government is providing our kids with the opportunity to achieve success today, tomorrow and in the jobs of the future."

These initiatives complement previous actions including a revamped math curriculum introduced in 2020 which goes back to the basics; de-streaming of Grade 9 math and science; the restoration of merit-based hiring of educators and a one-of-a-kind, publicly funded tutoring program designed to empower students with proven learning strategies and techniques.

- <u>Beginning with the Grade 9 cohort starting in September 2024, all students will</u> <u>now be required to earn a Grade 9 or 10 Technological Education credit as part</u> <u>of their Ontario Secondary School Diploma</u>.
- <u>Ontario's government is taking new steps to support students understand</u> <u>financial literacy</u>.
- Ontario is <u>expanding Dual Credit opportunities for health care related courses</u>, <u>ensuring Ontario's students have the skills they need to fill high-paying</u>, in-<u>demand jobs</u>.
- In November 2022, <u>Ontario announced the expansion of the Dual Credit</u> program to help more secondary students participate in apprenticeship training.
- Ontario has recently helped families pay for learning supports for over 1.4 million Ontario students through Catch Up Payments to fill gaps that may have emerged because of COVID-19.
- In December 2022, <u>Ontario announced the modernization of the Computer</u> <u>Studies and Technological Education curriculum to ensure students are</u> <u>prepared for the jobs of the future</u>.

Province Improving Accountability and Transparency in Ontario Schools

Proposed legislation will help deliver better schools, jobs and outcomes for students

April 17, 2023 Education

TORONTO – Today, the Ontario government introduced *The Better Schools and Student Outcomes Act,* which would, if passed, ensure the province's public education system focuses on what matters most: important life-long skills, like reading, writing and math. The act would also ensure accountability and transparency for parents and families.

"We are taking action to refocus Ontario's education system on what really matters: strengthening reading, writing and math skills," said Stephen Lecce, Minister of Education. "Our proposed legislation would centre the education system on preparing students to succeed in life and work, putting more highly qualified educators in the classroom while ensuring parents have the information they need at their fingertips to support their kids. These reforms would ensure students graduate with a competitive advantage while learning modern lessons in modern schools, preparing them for the jobs of the future."

If passed, *The Better Schools and Student Outcomes Act* would help students and families by:

- Improving accountability and transparency by allowing the Minister of Education to set priorities in important areas on student achievement, like reading and math, and requiring school boards to update parents on progress
- Requiring school boards to publicly post a multi-year Board Improvement Plan that reflects the minister's priorities for student achievement, creating authority to deploy personnel to support school boards when needed, along with greater

oversight over provincially funded tax dollars

- Ensuring new teachers and educators have the skills they need to teach students effectively in math, reading and literacy
- Directing school boards to increase engagement and reporting to parents on student achievement and ensuring parents have easy access to the information

they need to meaningfully engage with their children's education and success

- Building schools faster and implementing measures to utilize current school spaces, ensuring Ontario is getting more classrooms into communities who need them
- Strengthening the requirement for school boards to have a code of conduct for boards of trustees, creating a neutral dispute resolution process and authority to standardize and mandate training requirements for school board leadership
- Building on our progress to establish a leading system of student safety and educator oversight, furthering measures to expedite disciplinary decisions for educators convicted of a criminal offense
- Expanding eligibility for therapy counselling for student victims of sexual abuse through the Ontario College of Teachers
- Providing for more consistent approaches to student learning and well-being, including on student mental health
- Improving processes at the Ontario College of Teachers and College of Early Childhood Educators to enable them to operate more efficiently, including more consistent disciplinary processes.

Currently, school boards set their own education priorities, resulting in differences across the education system. For example, there are some schools consistently underperforming in EQAO data, including declining reading, writing and math scores. Moreover, it takes on average five to 10 years to build a standard school in Ontario and it can take more than 100 days to certify internationally educated teachers.

The province will work with the Ontario College of Teachers and Ontario's faculties of education to modernize teacher training and certification processes to meet the needs of students in the classrooms, including decreasing times to process applications to certify teachers.

Nearly 2,000 front-line educators will be hired, supported by overall education funding at the highest levels in Ontario history. This includes \$693 million more in base Grants for Student Needs (GSN) funding compared to the year prior, or a 2.7 per cent increase. With a focus on supporting students across the province, and building off the approximately 8,000 additional staff hired since 2018, the government will fund:

- Nearly 1,000 specialized math and literacy educators to boost skills
- Over 940 educators to support students from grades 7 to 10 with a seamless transition into high school and in de-streamed courses.

In addition, Ontario's students are supported with the highest level of per-student base funding in provincial history at \$13,125. This record-setting investment will support school boards and educators as they prepare Ontario's students with the skills they need to succeed in life. To prepare and support students in the destreaming of Grade 9, Ontario is investing in nearly 1,000 educators.

"Our mission is simple: drive continuous improvement to Ontario's education system so that we graduate the brightest, most ambitious, skilled and entrepreneurial students in the country," said Minister Lecce. "We are sending a signal across the province: we must – and we will – do better to ensure your children get a quality education that leads them to a good-paying job, home ownership and a life of opportunity."

Quick Facts

- Yesterday, Ontario introduced a <u>\$180-million reading and math strategy</u> to help students build the skills they need to succeed.
- For the 2023-24 school year, the province is providing school boards with \$1.4 billion in funding to revitalize and renew aged building systems and components.
- Ontario is launching a new student transportation funding formula in 2023-24, with an additional investment of \$111 million. The new formula is designed to be more transparent and help school boards provide more effective student transportation.

BACKGROUNDER

Improving Accountability and Transparency in Ontario Schools

April 17, 2023 Education

The government is committed to delivering a world-class education system that helps prepare students for the jobs of tomorrow.

The legislative changes proposed through *The Better Schools and Student Outcomes Act*, together with future regulatory amendments, would if passed, lay the groundwork for a truly world-class education system unified with a singular focus: to improve student outcomes in important life-long skills like reading, writing and math.

Accountability and transparency

Ontario's school boards are not consistently working toward the same priorities. School board performance varies across the province on indicators related to literacy, math, graduation and student attendance.

In addition, some parents can review and assess their school board's performance, while other boards do not proactively share this information.

In response, Ontario is taking action through proposed legislation to set student achievement priorities and expectations for Ontario's education sector. Proposed legislative and future regulatory changes, if passed, would:

• Allow the Minister of Education to set provincial priorities to focus boards in

important areas of student achievement, like reading, writing and math

- Require school boards to report on progress toward these priorities and enable the Ministry of Education to support struggling boards sooner
- Allow the minister to require school boards to make any report that the minister may require from the board available to the public
- Require enhanced school board financial reporting on funding and spending, planned and actuals
- Allow the minister to strengthen rules around financial accountability and transparency

- Allow the minister to prescribe school board limitations in participating in business activities that could place school boards in financial risk
- Allow the minister to enhance financial accountability of school boardcontrolled entities
- Promote greater school board-municipality co-operation on delivering child care
- Enable an accelerated apprenticeship pathway.

Governance and leadership

There are about 700 trustees that make critical decisions in Ontario's school boards who bring valuable perspectives and local considerations into how school boards are governed.

Directors of Education also play a vital leadership role in school boards by managing the day-to-day operations of schools, student transportation, the building of schools and oversight of thousands of teachers, education workers and administrators.

Together, school board leadership plays a critical role in ensuring Ontario's education system is focused on what is most important: life-long skills like reading, writing and math. We also know that parents and students need more tools for transparency and accountability. As such, it is imperative the individuals in these roles are trained with the knowledge to deliver high-quality public education to the students in their school boards.

However, there is currently inconsistency across the province in the support and training provided to trustees and how the performance of Directors of Education is assessed.

Proposed legislative changes, if passed, would:

- Authorize the minister to establish policies and guidelines setting out training, including the content, timing and frequency of training to be completed by trustees
- Allow the government to establish a performance appraisal process for Directors of Education.

To strengthen trustee codes of conduct and reduce disruption so trustees can focus their attention on student achievement, the proposed changes, if passed, would establish a new impartial Integrity Commissioner-led process for resolving code of conduct complaints.

Maximizing capital assets

It is more important than ever that school board capital assets are used effectively and efficiently to meet the needs of growing communities, support student learning and ensure value for taxpayer dollars.

Providing the Minister of Education with additional powers regarding school board sites would support the government's goals of ensuring modern schools are built faster, school capacity is better utilized, surplus school property is leveraged for provincial priorities, and accountability and transparency are enhanced.

Proposed legislative and future regulatory changes would:

- Establish a framework for property identified by school boards as excess property that is not needed to meet current or future pupil accommodation needs, and better leverage surplus property for provincial priorities, including affordable housing, and long-term care spaces
- Establish a framework that reduces barriers to facilitate agreements for schools in multi-use buildings to address accommodation needs in urban and high-growth areas
- Require school boards to collaborate with municipalities to better plan for schools, aligned with the government's new Provincial Planning Statement
- Enable the minister to direct school boards to utilize available classroom spaces more efficiently by operating schools in joint-use facilities
- Enable the minister to direct school boards to utilize specific design standards for capital projects, speeding up approvals and helping get new schools built faster.

Teacher training and oversight

The Ontario College of Teachers and College of Early Childhood Educators play a vital role in governing their respective professions. The government has made important advancements to ensure fair and effective disciplinary measures and is

building on this progress through proposed reforms.

There is also an opportunity to enhance how teachers are trained in Initial Teacher Education programs to ensure they have the skills and knowledge required to deliver students a world-class education which will help them succeed in the jobs and economy of tomorrow.

Proposed legislative changes, if passed, would:

• Provide clarity on membership status for teachers

- Build on our progress to establish a leading system of student safety and educator oversight, further measures to expedite disciplinary decisions for educators convicted of a criminal offense
- Expand eligibility for therapy funding to all students that have been impacted by sexual abuse by teachers through the Ontario College of Teachers
- Enable more efficient disciplinary processes.

In addition, the Ministry of Education will work with the Ontario College of Teachers to help cut in half the amount of time it takes to process an application for certification of a teacher in Ontario, ensuring we are getting the educators we need into classrooms.

Consistent information and approaches to student learning

Consistency in the classroom experience is vital to ensure that no matter where one lives, a student is getting the education they need to master important life-long skills, like reading, writing and math, while learning about mental health and getting the support they need. The same can be said for parents when it comes to knowing what is happening in their child or children's classrooms.

Proposed legislative and future regulatory changes would:

- Ensure Ontario's curriculum reflects current and future trends by authorizing the minister to issue a guide on curriculum review for greater transparency to students and families
- Enable the minister to issue binding policies and guidelines respecting student mental health
- Strengthen parent involvement by authorizing the minister to require school boards to provide parent-friendly information about their child's education, so they can have the information they need at their fingertips to support their children.

As implementation moves forward, there will be opportunities to engage with

Ontario Getting More Boots on the Ground by Making it Easier to Recruit and Train Police Officers

Free tuition and expanding enrollment for basic constable training will help address policing shortages

April 25, 2023 Office of the Premier

TORONTO — The Ontario government is making it easier for police services across the province to recruit and train more police officers by removing tuition fees for the Basic Constable Training program at the Ontario Police College (OPC) and immediately expanding the number of recruits that can be trained each year.

"Ontario is grateful to the thousands of brave women and men who serve as police officers across the province, keeping our communities safe," said Premier Doug Ford. "To push back the growing tide of crime in our communities, we're urgently getting more boots on the ground. That's why our government is making the path to becoming a police officer as open as possible, expanding enrollment at the Ontario Police College and covering 100 per cent of the tuition cost for Basic Constable Training."

To get more boots on the ground, the Basic Constable Training program at the Ontario Police College will be expanded immediately to accommodate an additional 70 recruits per cohort, from 480 to 550. Starting in 2024, the Basic Constable Training program will also be expanded to four cohorts per year instead of three. Additionally, to support recruitment efforts at a time when local police officers have signaled challenges in doing so, the province is introducing legislation that, if passed, will eliminate the post-secondary education requirement to become a police officer, as set out in the *Community Safety and Policing Act* (CSPA). If passed, the act would amend the CSPA to provide that a secondary school diploma or equivalent is sufficient education for the purposes of being appointed as a police officer.

"These changes are good news for police services across the province, as well as for Ontarians considering a career as a police officer," said Solicitor General Michael Kerzner. "We listened to the concerns about recruitment shortfalls and training limitations and have taken steps to remove barriers and expand the possibilities for those considering a career as a police officer."

Ontario's new measures compliment other recent enhancements in Basic Constable Training at the OPC. Earlier this year, the duration of the training program was expanded from 60 to 66 days to accommodate immediate rapid deployment and active attacker and mental health response training for individuals in crisis. The college's mental health response training for individuals in crisis provides police officers with the skills they need to work with on-the-ground supports such as mobile crisis response teams.

The elimination of the tuition fee for the Basic Constable Training program at the Ontario Police College will be retroactive to January 1, 2023. Recruits who paid for their twelve-week Basic Constable Training earlier this year will be reimbursed.

Quick Facts

- Under the *Police Services Act*, municipal police recruits in Ontario are required to complete the Basic Constable Training (BCT) program within six months of being hired.
- Ontario Provincial Police and Indigenous Police Services recruits also complete the BCT at the Ontario Police College.
- Legislation proposing to eliminate the post-secondary education requirement to become a police officer, as set out in the *Community Safety and Policing Act 2019* (CSPA), is expected to be introduced later today along with several amendments required to bring the CSPA into force. If passed, the Bill would amend the CSPA to provide that a secondary school diploma or equivalent is sufficient education for the purposes of being appointed as a police officer. This change, if passed, would come into effect when the CSPA comes into force.
- BCT courses cover a variety of topics, including federal/provincial/traffic law, human rights, diversity and professional practice, leadership, ethics, mental health for first responders and for people in crisis, physical wellness and fitness

for duty, community safety, defensive tactics, use of force and de-escalation techniques, firearms, and officer safety.

 The Ontario Police College is continually reviewing and modernizing its curriculum, programming, and training to address current needs, trends and best practices.

Ontario Building Safer and Secure Communities

Legislation will clear the path for more people to consider a career in policing and strengthen animal welfare enforcement across the province

April 25, 2023 Solicitor General Attorney General

TORONTO — Today, the Ontario government introduced the *Strengthening Safety and Modernizing Justice Act, 2023,* which would, if passed, clear the path for more people to consider a career in policing, strengthen protections for animals and increase access to the courts by reducing backlogs.

Proposed amendments to the *Community Safety and Policing Act, 2019* (CSPA) include:

- Police recognition and education: such as expanding King's Commissions to include municipal and First Nations police officers; and eliminate the postsecondary education requirement in the CSPA to become a police officer to address the recruiting shortage of police officers in Ontario.
- Improved budget arbitration: such as clarifying responsibility for costs for municipal police service board budget disputes.
- Enhanced oversight and governance: such as strengthening governance of the future Ontario Police Arbitration and Adjudication Commission by creating the possibility for the appointment of one or more vice chairs. This change is intended to improve governance of the agency and to support the integrity of

its arbitration and adjudication related functions.

Once in force, the CSPA will update the police discipline process in Ontario. This includes increasing the availability of suspension without pay including where charges have been laid for serious offences as defined in regulation.

There are several other pieces of legislation that would be amended if passed:

• A strengthened animal welfare enforcement framework: the *Provincial Animal Welfare Services (PAWS) Act, 2019* - amendments would improve animal welfare

through enhanced enforcement capabilities as well as streamline processes related to the Animal Care Review Board.

- Improved efficiency in fire operations and oversight: the *Fire Protection and Prevention Act, 1997* - amendments would close gaps in cost recovery provisions and support effective decision making at the Fire Safety Commission.
- Enabling future health and forensic testing: the *Coroners Act* amendments would allow regulations on the collection of tissue samples during a coroner's investigation for reasons that go beyond the investigation, including for current and future advances in health and forensic sciences, such as genetic testing.
- Supporting education of judges and justices of the peace: the *Courts of Justice Act* and the *Justices of the Peace Act* – amendments would support judicial education related to gender-based violence for provincially appointed judges and justices of the peace.
- Reducing backlog in the courts: the *Courts of Justice Act* amendments would free up judicial time and resources in the Superior Court of Justice by preventing plaintiffs from starting low-value claims at the Superior Court of Justice if the claims are in the Small Claims Court's jurisdiction, unless the court orders otherwise.
- Improving administration in municipal courts: the *Provincial Offences Act* amendments would and clarify that it is court staff and not judicial officers who file judicial review application materials with the courts.

BACKGROUNDER

Strengthening Safety and Modernizing Justice Act

April 25, 2023 Solicitor General

The *Strengthening Safety and Modernizing Justice Act, 2023* includes legislative amendments that if passed, would support bringing the *Community Safety and Policing Act, 2019* (CSPA) into force. It proposes amendments that would clear the path for more people to consider a career in policing, strengthen protections for animals and increase access to the courts by reducing backlogs.

Community Safety and Policing Act, 2019 (CSPA)

On March 26, 2019, the CSPA received Royal Assent; however, there are several important operational and critical amendments to make to bring the act into force. These amendments focus on oversight and governance, labour arbitration, police recognition and education, and providing clarification and alignment with other statutes.

Through the CSPA and its regulations, the government will establish a legislative framework that improves Ontario's approach to policing and community safety that addresses changes to policing over the last 30 years, including improving accountability for the policing sector. This updated framework is designed to advance policing that is fair, equitable, safe, transparent, and effective.

Provincial Animal Welfare Services (PAWS) Act, 2019

The PAWS Act came into force on January 1, 2020 and sets out standards of care and prohibitions against causing animals distress, that help ensure that animals in the province are protected and treated in a humane manner.

The proposed statutory amendments to the PAWS Act will help improve animal welfare, strengthen compliance, and enhance enforcement capabilities. These amendments relate to improving cost recovery for Animal Welfare Services (AWS), clarifying Animal Care Review Board processes, and narrowing gaps related to AWS inspector authorities to help strengthen protections for animals. It is anticipated that these changes will lead to improvements in enforcement, compliance, and animal welfare.

Coroners Act

The *Coroners Act* creates the authority to examine a body to determine the circumstances of the death (who, how, when, where and by what means); if an inquest is necessary; and to collect and analyze information about the death to prevent further deaths.

The Office of the Chief Coroner and the Ontario Forensic Pathology Services (OCC/OFPS) have the authority under the *Coroners Act* (Regulation 180) to retain and store tissue samples and body fluids obtained during a post-mortem examination. The regulation identifies the types of specimens that can be stored and the retention period.

The proposed statutory amendment would enable the government to make regulations to allow for the collection of tissue samples during a coroner's investigation that are not immediately required for the investigation under the *Coroners Act*. Such tissue samples may be of benefit in relation to current and future advances in health and forensic sciences, such as genetic testing.

Tissue samples retained by the OCC/OFPS may be used for DNA testing to assist with identifying fatal genetic conditions both at the time of death and in the future as medical advances continue to improve knowledge about genetic connections to medical conditions.

Fire Protection and Prevention Act, 1997 (FPPA)

The FPPA establishes the legislative framework for the delivery of fire protection services in Ontario including, among other things: rights of entry in emergencies and fire investigations, inspection powers, offences and enforcement, and recovery of costs.

The proposed amendments to the FPPA would:

• allow full implementation of cost recovery provisions added in 2019 for

immediate Authorizations to Close

- allow more than one deputy fire marshal to be appointed and fulfill the duties of the deputy fire marshal in the act
- provide the Fire Safety Commission (FSC) with the authority to extend the time to appeal an order beyond the current 30-day period in exceptional circumstances
- eliminate the three-member quorum requirement so that appeals before the FSC can be heard by a single member.

Courts of Justice Act and Justices of the Peace Act

The federal government has recently passed legislation enhancing the judicial education provisions under the *Judges Act* to encourage training on sexual assault for federally appointed judges. Similar legislation for educational changes related to intimate partner violence is at third reading in the Senate.

The proposed changes to the *Courts of Justice Act* and *Justices of the Peace Act* will support judicial education related to gender-based violence for provincially appointed judges and justices of the peace. These changes would ensure a consistent approach to the way judges are educated about gender-based violence and its impacts on children, families and communities.

Courts of Justice Act

Currently, claims for money or personal property valued up to \$35,000 can generally be started in either the Small Claims Court or the Superior Court of Justice (SCJ).

The proposed change to the Courts of Justice Act would prevent plaintiffs from starting claims in the SCJ that are within the jurisdiction of the Small Claims Court (unless the SCJ orders otherwise). This would eliminate cases in the Superior Court that could instead be heard in the Small Claims Court and would free up judicial time and resources to focus on urgent priorities. In this way, this amendment should reduce case backlogs in the SCJ.

Provincial Offences Act

The Provincial Offences Act (POA) governs the prosecution of offences established under provincial law and municipal by-laws. The POA creates a system for the prosecution of non-criminal charges such as traffic offences, as well as trespass to property charges, environmental charges, and liquor licensing violations.

The proposed housekeeping amendment would clarify the current practice that it is

New projects will help up to 2,000 people with criminal records escape the cycle of poverty, incarceration, and crime

April 26, 2023

Labour, Immigration, Training and Skills Development

TORONTO — The Ontario government is investing \$12 million to support nine innovative projects designed to help up to 2,000 people leaving the justice system or with prior criminal records find meaningful jobs with local businesses, helping them create connections and a sense of belonging within their communities. More than one million people in Ontario live with a criminal record, which can decrease the chances of a second interview by 50 per cent and drastically increases the likelihood of long-term poverty. Stable employment has been shown to help address the root causes of crime and reduce the likelihood of someone reoffending.

"Across Ontario, tens of thousands of people have paid their dues and just want to roll up their sleeves and give back," said Monte McNaughton, Minister of Labour, Immigration, Training and Skills Development. "Under the leadership of Premier Ford, our government believes in the power of second chances. I urge business leaders to join us as we smash through the stigma of a criminal record."

Led by various organizations across <u>multiple sectors</u>, the programs announced today will prepare jobseekers for well-paying careers in construction, manufacturing, hospitality, food and beverage processing, and other industries.

They will provide a range of employment and training needs through apprenticeship and technical training, on-the-job learning, and improving job readiness and interview skills. The projects include wrap-around support like mentorship, job placement, and mental health resources to ensure a smooth transition to the job market.

"We believe in second chances and in the inherent potential of each person," said Michael Kerzner, Solicitor General. "Building a strong Ontario means that no one gets left behind, including those with previous criminal records. By connecting those with criminal records to skills training, we are creating brighter futures and better tomorrows."

The government will be unveiling additional programs to help people with prior involvement in the criminal justice system over the coming months. These projects are funded through the Skills Development Fund, a \$700 million initiative, which supports ground-breaking programs that connect jobseekers with the skills and training they need to find well-paying careers close to home.

"Minister McNaughton and his team have done incredible work to support training and skills development in the hospitality sector," said Terry Tsianos, Chairman of Scale Hospitality. "The ongoing funding received through the provincial SDF program has allowed us to provide second chance training to at-risk youth across the GTA and provide them with valuable training to transform their lives. The support this year will, once again, position the hospitality sector as a viable option for individuals who want meaningful, well-paying employment. We are thankful for the leadership of Premier Ford, Minister McNaughton, and Minister Kerzner for their continued support for skills development and second chance programs."

Ontario Providing Second Chances for those with Criminal Records

April 26, 2023

Labour, Immigration, Training and Skills Development

The Ontario government is investing \$12 million to provide people with criminal records a second chance to find meaningful jobs and give back to their communities.

This is part of Ontario's \$700 million Skills Development Fund, which supports innovative ideas for training and skills development to help drive Ontario's economic growth and build a stronger province.

The funding recipients include:

Building Up

- Building Up is receiving **\$593,956** for a holistic project aimed at improving job retention and career progression for individuals who face significant barriers to employment and that have completed their pre-apprenticeship program.
- This project will help 200 people work in the skilled trades in communities in the Toronto area.

Calibre Recruitment Inc.

• Calibre Recruitment Inc. is receiving **\$590,365** for a project that aims to reduce the barriers that people with previous interactions with the criminal justice system face when trying to access employment, while also helping local

employers address critical labour shortages.

- The program is designed to give individuals the skills training, job coaching, and wrap-around supports required to access and transition into stable employment opportunities.
- This project will help 30 people access employment in sectors including food and beverage processing, hospitality, and manufacturing in communities in London and the surrounding area.

Community Justice Initiatives of Waterloo Region

- Community Justice Initiatives of Waterloo Region is receiving \$119,552 for a
 project that will work with people who have lived experience of incarceration or
 criminalization and local business leaders to co-design an approach to training
 and employment that supports both the needs of the employer, along with the
 needs of program participants.
- This project will help 96 people work in various sectors in the Kitchener Area.

Fernie Youth Services

- Fernie Youth Services is receiving \$514,459 for a project focusing on removing barriers in education and skills training opportunities for justice-involved and racialized youth by delivering new and innovative approaches to skills training. This includes providing tools, equipment, and wrap-around supports to jobseekers, such as mentorship, job placement and coaching, mental health supports, educational supports, career and learning plans, and social supports, such as housing and medical care.
- This project will help 25 people work in various sectors in communities in the Toronto Area.

Hammer Heads Program

- Hammer Heads Program is receiving **\$204,850** to support a project aimed at improving job retention and career progression for apprentices in their program, by guiding them through the first years of their employment with regular follow-ups in the field to ensure sustainability and long-term success.
- This project will help 200 people work in the skilled trades in communities in the Toronto area.

Prison Fellowship Canada

- Prison Fellowship Canada is receiving \$500,000 for a comprehensive project that will provide in-class and on-the-job training support for apprentices, including tutoring, exam preparation, mentorship, and wrap-around supports that promote apprentice progression and obtaining the highest level of certification possible in a particular trade. It will also provide on-the-job supports to help journeypersons provide the training that apprentices need to successfully progress through their program.
- This project will help 100 people work in the skilled trades in communities in Mississauga.

SPOT App

- SPOT App is receiving **\$1,640,000** for a specialized program that will provide jobseekers from the second chances population with job opportunities and training through a new mobile job placement app. They will also work with employers to reduce stigma and promote the benefits of giving people with prior involvement in the criminal justice system a second chance.
- This project will help 260 people work in a range of sectors in communities in the Toronto area.

Scale Hospitality

- Scale Hospitality is receiving \$6,000,000 to support an industry-led initiative aimed at supporting growth in the hospitality sector through various training opportunities. These include initiatives such as micro-credential training programs and increasing accessibility for those who face barriers to employment through community partnerships.
- This project will help 1,205 people work in hospitality in communities in the Toronto area.

The Oaks Revitalization Association

- The Oaks Revitalization Association is receiving **\$1,943,177** for a project that will support young offenders by training them as apprentices and helping them to transition into employment in the Skilled Trade industry.
- The Skilled Trade Development program provides access to the Skilled Trade labour market and rehabilitates and reintegrates young offenders back into society. The mentorship program will provide core life skills, mental health support, reintegration, anti gangs/crime, and support dealing with on-the-job challenges. Clients will be mentored and placed into apprenticeships within the skilled trades industry.
- Breaking the cycle of recidivism will have meaningful change for marginalized communities. The Oaks will be working with Toronto Police Service, Correctional Services, Toronto Focus Tables, Community Agencies, and DAP (Direct

Accountability Program).

• This project will help 16 people work in communities in Central Toronto in the first cohort.

Ontario Takes Action on High-Risk and Repeat Violent Offenders

Province working alongside federal government to fix broken bail system

April 27, 2023 Office of the Premier Attorney General Solicitor General

SCARBOROUGH — The Ontario government is investing \$112 million to immediately strengthen the province's bail system and ensure that high-risk and repeat violent offenders comply with their bail conditions. The funding will be used to support new technology, establish violent crime bail teams, expand the Ontario Provincial Police (OPP) Repeat Offender Parole Enforcement Squad and provide prosecutors with the resources they need to conduct complex bail hearings.

"As the country and our province face rising crime rates and people are feeling increasingly unsafe in their communities, this funding will help ensure anyone out on bail is following the rules and high-risk, repeat offenders are kept in jail," said Premier Doug Ford. "We can't have a justice system where violent criminals are arrested one day and back out on the streets the next. We're doing our part to fix a broken bail system and look forward to working with our federal partners to finish the job."

Specifics of the investment include:

- The creation of a new Bail Compliance and Warrant Apprehension Grant

 \$24 million will be made available over three years to help the OPP and municipal and First Nations police services establish dedicated bail compliance teams. Teams will also assist prosecutors with gathering evidence and assessing public safety risk during the bail hearing stage.
 Grant funding may also be used to acquire bail compliance technology or support a network that police services could use to share bail offender information.
- Expansion of the OPP Repeat Offender Parole Enforcement (ROPE) Squad

- \$48 million to create a dedicated Bail Compliance Unit within the OPP's Repeat Offender Parole Enforcement Squad. This new dedicated, provincewide, Bail Compliance Unit will apprehend high-risk provincial offenders who have broken their bail conditions or are unlawfully at large.
- Establishment of Intensive Serious Violent Crime Bail Teams
 - \$26 million to create Intensive Serious Violent Crime Bail Teams within the courts system to ensure that there are dedicated prosecutors and subject matter experts to prepare for and properly conduct the often lengthy and complex bail hearings.
- Rollout of the Bail Compliance Dashboard
 - A new provincewide bail monitoring system to allow police services to monitor high-risk offenders with the most accurate data possible.

"When it comes to keeping people safe and addressing crime in our communities, we'll stop at nothing," said Solicitor General Michael Kerzner. "This funding will help police and justice sector partners address issues of bail compliance by expanding the resources needed to monitor and apprehend high-risk repeat offenders violating bail conditions. It will also help to ensure that both sentencing and bail processes work to reduce violent acts and keep our communities safe."

Today's announcement follows months of advocacy from all of Canada's premiers for the federal government to amend the *Criminal Code* and implement meaningful bail reform to prevent violent and repeat offenders from being released back into communities. The federal government has signalled its willingness to work with all provinces and territories to identify and implement meaningful solutions. Ontario will continue to be a partner in this work and looks forward to these changes being made.

"As part of our ongoing efforts with the federal government to reform the broken bail system, we are adding new resources to support our work to make Ontario's bail process stronger," said Attorney General Doug Downey. "These investments will immediately help to address serious, violent and repeat offenders by providing more resources to police to investigate and apprehend these accused persons and to prosecutors and courts to conduct complex, time consuming bail hearings with the best evidence possible."

Quick Facts

 On March 10, 2023, federal, provincial and territorial Attorneys General and Ministers of Justice and Ministers of Public Safety <u>met to discuss Canada's bail</u> <u>system</u>. The federal government agreed to take action through amendments to the *Criminal Code* that would target repeat violent offenders and serious offences committed with firearms and other dangerous weapons.

- Ontario experienced a 57 per cent increase in serious violence and weapons cases before the courts between 2018 and 2021. (<u>Ontario Court of Justice</u>)
- Toronto Police Service report that over the last two years in the city of Toronto, 17 per cent of accused charged with shooting-related homicides were already out on firearms bail at the time of the alleged fatal shooting.

Ontario Launches New Interactive High-Speed Internet Map

Province announces service providers for 14 high-speed internet projects

April 27, 2023 Infrastructure

THUNDER BAY — The Ontario government is launching a <u>new interactive map</u> that will make it easier for residents and businesses to learn more about provincially funded high-speed internet projects across the province. Users can search the map by address, community or municipality to find project details, including information on construction status and internet service providers that will be delivering reliable high-speed internet in unserved and underserved communities.

"I am so proud to launch this new online tool that will help people learn more about high-speed internet access currently available and coming soon to communities across the province," said Kinga Surma, Minister of Infrastructure. "This user friendly map will provide Ontarians with the latest information about our government's progress in bringing reliable high-speed internet access to every community by the end of 2025. Through our ambitious plan, our government will ensure that no community will be left behind in today's digital world."

Ontario has finalized agreements totalling more than \$2.3 billion for nearly 200 high-speed internet and cellular projects across the province. As part of these agreements, the Ontario government is announcing the internet service providers for <u>14 high-speed internet projects</u> that will receive over \$8.4 million in provincial funding through the Improving Connectivity for Ontario (ICON) program. These projects, which are also featured on the <u>new high-speed internet map</u>, will bring reliable high-speed internet access to more than 11,000 homes and businesses across the province.

Ontario is providing families, businesses and communities with the infrastructure they need by investing more than \$184 billion over the next 10 years in roads, highways, public transit, hospitals, long-term care homes, schools, and high-speed internet.

Quick Facts

- The Ontario government is investing nearly \$4 billion to bring access to reliable high-speed internet for every community across the province by the end of 2025. This is the largest single investment in high-speed internet, in any province, by any government in Canadian history.
- In 2021, Ontario passed the Supporting Broadband and Infrastructure Expansion <u>Act, 2021</u> to help speed up construction of broadband projects. To build upon this legislation, the Ontario government passed the **<u>Getting Ontario Connected</u>** <u>Act, 2022</u> which further reduces barriers, duplication and delays.

TORONTO — On May 6, 2023, Ontario will celebrate the Coronation of His Majesty King Charles III and Her Majesty The Queen. This historic occasion will mark the first coronation of a Canadian Head of State in seven decades.

Following the ceremony, 'Coronation Celebration: A Fun Royal Fair' will be held on the South Lawn of Queen's Park from noon to 6 p.m. Free family fun activities will include carnival rides and live entertainment. A 'Taste of Ontario' will provide complimentary food and beverages from Ontario farmers and processors. The Coronation Celebration is open to the public, free of charge.

Ontario Launching New Mental Health Learning and Increasing Funding

Province introducing new mandatory learning on mental health starting this upcoming school year

May 01, 2023 **Education**

BURLINGTON — Following a motion in the legislature by Natalie Pierre, Member of Provincial Parliament for Burlington, to strengthen mental health learning and supports in the classroom, the Ontario government is updating the Grade 10 Career Studies curriculum and is introducing mandatory resources for teachers and students on mental health literacy in Grades 7 and 8. These resources, developed in consultation with experts, would support students as they achieve and prepare for the next steps in their future.

Stephen Lecce, Minister of Education, and MPP Pierre also announced an additional \$12 million this year and \$14 million next year to provide mental health services over the summer months. This funding will further students' access to school-based mental health professionals and services year-round, with the aim of providing students consistent and reliable support, responding to a key recommendation of families and student trustees.

"We know that strengthening mandatory mental health literacy in the curriculum is the right thing to do. Natalie Pierre is a strong advocate and MPP, but most of all she is a mother driven to ensure we prevent tragedies and save lives," said Stephen Lecce, Minister of Education. "That is why it is so critical that all students learn

healthy coping strategies, stress management and better recognition of the early signs. We want children to have the tools and confidence to succeed in the classroom and to always know that they are not alone."

Announced at the start of National Mental Health Week and proposed for introduction in schools in the next school year, the new mandatory mental health literacy resources will include:

• New learning materials for Grade 7 and 8 students that are aligned with the Health and Physical Education curriculum. This includes important tools like https://news.ontario.ca/en/release/1002993/ontario-launching-new-mental-health-learning-and-increasing-funding 44

student activities, videos and interactive programming and information that will help students learn how to manage stress, understand the relationship between mental health and mental illness, recognize the signs and symptoms of a mental health concern, counteract mental health stigma and know when and how to get help.

 Mandatory learning on mental health literacy for Grade 10 students will start in fall 2024 and will include how to recognize signs of being overwhelmed or struggling, as well as where to find help locally when needed. This will be included in the Career Studies course.

"Improving mental health literacy in schools is a critical part of building the resiliency skills that our children and youth need to grow up to be happy and healthy adults," said Michael Tibollo, Associate Minister of Mental Health and Addictions. "There is no health without mental health. By providing schools these resources, we can lower stigma and improve connections to the community sector where students and their families can access Ontario's continuum of care."

The Ontario government is also announcing an increase in mental health funding in schools to a historic \$114 million in 2023-24, representing an over 500 per cent increase since 2018.

This includes:

- \$50.4 million to help school boards meet local needs and priorities related to mental health, including professional development, student engagement, wellness promotion and mental health professionals
- \$26.5 million to hire permanent mental health workers in secondary schools
- \$10.8 million for mental health leaders in school boards who collaborate with community partners to provide integrated student mental health services
- \$6.5 million to School Mental Health Ontario to provide clinical expertise, resources and practical tools for educators, and the delivery of professional learning to school-based mental health clinicians
- \$3.75 million towards mental health supports for racialized and marginalized students
- \$2 million to increase awareness for parents and guardians on student mental health
- \$2 million to support emerging student mental health needs, including initiatives that promote healthy behaviours such as the prevention and awareness of substance use and addiction.

The new learning on mental health aligns with Ontario's nation-leading updated <u>2019 Health and Physical Education Curriculum</u> that includes learning on mental health literacy in every grade.

To date, over \$525 million in funding has been provided as part of the <u>Roadmap to</u> <u>Wellness</u> to improve the quality and access to mental health supports while shortening wait times and removing gaps in service. This includes over \$130 million for child and youth mental health services and supports. In addition to expanding services and launching the "One Stop Talk" virtual counselling program for youth and their families, our government has also significantly expanded the number of Youth Wellness Hubs across the province to make it faster and easier for youth to connect with primary care, mental health and substance use support, social services and more.

This past fall, the government consulted with parent and student groups, educators, community-based child and youth mental health organizations and school-based mental health professionals to discuss ways to further improve student mental health supports. Ontario will continue to work with community partners to build a stronger continuum of care, so students have access to appropriate mental health services when they need it.

Quick Facts

- The <u>Better Schools and Student Outcomes Act, 2023</u> was introduced two weeks ago and would, if passed, give the Minister of Education the authority to issue policies and guidelines for school boards respecting student mental health.
- <u>School Mental Health Ontario</u> is a provincial organization that provides school boards with student mental health evidence-informed resources, programs and professional training.
- The Grade 10 Career Studies course is a compulsory course requirement towards the Ontario Secondary School Diploma.
- Through the <u>Roadmap to Wellness: A Plan to Build Ontario's Mental Health and</u>

<u>Addictions System</u>, Ontario is better connecting people to mental health services that are convenient for them, including strengthening the continuity of mental health care for youth in schools and in the broader community.

• In the 2023 Budget, the government committed an additional \$425 million over three years to support mental health and addictions services, including a five per cent increase in the base funding of community-based mental health and addictions services providers funded by the Ministry of Health.

Ontario Declares May as Building Safety Month

Updated Building Code will support efforts to increase Ontario's housing supply

May 01, 2023

Municipal Affairs and Housing

TORONTO — Today, the Ontario government declared May to be Building Safety Month. This recognizes the importance of the province's Building Code and the critical role building officials play in maintaining public health and safety, while making it easier and faster to build new homes.

"Building Safety Month is an excellent opportunity to highlight the important role Ontario's building officials play in protecting public safety and tackling Ontario's housing supply shortage," said Steve Clark, Minister of Municipal Affairs and Housing. "It is also a time to reflect on the many ways Ontario's Building Code impacts our daily lives — from establishing safety standards for our homes to ensuring people have barrier-free access to buildings, restrooms and other public spaces as we work to build 1.5 million homes by 2031."

Ontario's Building Code establishes high standards for construction to keep people safe, including requirements for fire safety devices, accessibility, structural sufficiency and water and energy conservation. It is updated regularly to reflect technical advancements, expert research and government priorities. The government works closely with its partners in the sector — building officials, fire prevention officials, architects, engineers, builders and the construction industry to ensure that Ontario's buildings continue to be some of the safest and most accessible in North America.

"Every day, Ontario's building officials play a critical role in ensuring the safety of homes and buildings in municipalities across the province," said Lawrence Wagner, CEO of the Ontario Building Officials Association. "We like to refer to them as 'guardians of building communities' and we're pleased that the Ministry of Municipal Affairs and Housing is proclaiming May as Building Safety Month across Ontario to recognize their important contributions and the importance of the Ontario Building Code."

The province is making changes to Ontario's Building Code to unlock housing, reduce barriers and help speed up housing construction. The changes make it easier to use innovative construction materials and techniques that can save time and money, including allowing encapsulated mass-timber construction for buildings up to 12-storeys tall. The province also streamlined modular multi-unit residential building requirements so they can be quickly assembled and occupied. The government is also encouraging innovative approaches to homeownership and increasing housing supply — such as <u>tiny homes, second units and laneway</u> housing.

Last year, Ontario introduced a new <u>digital Building Code compendium</u> that can be used on mobile phones and tablets, making it easier to use on construction sites and in remote areas. The province is also working to better align Ontario's Building Code with the National Construction Codes. Increased harmonization of construction codes will help reduce red tape and overcome barriers related to trade, product manufacturing, and building design and maintenance, supporting market standardization across the country.

The government recognizes that labour shortages are limiting home construction. The province's latest Housing Supply Action Plan, <u>Helping Homebuyers, Protecting</u> <u>Tenants</u>, proposes to address the shortage of building inspectors by redesigning the qualification program and supporting uptake of the new internship program. Developing more tools and guidance materials would also help to make their jobs more efficient.

The government will continue to respond to the needs of the sector, work with its municipal and building sector partners to keep people safe and better meet the needs of Ontario's building professionals. This is critical to helping the province address Ontario's housing supply shortage and reach its goal of building 1.5 million homes by 2031.

- The province continues to take decisive action to tackle Ontario's housing supply shortage and deliver on its promise to build 1.5 million homes by 2031 – most recently, with the introduction of the Helping Homebuyers, Protecting Tenants plan.
- The <u>Building Code Act, 1992</u> lays out the legislative framework governing the construction, renovation, demolition and change of use of buildings in Ontario. The <u>Building Code</u> is a regulation under the Act that includes standards for public health and safety, fire protection, structural sufficiency, energy

conservation, water conservation, environmental integrity and barrier-free accessibility of buildings.

- Municipalities are responsible for the enforcement of the Building Code within their jurisdiction. Municipal councils must appoint a chief building official and building inspectors to ensure proper enforcement of the Building Code.
- The province has fulfilled over 9,000 requests for the <u>digital Building Code</u>
 <u>Compendium</u> since its initial release in March 2022. This product provides the building industry and public with a more convenient way to access Ontario's Building Code than the original 2,300-page paper document.

"Today, the Government of Ontario announced the appointment of the Honourable Sharon Margaret Nicklas as Chief Justice of the Ontario Court of Justice.

Associate Chief Justice Nicklas was first appointed a judge of the Ontario Court of Justice in Kitchener in 2007, where she presided over criminal and family law matters. From 2013 to 2019, she was Regional Senior Judge for the Central West Region. In 2019, she was appointed Associate Chief Justice – Co-ordinator of Justices of the Peace.

Associate Chief Justice Nicklas graduated from the University of Toronto Faculty of Law in 1992 and was called to the bar in 1994. She was an Assistant Crown Attorney in Hamilton, Brantford and Waterloo Region from 1994 to 2003. In 2003, she became the Deputy Crown Attorney in Waterloo Region, and shortly before her appointment in 2007, she was the Acting Crown Attorney in that region.

Associate Chief Justice Nicklas will replace outgoing Chief Justice Lise T. Maisonneuve, whose eight-year term ends May 31, 2023."

This year's winner, Somewhere Inn Calabogie, is certified through Green Step, Rainbow registered, ECO Fund program participants, One tree planted per stay participants, and Living Wage certified.

"Somewhere Inn provides a sustainable, inclusive, and year round employment opportunity with a focus on growth, education, and the mental and physical wellbeing of their team," said nominator Meghan James. The New Tourism Product award was granted to Rio Tap & Grill for the creation of their rooftop patio. This new award was created to recognize innovation and excellence including an existing business who develops a new tourism product as part of their experiences.

"The rooftop patio is a draw for visitors while at the same time provides an offering for locals that is unique and in our own community," said nominator Chris Hinsperger.

Finally, the Tourism Marketing Award was granted to Oh-el-la Café. This award was created for an OVTA member who has implemented an exceptional digital marketing or promotional strategy based on execution, impact, creativity and contributing to the success of the business or tourism product.

"Oh-el-la's promotional strategy of consistency with daily Instagram stories, business partnerships, and social media giveaways are what keep clients coming back for more," noted Ella Guckes in her nomination.



Ontario increasing support for Homelessness Prevention in Renfrew County

The Ontario government is investing an additional \$202 million annually in the Province's Homelessness Prevention Program and Indigenous Supporting Housing Program, bringing Ontario's total yearly investment in these programs to close to \$700 million. The additional funding will help those experiencing, or at risk of, homelessness and support community organizations delivering supportive housing.

This includes a \$3.5 million investment in 2023-24 for the County of Renfrew's Community Services Department, nearly doubling the previous year's funding allocation. The funds from this program are used to cover a variety of housing and homelessness supports that help with housing acquisition, retention, and affordability. The County of Renfrew's Homelessness Prevention Program includes funding for emergencies, rent allowances, and essential home repairs. More information about these programs can be found at the <u>Community Services section</u> of the County's website.

"This increase in funding demonstrates our government's commitment to addressing the housing supply crisis, which we know impacts individuals across Ontario," said Renfrew-Nipissing-Pembroke MPP John Yakabuski, following the funding announcement which was part of the 2023 Ontario Budget. "Investing in programs that support housing affordability and security will help Renfrew County residents to stay housed safely in our community."

The additional funding represents a 40 per cent increase in provincial funding to support the most vulnerable by providing supportive housing and homelessness prevention services across Ontario. Under the \$202 million investment, \$190.5 million each year will be allocated to the Homelessness Prevention Program (HPP), which gives Ontario's 47 Service Managers greater flexibility to allocate funding and make better use of existing resources to focus on delivering supports.

"We are extremely grateful for this injection of funding as it will increase the number of households we are able to assist and have a positive impact on the wellness of low-income households in Renfrew County," said County of Renfrew Warden Peter Emon. "These funds will certainly help with our plans to create affordable housing in Renfrew County and allow us to develop more supportive housing stock and housing options. The government listened when we spoke of the need and provided the funding to allow us to work toward solutions."

The increased funding is a result of a revised funding model that better reflects the current needs of individuals who are facing homelessness across Ontario. Funding dollars are being increased to address growing needs, particularly during a time of rising inflation, and to help ensure that no service manager receives a decrease in funding compared to 2022-23 because of the transition to the new model.

Ontario will continue to support the most vulnerable by providing supportive housing and homelessness prevention services to help those most in need.

Through this announcement, the County of Renfrew is pleased the Province has also provided details about funding allocations for the two following fiscal years which will assist in planning purposes for ongoing and seamless program delivery.

County Council Summary

April 26, 2023

Warden's Address

Key highlights

During the month of April, Warden Peter Emon attended 17 meetings on County business.

- On April 3, he met with the Chair of the Western Ontario Wardens' Caucus to discuss shared initiatives and priorities, including common advocacy topics for upcoming meetings with members of Federal and Provincial Parliament.
- On April 5, he presented the Eastern Ontario Wardens' Caucus '7 in 7' housing initiative to the Council of the County of Leeds and Grenville, and on April 7, he made the same presentation to the Council of Frontenac County.
- On April 6, he attended the Annual General Meeting of the Eastern Ontario Regional Network via zoom.
- On April 14, he attended a ROMA Board of Directors meeting. Discussion was held on the 2023 budget review, LAS Cyber Insurance Program, and updates on broadband, housing, drainage action and Justice of the Peace vacancies.
- On April 14, the Warden also participated in the Ottawa Valley Tourist Association Tourism Awards judging panel. These awards were presented at the OVTA Annual General Meeting and Conference April 25 at Maplehaus in Harwood Lake in the Township of Brudenell, Lyndoch and Raglan. See our media release highlighting the <u>award winners</u>.
- On April 14, he attended an electronic meeting with the Western Ontario Wardens' Caucus and the MP and MPP from southwestern Ontario about EOWC priorities.
- On April 15, he attended the Hospice Renfrew 15-year anniversary held at St. Joseph's High School in Renfrew.
- On April 17, he attended a ROMA Board of Directors meeting via zoom (FCM Legal Counsel).
- On April 19, he attended an SVN Research Affordable Housing Seminar Planning Session Webinar.
- On April 24, the Warden, along with CAO Craig Kelley, met with Garrison Petawawa Commander Colonel J.C. Guiney. This was an opportunity to meet and discuss mutual interests. The Warden has invited Colonel Guiney to the May County Council meeting.



Delegations

- County of Renfrew Paramedic Service Chief Michael Nolan presented Chief's Commendations to Dr. Robert Cushman, former Acting Medical Officer of Health, Renfrew County and District Health Unit and Leah Levesque, President and CEO, Arnprior Regional Health, to recognize their contributions during the COVID-19 pandemic and throughout the development and early days of the Renfrew County Virtual Triage and Assessment Centre. The Chief's Commendation is an award which was created more than 10 years ago for exemplary service and going above and beyond in our community. It's been awarded to members of the public, paramedics, administrative staff and individuals to recognize their extraordinary efforts.
- Darrel O'Shaughnessy, founder of the Arnprior McNab/Braeside Men's Shed, spoke about his group, which he called a social healthcare innovation. Men's Sheds help senior men lead healthy, active lives and stay connected with their communities through companionship and fun. They provide a place to hang out, tinker on projects, connect and tell stories. They also help to form age-friendly communities. The Arnprior McNab/Braeside Men's Shed, which began with five members, now boasts about 50 regular members and is the fastest growing Men's Shed in Canada. He asked members of County Council to help promote the Men's Shed concept in their own communities and consider establishing new Men's Sheds across the County of Renfrew.
- Dr. Jason Morgenstern, the new Medical Officer of Health for the Renfrew County and District Health Unit, attended the meeting and introduced himself to members of County Council. This marks the first time since 2015 that the RCDHU has had a full-time and permanent MOH. Dr. Morgenstern was the Associate MOH for Halton Region and earlier in his career worked in Southern Ontario. This is a homecoming of sorts since Dr. Morgenstern spent his childhood in Renfrew and Lanark Counties.

On the job since April 3, 2023, Dr. Morgenstern indicated his focus is listening and learning, getting to know the community, getting to know the programs and partners better and introducing himself to County Council is an important part of that.

He is optimistic about the future of the RCDHU, which he said has been doing amazing work and he is eager to continue collaborating and working together to support optimal health for Renfrew County and District residents.

Announcements

- The Development and Property Committee provides the option for local municipalities to host one of its regular meetings at the offices of local municipalities. In response to this, the Township of McNab/Braeside has requested to host the Development and Property and Operations Committees in June in their municipal Council Chambers. The objective with hosting in the local municipality is to enable the staff and local municipal Councils to meet with the Development and Property Committee and Operations Committee to discuss any matters of common interest or concern.
- County Councillor Dan Lynch made a special presentation to Warden Peter Emon, Chair of the Renfrew County 2023 Ontario Winter Games Organizing Committee and Councillor Jennifer Murphy, Finance Chair for the OWG committee. He had a vision and he took some of the wooden stumps used as benches by the athletes during the Opening Ceremony on Feb. 2, 2023. He commissioned Arnprior artist Bonnie Giles to paint the sport logos from the Games on the log, along with the Algonquins of Pikwakanagan logo and the Renfrew County side of the medals



on top. He also presented wooden cookies with the same medal logo to Warden Emon, Councillor Murphy and one for Games Manager Cindy Burwell. Councillor Lynch offered his thanks and congratulations for leading such a successful event.

Finance & Administration Committee

Presented by: Jennifer Murphy, Chair

- The 2023 Warden's Golf Tournament is scheduled for Thursday, September 21, 2023 at the Dragonfly Golf Course in Renfrew. Further details will follow.
- The annual Service Award dinner for County of Renfrew staff will be held on Thursday, November 23, 2023. Further details will follow.
- On November 23, 2022, proposed amendments to the POA aimed at modernizing and streamlining processes in POA courts were introduced in the Ontario Legislature as Schedule 8 under Bill 46, the *Less Red Tape, Stronger Ontario Act, 2023.* Bill 46 received Royal Assent on March 22, 2023.

As a result, the following change to the POA have been approved:

- Clerks of the court will grant, but not deny, applications to strike a conviction on a ticket, if satisfied that the defendant, through no fault of their own, missed a notice or was unable to attend a meeting or hearing related to the ticket. If the clerk is not able to grant the application and strike the conviction, the clerk must forward the application to a justice of the peace to make the determination whether to grant or deny the request for a reopening.
- At the request of the Chief Administrative Officer, in consultation with the Senior Leadership Team, the Human Resources division created and launched a survey designed to capture feedback on the experiences of County employees in a number of key areas. Among the proposals to come out of the survey are implementing alternative work arrangements; offering management training curriculum; launching recognition and referral programs; and implementing quarterly all-staff meetings. County Council approved Corporate Policies J-04 – Employee Referral Bonus Program and J-05 – Employee Recognition Program.
- County Council passed a resolution approving changes to the September Standing Committee schedule to allow elected officials the opportunity to attend the rescheduled Ontario East Municipal Conference in Ottawa. The September meeting schedule is as follows:
 - o September 12, 2023 (9:30 a.m.) Development and Property Committee
 - September 12, 2023 (1:00 p.m.) Operations Committee
 - September 13, 2023 (9:30 a.m.) Health Committee
 - September 13, 2023 (1:00 p.m.) Community Services Committee
 - o September 14, 2023 (9:30 a.m.) Finance and Administration Committee
- County Council passed a resolution approving the 2023 membership fee to the Federation of Canadian Municipalities (FCM) in the amount of \$23,093.95 including HST.
- County Council passed a resolution approving the use of \$112,879.25 from the existing Community Paramedic Reserve to cover the operating deficit within the Community Paramedic Long-Term Care Program as of December 31, 2022.
- Several by-laws were passed in relation to the 2023 Tax Policy:



- A by-law to set tax ratios for County and lower-tier purposes.
- A by-law to include a revenue neutral ratio for the Landfill class at 1.189066.
- A by-law to approve a final reduction in the Broad Industrial Ratio down to the Provincial Threshold of 2.63, which was phased in over a 2-year period beginning with the 2022 taxation cycle.
- County Council adopted a by-law to establish the 2023 Tax Rates for County of Renfrew purposes.

Community Services Committee

Presented by: Anne Giardini, Chair

- The Renfrew County Housing Corporation has demolished a single-family unit structure located at 202 Cecil Street, Pembroke, Ontario as it was deemed to be uninhabitable due to significant structural deficiencies and evidence of mold. The Renfrew County Housing Corporation Board of Directors approved a proposal to construct a new two-unit structure at the location, prioritizing energy efficiency and accessibility. The cost for the contract to replace the original home and add an additional unit, which will be an increase to the RCHC portfolio, is covered under the Canada-Ontario Community Housing Initiative (COCHI) program funding through the Ministry of Municipal Affairs and Housing. The approved budget for design and build is \$545,471.
- County Council approved the transition of the two Licensed Home Visitor positions within the Child Care and Early Years Division from full-time equivalent (FTE) contract to full-time permanent with benefits.
- County Council approved an additional full-time permanent Inclusion Coordinator position with benefits within the Child Care and Early Years Division.
- County Council approved a by-law authorizing the County of Renfrew to enter into an agreement with child-care agencies and recreation programs for special needs resourcing funding be amended to enter into a special needs resourcing agreement with Wise Owl Child Care Centre.
- County Council approved a by-law authorizing the County of Renfrew to enter into an agreement with Tiffany Ploughman (Pembroke), to provide Licensed Home Child Care services.

Development & Property Committee

Presented by: James Brose, Chair

In partnership with the Township of Whitewater Region, the Economic Development Division is hosting the Ontario Ministry of Agriculture, Food, and Rural Affairs' (OMAFRA) <u>Community</u> <u>Economic Development 101 workshop</u> on Wednesday, May 3 from 9:00 a.m. to 12:00 p.m. at the Cobden Legion. Presented by Economic and Business Advisors from OMAFRA, the Community Economic Development 101 workshop aims to share the basics about economic development in a community and how the concepts can be applied in a municipal environment. Elected officials, economic development boards/committees, municipal staff and community leaders from across Renfrew County and the Ottawa Valley are encouraged to attend the free workshop.



- The Ontario East Municipal Conference will be held in Ottawa this year from September 6-8, 2023 at the Ottawa Conference and Events Centre and Courtyard Marriott Hotel. Register at: <u>Home Ontario East Municipal Conference (oemc.ca)</u>
- The Ottawa Valley Tourist Association (OVTA) engaged the services of the Culinary Tourism Alliance to develop the strategy, which was completed between August and December 2022. The strategy contains research and data, as well as a three-year action plan aimed to support the development, growth and awareness of the Ottawa Valley's culinary tourism offerings by focusing on four areas of opportunity including:
 - Improve stakeholder awareness and appreciation for regional food identities and foodways;
 - Increase business and marketing literacy, to grow the number of market-ready businesses within the culinary tourism value chain;
 - Support the development of new and/or enhanced culinary and agri-tourism experiences;
 - Increase awareness of the Ottawa Valley as a culinary destination through marketing efforts.

The <u>culinary tourism strategy</u> (Appendix II of the Development and Property Report) was presented to members and stakeholders at the OVTA tourism conference on April 25.

- County Council adopted a by-law authorizing the Warden and Clerk to enter into a formal agreement with the City of Pembroke and the Ottawa Valley Tourist Association with respect to ongoing financial and program participation in a Destination Marketing Organization (DMO) for a five-year term commencing on January 1, 2023.
- County Council adopted a by-law approving Official Plan Amendment No. 35 (OPA 35). OPA 35 was drafted as a result of Provincial amendments to the Planning Act under Bill 109 "More Homes for Everyone Act, 2022" and Bill 23 "More Homes Built Faster Act, 2022". Among many changes, Bill 109 would implement financial penalties on municipalities in the form of application refunds if applications (Zoning, Official Plan, and Site Plan) were not processed within specific time periods.

Bill 109 did not change the municipalities' responsibility for the review of planning applications, however, did change the timeframe that municipalities have to make a decision on a complete application. The proposed revised process is already implemented in many municipalities across Ontario and will likely become "industry standard" moving forward. While staff understands that a few of the proposed amendments implementing Bill 109 have been appealed to the Ontario Land Tribunal, the majority have not been appealed and are in effect including the Town of Petawawa and the Township of Laurentian Valley. The amendment was circulated and provided to the Ministry of Municipal Affairs and Housing. The Ministry did not indicate any concerns with the enhanced or "front-ended" pre-consultation review proposed in OPA 35.

- County Council passed a resolution requesting a letter be sent under the Warden's signature expressing the County of Renfrew's support to Videotron | Freedom Mobile in their intent to submit a request for funding to build and upgrade fibre transport network in Renfrew County through the CRTC Broadband fund.
- County Council passed a resolution directing staff to continue engagement with local municipalities regarding potential impacts as a result of the proposed Bill 97 "Helping Homebuyers, Protecting Tenants Act" and the changes to Provincial Policy Statement.



Health Committee

Presented by: Michael Donohue, Chair

- On Friday, March 24, 2023 at the Renfrew Paramedic Base, Renfrew-Nipissing-Pembroke MPP John Yakabuski announced that the Renfrew County Virtual Triage and Assessment Centre (RC VTAC) will become a permanent service in the County of Renfrew, with an initial annual investment by the provincial government of \$3.2 million in 2023-24. Council reviewed a letter from Mr. Evan Mills, Director, Digital Health Program Branch, Digital and Analytics Strategy Division, confirming the operational funding for 2023-24.
- County Council reviewed a letter and funding schedule from Assistant Deputy Minister Susan Picarello, providing funding details for COVID-19 response in the emergency health services sector. The County of Renfrew Paramedic Service will receive one-time funding of up to \$1.2 for 2022 calendar year and \$357,470 for January to March 2023.
- County of Renfrew Long Care Homes will undergo the Accreditation Canada Survey process June 26 to June 29, 2023. Members of the Health Committee recently completed the Renfrew County Long Term Care Homes Accreditation Canada Governance survey. The results were reviewed by Council along with an action plan setting out how compliance will be achieved.
- County Council adopted a by-law authorizing the Warden and CAO/Clerk to sign the Lease Agreement and letter of agreement between the County of Renfrew and Carefor Health and Community Services to lease office space at 425 Cecelia Street, Pembroke for tenancy of the Renfrew County Virtual Triage and Assessment Centre for a term of one year: April 1, 2023 March 31, 2024.
- County Council adopted a by-law authorizing the Warden and Chief Administrative Officer/Clerk to sign the Long-Term Care Service Accountability Agreements from April 1, 2023 until March 31, 2024 between Ontario Health and Bonnechere Manor and Miramichi Lodge for submission by April 27, 2023.
- County Council adopted a by-law authorizing the Warden and Chief Administrative Officer/Clerk to sign the Multi-Sector Service Accountability Agreement from April 1, 2023 to March 31, 2024 between Ontario Health and Bonnechere Manor Senior/Adult Day Program for submission by April 27, 2023.

Operations Committee

Presented by: Glenn Doncaster, Chair

- The Fire Dispatch System for the County of Renfrew located at the Central Ambulance Communications Centre (CACC) in the Town of Renfrew is at its end of life and requires upgrading. The system is used to dispatch 18 Fire Departments within the County of Renfrew (with the exception of Arnprior) and includes the City of Pembroke and the Algonquins of Pikwakanagan First Nation. BearCom, which maintains the equipment, has provided a quote in the amount of \$318,710 plus taxes to replace the equipment. As this purchase is unbudgeted for in 2023, staff has been directed to develop a business case and explore options for the County of Renfrew's Fire Dispatch System for Council consideration.
- The reconstruction of County Road 512 (Foymount Road) is being impacted due to the delays in the relocation of utility poles on the road. The Design Consultant has recommended that the



tender for the road works in 2023 include both Part 1 [from Harrington Creek (B257) to Buelow Road (2.88km long)] and Part 2 [from Buelow Road to Miller Road (3.96km long)], but specify a completion date in 2024. The tender would note the operational constraints as follows:

- Utility relocations for Part 2 will not be complete until October 1, 2023 (this is a conservative date to make sure utilities will be done);
- No section of roadway shall be left without base course asphalt over any winter shutdown period;
- All paving shall be completed prior to November 15, 2023.

Staff has requested that the consultant proceed with tender preparation on this basis; and is continuing discussions with Hydro One and Bell to attempt to move up the October 1 utility date to complete as much road works as possible in 2023.

- County Council passed a resolution requesting the Warden write a letter to Garrison Petawawa endorsing the construction of a roundabout on County Road 51 (Petawawa Boulevard) at the gate leading into Garrison Petawawa and that a second letter be written advising that the County of Renfrew will be responsible for the asset once completed, however, indicating it is not in a position to provide financial contributions to this project.
- County Council approved removing County Road 24 (White Water Road) from Stafford Third Line to Highway 17 at a budget of \$1,309,911 from the 2023 Capital Budget and further adding County Road 4 (Storyland Road) from County Road 653 (Chenaux Road) to Alex Lane to the 2023 Capital Budget in the amount of \$1,309,911.
- County Council approved a reduction of the 2023 Capital Budget allocation for County Structure C325 (Neilson Creek Culvert) from \$450,000 to \$31,000 and the addition of County Structure C168 (Lake Clear Tri Culverts) to the 2023 Capital Budget in the amount of \$419,000.
- County Council approved the fees associated with signage permits be altered from their existing values to \$450 for a three-year permit. This fee structure is for private advertising signage within a County Road allowance. The change would require a greater level of commitment from businesses when considering placing signage within a County Road allowance, however, would also reduce the level of burden placed on staff in administering the program.
- County Council adopted a by-law appointing Mr. Richard Bolduc as Weed Inspector for the County of Renfrew.
- County Council approved a number of contracts as submitted:
 - For the rehabilitation of County Structure B310 (Ski Hill Bridge) located on County Road
 58 (Round Lake Road) in the Township of Laurentian Valley, to Bonnechere Excavating
 Inc. (BEI), Renfrew, Ontario in the amount of \$847,082 plus HST.
 - For the manufacture, supply, and delivery of a single glass reinforced plastic pipe liner for County Structure C197 (Etmanskie Swamp Culvert) located on County Road 62 (John Street), Township of Madawaska Valley, to Channeline International Fiber Glass Manufacturing LLC, Dubai in the amount of \$332,408 plus applicable taxes.
 - For rehabilitation of County Structure B044 (Douglas Bridge) located on County Road 5 (Stone Road), Township of Admaston/Bromley, to Bonnechere Excavating Inc. (BEI), Renfrew, Ontario in the amount of \$741,223 plus HST.
 - For rehabilitation of County Road 37 (Murphy Road) from Portage Road to Woodland Crescent, a distance of 1.20 km in the Town of Petawawa, to H&H Construction Inc., Petawawa, Ontario in the amount of \$710,091.74 plus HST.
 - For pavement markings in the amount of \$650,117.40 plus HST to Trillium Pavement Marking, Carleton Place, Ontario.



- County Council adopted a by-law restricting the weight of vehicles passing over bridges in the County of Renfrew. Since a by-law was initially passed in 2021 setting out bridges requiring load postings, major rehabilitation or reconstruction has taken place to bring some of the structures into compliance.
- County Council adopted a by-law approving Corporate Policy PW-02 Bridges which outlines the criteria for new, existing or replaced bridges to be considered for County of Renfrew structures. Amendments to Policy PW-02 Bridges include the removal of the requirement for County structures to be located on maintained roads; a stipulation that the design for County structures on seasonal roads include a review of potential removal for Council's consideration; and greater description of design, construction, and maintenance responsibilities on County Structures. Comments received from the local municipalities have been incorporated into the Policy.
- County Council adopted a by-law authorizing the execution of a Road Access Agreement to County Road 56 (Woito Station Road) in the Township of North Algona Wilberforce between Tera Dojczman and Jacob Dojczman and the County of Renfrew.
- County Council adopted a by-law to Amend By-law No. 7-21, being a by-law to Regulate the Operation of Off-Road Vehicles on County of Renfrew Roads to remove restrictions for Off-Road Vehicles from County Road 72 (Ridge Road) and County Road 73 (Deep River Road). This is in response to a request from the Town of Deep River.
- County Council adopted a by-law approving the 'Class A' estimate by Hydro One for the relocation of the lines along the corridor of County Road 512 (Foymount Road), between Buelow Road and Miller Road, Township of Bonnechere Valley, in the amount of \$423,740.13 plus applicable taxes.

Flood Water Safety

The Ministry of Natural Resources and Forestry has issued a Flood Warning for <u>Pembroke District</u> and <u>Bancroft District</u>; this includes Renfrew County, and the Township of South Algonquin. Rising water levels may pose a threat to the health and safety of residents.

Flood water and water ponding around wells can affect the safety of your drinking water. Renfrew County and District Health Unit is recommending that residents with water wells **in contact with flood water**:

- 1. boil their water for one minute at a rolling boil before drinking, food preparation or brushing teeth with the water,
- 2. use bottled water or,
- 3. use water from an alternate potable water source.

Well water should be tested for bacteria after flood waters recede. Water sample bottles can be picked up and dropped off at the Renfrew County and District Health Unit. For more locations, visit <u>https://www.rcdhu.com/healthy-living/safe-water/</u>.

During floods, the ground can become saturated, preventing proper operation of septic systems. If your septic system has been affected, avoid using the septic system if possible, or reduce the amount of water used by limiting toilet flushing, dishwashing, washing clothes, and showering.

Do not pump your septic system when the ground around it is still saturated. High ground water levels may cause an empty septic tank to float out of the ground and damage the inlet and outlet fittings.

Flood waters can be contaminated with sewage and cause illness. The following tips will help protect your family during flooding events:

- Keep your family safe by keeping family members and pets away from and out of the flood water.
- DO NOT enter areas where electrical systems have been affected by flood water, as there is a risk of electrocution. Always wait for clearance from an electrical authority before entering these areas.
- Building materials, clothing and furniture exposed to flood waters may be contaminated with sewage or other hazards and can support the growth of mould. Some items can be cleaned and disinfected; others may need to be thrown out.

Here is an update from Cogeco that you are welcome to share with your residents via a website update and/or in a newsletter.

Cogeco bringing fibre-to-the-home to Arnprior


Starting in 2019, Cogeco began a fibre backbone project in partnership with Innovation, Science, and Economic Development (ISED) as part of their Connect to Innovate (CTI) program. This project is the crucial first step to providing high-speed Internet in the region, as it establishes a fibre connection between Petawawa and Deep River/Chalk River, providing increased bandwidth. As this project is nearing completion, with the final components planned for Spring 2023, Cogeco now intends to move into Phase 2 for the area.

As part of Infrastructure Ontario's Accelerated High Speed Internet Program (AHSIP), Cogeco will be expanding its high-speed broadband services to almost 6,000 premises across Arnprior, Deep River, Head, Clara & Maria, Laurentian Hills, Laurentian Valley, Petawawa, and Whitewater Region with a predominantly fibre-to-the-home solution.

Design work is now underway, and full project completion is planned for December 2025, with Cogeco's goal of having some homes progressively serviceable by the end of 2024. Further details, including specific communities within the scope of work, will be communicated as the design work progresses and permitting begins.

The attached graphic identifies the stages of our network expansion process and are welcome to include this in your update.
