# To Build More Homes, Ontario Launching Building Faster Fund and Expanding Strong Mayor Powers

Three-year, \$1.2 billion fund will reward municipalities that deliver on housing targets

August 21, 2023

LONDON — To reward municipalities that build homes, the Ontario government is launching the Building Faster Fund, a new three-year, \$1.2 billion program that provides significant new funding based on performance against provincial housing targets. To ensure more municipalities have the tools needed to build homes and to expand eligibility for the Building Faster Fund, the province is also expanding strong mayor powers to municipalities projected to have populations of 50,000 or larger by 2031 that commit to meeting their provincial targets.

"With these new measures, we're supporting municipalities and giving them the tools they need to build more homes faster to tackle the affordability crisis that's pricing too many people, especially young families and newcomers, out of the dream of home ownership," said Premier Doug Ford. "We have two choices: We can sit back and ignore the crisis, or we can build more homes. Our government is choosing to build homes."

The Building Faster Fund will provide \$400 million in new annual funding for three years to municipalities that are on target to meet provincial housing targets by 2031. Municipalities that reach 80 per cent of their annual target each year will become eligible for funding based on their share of the overall goal of 1.5 million homes. Municipalities that exceed their target will receive a bonus on top of their allocation.

Funding from the Building Faster Fund can be directed toward housing-enabling infrastructure and other related costs that support community growth. Eligible expenses will be determined following consultations between the province, the Association of Municipalities of Ontario, the City of Toronto and the Housing Supply Action Plan Implementation Team. A portion of the overall funding will also be

allocated to single and lower tier municipalities that have not been assigned a housing target, including small, rural and northern communities, in order to address their unique needs, following municipal consultations.

Ontario is also expanding strong mayor powers to 21 more municipalities that are projected to have populations of 50,000 by 2031 and whose heads of council are committed to a provincially assigned housing target. The expansion of strong mayor powers will take effect on October 31, 2023. The expansion is in addition to the 28 municipalities that already have strong mayor powers, having committed to targets through municipal housing pledges. Once a housing pledge is received from the head of council, these municipalities will also become eligible for and will have access to the Building Faster Fund.

"There is an urgent need to get more homes built quickly across Ontario," said Minister of Municipal Affairs and Housing Steve Clark. "By providing additional financial resources to our municipal partners as well as strong mayor powers to help speed up the approvals process, our government is acting decisively to tackle Ontario's housing supply crisis and build the homes our residents need and deserve."

#### **Quick Facts**

- The 29 municipalities assigned housing targets in 2022 and the 21 municipalities with newly assigned housing targets represent more than 88 per cent of the provincial target of 1.5 million homes.
- Municipal housing pledges identify the tools and strategies that municipalities intend to use to achieve their housing targets as part of the ongoing work to increase housing supply. Municipalities with housing targets must submit a pledge to access the Building Faster Fund.
- An eligible municipality would receive no funding if it is below 80 per cent of its annual assigned target. However, it would receive up to 100 per cent of allocated funding if it is on track to meet its target and could receive potential bonus funding if it exceeds that.
- In 2022, Ontario saw the <u>second-highest number of housing starts since 1988</u>, with just over 96,000 new homes. Ontario also broke ground on nearly 15,000 new purpose-built rentals, the highest number ever on record.

# Ontario Providing New Tools to Municipalities to Build More Homes Sooner

August 21, 2023

The Ontario government has assigned housing targets to 21 additional municipalities as part of its plan to build at least 1.5 million homes by 2031. Once these municipalities, through their heads of council, have pledged to achieve their targets, they will have access to the new Building Faster Fund, which will reward municipalities that are on track to meet their housing targets.

## **Building Faster Fund**

The three-year, \$1.2 billion fund will provide up to \$400 million per year to municipalities that have committed in writing to achieve their overall 2031 housing target. Ten per cent of the overall funding will be reserved for small, rural and northern communities that have not yet been assigned a housing target by the province to support unique needs and circumstances.

For municipalities with targets, each municipality's portion of the \$400 million annually will be determined based on their share of the greater provincial housing supply goal, as well as their performance compared to their annual assigned targets. For example, if a municipality's target represents 10 per cent of the province-wide target, that municipality will be eligible for 10 per cent of funding through the Building Faster Fund.

Performance will be evaluated by comparing the municipality's number of housing starts and additional residential units created in a given calendar year against the annual target. Municipalities that are achieving 80 per cent or more of their annual target will be able to access a portion of their allocation. Those that exceed their target will be eligible to receive additional funding. Municipalities that are not achieving at least 80 per cent of their annual target will receive no funding.

If a municipality has a total housing target of 150,000 homes by 2031, this represents 10 per cent of Ontario's target of 1.5 million homes and makes them eligible for \$40 million in annual funding, plus bonus. The Building Faster Fund provides double the funding for every one per cent above 100 per cent of a municipality's target.

If this municipality hits 80 per cent of their annual housing target, they receive \$32 million (\$40 million x 80% = \$32 million).

If this municipality hits 90 per cent of their annual housing target, they receive \$36 million (\$40 million x 90% = \$36 million).

If this municipality hits 105 per cent of their annual housing target, they receive \$44 million (\$40 million x  $100\% + (5\% \times 2 = 10\%) = $44$  million).

If this municipality hits 110 per cent of their annual housing target, they receive \$48 million (\$40 million x  $100\% + (10\% \times 2 = 20\%) = $48$  million)

For the first year of the program, 2023, province-wide housing targets will start at 110,000 new housing starts, which would represent a historic year for Ontario. From there, housing targets will ramp up over time until the province is on track to achieve at least 1.5 million homes by 2031.

## **Expanding Strong Mayor Powers**

Municipalities with targets would also be given strong mayor powers if their head of council has committed to meeting these targets, in writing, by October 15, 2023. These municipalities would then receive strong mayor powers by October 31, 2023 and would be eligible for the Building Faster Fund.

There are now 50 municipalities with assigned municipal housing targets in Ontario:

## Ontario Investing in a Stronger Public Health Sector

Province also increasing funding to municipalities to connect people to paramedics and ambulance services faster

August 22, 2023

LONDON — The Ontario government is taking an important step forward to deliver on <u>Your Health: A Plan for Connected and Convenient Care</u> by increasing provincial funding for public health agencies to build a robust public health sector that has the support and resources needed to connect people to faster, more convenient care in their communities.

Starting January 1, 2024, the province will restore \$47 million in provincial annual base funding for public health units, which is the level previously provided under the 75 per cent provincial / 25 per cent municipal cost-share ratio. The province is also providing local public health units an annual one per cent funding increase over the next, three years so they can more effectively plan ahead and prepare. This will also allow time for the province to collaborate with municipalities on a longer-term sustainable funding agreement that will not put any additional financial burden on municipalities.

"Building a stronger public health system, with more convenient and consistent access to public health services, is one more way our government is connecting people in Ontario to health care closer to home," said Sylvia Jones, Deputy Premier and Minister of Health. "The pandemic showed that we need a stronger public health system and this increased funding will help to create a more connected public health system that will support Ontario communities for years to come."

The province will also work with its partners to refine and clarify the roles of local public health units, to reduce overlap of services and focus resources on improving people's access to programs and services close to home. One-time funding, resources and supports will be offered to local public health agencies that voluntarily merge to streamline and reinvest back into expanding programs and services.

To connect people to emergency care faster and increase the availability of paramedics and ambulances in communities, Ontario is increasing land ambulance funding to municipalities by an average of six per cent, bringing the province's total investment this year to over \$811 million.

The province is also investing an additional \$51 million into the Dedicated Offload Nurses Program over the next three years which helps reduce delays paramedics encounter dropping off patients at a hospital and allows them to get back out into the community faster. This investment will help 30 municipalities cover around 800,000 dedicated hours to support offloading ambulance patients in the emergency department, ensuring paramedics can get back out in the community faster.

With <u>Your Health: A Plan for Connected and Convenient Care</u>, the government continues to take action to strengthen the health care system so that it is responsive and is evolving to meet the health needs and priorities of Ontarians, no matter where they live.

- Key public health lessons learned from the COVID-19 pandemic will inform how
  Ontario strengthens the public health sector, including the importance of local
  public health agencies having capacity to respond in a crisis, the benefit of
  collaboration across the health care system and the need for stability and
  sustainability to help local public health agencies plan for, and be able to
  respond to, ongoing and future crises and challenges.
- Provincial funding for local public health agencies to support the delivery of public health programs and services has increased by approximately 16 per cent since 2018.
- The province's 2023 investment of \$811 million in the Land Ambulance Services
   Grant represents an average funding increase of 11 per cent for municipalities
   over the last two years.
- Nearly 200 patient care models being led by more than 50 paramedic services across the province are now approved to provide more appropriate and timely care options for eligible 9-1-1 patients in the community instead of in the emergency department.
- Ontario is investing an additional <u>\$44 million</u> this year in 165 high volume and smaller emergency departments to reduce wait times and provide people with faster and easier access to timely care close to home.

# Ontario Investing an Additional \$160 Million to Train Workers

Province accepting proposals for solutions to help people on social assistance, including those with criminal records, find purpose-driven careers

DRESDEN — The Ontario government is investing an additional \$160 million in the Skills Development Fund (SDF) to tackle the labour shortage and help at least 100,000 workers get free training to meet the needs of employers hiring in their communities. The funding will prioritize programs that propose innovative training solutions to help people on social assistance and with prior criminal records find meaningful employment in critical industries like healthcare, auto-manufacturing, information technology, hospitality and the skilled trades.

"For too long, too many in our community have been forgotten and treated as second class in their own province. In the middle of a historic labour shortage, we need all hands on deck," said Monte McNaughton, Minister of Labour, Immigration, Training and Skills Development. "That is why our government is leaving no stone unturned to ensure we give anyone who wants a job and a paycheque they can be proud of a shot at the Ontario dream. Whether you've been on social assistance for 10 months or 10 years, we'll help you."

Roughly 300,000 jobs in Ontario are going unfilled every day, which threatens to hold back the economy and the government's ambitious infrastructure plans, including building at least 1.5 million homes by 2031. At the same time, more than 800,000 people in Ontario rely on social assistance when the majority are willing, able and eager to work. This includes hundreds of thousands of people who made a mistake in the past and carry a criminal record and have not reoffended – almost half of whom are on social assistance even 15 years after release from prison.

In response, the fourth round of the <u>Skills Development Fund</u> Training Stream will support programs that help them find meaningful work and tackle the labour shortage.

The announcement was made in Dresden, where the government announced a \$465,000 investment through a previous round of the Skills Development Fund Training Stream to prepare 24 young people for well-paying careers in construction and the skilled trades in Chatham-Kent. SkillShift will provide a free six-week introductory course that teaches participants essential skills for construction, such as blueprint reading, scissor lift certifications, as well as financial literacy and soft skills, with mentors, networking opportunities and \$1,125 for equipment and transportation. Participants will also receive a paid two-week job placement with a local employer.

"Through this transformative \$465,000 investment, the Government of Ontario is shaping brighter futures for 24 youth in Chatham-Kent while invigorating our local construction industry," said Phillip Mock, Executive Director at Vision Us. "Vision Us is excited to be leading this investment in our community with our partners."

Through its first three rounds, the Skills Development Fund has supported 596 projects in a variety of sectors, helping half a million people take the next step in their careers, including people with disabilities, auto workers, firefighters and construction workers.

"This \$465,000 investment in our youth through the Skills Development Fund is a transformative step," says Trevor Jones, MPP for Chatham-Kent-Leamington. "Empowering youth for rewarding careers in construction and skilled trades not only secures their future but also fuels the growth of Chatham-Kent-Leamington as a thriving community."

Today's announcement brings Ontario's total investment in the Skills Development Fund Training Stream to over \$860 million.

## **Ontario Preparing Students for Success**

Students and parents can expect updated curriculum, more support and staffing for new school year

August 28, 2023

TORONTO — The Ontario government is providing new student supports and updating curriculum for the 2023-24 school year. These actions will refocus school boards on the development of foundational skills in reading, writing and math, supported by almost \$700 million more in base education funding, \$109 million in a new strategy to boost literacy rates, and the hiring of 2,000 more educators.

"Our government is delivering on our commitment to continue to raise the bar by boosting student success in the classroom with a focus on reading, writing, math, STEM disciplines, and learning about mental health literacy," said Stephen Lecce, Minister of Education. "Our students deserve a stable and enjoyable school year with the full school experience of extracurriculars, clubs and more that build real life and job skills that go beyond the classroom."

Beginning this September, all publicly funded school boards will be required to adopt provincial student achievement priorities and metrics to:

- Help students improve EQAO scores in reading, writing and math;
- Prepare students for future success to raise graduation rates, encourage more students to participate in job skills programs and take senior math and science courses; and
- Improve student engagement and awareness of mental health supports.

To further support students facing challenges with math, Ontario is investing over \$71 million to launch the Math Action Achievement Plan, a strategy to boost math competence in the classroom and improve board accountability. This includes:

- One lead per school board with the focus of helping improve math outcomes for students. These leads will be responsible for curriculum implementation and standardized training and lead board-wide actions to meet targets.
- More than 300 math coaches will provide direct support in classrooms.

• New Math Action Teams will work directly with school boards to identify and recommend targeted strategies to improve student achievement.

To ensure students have the skills they need to compete and succeed, the province is investing more than \$100 million to hire over 940 educators to support students from Grades 7 to 10 transition to high school. Ontario also intends to fund \$1 million per year for two years beginning in 2024 for the Ontario Science Centre to create hands-on learning experiences and virtual lesson plans for students, as well as STEM teaching materials for educators.

For the 2023-24 school year, Ontario is introducing revamped curriculum supports to ensure student success including:

- Language Curriculum: Last updated in 2006/2007, the revised Language and Français Grade 1 to 9 curriculums include foundational instruction to support reading and writing, critical thinking, and digital media literacy skills.
- Educator Resources: The government has provided \$825,000 to Dyslexia Canada to develop, in partnership with International Dyslexia Association Ontario, evidence-based systematic and explicit instruction resources and learning supports that are now ready for use.
- Reading Screener and Supports: The province's \$109 million 2023-24 investment includes the largest screening program in Canada, funded with \$12.5 million annually to support students from Year 2 of Kindergarten to Grade 2 to be screened for early reading. Up to 700 literacy educators will work to support students who are behind in reading development.
- Grade 10 Digital Technology and Innovations in the Changing World: This course will equip students to be innovative leaders by teaching them how to apply coding concepts and skills, build hands-on projects, and investigate artificial intelligence, cybersecurity, and other emerging digital technologies.
- **Financial Literacy Modules:** Secondary students will learn how to create a budget, manage their money, protect themselves from financial scams, and plan for long-term purchases such as buying a house or car with new modules.
- Mental Health Modules: The Ontario government has partnered with School Mental Health Ontario in collaboration with the Hospital for Sick Children to develop Mental Health Literacy Modules, for teacher use in Grades 7 and 8.

These measures will improve transparency for parents and ensure Ontario's public education system continues to focus on improving student outcomes by providing them with the skills and tools they need to succeed, particularly in key areas like reading, writing and math.

#### **Quick Facts**

- Student mental health funding in schools is increasing to a historic \$114 million in 2023-24, representing an increase of 555 per cent since 2017-18.
- In April 2023, the Ontario government introduced a new <u>\$180-million reading</u> and math strategy to help students build the skills they need to succeed.
- As announced in the budget, the government will provide \$6.8 million over three years to support practical, hands-on experiences for students to further their financial literacy learning and growth.
- The Ontario government also <u>announced an accelerated apprenticeship</u> <u>pathway</u>, starting in Grade 11 that will help prepare students to access rewarding careers in the skilled trades. Consultations will begin in Fall 2023.

## Ontario Doubling Career Fairs to Help More Young People Enter Skilled Trades

Over 25,000 students in grades 7 to 12 will learn about exciting and in-demand careers close to home

August 31, 2023

TORONTO — The Ontario government is expanding its successful skilled trades career fairs, now in its second year, to even more cities with more exhibitors and twice as many participating students. Ontario will need over 100,000 new skilled trades workers this decade to help build the province, making it crucial for more young people to have the opportunity to unlock their potential in the trades. The new cities with career fairs this year are Hamilton, Windsor, Sault Ste. Marie, Oshawa and Dryden.

"Last year's career fairs were a phenomenal success, giving thousands of students and their families exposure to the many career opportunities in the skilled trades," said Premier Doug Ford. "As we make historic investments to build roads, transit, hospitals, schools and other critical infrastructure, these expanded fairs will help us attract more young people into the trades and develop the skilled workforce our growing province needs."

Level Up! is a series of dynamic, multi-day career fairs highlighting the 144 skilled trades, from electricians to boilermakers. Over 25,000 students in grades 7 to 12, as well as parents and jobseekers, will have the opportunity to learn about these trades through interactive exhibitions and hands-on activities while hearing directly from tradespeople and local employers. The first fair kicks off September 19 and 20 in Thunder Bay and will continue with fairs in communities across the province.

"For far too long, parents and students have been told the only way to succeed in life is by going to university – this is simply not true," said Monte McNaughton, Minister of Labour, Immigration, Training and Skills Development. "There are lucrative and purpose-driven careers waiting in the skilled trades where you can help build our province. Under Premier Doug Ford, we are giving more students the opportunity to learn about the life-changing careers in skilled trades that come with defined pensions and benefits."

"In an ever-changing global economy, we are seizing the opportunity to inspire students with hands-on learning in the skilled trades and increasing pathways to apprenticeship that better connect students to good-paying jobs," said Stephen Lecce, Minister of Education. "Our priority is to keep students in stable and normal classrooms, benefiting from a focus on strengthening foundational skills on reading, writing, math. This is supported by expanded career fairs and a new mandatory requirement that all students take at least one technological education course starting next year, so that students graduate into fulfilling careers of the jobs of tomorrow."

Additionally, Ontario is investing \$24 million for 2023-24 through the Apprenticeship Capital Grant program, helping 66 training institutions across Ontario upgrade their training equipment and existing facilities that support handson learning for students and apprentices.

Last month, the government announced apprenticeship registration increased by 24 per cent in the last year – from 21,971 to 27,319 – as more people joined the skilled trades, playing a role in building Ontario. This follows more than \$1 billion investment in the skilled trades over three years, along with the launch of Skilled Trades Ontario, as part of its strategy to attract more people into the trades.

- Nearly 300,000 jobs are going unfilled across the province, while one in five new job openings in Ontario will be in the skilled trades by 2025.
- 1.2 million people were working in skilled trades-related occupations in Ontario in 2022.
- Roughly one in three workers in Ontario with an apprenticeship or trade certificate is aged 55 or over and nearing retirement.
- The <u>Level Up! skilled trades career fairs</u> are open to all students, including First Nations schools. Last year, 12,800 students, parents, friends, and teachers visited the fairs.

- Most of Ontario's skilled trades initiatives are supported through labour market transfer agreements between the Government of Canada and the Government of Ontario.

## **Ontario Driving Economic Growth in Rural Communities**

Up to 80 projects receiving funding through the Rural Economic Development Program

**PETERBOROUGH** — The Ontario government is investing over \$4.3 million in up to 80 projects across the province through the latest intake of the Rural Economic Development (RED) Program. The RED program supports projects that diversify rural economies, retain skilled workers, and create jobs in local communities.

"Our government values rural communities throughout the province, and this program provides municipalities, Indigenous communities, and not-for-profits with the funding they need for projects that contribute to local economic vitality," said Lisa Thompson, Minister of Agriculture, Food and Rural Affairs. "The Rural Economic Development program is another example of how our government is ensuring small towns and communities across Ontario continue to share in the province's growth and economic prosperity."

In Peterborough, the Innovation Cluster is receiving up to \$73,750 for the launch of a new program that will support:

- The hiring of a project coordinator, as well as experts to train, consult, and advise entrepreneurs throughout the program
- The purchase or software subscriptions for virtual platform programming
- Hosting project events and workshops for the innovation and technology program
- The development and implementation of a marketing and promotional campaign with advertising to help support the innovation and technology program
- Creating opportunities to further facilitate the growth of entrepreneurs through networking events.

The project will positively impact rural Ontario by supporting entrepreneurship in the region, strengthening the skills of community members, preparing the next generation of entrepreneurs, and strengthening partnerships among the economic development community. "The Agri-food industry has been a key innovator in so many technologies that we take for granted in our everyday lives," said Dave Smith, Member of Provincial Parliament for Peterborough-Kawartha. "Good things grow in Ontario when we nurture local entrepreneurs and give them the tools they need to collaborate and innovate."

The RED program provides cost-share funding support towards activities that create strong rural communities. This includes funding assistance to build local capacity and improve job prospects. The program aligns with the government's priorities of removing barriers to investment, opening doors to rural economic development, and creating good jobs across the province.




