#### The Corporation of the Town of Amprior

### By-law Number 7457-24

A by-law to authorize the Corporation of the Town of Arnprior to enter into a Transfer Payment Amending Agreement with His Majesty the King in Right of Ontario as represented by the Minister of Infrastructure, for an approved scope change to the original Investing in Canada Infrastructure Program (ICIP) COVID-19 Resilience Infrastructure Stream submission (Growing Outdoor Play in Arnprior - Legion and Caruso Park).

Whereas the Town of Arnprior entered into a transfer payment agreement with the Province of Ontario, under the ICIP COVID-19 Resilience Infrastructure Stream, in October 2021, for two (2) projects: Growing Outdoor Play in Arnprior – Legion Park; Growing Outdoor Play in Arnprior – Caruso Park; and

**Whereas** the Town of Arnprior has applied to the Province of Ontario, for a project timeline extension, under the ICIP COVID-19 Resilience Infrastructure Stream Submission for these two projects; and

**Whereas** the Province of Ontario has granted approval for the timeline extension, through amendment to the original Transfer Payment Agreement, titled "Amending Agreement No. 1" which states a new proposed date for the projects to be substantially completed being December 31, 2024; and

**Whereas** Council deems it expedient to move forward with authorizing an amended agreement for these projects.

**Therefore**, the Council of the Town of Amprior enacts as follows:

- 1. That the Mayor and Deputy Clerk are hereby authorized for and in the name of the Corporation of the Town of Arnprior to execute and to affix the seal of the Corporation to the amending agreement in the form attached hereto as Appendix A between the Corporation of the Town of Arnprior and His Majesty the King in right of Ontario.
- **2.** That the agreement attached hereto and annotated as Appendix A is hereby deemed to be a term of this by-law.
- 3. That this By-law shall come into force and effect on the day of its passing.

- 1. The Province and the Recipient entered into an agreement effective as of October 8, 2021.

**IN CONSIDERATION** of the mutual covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

- 1. Capitalized terms used but not defined in Amending Agreement No. 1 have the meanings ascribed to them in the Agreement.
- 2. Section A.3.2. (Substantial Completion) of Schedule "A" (General Terms and Conditions) of the Agreement is deleted and replaced with the following:
  - A.3.2. **Substantial Completion**. The Recipient will ensure that each Project set out below is Substantially Completed on or before the associated date set out below:

- Section F.1.1 (Recipient's Participation in Project and ICIP Evaluations) of Schedule "F" (Evaluation) of the Agreement is deleted and replaced with the following:
  - F.1.1 Recipient's Participation in Project and ICIP Evaluations. The Recipient understands that the Province or Canada, or both, may ask the Recipient to participate in one or more evaluations in respect of any Project or the ICIP during and for a period of up to six years after the Substantial Completion date. The Recipient agrees, if asked and at its own expense, to provide Project-related information to the Province or Canada, or both, for any evaluation. Please refer to the section A3.2 for substantial completion date.
- 7. This Amending Agreement No. 1 shall be effective as of the date set out at the top of the Amending Agreement No. 1.
- 8. Except for the amendments provided for in Amending Agreement No. 1, all provisions in the Agreement shall remain in full force and effect.
- This Amending Agreement No. 1 may be signed in any number of counterparts, each of which will be deemed to be an original, but all of which will constitute one and the same instrument.
- 10. This Amending Agreement No. 1 may be validly executed electronically, and the respective electronic signatures are the legal equivalent of manual signatures. The electronic or manual signature of a Party may be evidenced by one of the following means, and transmission of this Amending Agreement No. 1 may be brought about as follows:
  - (i) a manual signature of an authorized signing representative placed in the respective signature line of this Amending Agreement No. 1 and it is scanned as a PDF file and delivered by email to the other Party;
  - (ii) a digital signature, including the name of the authorized signing representative is typed in the respective signature line of the Amending Agreement No. 1, an image of a manual signature or an Adobe esignature of an authorized signing representative, or any other digital signature of an authorized signing representative with the other Party's prior written consent, is placed in the respective signature line of this Amending Agreement No. 1 and it is delivered by email to the other Party; or
  - (iii) any other means with the other Party's prior written consent.
