#### Good morning,

I'm pleased to inform you that, in partnership with Natural Resources Canada (NRCan), the Ministry of Natural Resources (MNR) is now accepting applications from municipalities, Indigenous communities, planning authorities and conservation authorities to participate in the extension of the Flood Hazard Identification and Mapping Program (FHIMP), where up to 50% matched federal funding can be received for eligible flood mapping projects. The extension of the FHIMP through 2028 builds on the success of the program in Ontario to date, whereby 56 projects across 36 organizations were funded.

Project proposals can now be made under two funding streams:

- For proposals where any funds are requested prior to February 2025, applications will be accepted until 4:30 pm EST on October 9, 2024. This may include multi-year projects.
- 2. Where funds are not requested until or after February 2025, applications may be submitted through April 2027. This funding stream will remain open until that time, or until all funding has been allocated. Both single year and multi-year project proposals are eligible.

All funding is available on a first come, first serve basis, with applications being assessed against eligibility criteria.

Increasing the accuracy of publicly accessible flood maps in the province will inform land use planning decisions by helping reduce risks to people and property, directing development away from flood-prone areas, and providing certainty for developers and property owners. Eligible projects include those that support:

- flood hazard assessment, priority setting and scoping;
- the acquisition of data used in hydrological and hydraulic modeling;
- the development of flood hazard modelling and mapping;
- the dissemination of flood hazard information;
- NEW! erosion hazard studies, if they are included as part of a flood study;
   and

 NEW! regional modelling and mapping (completed at coarse level resolution).

I am also pleased to inform you that MNR continues to acquire lidar data under the Ontario Elevation Mapping Program. If you are planning to include lidar as part of your FHIMP proposal, please contact MNR's Geospatial Ontario section at pmu@ontario.ca.

To support the application process, we will be hosting two identical information webinars, which will cover information such as the application process, technical requirements, and program changes. Dates for these webinars are:

# Convenience Stores Across Ontario Can Now Sell Beer, Wine, Cider and Ready-to-Drink Beverages

Expansion delivers on government's promise to give people more choice and convenience

September 05, 2024

TORONTO — Starting today, all licensed convenience stores in Ontario can sell beer, cider, wine and ready-to-drink alcoholic beverages, marking the largest expansion of consumer choice and convenience in provincial alcohol sales since the end of prohibition almost 100 years ago. As of September 5, 4,187 <u>convenience</u> <u>stores across Ontario are licensed to sell alcoholic beverages</u>, in addition to nearly 3,000 other licensed retail outlets as well as takeaway options from licensed bars and restaurants.

"Today's expansion delivers on our government's promise to give people in Ontario the same choice and convenience enjoyed by people throughout the rest of Canada," said Premier Doug Ford. "With today's announcement, we're also creating new opportunities to produce and sell world-class Ontario-made beer, wine and ready-to-drink beverages in nearly 4,200 convenience stores across the province."

The government's phased expansion, which began earlier this year, is giving customers across Ontario more choice and convenience, supporting businesses and helping to promote Ontario-made beverage producers. By the end of October 2024, as part of the government's plan to expand alcohol sales, every eligible convenience, grocery and big-box grocery store in Ontario will be able to sell beer, cider, wine and ready-to-drink alcoholic beverages if they choose to do so.

"People finally have more options to responsibly and conveniently support local Ontario breweries and wineries – or whatever their drink-of-choice may be – even closer to home, and today's announcement is another milestone in the government's commitment to deliver more choice and convenience to consumers," said Peter Bethlenfalvy, Minister of Finance. "In addition to supporting Ontario retailers, domestic producers and workers in the alcohol industry, our vision for a better marketplace has come to life thanks to people and businesses across the province."

The government is also permanently allowing the transfer of wine and spirits between locations with the same owner and/or affiliated licensees in order to help bars and restaurants effectively manage inventory, and is allowing licensed grocery and convenience stores to display alcoholic beverages in multiple areas of a store, while maintaining small-producer shelf space requirements as well as policies that will continue to ensure the safe and responsible sale of alcohol.

The government will continue to work closely with the Liquor Control Board of Ontario (LCBO), the Alcohol and Gaming Commission of Ontario (AGCO) and The Beer Store, in addition to consulting and meeting with industry partners, local beverage alcohol producers and other stakeholders as it completes the launch of this new marketplace.

# **Quick Facts**

- To support a vibrant beverage alcohol industry, at least 20 per cent of the beer, cider, wine and ready-to-drink beverages on display in grocery and convenience stores must be produced by craft producers.
- The government is enhancing protections for winery retail stores, offering
  additional support to the local industry. These time-limited measures are
  designed to incentivize the co-location of these stores and ensure their viability
  in the evolving alcohol marketplace. The measures include extending
  protections and incentives for co-located winery retail stores until January 1,
  2036 and enabling co-located winery retail stores to offer home delivery
  services.
- Over time, Ontario's new, more open marketplace will introduce up to an estimated 8,500 new stores where these products can be sold.

# Ontario Laying the Groundwork for New Investments and Good-Paying Jobs

September 06, 2024

Economic Development, Job Creation and Trade

TORONTO — Vic Fedeli, Minister of Economic Development, Job Creation and Trade, issued the following statement on today's monthly employment release by Statistics Canada, which showed that while employment in Ontario dipped last month, the province has added more than 150,000 jobs so far this year.

"As we continue to face ongoing economic headwinds, our government is on a mission to rebuild Ontario's economy while keeping costs down for workers and families.

Across the province, we're continuing to get shovels in the ground for infrastructure projects that will drive economic growth and job creation for decades to come. We're spending nearly \$100 billion to expand our transportation infrastructure; investing in critical housing-enabling projects to help bring the dream of home ownership within reach for more people; training and up-skilling hundreds of thousands of workers for the jobs of the future; and, last month, launched the largest competitive energy procurement in Ontario history to ensure families and business have access to affordable electricity amid rising demand.

These investments, along with our competitive business environment, are already showing strong returns. Last month, we celebrated another major milestone in our auto sector. Building on the \$44 billion in electric vehicle and battery investments attracted over the past four years, <u>Goodyear Canada Inc.</u> announced a \$575 million investment to modernize and expand its tire manufacturing plant in Napanee. The project will create 200 new, highly skilled manufacturing jobs by 2027 and secure more than 1,000 jobs in Napanee.

Our government remains laser focused on laying the groundwork for new investments, better jobs and bigger paycheques in auto, tech, life sciences and other key sectors. We're going to continue supporting Ontario workers and families."

# Province Renames Ontario Medal for Good Citizenship

Medal redesignated to honour Her Late Majesty Queen Elizabeth II

September 08, 2024

TORONTO — Today, on the second anniversary of the passing of Her Late Majesty Queen Elizabeth II, the provincial government is renaming the Ontario Medal for Good Citizenship (OMGC) to the Queen Elizabeth II Ontario Medal for Good Citizenship (QEIIOMGC). The renaming of this provincial medal of merit celebrates the connection between those who are bestowed this honour and Her Late Majesty's sense of duty and exemplary lifetime of service.

The Ontario Medal for Good Citizenship was first presented by Queen Elizabeth II during a Royal Visit to Ontario in 1973. Since then, 573 Ontarians have received this honour, recognizing the many ways they have driven positive change in their communities and helped build a stronger province.

"The new name for this honour is a tribute to the strong connections forged between Her Late Majesty and our province during her long and extraordinary reign," said the Honourable Edith Dumont, Lieutenant Governor of Ontario. "The renamed medal will ensure her legacy of service will continue to inspire Ontario's volunteers and civic leaders for generations to come."

Applications are now open until January 15, 2025 and Ontarians are encouraged to submit nominations through the program's <u>application portal</u>. Nominating someone is easy and can be done in <u>three steps</u>: gathering the required information; creating an account on the <u>Ontario Honours and Awards Portal</u>; and submitting the application on the portal.

"Her Late Majesty Queen Elizabeth II led a life of leadership and exceptional service," said Michael Ford, Minister of Citizenship and Multiculturalism. "The redesignation of the Ontario Medal for Good Citizenship will ensure Her Majesty's legacy continues to live on through this provincial medal of merit and its recipients."

To be eligible for this honour, the nominated individuals must stand as a model Ontarian who exemplifies civic-mindedness, integrity and community leadership. The nominee must be a resident of Ontario and have contributed to areas meaningful to the Late Queen Elizabeth II, such as: the environment; arts and culture; seniors; education and youth; community and civic engagement; health care and hospices; social clubs; history and heritage; sport and recreation, faith or animal care.

- The QEIIOMGC is Ontario's second highest civilian honour and is included in the <u>Canadian Honours Order of Precedence</u>.
- Since 1973, 573 remarkable individuals from across Ontario have been invested with the Ontario Medal for Good Citizenship.
- The Ontario Medal for Good Citizenship was originally established in 1973 as an event for the Queen to participate in during her Royal Visit to Ontario when she visited Queen's Park.

# Ontario Driving Economic Growth in Rural Communities

Eighty-five projects receiving funding through the Rural Economic Development Program to help boost the local economy

BELLEVILLE – The Ontario government is investing more than \$5.7 million in 85 projects that are helping create jobs and boost economic development in rural communities across the province. The funding through the recent intake of the Rural Economic Development (RED) program supports projects that diversify and grow local economies, build community capacity and address barriers to economic development and labour force challenges.

"Our government values rural communities throughout the province and this program provides municipalities, Indigenous communities, and not-for-profits with essential funding for projects that contribute to local economic vitality," said Lisa Thompson, Minister of Rural Affairs. "The Rural Economic Development program is another example of how our government is ensuring small towns and communities across Ontario continue to share in the province's growth and economic prosperity."

In Belleville, the Belleville Downtown District Business Improvement Association (BIA) is receiving up to \$57,427 to launch a new program that will support the business community in the downtown area.

The BIA will develop an in-person Membership Care Program (MCP) that will work with member businesses to connect them to services such as the Welcoming Streets Program to address local challenges and provide training to businesses and their staff. The BIA will also hold town hall meetings to help manage communication between business and residents. This project will support the community by addressing labour force challenges and help attract and retain investment and businesses.

The Corporation of Prince Edward County is also receiving \$65,000 through the RED program for their Workforce Development Training for Community Benefit project. The funding will support the development of a community benefits framework to

address the need for a skilled local workforce and provide employment opportunities in the region. The project will involve developing and piloting the framework and rolling out the full training programs to residents based on the lessons learned from the pilot. The project will help create a pipeline of skilled workers through local training and skills development.

"Our government recognizes the need to prepare rural Ontario for expansion through the Rural Economic Development Program," said Steve Pinsonneault, Parliamentary Assistant to the Minister of Rural Affairs. "We are committed to supporting projects that continue to benefit rural communities. The projects we are investing in will incorporate the right tools necessary to help build the best possible future for the entire province."

"Our project would not have been possible without the generous support of the provincial government and we extend our deepest thanks for their commitment to rural community revitalization," said Danielle Hanoman, Executive Director, Belleville Downtown District BIA. "This is just the beginning of a renewed chapter for downtown Belleville, and I am confident that together, we will create a vibrant and thriving community that we can all be proud of."

The RED program provides cost-share funding support towards activities that create strong rural communities. This includes funding assistance to build local capacity and improve job prospects. The program aligns with the government's priorities of removing barriers to investment, opening doors to rural economic development, and creating good jobs across the province.

- Since 2019, the RED program has committed more than \$27.4 million to fund 473 projects that are helping to attract investment, create jobs, and boost economic development in rural communities across the province.

# Ontario Enhancing Tools to Help People Prepare for Respiratory Illness Season

Flu, COVID-19 vaccines and expanded RSV immunization program expected by early October for those at risk

TORONTO — The Ontario government is reminding everyone to stay safe this respiratory illness season and prevent unnecessary visits to the hospital by staying up to date on vaccinations. To protect against serious illness throughout the upcoming respiratory illness season, it is recommended everyone get their flu and COVID-19 shots as soon as they become available to them.

"As we approach this respiratory illness season, our government is ensuring Ontarians are prepared and have the tools they need to keep themselves and their loved ones safe and healthy," said Sylvia Jones, Deputy Premier and Minister of Health. "We are working closely with our partners to make it easier for people of all ages to be protected this fall and access the care they need close to home and within their community."

Starting in early October, flu shots will be available for the most vulnerable and high priority populations, including hospitalized individuals, hospital staff, and residents and staff in long-term care homes, followed by those in retirement homes and other congregate settings and individuals 65 years and older. Free flu shots for the general public aged six months and older will be available starting October 28, 2024, at doctor and nurse practitioner offices, participating pharmacies and some public health units. To learn more about the flu shot this fall, visit Ontario.ca/flu.

It is safe and convenient to receive both the COVID-19 and flu shots at the same time, reducing the need for multiple visits to a doctor, nurse practitioner or local pharmacy. Ontario expects to receive shipments of the updated COVID-19 vaccine from the federal government by early October following approval by Health Canada. Initial doses will be prioritized for higher risk populations and more details will be provided once doses are distributed to Ontario.

Beginning in October, families with infants and high-risk children up to 24 months old, will now have access to the <a href="new RSV">new RSV</a> immunization, Beyfortus®, through the recently expanded publicly funded RSV prevention program. Families can access the Beyfortus® immunization through their health care provider, as well as within hospital settings for infants born during the 2024/25 respiratory illness season. Pregnant women also have the option of receiving a single dose of Abrysvo®, to provide protection for their infant from birth to six months. The RSV prevention program has also expanded this fall to include all retirement home residents. For more details on the RSV program, visit <a href="Ontario.ca/rsv">Ontario.ca/rsv</a>.

"Staying up to date on vaccination helps everyone stay healthy this respiratory illness season, especially those who cannot protect themselves including younger children and others who can't be immunized," said Dr. Kieran Moore, Ontario's Chief Medical Officer of Health. "With a large rise in cases of whooping cough (pertussis) this year, particularly in children and teens aged 10-18, it is especially important for parents and guardians to ensure their children are up to date with all of their vaccinations as well as vaccines for pregnant individuals."

Vaccines in <u>Ontario's routine immunization schedule</u> are provided free of charge if you meet the eligibility criteria. If you are unsure about which immunizations you or your family have received or are eligible for, talk to your health care provider or <u>public health unit</u>.

Through <u>Your Health: A Plan for Connected and Convenient Care</u>, the Ontario government is providing people with the tools they need early to connect to the care they need to keep themselves, and their loved ones safe and healthy.

## **Quick Facts**

- As recommended by the National Advisory Committee on Immunization (NACI), individuals should receive the most recent formulation of the COVID-19 vaccine in the fall as it is expected to provide a better immune response against currently circulating COVID-19 strains. Full details on COVID-19 vaccination this fall will be available by visiting <a href="Ontario.ca/COVID-19">Ontario.ca/COVID-19</a>.
- The risk of severe outcomes from RSV infection is highest among infants under six months of age and children under 24 months of age with chronic conditions such as chronic lung disease, congenital heart disease, compromised immune systems, or neuromuscular disorders.
- All Ontarians should stay up to date on their immunizations, especially children. Talk to a health care provider or public health unit if you are unsure if your child

has missed routine immunizations or if you are unsure about which immunizations they have received.

- Vaccines in Ontario's routine immunization schedule are provided free of charge if you meet the eligibility criteria.
- Visit <u>Health811 online</u> or call 811 (TTY: <u>1-866-797-0007</u> toll free) for health advice and information 24 hours a day, seven days a week.

# Ontario Connecting People to Faster Emergency Care

Investments in emergency care reducing ambulance offload times by more than 50 per cent

September 12, 2024

**Health** 

HASTINGS — The Ontario government is investing over \$910 million to increase the availability of ambulances across the province and connect people and families to emergency care faster and closer to home.

"When someone experiences an emergency, it is vital that they receive the care they need as quickly as possible," said Sylvia Jones, Deputy Premier and Minister of Health. "By strengthening all aspects of the health care system and ensuring faster access to emergency care, our government is providing paramedics and emergency departments with the tools they need as we connect more people across the province to high-quality care, when they need it most."

Ontario is increasing land ambulance funding to municipalities by an average of eight per cent, bringing the province's total investment to over \$877 million this year, including over \$10.7 million in Land Ambulance Services Grant funding for Hastings County. This increase in base funding will help municipalities address increased costs so they can continue to deliver high-quality emergency care.

To further reduce delays paramedics encounter when dropping patients off at a hospital, Ontario is also investing over \$33 million through the Dedicated Offload Nurses Program to help hospitals hire more nurses and other eligible health professionals that are dedicated to offloading ambulance patients in hospital emergency departments.

This program allows paramedics to get back out into the community faster and respond to their next 9-1-1 call sooner and has played a significant role in reducing ambulance offload times and increasing ambulance availability for 9-1-1 patients across the province. As a result of this investment, provincial ambulance offload time has been reduced by more than 50 per cent since its peak in October 2022.

To ensure people receive urgent critical care sooner, Ontario is continuing to implement the Medical Priority Dispatch System (MPDS) across the province. The system helps prioritize and triage emergency medical calls to 9-1-1 so that paramedics can be dispatched sooner. Over the last year, the province has rolled out the system to Mississauga, Kenora, Thunder Bay, Ottawa and Renfrew. The province is now accelerating the system's implementation at the 15 remaining dispatch sites across Ontario by May 2027, over a year ahead of schedule.

With <u>Your Health: A Plan for Connected and Convenient Care</u>, the government continues to take action to strengthen the health care system so that it is responsive and is evolving to meet the health needs and priorities of Ontarians, no matter where they live.

- The government's additional investments in the Dedicated Offload Nurses
   Program over three years will help municipalities cover around 800,000
   dedicated hours to support offloading ambulance patients in the emergency
   department.
- Hastings County is receiving nearly \$400,000 in Dedicated Offload Nurses Program funding for 2024/25.
- Currently, over 200 patient care models led by paramedic services across the province are now approved to provide appropriate and timely care options for eligible 9-1-1 patients in the community, instead of in the emergency department.
- The government is helping more students who want to become paramedics by adding more than 300 spaces in paramedic programs at provincial colleges across Ontario, making it easier for future paramedics to access education and training closer to home.
- The <u>Ontario Learn and Stay Grant</u> is providing over 350 first-year paramedic students studying in <u>select Northern postsecondary institutions</u> with funding for free tuition, books, compulsory fees and other direct educational costs.
   After graduating, students will need to work in the same region they studied for a minimum of six months for every full year of study funded by the grant.

# **Ontario Strengthening Emergency Preparedness**

Applications are now open for the province's \$5 million Community Emergency Preparedness Grant

TORONTO — The Ontario government is expanding its support for local emergency readiness with a second round of funding for the <u>Community Emergency</u> <u>Preparedness Grant</u> (CEPG) for 2024-25. This new \$5 million investment will help equip municipalities and organizations with essential resources, equipment and training to better prepare for natural disasters and emergencies.

"Our government is ensuring that municipalities and community organizations across the province have the tools needed to face future challenges head-on," said Trevor Jones, Associate Minister of Emergency Preparedness and Response. "This funding will strengthen resilience across communities, providing essential emergency supplies, equipment and training. A safer, more prepared Ontario starts with ensuring our communities have the resources they need to respond effectively in times of crisis."

The CEPG is part of the government's three-year, \$110 million investment to strengthen emergency preparedness in Ontario, providing communities with the resources they need to stay safe, practiced and prepared. The next round of CEPG funding will be tailored to each recipient's unique needs and can be used for purchasing equipment such as generators, sandbagging machines, thermal imaging drones and radio systems. It can also be directed towards emergency management training and awareness initiatives.

Applications are open until October 31, 2024, 5:00 p.m. ET.

# **Quick Facts**

- Eligible applicants must be located in Ontario and include:
  - Small- and medium-sized municipalities (with populations under 100,000 people);
  - Local services boards established under the Northern Services Board Act;

- First Nations communities, Tribal Councils and Indigenous service organizations that support emergency management programming in First Nations communities;
- Non-governmental organizations with an emergency preparedness mandate or responsibility;
- Non-governmental organizations that provide fire protection services to communities;
- Non-municipal fire departments or entities providing fire protection services as defined in the *Fire Protection and Prevention Act* in unincorporated Ontario.
- In 2023-24, the \$5 million grant program supported 113 recipients across Ontario.
- Recipients who received funding in 2023-24 will be ineligible, allowing other communities and organizations from across Ontario to benefit from this program.
- Applicants must have a <u>My Ontario Account</u> and register for <u>Transfer Payment</u> Ontario.
- The province is hosting <u>information sessions</u> to help guide applicants through the application process. Participants must register in advance if they are interested in attending.

County Road 64 (Opeongo Road) - Bonnechere Valley Township

### Construction Update - September 5, 2024

The County of Renfrew Department of Public Works and Engineering provides monthly updates on construction projects within the County. This notice should be shared with members of the public, or in public forums, in order to keep residents, businesses, and stakeholders informed of any potential upcoming traffic interruptions due to construction projects. ### **Upcoming Projects**

**County Road 70 (Ruby Road)** – Township of Killaloe, Hagarty and Richards The rehabilitation of County Road 70 (Ruby Rd.), from County Road 512 (Brudenell Rd.) to Gorman Rd., is anticipated to commence the week of September 9 and is anticipated to be completed late-October. During construction, the road will be reduced to a single lane of traffic in locations.

**County Road 508 (Calabogie Road)** – Township of McNab/Braeside The rehabilitation of County Road 508 (Calabogie Rd.), from County Road 52 (Burnstown Rd.) to Goshen Rd., is anticipated to commence the week of September 9 and is anticipated to be completed late-October. During construction, the road will be reduced to a single lane of traffic in locations.

# **County Structure C325 (Neilson Creek Culverts)** – Township of Bonnechere Valley

The rehabilitation of County Structure C325 (Neilson Creek Culverts), located on Lake Clear Road, approximately 2.2km south of County Road 512 (Foymount Rd.), is anticipated to commence the week of September 16 and is anticipated to be completed early-October. During construction, the road will be reduced to a single lane of traffic and will be closed to all traffic for up to five (5) days.

#### **Ongoing Projects**

**County Road 30 (Lake Dore Road)** – Township of North Algona/Wilberforce The rehabilitation of County Road 30 (Lake Dore Rd.), from Sperberg Rd. to Trailblazers Rd., commenced the week of July 29 and is anticipated be completed mid-September. During construction, the road will be reduced to a single lane of traffic in locations.

#### County Road 37 (Murphy Road) – Town of Petawawa

The reconstruction of County Road 37 (Murphy Rd.), from Woodland Crescent to County Road 51 (Petawawa Blvd.), commenced construction on June 17 and is anticipated to be completed late-November. During construction, the road will be reduced to a single lane of traffic in locations and short term closures will occur with detours in place.

#### County Road 73 (Deep River Road) – Town of Deep River

The rehabilitation of County Road 73 (Deep River Rd.), from Algonquin St. to Champlain St., commenced the week of August 26 and be completed mid-October. During construction, the road will be reduced to a single lane of traffic in locations and short-term closures may be required with detours in place.

**County Road 512 (Foymount Road)** – Township of Bonnechere Valley The reconstruction of County Road 512 (Foymount Rd.), from Miller Rd. to B257 (Harrington Creek Bridge), resumed construction on May 27 and is anticipated to be completed early-September. The works in this phase will primarily occur from Lake Clear Rd. to Harrington Creek Bridge, and will include the replacement of County Structure B257 (Harrington Creek Bridge). During construction, the road will be reduced to a single lane of traffic in locations.

# **County Road 512 (Foymount Road)** – Township of Brudenell, Lyndoch and Raglan

The rehabilitation of County Road 512 (Foymount Rd.), from Hubers Rd. to County Road 515 (Palmer Rd.), commended the week of September 2 and is anticipated to

be completed late-October. During construction, the road will be reduced to a single lane of traffic in locations.

**County Road 515 (Palmer Road)** – Township of Madawaska Valley The rehabilitation of County Road 515 (Palmer Rd.), from County Road 62 (Combermere Rd.) to Finch Rd., commenced the week of August 5 and is anticipated to be completed late-September. During construction, the road will be reduced to a single lane of traffic in locations.

County Structure B007 (Butler Bridge) – Township of Admaston/Bromley The rehabilitation of County Structure B007 (Butler Bridge), located on Butler Rd., approximately 1km south of Highway 60, commenced construction on May 13 and is anticipated to be completed early-November. During construction, the road at the bridge will be closed with alternate routes, using South McNaughton Rd., Bonnechere Rd., and Highway 60, posted.

**County Structure B108 (Tramore Bridge)** – Township of Killaloe, Hagarty and Richards

The rehabilitation of County Structure B108 (Tramore Bridge), located on Tramore Road, approximately 0.25km north of County Road 58 (Round Lake Rd.), commenced construction on July 15 and is anticipated to be completed early-October. During construction, the road at the bridge will be closed to traffic with an alternate route, using County Road 58 (Round Lake Rd.) and Highway 60, posted.

County Structure B181 (Peter Black Bridge) – Township of Laurentian Valley The rehabilitation of County Structure B181 (Peter Black Bridge), located on County Road 24 (White Water Road), approximately 1.5km east of Highway 41, commenced construction on June 17 and is anticipated to be completed early-October. During construction, the road at the bridge will be closed to traffic with an alternate route, using Highway 17 and Highway 41, posted.

# **County Structure C001 (Berlanquet Creek Culvert)** – Township of Admaston/Bromley

The rehabilitation of County Structure C001 (Berlanquet Creek Culvert), located on County Road 5 (Stone Road), approximately 4km west of Highway 132, commenced the week of July 15 and is anticipated to be completed late-September. During construction, the road at the structure will be limited to a single lane of alternating traffic.

**County Structure C134 (Campbell Drive Culvert)** – Township of McNab/Braeside The rehabilitation of County Structure C134 (Campbell Drive Culvert), located on Campbell Drive, approximately 3km west of Highway 417, commenced the week of July 15 and is anticipated to be completed late-September. During construction, the road at the structure will be limited to a single lane of alternating traffic.

# **County Structure C204 (Bellowes Creek Culvert)** – Township of Whitewater Region

The rehabilitation of County Structure C204 (Bellowes Creek Culvert), located on County Road 12 (Westmeath Rd.), approximately 4.5km east of County Road 21

(Beachburg Rd.), commenced on July 15 and is anticipated to be completed late-October. During construction, the road at the structure will be limited to a single lane of alternating traffic.

**County Structure C268 (St. Columbkille's Culvert)** – Township of Laurentian Valley

The rehabilitation of County Structure C268 (St. Columbkille's Culvert), located on County Road 58 (Round Lake Rd.), approximately 50m south of TV Tower Rd., commenced on September 3 and is anticipated to be completed late-October. During construction, the road at the structure will be limited to a single lane of alternating traffic.

#### **Completed Projects**

**County Road 1 (River Road)** – Townships of McNab/Braeside and Horton The rehabilitation of County Road 1 (River Rd.), from Moore St. to Dochart St. as well as from Algonquin Trail to the Bonnechere River crossing in Castleford, commenced on July 2 and was completed late-August. Line painting remains to be completed.

**County Road 5 (Stone Road)** – Township of Admaston/Bromley The rehabilitation of County Road 5 (Stone Rd.), from Mhusk Rd. to Highway 60, commenced construction on June 3 and was completed late-July.

**County Road 8 (Cobden Road)** – Township of Whitewater Region The rehabilitation of County Road 8 (Cobden Rd.), from County Road 9 (Bulger Rd.) to the urban limits of Cobden, commenced the week of August 12 and was completed late-August. Line painting remains to be completed.

**County Road 19 (Mud Lake Road)** – Township of Laurentian Valley The rehabilitation of County Road 19 (Mud Lake Rd.), from County Road 24 (White Water Rd.) to the City of Pembroke boundary, commenced the week of July 8 and was completed early-August. Line painting remains to be completed. Additional minor shoulder repairs are anticipated with minimal traffic disruptions.

**County Road 64 (Opeongo Road)** – Township of Bonnechere Valley The rehabilitation of County Road 64 (Opeongo Rd.), from Wieland Shore Rd. to Highway 41, commenced construction on May 27 and was completed late-August.

**County Road 65 (Centennial Lake Road)** – Township of Greater Madawaska The rehabilitation of County Road 65 (Centennial Lake Rd.), from former Matawatchan/Brougham Township Line to Civic Address 2872, commenced construction on July 2 and was completed early-August. Line painting remains to be completed.

**County Structure B102 (Brennans Creek Bridge)** – Township of Killaloe, Hagarty and Richards

The rehabilitation of County Structure B102 (Brennans Creek Bridge), located on County Road 512 (Queen Street), approximately 1.45km south of Highway 60, in

Killaloe, commenced construction on July 2 and was completed late-August. Additional works are required on hand railings; however, limited traffic disruption is anticipated.

**County Structure C062 (John Watson Culvert 2)** – Township of Brudenell, Lyndoch and Raglan

The replacement of County Structure C062 (John Watson Culvert 2), located on John Watson Rd., approximately 3.3km west of County Road 66 (Opeongo Rd.), commenced the week of August 12 and was completed late-August.

**County Structure C221 (Kenny's Culvert)** – Township of Whitewater Region The replacement of County Structure C221 (Kenny's Culvert), located on Pleasant Valley Rd., approximately 0.5km north of County Road 12 (Westmeath Rd.), commenced the week of August 26 and was completed late-August.

Like many communities across North America, the opioid crisis is having a tragic impact on local families and communities across Renfrew County and District (RCD). In 2023, there were 69 opioid overdose-related emergency department visits and 41 suspected drug poisoning deaths in RCD, with both increasing relative to 2022. The rate of suspect drug poisoning deaths in 2023 was over 3 times the rate in 2018 to 2019.

Local nonprofits, private and public sector organizations, and persons with lived experience have joined forces to begin the development of a Renfrew County and District Drug Strategy (RCDDS), led by co-chairs Dr. Jason Morgenstern, Medical Officer of Health for the Renfrew County and District Health Unit (RCDHU), and Jama Watt, Strategic Implementation Lead for the Ottawa Valley Ontario Health Team.

The drug strategy will focus on four key pillars: prevention, harm reduction, treatment, and community safety. Each pillar will be addressed by a working group comprised of related local organizations and people with direct experience of the issues.

"The RCDDS truly brings together individuals from every sector – community and social services, addiction treatment, government, residents, public health, and healthcare," states Dr. Morgenstern. "It's exciting because the strategy will help coordinate the many great initiatives already underway, while systematically identifying the most effective ways to enhance our response."

"The County of Renfrew's <u>mesa initiative</u>, tackling homelessness, substance use, addictions, and mental health, is a great example of one initiative that is helping achieve the goals of the drug strategy," Dr. Morgenstern adds.

"Building on that, we have Addiction Treatment Services, MacKay Manor and Pathways Alcohol and Drug Treatment Services, and organizations like The Grind continuing to work hard to connect residents to treatment, while organizations such as Renfrew County and District Health Unit, the Phoenix Centre for Children and Families, Youth Wellness Hubs, and school boards, among others, are actively continuing work in education, awareness, and prevention," notes Watt.

The goals of the local drug strategy include reduced drug-related harms and overdoses, enhanced community safety, a coordinated response to drug addiction to help ensure individuals receive the help they need, and a reduction in healthcare and social service costs.

Once a draft strategy and report is developed, a key next step will be community consultation and input, expected by early 2025.

In the meantime, RCDDS partners remind residents that support is available. The <u>Renfrew County Addiction Treatment System</u> delivers assessment, counselling, and treatment programs to individuals who use substances. Additionally, RCDHU's <u>harm reduction program</u> offers safe supplies, which can be accessed at 141 Lake Street in Pembroke, OATC Renfrew, and Arnprior Shoppers Drug Mart. You can call or text 613-602-6056 during RCDHU's business hours before you arrive to pick up or return supplies. Walk-ins are also accepted.



Please be advised that the Council of the Town of Tillsonburg, at its meeting on September 9<sup>th</sup>, 2024 passed the following resolution:

- A. THAT report EDM 24-029 titled "Cellular Coverage Concerns" be received;
- B. THAT Council of the Town of Tillsonburg endorses the following:
  - a. Whereas the residents of our community are not able to have reliability and confidence in our telecommunications infrastructure for our commercial establishments and economic growth, employment, school, virtual medical appointments, mental health, welfare and emergency services:
  - Whereas many areas in and around the Town of Tillsonburg are considered "Dead Zones" causing rural and urban communities to incur prohibitive costs which include roaming and overage fees and/or alternative resources in order to gain basic and limited communication functionality;
  - c. Whereas the Innovation, Science and Economic Development Canada (ISED) has committed to have a reliable Network and states that, "Reliable telecommunications networks have never been more



crucial. They support not only a wide range of economic and social activities but also other critical infrastructure sectors and government services, andthey are crucial for emergency services and public safety. They are fundamental to the safety, prosperity and well-being of Canadians."

- d. THAT the top priority of the ISED as stated in the Telecommunications Reliability Agenda is, "Robust Networks and Systems This means there is robust architecture for telecommunications networks with appropriate redundancy, diversity, and hardening against hazards, with particular care for emergency services. There are systems with controls and monitoring and the telecommunications supply chain including supplier equipment is trusted and secure. Investments are made to support these activities including in rural and remote areas or to address coverage gaps."
- C. THAT the Council of the Town of Tillsonburg requests that the Federal Government and ISED make it their priority to push forward with their commitment to provide this crucial infrastructure in a meaningful and time manner and provide action and enforcement on the regulations that mandate timely installation of approved cell tower installations; and
- D. THAT a copy of this resolution be also sent to all Ontario municipalities, SWIFT, local telecommunications providers, the local MP and MPP.
