Ontarians Want to Learn More About Saving Lives Through Organ And Tissue Donation

November 13, 2024

Toronto, ON – Over 2.1 million Ontarians now have an easier way to learn the important role they can play to save and improve lives.

With the launch of an innovative collaboration between the provincial and federal governments, Ontario taxpayers can now indicate their interest to learn more about organ and tissue donation and transplantation. Through a question that first appeared on the 2022 T1 General tax return, Ontario taxpayers who consent will receive an email from Ontario Health (Trillium Gift of Life Network) with more information. The goal of this initiative is to raise public awareness and increase donor registrations.

Beginning this week, over 2.1 million Ontario taxpayers who consented when they filed their 2022 and 2023 taxes will receive an email communication from Ontario Health (TGLN) that includes information about how to register as a potential donor.

"This initiative is an incredible opportunity for Ontarians to learn more about the importance of organ and tissue donation and the lives that can be saved and improved by transplantation," says Rebecca Cooper, Vice President, Ontario Renal Network and TGLN. "Our goal is to increase donor registrations and ensure that individuals are openly speaking with their family about their wishes. Partnering with the Canadian Revenue Agency allows us to reach a large number of individuals with our message so they may make informed decisions and will be inspired to register as organ and tissue donors."

Transplant recipient Shilpa Raju knows first-hand the life-saving power of donation. "The little things like running for the bus, and big things like pursuing a career or getting married; I never forget that I wouldn't be doing any of this without my donor. My lung donor and their family – they're the reason I'm still here. The impact of one person's choice is transformative, and it's a butterfly effect. Anything I do or accomplish is bigger than me."

Background and Quick Facts:

- In 2021, the Canadian House of Commons and Senate passed Bill C-210 43-2): An Act to amend the Canada Revenue Agency Act (organ and tissue donors), to support organ and tissue donation and transplantation across Canada.
- Ontario is one of the first jurisdictions to launch this initiative.
- One organ donor can save up to eight lives and enhance the lives of up to 75 others through tissue donation.
- On average, 1,400 people in Ontario are waiting for a lifesaving organ and thousands more are in need of a transformative tissue transplant.
- Every three days someone dies while they wait for their gift of life.

- While 90% of residents indicating support for organ and tissue donation, only one in three Ontarians are registered organ and tissue donors.
- Anyone 16 years or older with a valid Ontario health card can register either in person at any ServiceOntario location or online at <u>beadonor.ca</u> <u>C (http://www.beadonor.ca/)</u>.

Ontario Building Safer and Stronger Communities

New legislation supporting safety near supervised consumption sites, introducing new tools to monitor sex offenders and targeting auto theft

November 18, 2024

TORONTO — Today, the Ontario government introduced legislation that, if passed, will help keep streets and communities safe and hold criminals accountable. The *Safer Streets, Stronger Communities Act* includes targeted measures to help support public safety near supervised consumption sites, crack down on auto theft and careless driving, enhance the tools police can use to manage sex offenders, tackle illegal cannabis sales and support access to justice. The government is also exploring measures to improve the collection of bail statistics as part of its ongoing calls for *Criminal Code* reform.

"Our government is keeping our communities safe and holding criminals accountable," said Solicitor General Michael Kerzner. "Today, we're proposing impactful changes to strengthen tools for police officers, improve access to justice and eliminate dangerous activity that puts hard-working people at risk. In Ontario, crime doesn't pay."

Building on recent legislation and community safety initiatives, the *Safer Streets, Stronger Communities Act* will, if passed:

• Carry through on the government's <u>previously announced commitment</u> to protect children and families by prohibiting the operation of supervised consumption sites within 200 metres of a school, licensed child-care centre or

EarlyON Child and Family Centre through the creation of the *Community Care* and Recovery Act, 2024

- Require municipalities and local boards to seek provincial approval prior to making or supporting requests for new supervised consumption sites
- <u>Introduce new penalties for fraud</u> related to vehicle identification numbers (VIN) and further combat careless driving through the *Highway Traffic Act*
- Give police services more tools to monitor sex offenders and investigate sex crimes through *Christopher's Law (Sex Offender Registry), 2000* and make

individuals with active reporting requirements ineligible from legally changing their name, through the *Change of Name Act*

- Support terrorism victims by amending the *Limitations Act, 2002* to remove the limitation period for lawsuits under the federal *Justice for Victims of Terrorism Act*
- Prohibit advertising and promoting the sale of illegal cannabis through the *Cannabis Control Act, 2017*

"Our government is making bold and innovative changes to keep communities safe while improving access to mental health and addictions services that focuses on prevention and treatment, meeting people and their families where they are and putting them on a path to recovery," said Sylvia Jones, Deputy Premier and Minister of Health. "These proposed changes to consumption treatment sites, along with the \$378 million investment we are making in new Homelessness and Addiction Recovery Treatment Hubs, will support community safety along with the recovery of those struggling with opioid addiction."

"Our government has been crystal clear, enough is enough," said Associate Minister of Auto Theft and Bail Reform Graham McGregor. "We continue to call for meaningful bail reform. Our legislation today will make our streets safer and our communities stronger. The federal government needs to step up and do the same."

To support the commitment of creating safer communities, the government continues to call on the federal government for enhanced bail measures to keep repeat and violent offenders off Ontario streets.

In addition to amendments proposed in the act, the government is also exploring several initiatives such as:

- Proclaiming the month of November each year as Community Safety and Crime Prevention Month to raise awareness about the importance of local partnerships in combatting crime.
- Expansion of Justice Centres Integrated Treatment Courts to address the underlying causes of crime
- Examining opportunities to engage on and modernize the Private Security and Investigative Services Act, 2005

Ontario Boosting Efforts to Combat Bullying and Support Student Mental Health

Province ensuring more students feel safe, empowered and respected in schools

November 18, 2024 Education

TORONTO — The Ontario government is marking Bullying Awareness and Prevention Week by investing \$4.6 million to help combat bullying in schools and expand initiatives to equip students with the social and emotional skills they need to thrive. This funding will help foster stronger connections among students, promote a safe, respectful and inclusive school environment, and help reduce incidents of violence in schools across the province.

"As a mother, I understand firsthand how heartbreaking it is to hear about your child facing bullying or having a difficult day at school," said Jill Dunlop, Minister of Education. "Our investment in anti-bullying and mental health initiatives is a testament to our commitment to nurturing our students and making our schools places of respect and care. Through these efforts, we are fostering an environment where every child has the support they need to promote their mental health and reach their full potential without fear or hesitation."

To advance the government's efforts to improve student mental health and wellbeing, the funding is supporting the following community partners:

 \$1.485 million to Big Brothers and Big Sisters to provide a school-focused mentorship program for students in Grades 1 to 12, with the goal of increasing

school connectedness and improving social-emotional skills, mental health and educational outcomes

- \$1 million to Roots of Empathy to offer classroom programs aimed at reducing aggression and enhancing social-emotional competence in children aged 5-13, to build skills that support student success, mental health and well-being
- \$800,000 to Kids Help Phone to provide prevention counselling and offer highquality professional resources and crisis response
- \$436,500 to Egale Canada to support educators in facilitating learning opportunities to address cyberbullying, with particular emphasis on supporting

students who identify as 2SLGBTQIA+

- \$250,000 to Child Development Institute to improve students' emotion regulation, self-control, and problem-solving skills through the SNAP (Stop Now And Plan) program
- \$245,000 to Principal Association Projects to develop resources for parents and provide professional development opportunities for principals and viceprincipals on responding to cyberbullying
- \$150,000 to Victim Services Toronto to increase youth safety, and in particular \bullet young women, within the context of online dating, healthy relationships, healthy masculinity and peer pressure
- \$100,000 to pflag Canada to improve the mental health and relationships of 2SLGBTQIA+ students and their parents by providing culturally responsive community supports
- \$78,000 to Victim Services Durham Region to host a Youth Symposium that educates students in Grades 7 to 9+ and educators on youth safety and violence prevention
- \$65,000 to George Hull Centre for Children and Families to deliver culturally relevant socio-emotional learning initiatives designed to help students enhance self-management, social awareness, relationship skills and responsible decision-making

Ontario's investments address the critical need to support students through personal and academic challenges, help them build meaningful connections and achieve success. Support to address bullying and cyberbullying will advance broader efforts to improve student safety and prevent violence in schools, fostering a safe and respectful environment.

Quick Facts

- According to the Centre for Addiction and Mental Health (CAMH), more than half of Ontario students report symptoms of depression and anxiety and a third of students (31 per cent) rate their ability to cope as fair or poor.
- In 2023, CAMH found that one-quarter (25 per cent) of Ontario students reported being bullied at school since the beginning of the school year in 2022.
- For the 2024-25 school year, the Ministry of Education is providing \$127.5 million to support initiatives and programs that help build a safe and inclusive learning environment for all students. Additionally, mental health funding is being increased to nearly \$121 million, an increase of 595 per cent since 2017-18.

- Ontario requires all school boards to have an anti-bullying policy in place to help foster welcoming, supportive and inclusive school communities.
- School boards must establish and provide annual professional development to educate teachers and other school staff about bullying prevention and strategies for promoting a positive school climate.

Ontario Giving Police More Tools to Monitor Registered Sex Offenders

Proposed enhancements to Christopher's Law would help protect our most vulnerable people and keep communities safe

November 15, 2024

MISSISSAUGA — The Ontario government will soon introduce amendments to Christopher's Law, that, if passed, will strengthen Ontario's Sex Offender Registry by giving police more tools to better monitor and supervise registered sex offenders. The government is also proposing changes that would prevent sex offenders from legally changing their names in Ontario so they can't hide their identities.

"Decades ago, Ontario led the way with Canada's first sex offender registry, and today we're making it stronger," said Solicitor General Michael Kerzner. "By introducing changes to make Christopher's Law more effective, we're giving police new tools to prevent, investigate, and solve egregious sex crimes to protect those most vulnerable, especially our children."

The proposed changes would help to maintain Ontario's high reporting compliance rate for registered sex offenders and high-risk child sex offenders by:

- Requiring sex offenders to report to a police service within a prescribed period after being ordered to serve a conditional sentence
- Mandating sex offenders to report to a police service within a prescribed period after receiving a passport or driver's licence
- Requiring offenders to report when they are starting to use or make changes to email addresses, social media usernames and other digital identifiers
- Adding new strict travel notification requirements, including requiring registered sex offenders to provide 14 days advance notice if they intend on traveling for seven days or more and requiring that registered child sex offenders provide advance notice if they will be out of Canada for any length of time.

The government is also proposing to amend the *Change of Name Act* which would prohibit sex offenders from changing their names while they have reporting obligations to the Ontario Sex Offender Registry. While there are safeguards currently in place, this proposed change would make it easier for police to monitor sex offenders and prevent them from using a new identity to commit new crimes.

"Banning convicted sex offenders from legally changing their name in Ontario will improve public safety," said Todd McCarthy, Minister of Public and Business Service Delivery and Procurement. "By strengthening the *Change of Name Act*, we are closing a legal loophole that allowed these offenders to live in anonymity."

Quick Facts

- Ontario's Sex Offender Registry, the first of its kind in Canada, was sparked by the tragic 1988 murder of 11-year-old Christopher Stephenson at the hands of a convicted pedophile on federal statutory release. At the 1993 inquest into Christopher's death, the coroner's jury recommended creating a national registry for convicted sex offenders, requiring that they register with their local police service as soon as they are released from jail. With the support of the Stephenson family, victims' groups and law enforcement organizations, the province proclaimed *Christopher's Law (Sex Offender Registry), 2000* on April 23, 2001.
- Ontario has one of the highest compliance rates of all sex offender registries. More than 94 per cent of registered sex offenders are compliant.
- As of September 2024, there are over 14,000 registered sex offenders on the Ontario Sex Offender Registry with active reporting obligations.
- The act requires some individuals convicted of or found not criminally responsible on account of a mental disorder for a designated sex offence to register in person at their local police station and report annually each year and within seven days of specific events (for example, a change of address or change of name).
- Ontario remains the only province with its own registry. The Ontario Sex Offender Registry is administered by the Ontario Provincial Police and gives local police services a critical tool to prevent, investigate and solve crimes of a sexual nature and to manage sex offenders within their local community.

"Victim Services Toronto recognizes the importance of modernizing the Ontario Sex Offender Registry to meet the challenges of a digital world. Many of the survivors we support have experienced harm facilitated through online platforms, and by adapting the registry to include digital identifiers, we are moving towards a more comprehensive approach to prevention and accountability. While there are always considerations around privacy and implementation, these updates could help law enforcement and communities better respond to emerging threats, ultimately enhancing safety for survivors of sexual violence."

Ontario and Starlink to Bring High-Speed Satellite Internet to Remote Communities

New program offering connectivity for 15,000 eligible homes and businesses

November 14, 2024 **Infrastructure**

SUDBURY — The Ontario government is partnering with Starlink to launch the new Ontario Satellite Internet (ONSAT) program, which will offer high-speed satellite internet access to 15,000 eligible unserved and underserved homes and businesses, including in rural, remote and northern communities, beginning in June 2025.

"Our government is pleased to work with Starlink to offer a highly advanced satellite internet service that will help people living and working in the hardest to reach areas of the province access high-speed internet," said Kinga Surma, Minister of Infrastructure. "Our government knows how essential it is to have access to online services and supports, which is why we are using all viable options and technologies, including fibre, fixed wireless and satellite to ensure every community across the province has access by the end of 2025."

More details on the program and the registration process for eligible primary residences and businesses will be available in Spring 2025. The new ONSAT program is part of the government's nearly \$4 billion investment to help bring access to reliable high-speed internet to every community across the province by the end of 2025. This is the largest single investment in high-speed internet, in any province, by any government in Canadian history.

- Starlink has the world's first and largest constellation of highly advanced satellites operating in a low-Earth orbit to deliver broadband internet capable of supporting streaming, online gaming, video calls and more. Starlink is engineered and operated by SpaceX.

Ontario Investing Over \$74 Million Through Next Round of Skills Development Fund Capital Stream

Province also investing nearly \$5 million to train over 1,600 crane workers in Oro-Medonte

ORO-MEDONTE — The Ontario government is launching the second round of its <u>Skills Development Fund (SDF) Capital Stream</u> starting November 29, with over \$74 million in available funding to build, expand and retrofit training facilities for workers in the trades, including construction, manufacturing technology and health care. The government is also investing nearly \$5 million from the first round of the SDF Capital Stream with the International Union of Operating Engineers (IUOE) to build a new crane training facility for over 1,600 workers in Barrie. Since the province launched the Skills Development Fund in 2021, Ontario is building training facilities and providing training programs that are projected to support over one million workers across the province.

"With more than \$74 million committed to training and workers across the province, this new round of funding through our Skills Development Fund Capital Stream will help thousands of additional Ontario workers find better jobs and bigger paycheques," said Premier Doug Ford. "It's especially great to be here in Oro-Medonte to announce nearly \$5 million in support from the first round of funding and see first-hand how it's making a difference in the lives of Ontario workers."

Building on the success of the SDF Capital Stream <u>announced in 2023</u>, Ontario will open a second round on November 29, 2024, with an enhanced, streamlined application process that includes a new SEED pathway to help with the upfront costs of developing construction proposals, such as design drawings and technical plans. This addresses the needs of businesses and training providers who may lack the in-house capacity to develop complex construction plans. As a further improvement, the Capital Stream will now also accept funding proposals all year round, which enables faster application reviews. "Under Premier Ford, our government has an ambitious plan to build Ontario – from new housing that families can call home, to highways and public transit connecting our communities, to clean energy projects powering our economy," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "But with one in three tradespeople retiring over the coming years, we must pass on the skills and expertise from the Golden Generation of Skilled Tradespeople to the next generation of workers. With a new, second round of our Skills Development Fund Capital Stream, we are going to kick Ontario's training capacity into high-gear, training over one million workers for in-demand careers in every corner of Ontario."

The announcement was made in Oro-Medonte, where the government is investing nearly \$5 million in the International Union of Operating Engineers (IUOE) to build a new crane training facility, led by the Operating Engineers Training Institute of Ontario (OETIO). The SDF Capital Stream investment from round one will help build a new crane training facility focused on training apprentices in mobile and tower crane operation, as well as heavy equipment. This modern and high-tech centre will include simulation labs, workshops and an outdoor training area for tower cranes, in addition to classrooms, offices and a cafeteria. This full-service training facility will train over 1,600 jobseekers – including youth, Indigenous peoples and newcomers – and foster innovation, while helping to build a talent pipeline for the construction industry in the region and across Ontario.

Quick Facts

- SDF comprises two streams: the <u>Training Stream</u> supports hiring, training and upskilling programs for jobseekers, apprentices and workers; and the <u>Capital</u> <u>Stream</u> supports upgrades or construction of training centres for the skilled trades. The total investment for both streams is to up to \$1.4 billion.
- SDF Capital Stream Round 2 will open on November 29 and will allow a continuous intake of applications. This improved application process allows

interested organizations to apply year-round through <u>Transfer Payment</u> <u>Ontario</u>. Inquiries can be sent to: <u>SDFCapitalProgram@ontario.ca</u>.

- The new SEED pathway of the Capital Stream will help fund the development of capital plans for training facilities and will complement the already established GROW pathway that will continue to support projects to build, upgrade and expand new training infrastructure.
- Organizations that are interested in submitting a proposal for either the SEED or GROW pathways will be able to review the SDF Capital Stream application

guidelines over the coming week at

- Since its launch in 2023, Ontario's SDF Capital Stream has been supporting renovation and construction projects that aim to help almost 250,000 workers train for in-demand sectors.
- The SDF Training Stream supports hiring, training and upskilling projects for jobseekers, apprentices and workers. Round 5 of the SDF Training Stream closed on October 11, 2024 and over 800 applications for funding were submitted.
- Ontario's \$5 million investment through round one of the SDF Capital Stream will go to support the construction of IUOE's \$25 million crane training facility.
- Over 21,000 jobs were recently going unfilled in Kitchener-Waterloo-Barrie region, including jobs in the construction sector.
- The Capital Stream of the Skills Development Fund is exclusively funded by the Government of Ontario.
- The Training Stream of the SDF is supported through labour market transfer agreements between the Government of Canada and the Government of Ontario.
- As the Government of Canada has unilaterally cut over \$230 million annually from Ontario's Labour Market Transfer Agreements, which supports employment and settlement service programs, Ontario continues to call for the federal government to reinstate this critical funding for Ontario workers and jobseekers.

Ontario Building More Electric Vehicle Charging Stations

Province making it easier and more convenient to charge up outside of large urban centres

November 12, 2024

Energy and Electrification

AJAX — The Ontario government is building over 1,300 new electric vehicle (EV) charging ports in small and medium-sized communities, marking a major milestone in the province's plan to increase access to EV chargers outside of large urban centres and support the electrification of transportation across the province. As the province continues to see substantial job creation and investment in the growing EV and EV battery manufacturing sector, these new charging stations will provide critical supporting infrastructure in communities across the province, including for EVs made right here in Ontario.

"With more than 201,000 electric vehicles on the road in Ontario, we're putting shovels in the ground to build more charging stations and make life easier for drivers," said Stephen Lecce, Minister of Energy and Electrification. "That includes a focus on smaller and underserved communities across our province where we are providing more certainty for parents and workers during their commutes."

The new chargers are part of the government's \$63 million investment to build publicly accessible charging stations in communities with less than 170,000 people, as well as in any Indigenous community in Ontario. The chargers will be located at <u>270 sites across the province</u>, such as arenas, hospitals, parks and recreation centres. This includes 190 charging ports in northern Ontario, providing drivers

across the north with more options when travelling.

"Improving EV charging infrastructure is essential to ensuring drivers are confident in electric vehicles," said Prabmeet Sarkaria, Minister of Transportation. "By focusing on smaller and medium-sized communities, we're filling gaps in underserved areas to build a more connected charging network for everyone in Ontario." Each new EV charging site will include Level 2 charging stations, Level 3 charging stations, or a combination of the two. In addition, the government has also launched a new <u>Ultra-Low Overnight Electricity Price Plan</u> and is exploring options for <u>an Electric Vehicle Charger Discount Electricity Rate</u> to further support EV adoption and reduce emissions. The new Ultra-Low Overnight Electricity Price Plan is helping customers who use more electricity at night, including those who charge their electric vehicle, save up to \$90 per year.

"Having attracted \$45 billion in new electric vehicle and EV battery investments over the last four years, our government is delivering on a plan to build a fully integrated end-to-end EV supply chain in Ontario" said Vic Fedeli, Minister of Economic Development, Job Creation and Trade. "By expanding access to charging infrastructure beyond urban centres, we're ensuring workers and families across the province can feel confident in their adoption of EVs."

Quick Facts

- The government is investing a total of \$91 million through the EV ChargeON program which consists of two streams: the Community Sites Stream and the Government Sites Stream. <u>Requests for bids for the Government Sites Stream</u> closed in September 2024.
- Businesses, not-for-profit corporations, municipalities, Indigenous communities and organizations, and broader public sector organizations (such as hospitals, universities, and colleges) were invited to submit funding applications for the Community Sites Stream.
- As of October 2024, there were more than 201,000 EVs registered in Ontario, including both battery-electric vehicles and plug-in hybrid electric vehicles. By 2030, over one million EVs are expected on Ontario's roads.
- This initiative builds on <u>Driving Prosperity: The Future of Ontario's Automotive</u> <u>Sector</u>, a government plan that includes measures aimed to encourage EV uptake across Ontario.

Ongoing Projects

County Road 37 (Murphy Road) - Town of Petawawa

The reconstruction of County Road 37 (Murphy Rd.), from Woodland Crescent to County Road 51 (Petawawa Blvd.), commenced construction on June 17 and is anticipated to be completed late-November. During construction, the road will be reduced to a single lane of traffic in locations and short-term closures will occur with detours in place.

County Road 508 (Calabogie Road) – Township of McNab/Braeside

The rehabilitation of County Road 508 (Calabogie Rd.), from County Road 52 (Burnstown Rd.) to Goshen Rd., commenced the week of September 9 and is anticipated to be completed early-November. During construction, the road will be reduced to a single lane of traffic in locations.

County Structure B007 (Butler Bridge) – Township of Admaston/Bromley

The rehabilitation of County Structure B007 (Butler Bridge), located on Butler Rd.,

approximately 1km south of Highway 60, commenced construction on May 13 and is anticipated to be completed early-November. During construction, the road at the bridge is closed with alternate routes, using South McNaughton Rd., Bonnechere Rd., and Highway 60, posted.

County Structure C204 (Bellowes Creek Culvert) – Township of Whitewater Region The rehabilitation of County Structure C204 (Bellowes Creek Culvert), located on County Road 12 (Westmeath Rd.), approximately 4.5km east of County Road 21 (Beachburg Rd.), commenced on July 15 and is anticipated to be completed early-November. During construction, the road at the structure will be limited to a single lane of alternating traffic at times.

Completed Projects

County Road 70 (Ruby Road) – Township of Killaloe, Hagarty and Richards The rehabilitation of County Road 70 (Ruby Rd.), from County Road 512 (Brudenell Rd.) to Gorman Rd., commenced the week of September 9 and was completed October 31. Line painting remains to be completed, which should be done in early-November.

County Road 73 (Deep River Road) - Town of Deep River

The rehabilitation of County Road 73 (Deep River Rd.), from Algonquin St. to Champlain St., commenced the week of August 26 and was completed in late-October. Line painting remains to be completed, which should be done by early-November.

County Road 512 (Foymount Road) – Township of Brudenell, Lyndoch and Raglan The rehabilitation of County Road 512 (Foymount Rd.), from Hubers Rd. to County Road 515 (Palmer Rd.), commenced the week of September 2 and was completed November 1. Line painting and granular sealing remains to be completed, which should be done in early-November.

County Road 515 (Palmer Road) – Township of Madawaska Valley

The rehabilitation of County Road 515 (Palmer Rd.), from County Road 62 (Combermere Rd.) to Finch Rd., commenced the week of August 5 and was completed October 8.

County Structure C134 (Campbell Drive Culvert) – Township of McNab/Braeside The rehabilitation of County Structure C134 (Campbell Drive Culvert), located on Campbell Drive, approximately 3km west of Highway 417, commenced the week of July 15 and was completed early-October.

County Structure B181 (Peter Black Bridge) – Township of Laurentian Valley The rehabilitation of County Structure B181 (Peter Black Bridge), located on County Road 24 (White Water Road), approximately 1.5km east of Highway 41, commenced construction on June 17 and was completed mid-October.

County Structure C268 (St. Columbkille's Culvert) – Township of Laurentian Valley The rehabilitation of County Structure C268 (St. Columbkille's Culvert), located on County Road 58 (Round Lake Rd.), approximately 50m south of TV Tower Rd., commenced on September 3 and was completed October 25.

County Structure C325 (Neilson Creek Culverts) – Township of Bonnechere Valley The rehabilitation of County Structure C325 (Neilson Creek Culverts), located on Lake Clear Road, approximately 2.2km south of County Road 512 (Foymount Rd.), is commenced the week of October 14 and was completed October 31. BONNECHERE VALLEY – The County of Renfrew was thrilled to mark the official opening of its new Paramedic Base Station in the village of Eganville on November 1, 2024.

This base represents not only a commitment to the health and safety of our community but also the strength of our ongoing partnerships with provincial and local leadership. The new base is located in a landmark building which formerly housed the O'Grady Brothers Limited Garage at the corner of Highway 41 and County Road 512 (Foymount Road) in Eganville. Development and Property Committee Chair James Brose, Health Committee Chair Michael Donohue and Pembroke Mayor Ron Gervais also provided remarks at the ceremony, which was attended by students from nearby St. James Catholic Elementary School and other community partners.

The County of Renfrew purchased the building from Helen and Pat O'Grady in the fall of 2023 and work commenced last November. The renovations were administered in-house by the County's Real Estate Division. The building, originally built in 2008, now boasts 2,500 square feet of office space and includes shower and changing facilities, kitchen and dining area,

lounge, quiet quarters and meeting space in addition to a 4,000 square-foot four-bay garage to house Paramedic Service vehicles.



AMO Policy Update -Encampments and Opioid Crisis

Comprehensive Provincial Approach Needed to Make Tangible Progress on Homeless Encampments and the Opioid Crisis

Municipalities across Ontario understand the need for urgent action to address both the rising number of homeless encampments and the opioid crisis. There are more than 1400 encampments across the province. We can do better for our most vulnerable Ontarians and our broader communities.

Decades of isolated policy decisions made by successive provincial governments have compounded problems. More people are facing income insecurity. Health care and mental health demands are not being met. Help with addiction is hard to get. Affordable housing is desperately needed everywhere.

We need provincial action that is going to help the Ontarians who are struggling today and also tackle the root causes of homelessness so the crisis does not continue to grow.

Earlier this year, AMO released two policy papers calling for provincial action on the <u>opioid crisis</u> and <u>homeless encampments</u>. AMO engaged with municipal members, police, paramedics, and mental

health and addictions and housing experts over the course of months to identify the suite of actions needed.

This is a complex problem that won't be solved by simple, short-term solutions. We need a comprehensive approach, including:

- Provincial guidance that supports an appropriate and consistent approach to encampments across the province;
- Improvements to the income security system that leave too many living in poverty, and more than 1 million people in Ontario using food banks last year;
- Significant investments in deeply affordable housing and supportive housing;
- Long-term, sustainable, and substantial investment in prevention programs;
- Expanding access to voluntary and evidence-based treatment with same-day access and scaling up 24/7 crisis centres; and,
- Ensuring local say on the harm reduction approaches needed within local communities.

The current Ontario government did not create this crisis, but it has the resources and the wherewithal to take the comprehensive actions needed to solve it. Municipalities are ready to work together with the provincial government to tackle this systemic problem.

WHEREAS farm drainage is of paramount importance in Ontario due to its significant impact on agricultural productivity and sustainability. Effective drainage systems help mitigate waterlogging, control soil moisture levels, and enhance soil structure, thereby optimizing growing conditions for crops;

WHEREAS improved drainage also facilitates timely field operations, reduces erosion, and minimizes nutrient runoff, contributing to environmental conservation efforts;

WHEREAS Ontario's diverse agricultural landscape, where weather variability is common, well-maintained drainage systems play a crucial role in ensuring stable yields, economic viability, and long-term resilience for farmers across the Province;

WHEREAS the Tile Loan Drainage Act, R.S.O 1990, c. T.8 allows for the borrowing of money for the purpose of constructing drainage works;

Subject: Establishment of an Ontario Rural Road Safety Program

Too many Ontarians are being seriously injured or killed on our roads.

In 2023, there were 616 people killed and 36,090 people injured. The number of fatalities is up nearly 20% in the last ten years.

In 2021, the most recent year of complete data from MTO's Ontario Road Safety Annual Report (ORSAR), there were 561 fatalities – 426 of which occurred on municipal roads. While rural Ontario only represents 17% of the province's population, 55% of these deaths occurred on rural roads. By any measure, Ontario's rural roads are disproportionately more dangerous.

At the same time, municipal insurance premiums continue to increase. With no plausible reform being considered for joint and several liability, municipalities need to find innovative means for managing risk, particularly on their roadways,

To deal with this crisis, Good Roads has designed a multifaceted rural road safety program and have been in discussions with the Ministry of Transportation to fund it. The program would target a municipality's most dangerous roads, perform road safety audits, and install modern safety infrastructure that prevents serious injuries and save lives. This program is designed to be cost effective while also providing rural municipalities with a direct means for addressing risk associated with their roadways.

Good Roads has proposed leading a five-year \$183 million program that leverages our 131 years of municipal road expertise and our industry partnerships to quickly put in place the solutions that will address some of Ontario's most dangerous roads.

Good Roads is seeking support to address these preventable tragedies.

If the Town of The Blue Mountains would be interested in pursuing this, a Council resolution similar to the example below should be adopted and sent to the Premier and the Minister of Transportation:

WHEREAS official statistics from the Government of Ontario confirm that rural roads are inherently more dangerous than other roads;

AND WHEREAS, despite only having 17% of the population, 55% of the road fatalities occur on rural roads;

AND WHEREAS, rural, northern, and remote municipalities are fiscally strained by maintaining extensive road networks on a smaller tax base;

AND WHEREAS, preventing crashes reduces the burden on Ontario's already strained rural strained health care system;

AND WHEREAS, roadway collisions and associated lawsuits are significant factors in runaway municipal insurance premiums. Preventing crashes can have a significant impact in improving municipal risk profiles;

THEREFORE, BE IT RESOLVED THAT the Town of The Blue Mountains requests that the Government of Ontario take action to implement the rural road safety program that Good Roads has committed to lead. It will allow Ontario's rural municipalities to make the critical investments needed to reduce the high number of people being killed and seriously injured on Ontario's rural roads; and

FURTHER THAT a copy of this resolution be forwarded to Premier Doug Ford, Hon. Prabmeet Sarkaria, Minister of Transportation, Hon. King Surma, Minister of Infrastructure, Hon. Rob Flack, Minister of Agriculture, Hon. Lisa Thompson, Minister of Rural Affairs, Hon. Trevor Jones, Associate Minister of Emergency Preparedness and Response, and Hon. Sylvia Jones, Minister of Health, and Good Roads; and

FURTHER THAT this resolution be circulated to all municipalities in Ontario requesting their support.

AND WHEREAS the annual cost of the Ontario Provincial Police, Municipal Policing Bureau for small rural non-contract (5.1) municipalities is approximately

\$428 million;

AND WHEREAS this annual cost is significantly less than the repatriation costs of the Gardiner

Express Way, the Don Valley Parkway and Highway 174 (Ottawa Region) but provides a greater

RE: Child Welfare Funding

Dear Premier Ford:

The Council of the Corporation of the County of Renfrew, at their regular meeting on October 30, 2024, passed the following resolution regarding Child Welfare Funding. Council and our community are deeply concerned about the ongoing funding reductions to the child welfare sector. Renfrew County is experiencing a significant rise in complex social challenges within our communities, placing a heavy strain on local resources and hindering our ability to effectively support families in need.

WHEREAS the County of Renfrew and the City of Pembroke have no financial obligations concerning the funding of Child Welfare agencies; and

WHEREAS the Financial Accountability Office in June 2024 identified issues with funding in the Child Welfare sector; and

WHEREAS Family and Children's Services of Renfrew County has experienced a funding cut of \$1.59 million, or 10.8%, over the past ten years; and

WHEREAS Family and Children's Services of Renfrew County was provided planning allocations reflecting a further funding reduction of \$963, 603 over the next two years; and

WHEREAS Family and Children's Services of Renfrew County has achieved administrative efficiencies as a multi-service agency, has implemented various cost mitigation measures, including reductions in staff and services, and has reached a point where further measures could negatively impact children at risk and their families; and

WHEREAS both the County of Renfrew and the City of Pembroke are committed to improving the health and safety of their residents; and

NOW, THEREFORE BE IT RESOLVED that the County of Renfrew and the City of Pembroke formally request the Province of Ontario to consult with and collaborate with Child Welfare agencies to develop an updated and equitable Child Welfare funding formula; and

BE IT FURTHER RESOLVED that the newly developed funding formula be structured to ensure an equitable and proportionate distribution that meets the diverse, unique, individual, and complex needs of the communities and populations served; and

BE IT FURTHER RESOLVED that the Warden of the County of Renfrew and the Mayor of the City of Pembroke be directed to write a letter to Minister Parsa expressing their concerns and request a

meeting in the fall of 2024 or to submit a joint delegation request for the 2025 Rural Ontario Municipal Association (ROMA) conference;

AND THAT this resolution be shared with Premier Doug Ford, Renfrew-Nipissing-Pembroke MPP John Yakabuski, Association of Municipalities of Ontario (AMO), Rural Ontario Municipal Association (ROMA), Eastern Ontario Wardens' Caucus (EOWC), Eastern Ontario Mayors' Caucus (EOMC), Ontario Association of Children's Aid Societies (OACAS), and local municipalities.

A compounding challenge impacting our community is that the County of Renfrew has recently declared a state of emergency in response to the opioid crisis, with our service partner, the City of Pembroke, experiencing overdose death rates per capita that are twice the national average. Family and Children's Services of Renfrew County has been negatively impacted by a funding reduction of \$1.59 million over the past ten years and is facing a further cut of \$963,603 over the next two years. This continued erosion to the investment in our local child welfare agency will jeopardize the safety and wellbeing of vulnerable children and their families. The cuts will diminish the agency's capacity to offer essential support to those with the greatest need within our small and largely rural communities.

The social determinants of health play a critical role in shaping children's wellbeing, influencing their development, educational success, and overall health outcomes. For children in communities with geographic isolation and underdeveloped services such as we experience, these determinants become even more pronounced. In Renfrew County, families often face challenges such as limited access to quality healthcare, mental health support, and educational resources.

The lack of these essential services can result in children experiencing higher rates of chronic illnesses, mental health issues, and developmental delays. Furthermore, many families throughout our region are experiencing economic hardships, which can lead to poor nutrition, unstable housing, and heightened exposure to environmental stressors. Again, I am sure you will agree, all of which negatively impact children's long-term health and wellbeing.

Maintaining consistent funding for our rural agency that provides child protection and essential support services is vital. Without adequate financial support for these critical services, vulnerable children may not receive the interventions they need to develop and thrive. Child protection agencies are essential in safeguarding children from abuse and neglect while helping to address emotional and psychological challenges early in life, setting children on a path to healthier futures.

In an area like Renfrew County with limited clinical and assistive infrastructure, these services often become a lifeline, helping to mitigate the impact of social determinants on child health. Prioritizing funding for these services can help break the cycle of disadvantage, promote healthier environments, and ensure that all children have the opportunity to reach their full potential.

Thank you for your interest in our most vulnerable age group in our community.

RE: Motion for the Protection of Agricultural Lands and Sustainable Development in Relation to Provincial Projects and Excess Soil Management Practices

Please be advised that Township of Puslinch Council, at its meeting held on October 23, 2024 considered the aforementioned topic and subsequent to discussion, the following was resolved:

Resolution No. 2024-378: Moved by Councillor Hurst and Seconded by Councillor Sepulis

Whereas the provincial government is undertaking:

- a) significant road and underground projects over the next ten years which will generate significant excess soil to be managed and disposed; and
- b) studies of underground projects that if implemented will also generate significant excess soil: and



Whereas landfill sites across Ontario are already near capacity, necessitating amendments to legislation to allow certain quality soil to be disposed at excess soil reuse sites instead of being disposed of in landfills effective January 1, 2025; and

Whereas the Ministry of the Environment, Conservation and Parks (MECP) is currently under resourced and lacks the capacity to effectively manage the additional enforcement and oversight required for the relocation of excess soil; and

Whereas the responsibility to enforce and oversee excess soil regulations is being downloaded onto municipalities, which have limited enforcement capabilities and face the risk of significant costs being passed on to local taxpayers; and

Whereas contamination of existing soil and groundwater is a significant concern, particularly in rural municipalities with valuable agricultural lands and reliance on groundwater for its residents; and

Whereas agricultural lands must be prioritized equally with housing needs, roads and underground infrastructure; failure to adequately protect these lands could exacerbate the ongoing food crisis in Ontario; and

Whereas Ontario is not alone in navigating the challenges of sustainable development, and the United Nations provides guidance through its Sustainable Development Report, which includes goals focused on economic growth, infrastructure, sustainable communities, hunger, clean water and sanitation, climate action, and life on land; and

Whereas it is critical that governments consider the comprehensive impacts on all of these areas when conducting feasibility studies and implementing projects which generate excess soil; and

Whereas neglecting to account for the broader implications of projects may lead to negative outcomes;

Therefore Be It Resolved that the Council of the Township of Puslinch calls on the provincial government to:



- 1. Prioritize the protection of agricultural lands in the management of excess soil from roads and underground projects and in the planning and feasibility studies related to such projects.
- 2. Ensure that adequate resources are allocated to the MECP to support effective enforcement and oversight of excess soil regulations.
- 3. Collaborate with municipalities to provide necessary support and funding for enforcement activities related to excess soil management, minimizing financial burdens on local taxpayers.
- 4. Conduct a comprehensive impact assessment that considers all aspects of sustainable development, in alignment with the United Nations Sustainable Development Report, before proceeding with the traffic tunnel project and any further amendments to excess soil legislation; and

That the Township of Puslinch Council direct staff to send a copy of this resolution to the Minister of the Environment, Conservation and Parks; the Premier of Ontario; all Ontario municipalities; MPP Arnott; MPP Rae; the Wellington Federation of Agriculture; and OMAFRA requesting support for the protection of agricultural lands and sustainable development practices in Ontario.
