# Be Bear Wise and Prevent Bear Encounters

Take precautions and follow these tips as bears emerge from hibernation

March 20, 2025

**Natural Resources** 

The Ontario government and the Ontario Provincial Police (OPP) are reminding the public to exercise caution and prevent attracting black bears as they begin to come out of hibernation.

In Ontario, black bears wake up from hibernation between mid-March and late April. During this time of year, there is little natural food for bears, causing them to search for other food sources, including garbage and bird feed.

To keep our communities safe and bears in their natural habitat, follow these simple and effective precautions:

- Never feed or approach bears
- Store garbage in waste containers with tight-fitting lids, preferably indoors
- Wait until pickup day to put out garbage for collection
- Remove bird feeders for the spring and summer (instead you can offer birds natural alternatives such as flowers, nesting boxes or fresh water)
- Clean food residue from outdoor barbecue grills and grease traps after each use
- Keep dogs on leash and store pet food indoors
- Alert your neighbours about bear activity and share these Bear Wise tips to reduce attractants in your community

It is important to know how to handle a bear encounter, and who to call if you encounter one. The province operates a non-emergency, toll-free Bear Wise reporting line at 1-866-514-2327. The line operates from March 17 to November 30 and is available 24/7.

If a bear is posing an immediate threat by showing threatening or aggressive behaviour, remain calm and call 911 or your local police department.

# Ontario Ready to Respond to Wildland Fire Season

Additional staff and equipment prepared to protect people and communities

March 27, 2025

TORONTO — Ontario is ready to respond to this year's wildland fire season, which lasts from April 1 until October 31. This year the government has filled nearly 100 additional permanent positions to support the 2025 fire season and help ensure people and resources are in place to protect communities.

"We are ready to protect people, communities and properties across Ontario from wildland fires," said Mike Harris, Minister of Natural Resources. "When wildland fires hit, our brave and dedicated FireRangers, pilots and support staff are prepared to battle these fires and protect Ontarians."

Last year, the province partnered with the federal government to invest a total of \$64 million in the wildland fire program. This investment has allowed Ontario to enhance its firefighting capacity for the 2025 fire season and includes funding for forest fire suppression equipment and technology, such as fuel systems, trucks and emergency management software.

Approximately 50 per cent of all wildland fires are caused by humans. There are actions the public can take to reduce the risks of forest fires:

- Before starting an outdoor fire, check the interactive map at <u>ontario.ca/forestfires</u> and ensure you are aware of the fire hazard and restrictions in place in your area.
- Follow Ontario's <u>outdoor burning regulations</u>, including igniting fires no sooner than two hours before sunset and extinguishing them no later than two hours after sunrise.
- Ensure campfires do not get too big and are fully extinguished at the end of the evening or prior to leaving the site. Have tools and water on hand to control outdoor fires.

Ontario is recognized as an international leader in wildland fire management and proudly participates in agreements with its provincial, territorial, federal and international partners that allow for the sharing of personnel, equipment and aircraft between agencies during periods of escalated wildland fire activity.

## **Quick Facts**

- Ontario has a fleet of specialized aircraft used to manage wildland fires, hundreds of highly trained staff, 14 fire management headquarters, three attack bases and 11 forward attack bases, two regional fire centres, one provincial fire centre (which houses the ministry emergency operations centre), two regional logistics centres and one provincial logistics centre, seven aircraft hangars and one flight training centre. Together, these resources are used to coordinate the protection of 90 million hectares of public land in Ontario.
- In 2024, Ontario saw more than 470 fires and nearly 90,000 hectares burned compared to the 10-year average of 694 fires and 201,780 hectares burned.
- Approximately 50 per cent of all wildland fires are caused by humans.

# Ontario Raising Minimum Wage to Support Workers

Increase to \$17.60 an hour will take effect October 1

April 01, 2025

<u>Labour, Immigration, Training and Skills Development</u>

**TORONTO** — The Ontario government is increasing the minimum wage from \$17.20 to \$17.60 an hour effective October 1, 2025, to support workers and businesses. This annualized wage increase is based on the Ontario Consumer Price Index (CPI) of 2.4 per cent and will bring Ontario's minimum wage to the second highest provincial rate in Canada.

"Our government will continue to have the backs of Ontario workers, investing in skills training and development and helping ensure that work pays," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "Ontario's minimum wage remains one of the highest in the country. Now more than ever, workers and businesses need fair, balanced and predictable wages."

A worker making the general minimum wage and working 40 hours per week will see an annual pay increase of up to \$835.00 as a result of these changes. Under the *Employment Standards Act*, Ontario's minimum wage increases annually based on the Ontario CPI, a measure of inflation that represents changes in prices experienced by Ontario consumers.

This increase is just one of the ways the government is supporting Ontario workers and helping make Ontario the best place to work, live and raise a family. Most recently, Ontario passed the *Working for Workers Six Act, 2024*, which is helping more workers enter the skilled trades, removing barriers to employment, protecting workers and supporting frontline heroes and women at work.

## **Quick Facts**

- About 36 per cent of workers at or below the wage of \$17.60 per hour are in retail trade and 24 per cent are in accommodation and food services.
- Over the past seven years, Ontario's minimum wage has increased from \$14 per hour in 2018 to \$17.60 later this year.

# Ontario Taking Action to Protect Workers Amid Economic Uncertainty

Province delivering support to businesses, while making Ontario the best place in the G7 to invest, create jobs and do business

April 07, 2025

**TORONTO** — The Ontario government is providing approximately \$11 billion in relief and support for workers and businesses as it protects the province's economy from economic uncertainty and the impact of U.S. tariffs.

"In the face of President Trump's attacks on Ontario's economy, our government will do whatever it takes to protect Ontario workers and businesses. Today's measures will help give workers and businesses the support they need in the face of growing economic uncertainty," said Premier Doug Ford. "We can't control President Trump, but we're in full control of the kind of future we build for ourselves. The best way to protect Ontario is to build the most competitive economy in the G7, breaking down internal trade barriers and diversifying our trade so we can build a more resilient, prosperous and secure province."

As a first step to support workers and businesses, the province is:

- Deferring select provincially administered taxes for six months from April 1, 2025, to October 1, 2025, giving businesses and job creators approximately \$9 billion worth of cash flow they need to keep workers employed and weather the economic turmoil.
- Through the Workplace Safety and Insurance Board (WSIB), issuing a further \$2 billion rebate for safe employers to support businesses and help keep workers on the job, in addition to the previous \$2 billion rebate distributed in March.

To protect Ontario's economy, the government will deliver on its mandate to break down internal trade barriers, make the province's economy the most competitive in the G7, including by speeding up timelines and approvals for development, as well as diversifying trading partners and helping businesses if they need to retool and retrain workers for new customers in new markets.

"We are ready to protect Ontario's workers, businesses and families from the economic uncertainty of U.S.-imposed tariffs," said Peter Bethlenfalvy, Minister of Finance. "Today's measures help Ontario to weather the storm while continuing to build on our plan for ongoing prosperity."

"In the last year, the WSIB provided historic, 50-year-low premiums to over 320,000 employers and surplus rebates to over 280,000 safe employers," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "Ontario is looking to provide further relief to employers through an additional distribution that will help them keep workers on the jobs, whatever comes our way from President Trump."

"In the face of economic uncertainty, Ontario stands ready with a plan that will defend the interests of our families and workers, protect our economy and jobs, and build a strong, stable future for generations to come." said Vic Fedeli, Minister of Economic Development, Job Creation and Trade.

The government is ready to do whatever is necessary to protect Ontario.

# **Quick Facts**

- Ontario is granting relief to businesses remitting taxes under Ontario's 10 business-focused tax programs, including the Employer Health Tax, Insurance Premium Tax, Gasoline Tax, Fuel Tax, Mining Tax, Tobacco Tax, International Fuel Tax Agreement, Beer, Wine & Spirits Tax, the Retail Sales Tax on Insurance Contracts and Benefit Plans and the Race Tracks Tax.
- Providing up to \$9 billion in cash flow support to about 80,000 Ontario
  businesses by offering six months of interest and penalty relief will allow them
  to temporarily delay payments for select provincially administered taxes, giving
  them more flexibility to deal with any challenges resulting from U.S. tariffs.
- The six-month period begins April 1, 2025, and ends October 1, 2025. All taxes owed must be paid by October 1, 2025.
- The WSIB surplus rebate announced last November returned \$2 billion in surplus funds to Ontario businesses. Eligible businesses who are safe employers received their distribution amount in March.
- Last year, the government also provided additional support for workers by removing the \$150 fee for apprentices taking their first Certificate of Qualification exam, saving each apprentice at least \$330 in total when combined with other fee removals and deductions that the province has implemented since 2019.

 The province also unlocked \$400 million in health and safety programs for workers and employers developed by the WSIB, to support workers and ensure they have the supports they require.

# Ontario Proposing to Expand Strong Mayor Powers to 169 Additional Municipalities

Expansion will help municipalities deliver on provincial priorities like building homes and infrastructure

April 09, 2025

**Municipal Affairs and Housing** 

TORONTO — Ontario is proposing to expand strong mayor powers to the heads of council in <u>169 additional municipalities</u> effective May 1, 2025 to help deliver on provincial priorities, such as building more homes, transit and other infrastructure across Ontario.

This significant expansion reflects Ontario's commitment to streamline local governance and help ensure municipalities have the tools they need to reduce obstacles that can stand in the way of new housing and infrastructure development. The powers would allow heads of council of single- and lower-tier municipalities with councils of six members or more to support shared provincial-municipal priorities, such as encouraging the approval of new housing and constructing and maintaining infrastructure to support housing, including roads and transit.

"Heads of Council are key partners in our efforts to build homes and infrastructure across the province," said Rob Flack, Minister of Municipal Affairs and Housing. "By extending strong mayor powers to these additional municipalities, we are providing mayors every tool at our disposal to empower them to get homes and infrastructure built faster. Mayors know their municipalities best, and we support them in taking bold actions for their communities."

Ontario's strong mayor powers, initially introduced for Toronto and Ottawa in 2022, have been gradually rolled out across the province. The province currently has 47 municipalities with these enhanced powers, which have helped to cut red tape and accelerate the delivery of key priorities in their communities. These enhanced powers come with increased accountability for heads of council and maintain essential checks and balances through the oversight of councillors.

Strong mayor powers and duties include:

- Choosing to appoint the municipality's chief administrative officer.
- Hiring certain municipal department heads and establishing and re-organizing departments.
- Creating committees of council, assigning their functions and appointing the chairs and vice-chairs of committees of council.
- Proposing the municipal budget, which would be subject to council amendments and a separate head of council veto and council override process.
- Proposing certain municipal by-laws if the mayor is of the opinion that the
  proposed by-law could potentially advance a provincial priority identified in
  regulation. Council can pass these by-laws if more than one-third of all council
  members vote in favour.
- Vetoing certain by-laws if the head of council is of the opinion that all or part of the by-law could potentially interfere with a provincial priority.
- Bringing forward matters for council consideration if the head of council is of the opinion that considering the matter could potentially advance a provincial priority.

# **Quick Facts**

- Strong mayor powers have been used across the province to support the building of more homes. For example, they have been used to facilitate a new housing complex near transit in Ajax and to direct staff in St. Catharines to prioritize housing developments.
- Certain strong mayor powers can only be used to support <u>prescribed provincial</u>
   <u>priorities</u>, which include building new homes and constructing and maintaining
   infrastructure like roads that support new and existing housing developments.
- This tool complements historic and <u>ongoing investments in housing-enabling</u> <u>infrastructure</u> and the new <u>Provincial Planning Statement</u> that helps municipalities support growth by reducing and streamlining planning rules.
- The proposal will be posted on <u>Ontario's Regulatory Registry</u> until April 16, 2025.

# **Warden's Address**

### **Key highlights**

- The Renfrew County Virtual Triage and Assessment Centre (RC VTAC), a local solution launched just days after the COVID-19 pandemic began in March 2020, marked its fifth anniversary on March 27 as it continues to serve residents without access to primary care. A collaboration between family doctors, paramedics, local hospitals, and health organizations, RC VTAC has been instrumental in reducing pressure on Emergency Departments and providing accessible health-care services. In 2024 alone, it received nearly 74,000 calls and diverted approximately 1,000 Emergency Room visits monthly. Through a variety of services, including phone and video appointments, in-home assessments, and referrals, RC VTAC addresses a range of health concerns. The Honourable Sylvia Jones, Deputy Premier and Minister of Health, was in Renfrew on March 27 for a celebration to mark the five-year milestone.
- Nominations are open for the 2025 Ottawa Valley Tourism Awards and it is time to celebrate the
  best of Ottawa Valley tourism! The Ottawa Valley Tourism Awards recognize industry
  achievements, inspire future excellence, and honour those making a lasting impact in our
  region. The OVTA is encouraging member businesses, events and individuals to self-nominate or
  nominate a deserving fellow member for one of these six awards: Tourism Champion,
  Business/Organization of the Year Award, Event of the Year Award, Tourism Marketing Award,
  Sustainability Champion Award and New Tourism Product Award.
- Registration for the 18<sup>th</sup> annual <u>Warden's Golf Tournament</u> is now open. This year's event is being held at the Dragonfly Golf Links at Renfrew on Friday, June 20, with proceeds going towards the Darlene Aikens Memorial Fund of Family and Children's Services of Renfrew County to help send kids to camp and the Renfrew County Housing and Homelessness Fund.
- On March 4, the Warden attended Enterprise Renfrew County's Francophone Networking Breakfast hosted in partnership with Renfrew County Community Futures Development Corporation. He congratulated Luc Fleurant and Bernadette Demong of Ottawa Valley Taekwon-Do on winning the Francophone Entrepreneur of the Year Award.



# **Delegations**

• At the March 26 Development and Property Committee, Business Development Officer David Wybou, made a presentation about the proposed HYPE (Helping Your Place Excel) Regional Incentive Program for Renfrew County. In February, County Council approved \$100,000 in the Economic Development budget for the County of Renfrew initiative designed to drive economic development through financial incentives that support key areas of investment. Aligned with the County's Strategic Plan, Trail Strategy, Active Transportation Plan, Climate Action Plan, Housing/Homelessness Plan, and Economic Development Strategic Plan, it promotes Housing, Tourism, Business Retention & Expansion, and Investment Readiness.

This program will provide up to 50% matching grants for eligible projects in local municipalities that have a Community Improvement Plan in place. The total grants cannot exceed \$15,000 annually per property. The program is open to property owners, businesses, and not-for-profit organizations.

The program provides funding for projects that enhance: Agriculture & Agri-Tourism, Brownfield Redevelopment, Affordable Housing & Secondary Dwellings, Energy Efficiency & Environmental Enhancements, Accessibility Improvements, Commercial, Institutional & Industrial Development, and Regional Trail Expansion.

Following the presentation, the Development and Property Committee recommended that County Council receive and accept the Helping Your Place Excel (HYPE) Program details for consultation. Direction was given to staff to proceed with amending the County of Renfrew Official Plan permitting County Council to provide grants and/or loans to support local Community Improvement Plan initiatives. County staff is also available to those communities without a CIP and that want to discuss a path forward.

# **Development & Property Committee**

# **Presented by: James Brose, Chair**

• County Council approved the Terms of Reference for the Climate Action Ad Hoc Committee. It is proposed that the Climate Action Ad Hoc Committee be established to guide the implementation of the County of Renfrew's Climate Action Plan. The Committee will focus on identifying priorities, facilitating stakeholder engagement, recommending actionable strategies, and ensuring alignment with the County's Climate Action Plan for both the County of Renfrew goals and community goals for reducing greenhouse gas emissions. The goal is to achieve a 20% decrease in emissions from County operations and a 20-25% reduction in community-wide emissions by 2030 with 2021 as the baseline year.

# **Operations Committee**

# Presented by: Dan Lynch, Vice Chair

Public Works and Engineering staff will coordinate with the organizer of the Everest Climb
Cancer Fundraiser to explore and assess agreeable traffic management solutions to ensure
County Road 512 (Foymount Road) remains open during the Everest Hill Climb fundraiser while
promoting safety for road users and event participants. Staff will continue to explore other
potential traffic mitigation measures with the organizer.



- County Council approved several contracts/agreements as submitted:
  - For engineering services for the replacement of County Structure B188 (Turcotte Bridge), located on Code Road, approximately 2.2km northeast of Micksburg Road, in the Township of Laurentian Valley, by Tatham Engineering Limited, Collingwood, Ontario in the amount of \$83,575, plus applicable taxes.
  - For pavement marking as submitted by Trillium Pavement Marking (TPM), Carleton Place, Ontario, for one additional year (2025) in the amount of \$707,042.54, plus applicable taxes. This is an extension of the 2003 contract.
  - For Engineering Services for the rehabilitation of County Structure B145 (Combermere Bridge), to include Contract Administration and Construction Inspection, for Jacobs Consultancy Canada Limited, Ottawa, Ontario, in the amount of \$379,123.30, plus applicable taxes.
- County Council passed a resolution to develop an Ad-Hoc Committee to review potential options
  for a transit system with application for the County of Renfrew. This follows the writing of an indepth report by the Director of Public Works and Engineering, which can be found in the council
  package.
- County Council adopted a by-law approving the alterations to County Roads and Structures for the 2025 construction season. Approval of the alterations to a highway is intended to be the final step in the design process, where Council authorizes the work to proceed, subject to the budget and tender process. The approval is intended to apply only to those Capital Projects, which would result in alterations to the highway that could affect a person's access to and from their land, or that could significantly restrict or alter the use of the highway for a period of time. Only those projects that involve significant alterations are presented for approval. The By-law sets out 16 rehabilitation projects on County Roads, two bridge rehabilitation projects and the rehabilitation/reconstruction of five culverts.
- At the March 26 Operations Committee meeting, Committee approved the following recommendations:
  - The 2025 Work Plans as presented for the Algonquin Trail and the K & P Recreational Trail. On March 19, 2025, the Recreational Trails Advisory Ad Hoc Committee approved the 2025 Work Plans which include funds in the amount of \$203,900 for Algonquin Trail maintenance and \$25,000 for K & P Recreational Trail maintenance. The works will include dust suppression activities, repairs to signs and gates, general structural repairs, grading/surface repairs, fencing, ditching and vegetation management and tree planting.
  - The approved 2025 Budget also includes \$2,500,000 for Algonquin Trail Development, which includes allocations from the Active Transportation Fund for completion of the Algonquin Trail to Bissett Creek. Additionally, the Capital portion of the 2025 budget includes funds for the following Capital Projects on recreational trail infrastructure:
    - Replacement of AT009 (Jeffreys Creek) \$200,000
    - Engineering for AT032 (Highway 17 and Bissett Creek Overpass) \$110,000
    - Engineering for KP001 (Madawaska River 1) \$46,000
    - Legal and Ontario Land Survey Fees for Mississippi Valley Conservation Authority Land Transfer \$30,000
    - Legal Fees for Canadian National Transfer (Laurentian Valley and Whitewater Region) \$10,000



 A Contract for the purchase of three Light Duty Pick-Up Trucks, as submitted by Surgenor Chev Buick GMC Cadillac, Ottawa, Ontario, in the amount of \$163,740, plus applicable taxes.

# **Corporate Services Committee**

- By-laws were passed in relation to the 2025 Tax Policy:
  - o A by-law to set tax ratios for County and lower-tier purposes.
  - A by-law to set tax rate reductions for prescribed property subclasses for County and lower tier purposes for the year 2025.
- County Council adopted a by-law to establish the 2025 Tax Rates for County of Renfrew purposes.

# **Health Committee**

### Presented by: Michael Donohue, Chair

- County Council adopted a revised by-law to accept the Service Agreement between the County
  of Renfrew and the Ontario Provincial Police (OPP) for renewal of the 9-1-1 Primary Public Safety
  Answering Point (P-PSAP) Service Agreement for an indefinite term rather than a five-year term
  in the previous agreement.
- County Council adopted a by-law to enter into a collaborative agreement between the County of Renfrew, the University of Western Ontario and Scatr Inc. to participate in a Leading the Way: People with Living and Lived Experience (PWLLE) at the Forefront of Drug-Checking Initiative designed and developed by Western University research team. This project aims to engage the Mesa team and community paramedics in enhancing harm reduction strategies, including the optimal use of drug-checking services. Participation in this project will allow County of Renfrew Paramedics the opportunity to analyze the local drug supply and gather information that is not otherwise available. The Scatr machine will provide paramedics on the spot results, informing the identification of various substances and the estimated quantities of each substance in the sample.
- County Council adopted a revised by-law authorizing the lease of three additional ZOLL ONE program monitor/defibrillator units from ZOLL Medical Canada Inc. With the increased need in the community for paramedic service due to the expansion of the Mesa program and the Virtual Triage and Assessment Centre (VTAC) program, there is a desire to appropriately support our paramedics and patients with three additional ZOLL ONE program monitor/defibrillator units. Adding three units to the existing contract will increase the County's monthly payments by \$2,650.61 and the annual cost by \$31,807.32. This will raise the annual cost from \$344,241.30 to \$376,048.62.

A made-in-Renfrew-County solution to address health-care needs in response to COVID-19, launched mere days after the declaration of the global pandemic, has marked its fifth anniversary as it continues to evolve to provide impactful service for residents who do not have access to primary care.

The Renfrew County Virtual Triage and Assessment Centre (RC VTAC), a collaboration between family doctors, the County of Renfrew Paramedic Service, primary-care teams, Renfrew County Hospitals, and the Renfrew County and District Health Unit, officially launched on March 27, 2020. The goal was to reduce demands

on local Emergency Departments and provide Renfrew County residents, who did not have a family physician or could not access their family physician, with the appropriate level of care to address health-care concerns, including those related to COVID-19.

To mark this significant milestone, the Honourable Sylvia Jones, Deputy Premier and Minister of Health, was in Renfrew to tour the Clinical Assessment Centre and Paramedic Base on March 27. She was joined by MPP Billy Denault, elected officials, RC VTAC staff and other distinguished guests for the formal remarks in the atrium of Renfrew County Place.

"On behalf of Premier Ford and our entire government, I want to congratulate the world-class team at the Renfrew County Virtual Triage and Assessment Centre on a successful five years," said Minister Jones. "The innovative model of RC VTAC and the services you provide are a critical piece of our government's work to connect more people to the care they need, when they need it, close to home."

She presented Renfrew County Warden Peter Emon with a certificate of achievement to mark the RC VTAC anniversary and recognized Paramedic Chief Michael Nolan for his quick actions in response to the plane crash at Toronto Pearson Airport in February. Chief Nolan presented Minister Jones with a helmet and epaulettes to bestow the distinction of Honorary Paramedic Chief.

MPP Denault was excited to welcome Minister Jones to Renfrew-Nipissing-Pembroke to celebrate the innovative and local asset of RC VTAC.

"RC VTAC's five years of service to our community marks a milestone that is befitting of an asset so important to provide care to those who need it," he said. "It is a testament to our government's commitment to provide access to quality care that we have achieved this together in partnership with the County of Renfrew and the Province of Ontario."

RC VTAC continues to expand through collaborative efforts to meet the needs of the community, with approximately 30,000 people in Renfrew County still without a family doctor. In 2024, RC VTAC received nearly 74,000 calls and continually helps to divert 1,000 Emergency Room visits per month.

Through RC VTAC, Physicians and Paramedics assess and manage health concerns in multiple ways depending on the needs of individual callers. This includes:

- Phone appointments
- Video appointments
- In-home assessments and diagnostic testing by Community Paramedics
- Referral to other services, including mental health support.

Callers may also be directed to in-person Clinical Assessment Centres in Pembroke, Renfrew, Arnprior, Petawawa, and Eganville where they can be examined by Paramedics who work collaboratively with Physicians to make diagnoses. Options to further expand clinic locations are always being explored to best serve the residents of Renfrew County.

Another integral part of RC VTAC is Integrated Virtual Care (IVC), the next step in hybrid care, which provides comprehensive care to patients who do not have access to a family physician or a Family Health Team. Petawawa Centennial Family Health Centre (PCFHC) is the lead organization with two satellite locations – the West Champlain Family Health Team in Pembroke and the North Renfrew Family Health Team in Deep River.

The IVC family physicians are embedded into the Petawawa Centennial Family Health Team (FHT), working predominantly remotely, fully supported by the FHT's local interdisciplinary health-care providers (Dietitian, Social Worker, Pharmacist, Respiratory Therapist, Midwife, Registered Practical Nurse, Nurse Practitioner). IVC patients access in-person care at home and virtually depending on their individual needs and preferences. To date, nearly 7,000 patients have been attached to a named family physician, and there have been more than 30,000 physician appointments.

Permanent funding for RC VTAC was announced in March 2023 with a \$3.2 million annual investment by the Government of Ontario through the Ministry of Health and Ontario Health.

"RC VTAC continues to play a crucial role in providing accessible health-care services to residents across Renfrew County. RC VTAC helps bridge the gap in health-care access, ensuring that residents receive timely medical advice and support without needing to travel long distances," said Warden Emon. "Since its inception in March 2020, RC VTAC has emerged as a trusted and essential component of the local health-care system, ensuring that residents receive the care they need while alleviating pressure on traditional health-care facilities."

In 2022, the County of Renfrew was honoured with the Peter J. Marshall Innovation Award by the Association of Municipalities of Ontario, and RC VTAC received the Community Impact Award from the Upper Ottawa Valley Chamber of Commerce Business Excellence Awards Gala. In 2023, IVC received the Bright Lights Award from the Association of Family Health Teams of Ontario.

Recent feedback reveals high satisfaction rates among patients utilizing RC VTAC, with 86% of respondents reporting satisfaction or high satisfaction with their experience. Satisfaction was notably high across all service modalities: 89% for virtual appointments, 92% for hybrid appointments, and an impressive 98% for inperson paramedic appointments.

"RC VTAC enhances timely access to integrated health-care services for all residents, addressing any non-emergency medical concerns they may have," noted Chief Nolan. "It has served tens of thousands of residents, leading to fewer 911 calls and emergency department visits, thereby preserving these critical resources for those experiencing life-threatening emergencies."

# Northeastern Public Health Reports First Confirmed Cases of Measles in the Region

**Timmins, Ontario** — Northeastern Public Health (NEPH) is reporting 2 cases of measles in the District of Timiskaming. The risk to the public is low and the health unit continues to monitor the situation.

The individuals diagnosed with measles are currently in isolation and following the appropriate public health measures. Upon investigation of one of the confirmed cases of measles in the health unit area, an exposure was identified on Saturday, March 29, 2025, on Ontario Northland Buses and rest stops along the way.

Measles is a highly contagious virus that can lead to serious complications. A person with measles is contagious four days before and four days after the rash appears. The measles virus can live in the air for up to two hours, even after the person with measles has left the area.

The virus spreads through the air when an infected person breathes, coughs, or sneezes. The first symptoms of measles are a fever, a runny nose, sneezing, a cough, and red, sore, watery eyes. Some people may also get small spots in their mouth. A rash usually appears after two to three days and starts on the face before spreading to the rest of the body.

If you were present at the locations identified below, were born on or after January 1, 1970, and are not up to date with your vaccination, you are asked to call public health.

If you are protected against measles, it is very unlikely that you will develop the disease. As a precautionary measure, watch for measles symptoms until 21 days after the date of exposure.

People are considered protected if they have at least one of the following:

- Proof of vaccination with two valid doses of measles-containing vaccine (e.g. MMR vaccine)
- Blood work showing antibodies to measles
- Documentation of prior laboratory-confirmed measles infection
- Born before 1970 (with the exception of health care workers and military)

If you do not have any of the above, you are not protected against measles.

If you think you have been exposed, and you are not protected against measles:

- If you attend or work at a school, childcare, or healthcare setting, you MUST stay home and contact your local public health unit for further direction.
- If you have had no doses of MMR vaccine, stay at home and contact your local public health unit for further direction.
- If you have had one dose of MMR vaccine, call your healthcare provider or your local public health unit to receive an additional dose of MMR vaccine. Notify your healthcare provider of your exposure so that they can take appropriate precautions to limit the spread of measles. Unless you work in a healthcare setting, you can immediately return to work, school, or daycare after you get a second dose of measles-containing vaccine.
- If you (or a family member) are at high risk of complications as listed below, contact your healthcare provider or your local public health unit to discuss options to reduce the risk of measles infection through vaccination or a product called immunoglobulin. For these to be effective, they must be given very soon after exposure.
  - o Babies under one year age who have not received measles vaccine
  - o People with a severely weakened immune system
  - o Pregnant individuals who are not protected against measles
  - If you are uncertain about your vaccination status, call your healthcare provider or check the Legacy Porcupine Health Unit website via ICON, or the Legacy Timiskaming Health Unit website via ICON, to determine if you have received an MMR vaccine in the past.
- Watch for measles symptoms until 21 days after the date of exposure.
  - If you develop symptoms and need medical care, call ahead before you visit the doctor, clinic, or hospital to inform them of your exposure to measles so they can prepare for your arrival and take appropriate precautions. Wear a mask if you need to seek medical attention.



Symptoms can appear 7 to 21 days after contact with someone who has the measles virus. Measles symptoms include:

- A high temperature
- A runny or blocked nose
- Sneezing
- Coughing
- Red, sore, watery eyes
- Spots in the mouth. Small white spots may appear inside the cheeks and on the back of the lips after a few days. These spots usually last a few days.
- A rash usually appears a few days after the cold-like symptoms. The rash starts on the face and behind the ears before spreading to the rest of the body.

If you think you have measles, isolate immediately and call your health care provider to discuss testing. Call before visiting any healthcare setting so that they can prepare for your arrival. Wear a mask if you need to seek medical attention.



# AMO Policy Update – New Advocacy on Development Charges, Buy-Canadian & Buy-Ontario Initiatives, and Codes of Conduct

# **Municipal & Development Sector Collaboration on Development Charges Reform**

Ontario's housing crisis persists, with housing starts continuing to lag. All partners in Ontario's housing system – including municipalities and developers – must do their part and find new ways to increase housing supply.

AMO's evolving approach to this important issue is informed by:

- Ontario's persistent housing supply shortage, exacerbating affordability challenges. Tariffs and trade measures could continue to impact housing starts, creating additional urgency.
- Municipal development charges (DCs) and planning approvals continue to be unfairly blamed for the crisis. Both federal and provincial governments have committed to reducing DCs.
- A shifting approach to development sector advocacy. In January, the Ontario
  Home Builders Association (OHBA)/BILD released <u>a study</u> that recognized DCs
  as essential for growth, and advocated for targeted DC modernization as
  opposed to blanket reductions.

To build momentum for constructive and informed progress, AMO and OHBA have partnered to call for DC reform that is mutually agreeable. AMO and OHBA <u>wrote to the Minister of Municipal Affairs and Housing</u> to identify preliminary areas for reform to be considered collaboratively by homebuilding, provincial, and municipal partners. A cross-sector expert working group could recommend targeted and measured DC reform aimed at reducing housing production barriers and increasing clarity and predictability around DCs.

AMO consulted municipal finance experts to identify potential areas for reform. While the letter initiates the desired discussion, much work remains to be done. AMO has invited the Municipal Finance Officers Association (MFOA) and their DC expert table to support discussion. Their participation will be key in assessing impacts on municipal property taxes and user fees, informing recommendations that promote affordability by considering the total cost of homeownership.

# **Results of AMO Survey on Municipal Procurement from US**

To help inform policy discussions around banning US suppliers from participating in government procurement, AMO has conducted a survey of municipalities regarding non-construction procurement and is releasing a summary of the survey results.

Municipalities reported that over 98% of their procurement is from companies with Canadian addresses, but many of those businesses are integrated with the US market. US procurement was primarily for goods and services without Canadian alternatives, and needed to deliver essential services including:

- IT and communications products
- Emergency services equipment and medical supplies
- Heavy machinery and vehicles
- Health and safety including chemicals and equipment for water treatment.

AMO will continue to provide guidance to the province on how municipalities can support provincial buy-Canadian and buy-Ontario initiatives without impacting essential service delivery.

### **AMO Advocacy on Code of Conduct Legislation**

AMO wrote to Minister Flack urging the government to reintroduce code of conduct legislation with two recommended amendments:

 Removal of office vote requirement should be adjusted from unanimous to a supermajority (2/3 vote). A vote to remove an elected municipal official from office is different than a regular council vote and should have a higher threshold, but given the other checks and balances built into the process a unanimous vote is too high a threshold. • The legislation should include a progressive range of discipline options for integrity commissioners. The province should use the penalty framework established under the *Education Act* in 2023, including censure of a member, barring attendance at meetings, barring a member from sitting on committees, and barring a member from being chair or vice chair of committees

# AMO Policy Update – New Provincial Cabinet

#### **Premier Ford Unveils New Cabinet**

Yesterday, Premier Ford unveiled his new cabinet following his government's electoral victory at the end of February. The cabinet is largely the same as its pre-election make-up, with some notable changes including the appointment of a new Minister and Associate Minister of Municipal Affairs and Housing.

AMO is writing letters to these select Ministers to offer congratulations and advance AMO's top advocacy priorities:

- Rob Flack, Minister of Municipal Affairs and Housing and Graydon Smith, Associate Minister of Municipal Affairs and Housing on the urgent need to:
  - Establish a more sustainable municipal-fiscal framework
  - Secure stimulus to enable municipalities to emerge stronger from trade disruptions and tariffs
  - Develop an 'all of government' plan to tackle homelessness, and
  - Implement municipal codes of conduct.
- Lisa Thompson, Minister of Rural Affairs on top rural municipal advocacy priorities including their access to housing-enabling

infrastructure funding, homelessness, improving access to primary and hospital care, and supporting energy, broadband and cellular infrastructure expansion.

- Vic Fedeli, Minister of Economic Development, Job Creation and Trade offering support and collaboration in response to trade disruptions, including on reviewing inter-provincial trade barriers, retooling supply chains, and leveraging local municipal economic development capacity.
- Stephen Crawford, Minister of Public and Business Service Delivery and Procurement on the impact of international trade and tariff negotiations on municipal procurement and the need for provincial clarity on 'Buy Canadian' strategy in collaboration with our sector.
- Stephen Lecce, Minister of Energy and Mines on continued collaboration in support of successful long-term electricity procurements, finalization of the provincial Integrated Energy Plan and Natural Gas Policy, and clarity on the province's broadband implementation plan following Ontario's Starlink cancellation.
- Sylvia Jones, Deputy Premier and Minister of Health on the implementation of the Primary Care Action Plan, aligning public health standards to funding levels, making the community paramedic program permanent, and building a continuum of community mental health and addictions services to help tackle the root causes homelessness.
- Natalia Kusendova-Bashta, Minister of Long-Term Care on ensuring provincial operating grants better reflect real costs of operating municipal long-term care homes and reviewing proposed amendments to the Fixing Long-Term Care Act, 2021.
- Doug Downey, Attorney General on the need for a third-party review of the provincial offenses system.
- Michael Parsa, Minister of Children, Community and Social Services on development of a new administrative funding model for municipal delivery of social services, improvements to income security to help address the homelessness crisis, and preparing for a potential surge of asylum seekers.

 Paul Calandra, Minister of Education on advancing the extension and implementation of a renewed Canada Wide Early Learning and Child Care (CWELCC) bilateral agreement, and future planning for primary and secondary schools.

AMO will be engaging the Ministers of Finance and Infrastructure with a revised 2025 pre-budget submission. The submission will outline economic impacts of the ongoing trade war on municipalities. It will also call for stimulus investments in community housing and municipal infrastructure to help sustain Ontario's construction sector and invest in critical community infrastructure. Lastly, it will re-affirm the continued importance of action on <a href="Iong-standing municipal priorities">Iong-standing municipal priorities</a> including infrastructure, reducing municipal subsidies for areas of provincial jurisdiction, and tackling the root causes of homelessness.

RE: Motion to amend prior motion presented to Regional Council on February 26, 2025, re: Banning the Nazi Swastika in Canada, to remove references to "Swastika" from the motion and replace them with "Nazi symbols of hate", Our File: C00

As a follow-up to our previous correspondence sent on February 28, 2025, please be advised that the Council of the Region of Durham, at its meeting held on March 26, 2025, adopted the following recommendations of the Finance & Administration Committee:

- A) That subject to a 2/3rds majority vote, the resolution with respect to Banning the Nazi Swastika in Canada, adopted at the February 26, 2025 Regional Council meeting, be reconsidered; and
- B) That subject to Part A) being approved, that the resolution be amended to replace all references to Nazi swastika(s) with the words "Nazi symbols of hate", and make any necessary associated grammatical revisions.

For your reference, the resolution now reads as follows:

"Whereas in recent years, Nazi iconography has surfaced with alarming frequency in the public sphere, used by an increasing number of groups and individuals to promote hate and instill fear within Canadian society; and Whereas since the atrocities of WWII, the Nazi hakenkreuze, has become universally synonymous with systematic violence, terror and hate. Its growing presence in our country poses a threat to every single Canadian citizen, undermining the core values of equality, diversity, and inclusion that define our nation, and

Whereas eighteen countries have already taken action to ban these symbols, it is imperative that Canada follow suit;

Therefore be it resolved, that Durham Region Council supports B'Nai Brith's call to the Government of Canada to pass legislation banning, with exceptions for certain educational and artistic purposes, the public display of Nazi symbols of hate and iconography, including the Nazi hakenkreuze. Specifically, demanding that the Government of Canada immediately:

- 1. Ban the Nazi hakenkreuze
- 2. Ban all Nazi symbols of hate and iconography

Durham Region Council agrees that the people of Canada are counting on the federal government to ensure a future free from hate, where every Canadian is protected, valued, and respected; and

That a copy of this motion is sent to all Canadian Municipalities."
