Ontario Supporting New Emergency Communications System to Protect People, Families and Communities

Province extending Next Generation 9-1-1 funding for another year

TORONTO — As part of its plan to protect Ontario, the government is investing almost \$22 million to help municipalities and emergency response centres support the transition to a new 9-1-1 communications system known as Next Generation 9-1-1.

"Every second counts when calling 9-1-1, and that's why we are taking action to ensure Ontario's emergency operators and dispatchers have access to state-of-the-art technology so that they can get help to where it's needed most," said Solicitor General Michael Kerzner. "Extending Next Generation 9-1-1 funding for an additional year will support the continued adoption of this life-saving system, resulting in safer communities and a better-protected Ontario."

Public safety answering points (PSAPs) that handle emergency calls, and have not yet transitioned to Next Generation 9-1-1, will have the opportunity to apply for the funding this summer. The funding is part of the government's \$208 million investment to help municipalities and emergency response centres upgrade infrastructure and technology to support the transition to Next Generation 9-1-1. These upgrades include new telephone systems, call handling systems and internal network and cyber security infrastructure.

Once fully implemented, Next Generation 9-1-1 will make it easier to provide additional details about emergency situations such as video from the scene of an accident and to text 9-1-1 when requesting immediate help from police, fire or ambulance services. It will also give emergency operators and dispatchers the ability to identify the location of a call using GPS coordinates, resulting in a safer, faster and more informed emergency response.

Quick Facts

- There are 108 PSAPs across the province of Ontario that receive and process emergency calls.
- The Canadian Radio-television and Telecommunications Commission has extended the deadline for all phone and cell service companies to update their networks from analog to digital to March 31, 2027, so they are ready to provide Next Generation 9-1-1 services.
- The public will still be able to access 9-1-1 and other emergency communications throughout the transition to Next Generation 9-1-1.

Ontario Launches Award to Honour Exceptional Veterans

First-of-its-kind award recognizes veterans for outstanding community service

BRAMPTON – Today, the Ontario government launched the new Ontario Veterans Award for Community Service Excellence (OVACSE). The award honours individuals for exceptional and ongoing service to their communities, such as work to help veterans re-integrate into civilian life, supporting those dealing with ongoing mental or physical injuries, or other broader community-building initiatives.

"Premier Ford and our government are proud to launch the Ontario Veterans Award for Community Service Excellence, a historic program to honour the invaluable volunteer efforts of our veterans," said Graham McGregor, Minister of Citizenship and Multiculturalism. "We can never fully repay those who have served our country, but this award will help strengthen our province by recognizing the legacy of our veterans and their contributions to building a stronger Ontario."

The new initiative makes Ontario the first province in Canada to establish an award specifically dedicated to honouring veterans' excellence in community service. Each year, Ontario branches of The Royal Canadian Legion will each nominate one veteran who has demonstrated significant and sustained contributions to their community through exceptional work. The nominating Legion branches will present certificates and lapel pins to award recipients during local ceremonies in each year.

Ontario is home to approximately 149,000 veterans and each year, approximately 9,000 Canadian Armed Forces members are released from military service.

Ontario Protecting Workers on Construction Sites

Province proposing changes that would improve access to defibrillators at construction sites

May 23, 2025

Labour, Immigration, Training and Skills Development

WHITBY — The Ontario government will soon introduce first-in-Canada changes that will, if passed, create safer workplaces for construction workers by requiring automatic external defibrillators (AEDs) at construction sites. This builds on the lifesaving changes introduced in 2022 that require naloxone kits in at-risk workplaces.

"Our government is protecting Ontario workers that are building our province by requiring AEDs on construction sites," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "Our skilled workers are at the centre of our government's plan to build highways, energy and key infrastructure. Ensuring lifesaving equipment is where it's needed to keep them safe is one more way we're creating safer workplaces."

Cardiac events, including sudden cardiac arrest, are a leading cause of workplace fatalities, with construction workers being at higher risk. AEDs are electronic devices used to restore normal rhythm to a person's heart if they are in cardiac arrest. When used together with CPR in the first few minutes after a cardiac arrest, AEDs can dramatically improve cardiac arrest survival rates by more than 50 per cent.

The proposed amendments would require AEDs on construction projects that are expected to last three months or longer with 20 or more workers. To support businesses with the costs, a proposed program through the Workplace Safety and Insurance Board (WSIB) would reimburse constructors for the purchase of an AED.

The proposal is part of a larger proposed package that will expand on the ground-breaking actions across six previous Working for Workers Acts since 2021, which will be unveiled in the coming days. This latest package will help protect Ontario workers and the economy for the long-term, create safer workplaces for a stronger

workforce and fight worker abuse by cracking down on bad actors. This is all part of our plan to protect Ontario and help make it the best place to live, work, and raise a family.

Quick Facts

- During consultations held as part of <u>Working for Workers Five</u>, construction industry stakeholders recommended AEDs as essential devices to have on site and highlighted the need for financial support to help small businesses with the purchase of these devices.
- In April 2025, the cost to purchase one AED is on average \$2,300.
- This WSIB reimbursement program would be paid from the WSIB insurance fund.
- Data from the Ministry shows that more than 15% of inspection reports associated with "cardiac" or "heart attack" were in the construction sector.

Ontario Investing in Modern New Policing Facilities to Protect Communities

Province building 12 new OPP detachments and regional HQ in Thunder Bay

TORONTO — As part of its plan to protect Ontario and keep communities safe, the government is building 12 new Ontario Provincial Police (OPP) detachments and a regional headquarters in Thunder Bay.

"Our government is making record investments to fight crime and protect Ontario communities," said Solicitor General Michael Kerzner. "Once built, these new state-of-the-art facilities will respond to the demands of modern police operations and ensure the OPP have the tools and facilities they need to crack down on crime and protect our communities."

In addition to building a new regional headquarters in Thunder Bay, the government is also building new OPP detachments in Ignace, Niagara, Bracebridge, New Liskeard, Burlington, Kenora, Lancaster, Red Lake, Sioux Lookout, Killaloe, Espanola/McKerrow and Wawa.

"This project demonstrates a shared commitment with our government to ensure the OPP is as effective as possible at keeping communities safe," said OPP Commissioner Thomas Carrique. "Providing our officers, civilian and volunteer members with these modern new facilities will better position the OPP to evolve as we strive to be our very best at delivering on our public safety mandate."

In partnership with Infrastructure Ontario, the province is launching a competitive process to find qualified teams to help design, build, and finance the new detachments. Interested parties can visit www.merx.com to download the Request for Qualifications (RFQ).

Ontario Providing Record Education Funding while Ensuring School Board Accountability

Province working to ensure every dollar of school funding supports students in the classroom

May 23, 2025

Education

TORONTO — While ensuring school board accountability and transparency, the Ontario government is providing record education funding as part of its plan to protect Ontario and prepare students for the jobs of tomorrow. In 2025-26, Ontario is investing \$30.3 billion in Core Education Funding for the upcoming school year so schools can continue to deliver high-quality education with a back-to-basics approach that prepares students and our workforce with practical skills for goodpaying, stable careers.

"I have been clear with school boards across the province that we expect every dollar to be spent on directly supporting students, parents and teachers," said Paul Calandra, Minister of Education. "While we continue to make record investments into our students' future, I will be relentless in holding school boards accountable on the way they spend these funds."

Ontario's education funding helps strengthen core skills in reading and math, ensure support for students with special education needs and provide access to mental health services.

For the 2025-26 school year, these investments include:

- \$16.5 billion to support classroom staff, including teachers, kindergarten early childhood educators and educational assistants
- \$4.7 billion to fund staff who support students outside the classroom, such as librarians, guidance counsellors, mental health workers and school administrators, as well as classroom materials and equipment
- \$3.9 billion for special education to provide access to supports and resources for students with special education needs
- \$3 billion for school boards to operate, maintain, renovate and renew school buildings

• \$1.4 billion to fund safe, effective and efficient transportation services

Ontario is increasing school renewal funding to \$2 billion for the 2025-26 school year, primarily through capital funding, to modernize and improve school buildings, which includes new targeted investments to support accessible and healthy learning environments. This is in addition to the \$1.3 billion the government is investing through the Capital Priorities program to support 45 new schools and expansions. These projects will create more than 25,000 new student spaces and more than 1,600 licenced child care spaces across 23 school boards.

These investments are a part of the government's plan to build a strong, accountable and well-supported public education system that is focused on improving student outcomes. Ontario is moving quickly to bring forward enhanced governance measures in the coming weeks. These changes would provide broader and modernized powers of the government's oversight of school board financial, governance and program performance, including giving the Minister the ability to respond quickly to public concerns.

Quick Facts

- Last year, the province introduced the new <u>Core Education Funding model</u>, which clearly identifies key funding pillars supporting students from classroom staffing to school board administration making it easier for parents and guardians to understand funding allocation and strengthening school board accountability.
- While Ontario provides annual funding to the province's school boards, they are accountable for the quality of educational programs, student performance and the prudent management of financial resources.
- When performance or financial issues occur within school boards, the Ministry of Education can <u>conduct reviews</u> and/or financial investigations in respect of those matters.
- Since April 2025, Ontario has <u>appointed a supervisor</u> to oversee the Thames
 Valley District School Board and <u>launched financial investigations</u> at the Toronto
 District School Board, Toronto Catholic District School Board and Ottawa Carleton District School Board.

Ontario Helping Workers Access Skills Training Faster

Province cutting red tape to speed up construction of training centres and support workers impacted by tariffs and economic uncertainty

<u>Labour, Immigration, Training and Skills Development</u>

RICHMOND HILL — The Ontario government will soon introduce a series of proposed changes to protect workers, including cutting red tape to accelerate the construction of Skills Development Fund (SDF) training centres at a time when these centres are needed to support workers impacted by U.S. tariffs and economic uncertainty. The government is also proposing a number of other measures that would support workers, including workers who are directly impacted by tariff-related layoffs or other disruptions.

"Ontario workers are counting on us to have their backs by helping them access the skills training they need to stay on the job, despite the impact of U.S. tariffs," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "We're making sure our \$2.5 billion investment in SDF is going directly to the workers who need it most and we will continue fighting to protect Ontario workers no matter what comes our way."

To ensure Ontario builds a competitive and resilient workforce that is ready for whatever comes the province's way, the proposed legislative and regulatory amendments would exempt training centres supported by the <u>SDF Capital Stream</u> from certain permit and approval requirements that can slow down construction and impede Ontario's ability to quickly build essential training facilities. By exempting these projects from certain items related to the land use planning system, while maintaining health and safety focused permits and approvals such as those under the Ontario Building Code and the *Fire Protection and Prevention Act*, 1997, training partners will be able to get these centres built and start training workers faster.

Other proposed changes to support workers include:

• Requiring job posting platforms to have mechanisms to report fraudulent job advertisements to ensure workers are not exploited throughout their pursuit of

work.

- Keeping workers on the job by eliminating unnecessary barriers for construction projects required to implement Chief Prevention Officer (CPO)accredited health and safety management systems as part of the procurement process. This will increase competition and accelerate project timelines.
- Allowing Ontario Immigrant Nominee Program (OINP) employer applicants to submit their applications directly and electronically to the new OINP employer portal that will launch in Summer 2025.

This latest package will help protect Ontario workers and the economy for the long-term, create safer workplaces for a stronger workforce and fight worker abuse by cracking down on bad actors. New legislation would ensure response plans are tailored to local needs and enshrine Ontario Corps in law

May 26, 2025

Emergency Preparedness and Response

TORONTO — The Ontario government is taking action to protect communities and build a stronger and more resilient province by reintroducing the *Emergency Management Modernization Act, 2025.* The proposed legislation will enhance public safety and disaster response measures, including making Ontario Corps a key function of emergency responses in the province.

"Extreme weather events like the ice storm this spring are unfortunately becoming more frequent. Our legislation reflects the need to be more prepared in the event of an emergency," said Jill Dunlop, Minister of Emergency Preparedness and Response. "That's why our government is recognizing the critical need for Ontario Corps, so they can be deployed at a moment's notice to help protect families and build a stronger, safer and more resilient Ontario."

Ontario Corps brings together experienced non-governmental partners and skilled volunteers to enhance on-the-ground emergency response that can be deployed quickly to support communities across the province. During the spring ice storm, Ontario Corps partners volunteered over 6,000 hours, delivering generators, providing 3,725 meals and food hampers, conducting over 4,100 wellness checks, providing tree-clearing services and supporting evacuation reception centres.

Following the establishment of the Ministry of Emergency Preparedness and Response as a standalone ministry with a dedicated minister in March, this legislation, if passed, would enable a more effective, coordinated and comprehensive approach to provincial and community emergency management. The changes would prioritize community-led approaches that help municipalities design emergency management programs that reflect their unique needs and capacities.

Enhancing Ontario's emergency management capacity is part of the government's plan to build a stronger and more resilient province with the necessary tools in place to ensure the safety and wellbeing of people across the province.

- The proposed *Emergency Management Modernization Act, 2025* is the first comprehensive update to Ontario's emergency management legislation in more than 15 years.
- The legislation is informed by valuable feedback from partners, best practices in emergency management and lessons learned from past emergencies. The province engaged with more than 550 partners, including municipalities, First Nations communities and emergency management organizations. The ministry also received 91 written submissions on a publicly posted discussion guide.
- The legislation builds on the government's Provincial Emergency Management
 Strategy and Action Plan that outlines key actions the province is taking to
 ensure communities are safe, practiced and prepared before, during and after
 emergencies.
- Ontario is building a new Emergency Preparedness and Response
 Headquarters. The new state-of-the-art complex will be designed to support the
 province's work to prepare for and respond to all types of disasters that will
 operate 24 hours a day, 7 days a week, 365 days of the year. It will include
 dedicated training rooms and warehousing and aviation infrastructure and will
 be built to withstand all types of disasters including earthquakes, tornadoes
 and floods.

Ontario Supporting Recipients of Disability Benefits

Province exempting Canada Disability Benefit as income to protect recipients from benefit reductions

May 27, 2025

Children, Community and Social Services

TORONTO – The Ontario government intends to exempt the Canada Disability Benefit (CDB) as income so that social assistance recipients would receive the benefit without seeing a reduction in their provincial social assistance payments or entitlements. The changes would help recipients of the Ontario Disability Support
Program (ODSP), Ontario Works and the Assistance for Children with Severe
Disabilities (ACSD) program receive their maximum entitlements.

"In a time of unprecedented economic uncertainty brought on by <u>U.S. (United States)</u> tariffs and trade barriers, our government is taking action to keep costs down and protect Ontario families," said Michael Parsa, Minister of Children, Community and Social Services. "This starts with safeguarding our most vulnerable, which is why we are exempting the Canada Disability Benefit as income so people who rely on social assistance receive the benefit without seeing any reductions in their social assistance payments."

The <u>CDB (Canada Disability Benefit)</u> offers up to \$200 each month (\$2,400 each year) for eligible low-income, working-age Canadians with disabilities. By exempting the <u>CDB (Canada Disability Benefit)</u>, social assistance recipients will be able to fully benefit from the new program. Today's announcement furthers Ontario's commitment to protect families by building a more effective and efficient social assistance system that supports those who need it most.

This change would build on work the government has done to strengthen social assistance, such as tying <u>ODSP (Ontario Disability Support Program)</u> and <u>ACSD (Assistance for Children with Severe Disabilities)</u> rates to inflation and increasing the earnings exemption for people with a disability receiving <u>ODSP (Ontario Disability Support Program)</u>. Ontario continues to call on the federal government to amend its *Income Tax Act* so this new benefit has the broadest possible reach.

Quick Facts

- Ontario also fully exempts financial supports for veterans through the <u>Soldiers'</u>
 <u>Aid Commission</u> under <u>ODSP (Ontario Disability Support Program)</u> and Ontario
 Works, and continues to support Truth and Reconciliation efforts with
 exemptions specifically for Indigenous persons who receive social assistance.
- ODSP (Ontario Disability Support Program) rates and the maximum monthly
 ACSD (Assistance for Children with Severe Disabilities) payment are now tied to
 inflation. The next inflation-based rate increase will take place this July. Since
 September 2022, the government has increased social assistance disability
 payments by almost 17 per cent.
- Ontario has increased the earnings exemption for a person with a disability receiving <u>ODSP</u> (<u>Ontario Disability Support Program</u>). An individual can now earn up to \$1,000 a month through employment without it affecting their income support, benefits or eligibility.
- In addition to financial support, Ontario Works recipients receive employment supports through <u>Employment Ontario</u> to help people get the training, skills and experience they need to find and keep a job. These supports include workshops for resume writing, job counselling, job-specific training and basic education.
- Information about the Canada Disability Benefit, including eligibility and how to apply for the benefit, is available at the <u>Government of Canada's website</u>.

Ontario Protecting Communities from Wildland Fires and Hazardous Gas Wells

Province re-introducing legislation to help communities reduce risks of wildland fires and hazardous oil and gas wells, and enable safe use of carbon storage technology

May 27, 2025

Natural Resources

TORONTO — Today, the Ontario government is re-introducing the *Resource Management and Safety Act, 2025* that, if passed, would help protect communities from the risk of wildland fires and hazardous oil and gas wells. The legislation would also help attract more land surveyors to the profession to support Ontario's plan to build more homes and other infrastructure, as well as enable and regulate the use of carbon storage technology.

"We're focused on protecting Ontario's long-term prosperity and ensuring our communities are equipped to meet the challenges of today and tomorrow," said Mike Harris, Minister of Natural Resources. "This legislation takes a comprehensive approach to speeding up the building of homes and other critical infrastructure while protecting the environment and public safety. By adopting innovative technologies and cutting red tape, we're not only creating good jobs and helping industries succeed – we're ensuring Ontario thrives in a challenging global economy."

The Resource Management and Safety Act, 2025, includes the following changes:

- Strengthening community resiliency by modernizing the *Forest Fires Prevention Act* to enhance wildland fire prevention and preparedness, including new requirements for wildland fire management plans and stricter penalties for those who don't follow wildland fire laws, to reduce the risk of unwanted human-caused fires.
- Helping to protect the public and environment from the threat of hazardous oil and gas wells with changes to the *Oil, Gas, and Salt Resources Act* that would allow the ministry to take immediate action to address hazardous oil and gas wells that pose a public safety risk when an operator is not compliant with a

- ministry order in certain circumstances, such as death or bankruptcy, and recover costs of any action taken on the well.
- Supporting rapid infrastructure and housing development needs by proposing to amend the *Surveyors Act* to enhance the vital role land surveyors play in the province's development and growth and help attract more surveyors to the profession to support their key role in helping ensure access to safe and affordable housing options.

"This is a challenging time for the forestry sector and for trade-dependent businesses and workers," said Kevin Holland, Associate Minister of Forestry and Forest Products. "Prevention efforts to mitigate the risks of unwanted wildland fires are essential to the vitality of our forest industry and those communities who depend on it. By ensuring the long-term health of our forests, we will safeguard jobs, protect critical building materials and enhance the safety and resilience of our communities."

As part of the *Resource Management and Safety Act, 2025*, the Ontario government is also proposing a new *Geologic Carbon Storage Act*, to support innovation and manage carbon dioxide (CO2) emissions. If passed, the Act would enable the regulation of commercial-scale geologic carbon storage, which involves injecting captured CO2, that would have otherwise entered the atmosphere, into deep underground rock formations for permanent storage. This advanced technology could help energy-intensive industries cut greenhouse gas emissions by 5 to 7 million tonnes per year, create over 4,000 short-term jobs and reduce carbon costs for Ontario industries by nearly \$1 billion a year, all while ensuring public safety.

The ministry will continue to engage with stakeholders and Indigenous communities to develop supporting regulations and revise the proposed framework as industry brings forward commercial-scale project proposals.

"By supporting innovative carbon storage technology, we are enhancing Ontario's competitiveness, attracting new investment, creating jobs and driving economic growth – positioning the province as a leader in the global market," said Dawn Gallagher Murphy, Parliamentary Assistant to the Minister of Natural Resources. "Geologic carbon storage offers a significant opportunity for Ontario, and the ministry is dedicated to developing a framework that ensures its safe implementation while safeguarding both people and the environment."

If the *Resource Management and Safety Act, 2025* is passed, the province will continue to engage in consultations and develop necessary regulations to support its implementation.

Quick Facts

- Ontario's *Forest Fires Prevention Act* has not received significant updates since 1999. These proposed amendments would enable the use of more modern enforcement tools.
- The *Surveyors Act* has not substantially changed since 1987. Proposed changes would allow companies to leverage technology and other modern business practices to deliver improved services.
- During the 2024 wildland fire season, which runs from April to October, there were 480 fires and 89,841 hectares of forests burned.
- According to the Global Carbon Capture and Storage Institute an international think tank seeking to accelerate the deployment of carbon capture and storage there were almost 400 carbon capture and storage projects at various stages of development worldwide in 2023 and close to 300 million tonnes of CO2 has already been injected underground.

Ontario Introduces Seventh Working for Workers Act

New measures help more workers train for in-demand jobs, strengthen worker health and safety and protect workers affected by U.S. tariffs

May 28, 2025

Labour, Immigration, Training and Skills Development

TORONTO — Today, the Ontario government introduced the *Working for Workers Seven Act, 2025*, which builds on the previous six *Working for Workers* acts with a suite of 18 new proposed measures that will, if passed, protect Ontario workers and the economy in the face of U.S. tariffs and create safer workplaces for a stronger workforce.

"Our government is protecting Ontario workers by standing up for them when they need it the most," said David Piccini, Minister of Labour, Immigration, Training and Skills Development. "We're proposing changes that will prepare workers and businesses for the jobs of the future, while helping workers facing impacts from U.S. tariffs and economic uncertainty. This package underscores our unwavering commitment to protecting our province's most valuable resource – our workers."

In addition to <u>protecting workers on construction sites by requiring automatic</u> <u>external defibrillators (AEDs)</u> and <u>helping workers access skills training faster by cutting red tape for Skills Development Fund Capital projects</u>, this package would also enhance protections against job scams for prospective job seekers and expand entitlements for workers to provide better support in the event of layoffs.

This proposed legislation follows the *Working for Workers Six Act, 2024*, which received <u>Royal Assent</u> in December 2024. It is the latest step in our plan to protect Ontario, give workers and employers the tools, support and opportunities they need in the face of U.S tariffs and economic uncertainty.

- In 2024, the federal Canadian Anti-Fraud Centre (CAFC) reported an increase in job opportunity fraud. The CAFC found that economic losses in Canada due to job fraud rose to \$47 million in 2024, and losses in Ontario amounted to \$14.86 million due to job scams the highest among all provinces in Canada.
- During consultations held as part of Working for Workers Five, construction industry stakeholders recommended AEDs as essential devices to have on site and highlighted the need for financial support to help small businesses with the purchase of these devices. Data from the Ministry shows that more than 15 per cent of inspection reports associated with "cardiac" or "heart attack" were in the construction sector.
- The Skills Development Fund Training Stream, training and support centres and Employment Ontario are supported through labour market transfer agreements between the Government of Canada and the Government of Ontario.
- The Skills Development Fund Capital Stream is funded exclusively by the Government of Ontario.

Ontario to Introduce Legislation to Strengthen School Board Oversight

New measures would also help protect children and youth and promote student success

May 29, 2025

Education

Children, Community and Social Services

TORONTO —Today, Ontario will introduce the *Supporting Children and Students Act,* 2025, that, if passed, would strengthen government oversight, accountability and transparency in public school boards, postsecondary education and children's aid societies. The changes would also increase the safety, well-being and academic and personal achievement of children and youth.

To further <u>address several cases</u> of financial mismanagement by school boards, the proposed enhanced measures would increase government's oversight of school board finances, governance and program performance, including giving the Minister of Education the ability to respond quickly to matters of public interest.

"Parents deserve confidence that school boards are making decisions in the best interests of their children's education," said Paul Calandra, Minister of Education. "That's why we are strengthening accountability and transparency across Ontario's education system — to ensure that every dollar invested is preparing students with practical skills for good-paying, stable careers. These new measures would build on our previous actions to improve governance, enforce compliance and focus school boards on what matters most: student success. We are making it clear that school boards must put students first — not politics, not bureaucracy — and that we will act decisively when they fall short of that responsibility."

Other key accountability and oversight measures being proposed include:

- Setting out requirements for board expense policies and requiring school boards to post key individuals' expenses on their public-facing website
- Increasing the accountability of children's aid societies by taking measures to strengthen financial oversight, board governance and transparency

- Improving fee transparency for postsecondary students
- Requiring all publicly assisted colleges and universities to have clearly outlined, merit-based admissions policies

Additional proposed changes would promote student success and enhance student, child and youth safety by:

- Incentivizing student volunteerism by introducing a new Minister's Certificate of Recognition for Community Involvement for students who earn 50 or more community involvement hours
- Requiring school boards to implement School Resource Officer (SRO) programs where they are offered by local police services starting in the next school year
- Expanding the Ombudsman's investigative authority to include 18- to 22-yearolds who are eligible for, or are in the Ready, Set, Go program and requiring children's aid societies to notify these youth about the Ombudsman's services regularly
- Consulting on requiring children's aid societies and out-of-home care licensees
 to physically post age-appropriate information about children and youth rights
 and internal complaints processes in areas of a residence that are accessible to
 them

The measures contained in this legislation would build on the government's ongoing work to ensure students, children and youth interact with accountable and transparent public systems and benefit from the supports they need to reach ultimate achievement academically and personally.

Ontario Signs Agreement to Unlock Free Trade with Saskatchewan

Agreement will grow both provincial economies by removing internal trade barriers

SASKATOON — Ahead of the First Ministers' Meeting in Saskatoon, Premier Doug Ford was joined by Saskatchewan Premier Scott Moe to sign a Memorandum of Understanding (MOU) that will help grow both provincial economies by making them more competitive and advancing efforts to knock down barriers to trade across Canada.

"With President Trump taking direct aim at Canada's economy, we need to do everything we can to protect Ontario and Canadian workers by super-charging our own internal trade opportunities," said Premier Ford. TORONTO — Protecting Ontario's local agriculture and food industry is essential to ensuring a strong, self-sufficient food supply chain. This Local Food Week, from June 2-8, 2025, the Ontario government recognizes all of the farmers, food processors, distributors, retailers and restauranteurs that Ontario families depend upon. Ontario's <u>Local Food Report</u> highlights businesses that are strengthening Ontario's local food supply chain and supporting our economy. This year's report features a variety of local food success stories, including:

- A second-generation customized deli and frozen pizza company built on quality and family tradition.
- The 2025 winner of Farmers' Markets Ontario's Market of Year Award.
- One of the oldest cheese cooperatives in Canada.

In addition to these and other great examples, the Local Food Report also features the Foodland Ontario Retailer Awards program. Each year, grocery stores across the province submit photos of creative and innovative displays promoting fresh, locally grown, in-season fruits and vegetables. These displays educate and encourage Ontario consumers to identify and purchase locally grown produce. There are 60 grocery stores receiving 64 awards, and this year, Minister Jones kicked off the award presentations at Metro #73 in Mississauga.

"Supporting Canadian products and buying local is not a new concept for Metro. In the current context, we are putting a greater emphasis on local and Canadian products and optimising their visibility in all our Metro stores," said Joe Fusco, Senior Vice President, Metro. Throughout the month of June, winning grocery stores will be receiving plaques to commemorate their contribution to boosting local food literacy and consumption of locally grown and made food across the province.

This week, and every week, the Province encourages Ontarians to support local farmers and businesses by purchasing foods with the Foodland Ontario logo, or, where possible, buying directly from farmers either on-farm or at their local farmers' market.

Ontario Securing Affordable Energy for Future Generations

New legislation will drive investment, enable more 'Buy Canadian' and create jobs

June 03, 2025

Energy and Mines

TORONTO – The Ontario government is taking decisive action to build a more competitive, resilient and self-reliant economy by introducing the *Protect Ontario by Securing Affordable Energy for Generations Act, 2025.* If passed, this legislation will support major growth in the province's energy system to meet rising demand, while keeping energy affordable, secure, reliable and clean for generations to come.

"As global competition intensifies, energy demand surges, and affordability becomes more important than ever, Ontario isn't standing still – we're stepping up," said Stephen Lecce, Minister of Energy and Mines. "While we face an economic war with President Trump, our government is enabling utilities to 'Buy Canadian', in addition to making economic growth and job creation a centre of our energy plan."

Electricity demand is expected to rise 75 per cent over the next 25 years - the equivalent of adding four and a half cities the size of Toronto to the grid. In addition to investing record amounts to expand new energy capacity for the long-term, the government is meeting this demand by creating new tools to allow Ontario to plan smarter, act faster and deliver the right energy infrastructure to keep pace with economic growth, an increasing population and electrification.

One of the most significant drivers of long-term electricity demand growth are data centres. These facilities support artificial intelligence, cloud computing and digital services, which the government is embracing as a strategic opportunity to drive investment, innovation, and job creation, particularly in northern and rural communities where new investments could anchor high tech ecosystems. With dozens of new data centre projects looking to connect to the grid – representing up to 6,500 megawatts of demand, the equivalent of nearly 30 per cent of peak demand for the province – Ontario is taking steps to manage connections in a way that supports long-term economic and energy system goals.

Current legislation requires utilities to connect all data centres indiscriminately, regardless of economic impact or energy intensity. As electricity demand grows into the 2040s, the government is creating an authority to prioritize projects that maximize benefit to the Ontario economy and workforce. This includes projects that create high-quality-jobs, strengthens Ontario's digital economy and support domestic data housing – ensuring Canadian data stays in Canada, protected from misuse and weaker foreign privacy regimes.

The *Protect Ontario by Securing Affordable Energy for Generations Act, 2025*, if passed, will:

- Codify and add "economic growth" as a formal objective of Ontario's energy agencies the Independent Electricity System Operator (IESO) and the Ontario Energy Board (OEB) ensuring for the first time that agencies are required to actively support job creating investment into Ontario.
- Support Ontario utilities to buy-Canadian and build a more secure energy system by enabling them to fund investments necessary to implement new restrictions on hostile foreign participants in Ontario's energy sector protecting the province from risks of malware, manipulation, tampering and surveillance.
- Expand the eligibility of the <u>Future Clean Electricity Fund (FCEF)</u> to include nuclear generation and transmission infrastructure, which will be necessary to meet the province's growing electricity demand.

"Industries and job creators across Ontario are counting on affordable, stable, reliable power to plan for business growth, and to create new jobs," said Sam Oosterhoff, Associate Minister of Energy Intensive Industries. "This legislation demonstrates the Government of Ontario's commitment to energy-intensive industries and all power consumers, assuring them of an integrated, all-of-the-above energy approach that prioritizes economic growth and affordability – for decades to come."

The *Protect Ontario by Securing Affordable Energy for Generations Act* will support the implementation of Ontario's first Integrated Energy Plan, set to be released later this month. Together, they provide a coordinated, long-term approach to ensure Ontario has the energy it needs to power homes, businesses, and industry without

relying on other jurisdictions. The plan will put affordability first, while supporting economic growth, creating jobs, and by making our economy the most competitive in the G7, with abundant, reliable, clean, and affordable energy supply.

Council and Committee Monthly Summary

May 2025

Below you will find highlights of the County of Renfrew County Council and Committee meetings held May 14 and May 28, 2025.

Please note that this summary does not constitute the official record of the meetings and approved minutes should be consulted for that purpose.

Warden's Address

Key highlights

Warden Peter Emon attended the May 14 meeting virtually and was absent for the May 28 meeting. Acting Warden Jennifer Murphy presided over both meetings.

- She noted Warden Emon was invited by Premier Doug Ford to participate in a multi-minister
 meeting alongside members of the Eastern Ontario Warden's Caucus on May 13 in Toronto. The
 meetings included discussions with the Hon. Rob Flack, Minister of Municipal Affairs; Hon. David
 Piccinni, Minister of Labour, Immigration, Training and Skills Development; Parliamentary Assistant
 Matt Rae, Ministry of Municipal Affairs and Housing and the Hon. Victor Fedeli, Minister of
 Economic Development, Job Creation and Trade.
- At the May 28 meeting, she acknowledged National Paramedic Services Week and National Public Works Week, which were observed from May 18 to 24. On behalf of council and residents she thanked the members of these departments for their service and commitment to our communities.
- She also announced the return of the <u>Silver Chain Challenge</u>, a friendly competition between Renfrew and Lanark Counties which encourages everyone to get outside, stay active, and enjoy our beautiful communities by walking, running or cycling during the month of June. Let's lace up, ride out, and make every step and pedal count. Visit the Silver Chain Challenge website to get started. Let's bring the title home to Renfrew County!
- Councillor Dan Lynch represented the County at the Town of Petawawa's Kick Off to Accessibility
 Week, which is May 25-31. As part of the celebration, he was invited to paint a square, which will be
 part of a centrepiece that promotes Accessibility.
- On Sunday May 25, Councillor Lynch also brought greetings and congratulations from the County to Gerald Tracey in Bonnechere Valley, during the community celebration that highlighted the renaming of "Gerald Tracey Park".



Delegations

At the May 14 meeting, Council heard from the following interested parties:

- Ann Pohl, spokesperson for the Council of Canadians: Kitchissippi-Ottawa Valley spoke about the Climate Action postcards display at the County Administration Building to mark Earth Day. She also provided postcards from their communities to members of County Council.
- Sabine Mersmann, Co-chair of the Ottawa Valley Ontario Health Team, provided an update on Primary Care Team expansion proposals, which were recently submitted on behalf of the West Champlain Family Health Team and the Petawawa Centennial Family Health Team. These proposals are meant to serve high-needs and underserved populations across Renfrew County and South Algonquin and attach people to regular primary care providers. These teams seek to attach almost 18,000 patients to primary care providers by March 2027.
- Chris Brennan, Enbridge Gas, provided an update on the 20-year Franchise Agreement, initially entered with Enbridge Gas Distribution Inc. in April 2025, which was up for renewal.

At the May 28 meeting, Council heard from the following interested party:

- Three German Paramedics Andreas Bauer, Chief of Education, Bavarian Red Cross Regensburg; Stefan Dums, Preceptor, BRK Kreisverband Cham, Germany and Kristina Voith, who spent the week with the County of Renfrew Paramedic Service were introduced to County Council by Health Committee Chair Michael Donohue. He noted this visit provided a unique opportunity to strengthen professional relationships and foster international cooperation in the field of paramedicine. It also allowed the Paramedics to learn from one another, deepening the understanding of various approaches to public safety and patient care.
- Jason St. Pierre and Lisa Severson provided an annual update from the <u>Eastern Ontario Regional Network</u>, including the Cell Gap Project and highlights of the 2024-2028 Strategic Plan. In Renfrew County 47 new builds were planned with 27 of 47 new sites are in service, 25 upgrades were completed and nine-co-locations are in the process of being completed.
- Nadia Prescott, Ottawa West Four Rivers Ontario Health Team, made a presentation on the Primary
 Care Team expansion proposals recently submitted to address the needs in the communities of
 Arnprior and McNab/Braeside. The multi-organizational approach will be led by West Carleton
 Family Health Team with the support of the Arnprior & District Family Health Team among others.
 The goal is to attach 8,500 net new patients by March 2027, including 1,000 new patients for the
 Arnprior and District Family Health Team.
- Stefani Van Wijk (Chair) and Meghan James (Vice-Chair) of the Ottawa Valley Tourist Association
 Board of Directors provided an annual update on the state of tourism in the Ottawa Valley, the critical role played by the OVTA and how tourism is fuelling economic growth and community vitality in the region.

Development & Property Committee

Presented by: James Brose, Chair

County Council will send a letter to MPP Billy Denault, Renfrew-Nipissing-Pembroke and the
Honourable Vic Fideli, Minister of Economic Development, Job Creation and Trade (MEDJCT), in
support of the Small Business Centres Ontario's (SBC Ontario) recommendations and request for
increased CORE funding towards salary wages for Enterprise Renfrew County and all Small Business
Enterprise Centres across Ontario.



- County Council adopted a by-law to authorize Municipal Law Enforcement Services, Renfrew,
 Ontario to act as a By-law Enforcement Officer, on behalf of the County of Renfrew, on County of
 Renfrew Owned Forests. In recent years, issues within the Renfrew County Forests have been
 increasing in frequency and severity, including dumping, encroachment, fires and camping.
- A special meeting of the Development and Property Committee will be held on June 12, 2025 at 3 p.m. at the County of Renfrew Administration Building to host a public meeting to inform the public of the proposed Official Plan Amendment No. 47. The proposed Official Plan Amendment is to permit the County Council to provide grants and/or loans to support local Community Improvement Plans.
- The County of Renfrew is working with Esri Canada to do a full review of its location-based data to get ready for the new Next Generation 9-1-1 (NG9-1-1) system. This new system will help modernize how emergency services respond. Local municipalities play a big part in this work because they help create and update the data that emergency services rely on. For this project to be successful, strong teamwork and input is required from our municipal partners. Their local knowledge is key to making sure the data is correct and useful. To help move this project forward, a two-hour workshop is scheduled on June 5, 2025, from 10 a.m. to 12 p.m. An invitation was sent out to all local municipalities, including the City of Pembroke and the Algonquins of Pikwakanagan.
- During the first quarter of 2025, the Economic Development Division received seven requests
 related to site searches for businesses looking to expand and/or move within or to Renfrew County.
 The Division is also supporting a number of municipal requests related to potential investment and
 expansion opportunities, providing guidance, research and expertise.

Operations Committee

Presented by: Glenn Doncaster, Chair

- County Council adopted a by-law authorizing the acquisition of a piece of property with frontage on County Road 23 (Highland Road) in the Township of McNab/Braeside from Susan Patricia Clark. This land will be dedicated as part of the road allowance for County Road 23.
- County Council adopted a by-law to approve Corporate Policy PW-24, Community Safety Zones
 along County Roads. Community Safety Zones can be used near community centres, elementary or
 secondary schools, high pedestrian traffic locations (defined as a location experiencing an average of
 100 pedestrians per hour or more for any eight hours of the day), seniors' centres and residences,
 daycare centres, playgrounds, parks and hospitals.
- County Council adopted a new by-law that includes the execution of a Purchase and Sale Agreement
 and a Lease Agreement with the Mississippi Valley Conservation Authority for the K & P Recreational
 Trail, from the County of Renfrew border northward approximately 6.7km. It is estimated that the
 County of Renfrew's portion of costs associated with clearing title on the properties to be purchased
 will be approximately \$67,000.
- The Warden and Chief Administrative Officer executed the Housing-Enabling Core Services (HECS) Transfer Payment Agreement for the approved reconstruction of a roundabout at the intersection of Petawawa Blvd., Doran St., Mohns Ave. and Hilda St. This is in follow-up to the January 28, 2025, announcement that the Province of Ontario would provide \$2.8 million in funding support for a significant infrastructure improvement at the intersection of County Roads 26/51 (Doran Road/Petawawa Boulevard) in the Town of Petawawa. This project will see the construction of a roundabout designed to enhance traffic flow, improve safety, and support the growing needs of the community.



- County Council approved contracts/tenders as submitted:
 - For the purchase of two tandem truck plow and spreader units from Premier Truck Group of London, London, Ontario, in the amount of \$957,052, plus applicable taxes.
 - For the rehabilitation of County Road 71 (Matawatchan Road), from Civic Address 4882 to County Road 65 (Centennial Lake Road), Township of Greater Madawaska, as submitted by Bonnechere Excavating Incorporated, Renfrew, Ontario, in the amount of \$693,494.40, plus applicable taxes.
 - For the fabrication, supply, relocation, and rehabilitation of Access Control Gates in various locations on County Recreational Trails as submitted by G.P. Splinter Forest Products Limited, Pembroke, Ontario in the amount of \$148,855.96, plus applicable taxes.
 - For the supply, delivery, and installation of Steel Beam Guiderail on County Road 71
 (Matawatchan Road), approximately 8.41km east of Highway 41, Township of Greater
 Madawaska, as submitted by Borall Fence and Guiderail Contractors Limited, Waubaushene,
 Ontario, in the amount of \$215,231.25, plus applicable taxes.
 - For the rehabilitation of County Road 3 (Usborne Street), from County Road 1 (River Road) to the urban limit of Braeside, a distance of approximately 0.34km, Township of McNab/Braeside as submitted by Thomas Cavanagh Construction Ltd., Ashton, Ontario, in the amount of \$528,000, plus applicable taxes.
 - For Contract Administration and Construction Inspection Services for the reconstruction of County Structure C201 (Broomes Creek Culvert) and Dam as submitted by J.L. Richards & Associates Ltd. in the amount of \$286,472.48, plus applicable taxes.
 - For the rehabilitation of County Road 2 (Daniel Street), from County Road 1 (Madawaska Street) to Staye Court Drive, a distance of approximately 1.9km, Town of Arnprior, awarded to R.W. Tomlinson Ltd., Ottawa, Ontario, in the amount of \$1,597,200, plus applicable taxes (Town of Arnprior will cover \$544,203.23, plus applicable taxes.)
 - For the rehabilitation of County Road 36 (TV Tower Road), from County Road 35 (Jean Avenue) to County Road 42 (Forest Lea Road), and County Road 51 (Pembroke Street West), from County Road 42 (Forest Lea Road) to the City of Pembroke Limits, a distance of approximately 3.52km, Township of Laurentian Valley awarded to McCrea Excavating Ltd., Pembroke, Ontario, in the amount of \$1,810,000.
 - For the purchase of a Boom Mower from Colvoy Enterprises 2012 Ltd., Courtland, Ontario, in the amount of \$49,998, plus applicable taxes.

At the May 28 the Operations Committee recommended the following:

• County Council adopt a revised by-law to Regulate the Operation of Off-Road Vehicles on County of Renfrew Roads. The County of Renfrew has received a request from the Town of Petawawa to update the restrictions for off-road vehicles along County Roads within the Town. The effect of the amendment would permit Off-Road Vehicles on the following sections of County Roads in the Town of Petawawa: County Road 16 (Victoria Street), between Laurentian Drive and Petawawa Boulevard; County Road 25 (Laurentian Drive), between Victoria Street and Petawawa Boulevard; County Road 26 (Doran Road), between Petawawa Boulevard and Highway 17; County Road 37 (Murphy Road), between Petawawa Boulevard and Highway 17; County Road 51 (Petawawa Boulevard), between B-Line Road and civic address 2991 Petawawa Boulevard. In addition, the Town of Petawawa has requested crossings of CR51 (Petawawa Boulevard) be allowed at the Fred/Norman Street and Victoria Street/Portage Road intersections, which were also recommended.



Community Services Committee

• County Council supported the resolution passed by the Prince Edward-Lennox and Addington Social Services Committee in April requesting an increase to Ontario Works rates to match the ODSP rate increases that have already been made and be indexed to inflation and a commitment to ongoing cost of living increases above and beyond the rate of inflation to make up for the years they were frozen. A copy of this resolution be sent to the Minister of Children, Community, and Social Services, the Minister of Health, the Minister of Municipal Affairs and Housing, the Association of Municipalities of Ontario, the Ontario Municipal Social Services Association, the Rural Ontario Municipal Association, and all Ontario Municipalities.

Corporate Services Committee

 County Council directed staff to submit delegation request(s) at the upcoming Association of Municipalities of Ontario (AMO) Conference that are consistent with the 2023-2026 County of Renfrew Strategic Plan and other departmental strategic plan(s), that address current initiatives that require further advocacy and/or address funding shortfall(s).

Health Committee

Presented by: Michael Donohue, Chair

- County Council directed staff to proceed with hiring PRO-TEC 5 Incorporated, Pembroke, Ontario, as
 a security agency at Bonnechere Manor when required for the newly implemented security
 program.
- County Council authorized the Warden and Chief Administrative Officer to execute a Purchased Service Agreement with Mackay Manor, Renfrew, Ontario, for the period of June 1, 2025 until March 31, 2027. The County of Renfrew Paramedic Service is partnering with Mackay Manor following the successful approval of a joint application to the Substance Use and Addictions Program (SUAP). This funding will support the delivery of targeted paramedic-led outreach services. These services will focus on individuals experiencing homelessness, mental health challenges, and/or substance use concerns. This initiative aims to improve access to care for vulnerable populations by providing timely, community-based interventions. It also reflects the shared commitment of both organizations to integrated person-centered service delivery.

Renfrew County Mesa HART Hub invests in local leadership to advance collaborative care

Mesa is a collaborative and compassionate approach to care – a made-in-Renfrew-County response to the complex intersections of affordable housing, homelessness, mental health, substance use, and addiction. Informed by community needs and frontline experience and built upon Mesa principles, community partners were successful in the application for a Homelessness and Addiction Recovery Treatment (HART) Hub, a regional initiative funded by the Province of Ontario.

In January 2025, the Renfrew County Mesa HART Hub was approved for a three-year, \$6.3 million investment from the Government of Ontario to support coordinated services for individuals experiencing homelessness, mental health challenges, and substance use issues. With early development now underway, the HART Hub is pleased to announce the hiring of two key leadership roles.

To support this bold and collaborative initiative, Mesa partners are investing in local talent and proven leadership.

Molly Fulton will assume the role of HART Hub Lead, on a three-year secondment from her position as Manager of Community Mental Health at Pembroke Regional Hospital. She brings deep expertise and a strong commitment to local mental health systems.

The Renfrew County Mesa HART hub Lead is responsible for the overall operation, strategic direction, and management of the Renfrew County Mesa HART Hub. This position serves as a central point for coordinating health, addiction, and mental health resources in collaboration with local stakeholders and community partners. The Lead will oversee the hub's multidisciplinary team, ensuring efficient service delivery, fostering collaboration, and driving innovative approaches to meet community needs.

"We are strengthening our collaborative approach to compassionate care by building on what we know, learning from our work together, and investing in local expertise," said Sabine Mersmann, President & CEO, Pembroke Regional Hospital, a key partner in the HART Hub. "Establishing the HART Hub Lead position demonstrates our commitment to ensuring that those in need receive timely, coordinated care with the best opportunity for success."

We are also proud to welcome Tara Edeh of the Ontario Addiction Treatment Centre in Pembroke as HART Hub Site Manager, a skilled frontline leadership position that will support the coordination of accessible, client-centered pathways to care, ensuring individuals receive the right services at the right time—and have a safe place to call home.

The HART Hub Site Manager is responsible for the day-to-day management and coordination of services at HART Hub locations within Renfrew County, and plays a key role in operational execution, performance monitoring, and maintaining a safe, client-centered environment aligned with the HART Hub's mission.

"Our teams are on the front lines of a new, compassionate model of care. The Mesa HART Hub brings us together to deliver more coordinated, wraparound supports that lead to safer, healthier communities for all," said Renfrew County Warden Peter Emon.

These two positions mark a significant step forward in realizing the vision of the Mesa HART Hub: a compassionate, local system that meets people where they are -24/7 – and walks with them toward recovery, housing stability, and wellbeing.

Medical Officer of Health Report to the Board

HEALTH PROTECTION

Infectious Diseases

Measles:

As of May 21st, a total of 2 confirmed cases of measles have been reported in Renfrew County and District (RCD). Both cases are linked to the large multijurisdictional outbreak centered in Southwestern Ontario.

In our response to mitigate the spread of measles, the Renfrew County and District Health Unit (RCDHU) activated its Emergency Control Group and established a multidisciplinary Measles Response Team to meet increased operational demands.

The Measles Response Team has been:

- Responding to public inquiries via a dedicated intake line
- Conducting case and contact investigations
- Administering vaccinations through community clinics and door-to-door in the most at-risk areas
- Providing post-exposure prophylaxis to measles contacts as necessary
- Ensuring isolation and guarantine are adhered to when required
- Testing symptomatic individuals for measles

Throughout the response thus far, the team has followed 38 measles contacts and helped the most affected community increase their 1-2 dose measles immunization rate from 50% to 86%. This collaborative work is ongoing.

In April, RCDHU identified public measles exposure sites within Renfrew County. The public was advised to contact RCDHU if they were potentially exposed and either unvaccinated or experiencing symptoms. Interviews were completed with CBC and CTV to share details about the potential exposure in Renfrew County and about measles more generally. No additional suspect or confirmed cases resulted from this exposure – demonstrating how our relatively high local vaccination rates provide a significant measure of protection.

Both confirmed local measles cases are now resolved and can no longer spread infection. Thanks to a strong and coordinated response, the local spread of measles has been effectively contained at this time.

RCDHU continues to monitor the measles activity in Ontario. There have been 1622 total measles cases linked to the multijurisdictional outbreak across Ontario from October 18th, 2024 to May 13th, 2025. The majority (76.3%) of these cases have been among infants, children, and adolescents—95.5% of whom were unvaccinated.

In total, Ontario has reported 1646 measles cases so far in 2025. Of these, only 61 cases were not linked to the outbreak:

- 17 had a history of travel (measles acquired outside Canada)
- 1 was linked to a visitor to Ontario
- 43 cases remain without a known source of exposure

Respiratory Infections:

As of May 21st, local COVID-19, influenza, and RSV test positivity levels remain low. Hospital bed occupancy due to respiratory infections and respiratory outbreaks both remain at moderate levels. The proportion of local emergency department visits related to respiratory infections is still high at 10%, but has been trending down slowly since the beginning of the year.

Across the province, hospitalizations related to COVID-19 are at the lowest level since the summer of 2020. COVID-19 deaths in recent weeks are the lowest observed since the pandemic began.

Immunization

Immunization of School Pupils Act (ISPA):

On March 26th, 2025, the school suspension order became effective for 119 students born in 2007 and 2017. Staff have worked closely with schools, families, and healthcare providers to provide support with resources needed for students to meet the ISPA immunization requirements and return to school.

Over the course of the 20-day suspension period, 114 students (95.8%) who were suspended updated their requirements under ISPA and were able to return to school as soon as this was confirmed.

Grade 7 Program:

The second round of Grade 7 school-based immunization clinics for Hepatitis B (HB), Meningococcal, and Human Papilloma Virus started on April 2nd, 2025 and will continue until early June. Approximately 40 school-based clinics will be hosted across RCD. Students may also choose to be vaccinated through their health care provider, or by booking an appointment at an RCDHU routine immunization clinic. As of May 8th, 2025, 22 school-based clinics have been completed.

COVID-19 Vaccine:

The Ministry of Health announced that the Ontario Spring COVID-19 vaccine campaign

is running from April to June 2025. An additional dose of COVID-19 vaccine is recommended for previously vaccinated individuals who have completed their primary series and are at increased risk of SARS-CoV-2 infection including:

- Adults 65 years of age and older
- Adult residents of long-term care homes and other congregate living settings for seniors
- Individuals 6 months of age and older who are moderately to severely immunocompromised
- Individuals 55 years and older who identify as First Nations, Inuit, or Metis, and their non-Indigenous household members who are 55 years and older

As of May 9th, 2025, 4 mobile services clinics have been completed at retirement homes in RCD and additional clinics are scheduled over the following 4 weeks.

Emergency Preparedness and Response

Staff are participating in Freshet meetings to support ongoing preparedness for spring flooding. Municipalities along the Ottawa River from Pembroke to Arnprior have been affected by high water levels. The Ministry of Natural Resources issued a Flood Watch for the MNR Pembroke district, which expired on May 22nd. RCDHU has shared watershed statements through social media, as well as weather events that may impact flooding. Additionally, messaging about flood preparedness continues to be shared through social media.

A five-year commemoration was held for COVID-19 to recognize the dedication, resilience, and work done by staff over the course of the pandemic.

May 4th to 10th was Emergency Preparedness Week. Emergency Preparedness Week is a national awareness campaign that encourages individuals to take steps to protect themselves, their families, and their communities during emergencies. This year's theme was "Be Prepared. Know Your Risks." It served as a reminder for residents RCD to understand the local risks and take action to be ready in case of an emergency. Throughout the week, RCDHU shared social media posts to raise awareness and promote preparedness. These posts focused on understanding potential risks in the region and learning practical steps to stay safe.

Healthy Environments

Rabies Control:

RCDHU is once again promoting the <u>Yellow Ribbon campaign</u> for animal bite and rabies awareness in May. The campaign promotes the wearing of a yellow ribbon or collar or scarf around a dog's neck to let people know to approach with caution, thereby reducing the likelihood of unintended animal bites and unnecessary healthcare visits. Several veterinary clinics and pet stores across the health unit are promoting the campaign, offering free yellow ribbons and information cards. A media release has been issued to raise awareness.

Food Safety:

A large component of the healthy environments mandate is food premise inspections. Public health inspectors have completed the first round of inspections of high-risk establishments to protect the public from foodborne illness. High risk facilities are those that serve vulnerable populations and offer food that is prepared through multiple handling steps. Each high-risk facility must be routinely inspected at least once every 4 months. Inspections of moderate risk food establishments, such as fast-food restaurants, are being prioritized to have at least one inspection completed by the end of June, as advised under the Ontario Public Health Standards.

Vectorborne Disease:

Public health inspectors are actively monitoring ticks in RCD. Tick dragging is taking place in southern (Combermere, Renfrew), western (Wilno area), and northern (Chalk River) parts of RCD. The intention is to monitor for the movement of black-legged ticks that may carry tickborne diseases. Current confirmed risk areas are Arnprior, Calabogie, Cobden, and Eganville.

HEALTH PROMOTION

Renfrew County and District Drug Strategy


Following the April 10th release of the Renfrew County and District Drug Strategy (RCDDS), the promotion of the 25 priorities has been a major focus. Weekly social media messages have been posted to explain the context and priorities for each of the four pillars of prevention, treatment, harm reduction, and community safety.

A second communication campaign has also been running concurrently titled "Share Your Story," where Renfrew County and District residents have been engaged to tell their unique experience with recovering from a substance use disorder and the local support they received. Their courageous stories have garnered excellent online engagement and discussion that will hopefully inspire and empower others who face similar challenges to reach out for help.

Looking forward, the steering committee will receive progress updates from the pillar working groups on the indicators that are associated with each of the priorities. Additionally, the steering committee will review local data in consideration of which substances should be the focus of future phases of the strategy, as it expands beyond opioids.

RCCDS Substance Use Harm Indicators:

RCDHU staff continue to monitor key indicators associated with the harms of substance use. In 2025 so far, as of April 30th, there have been 11 emergency department visits related to opioid overdose and as of May 8th there have been 6 suspect drug toxicity deaths reported.



Harm Reduction

Outreach Team and SPRITE Testing:

The Outreach Team continues to bring RCDHU services to clients across RCD and forge new partnerships with community agencies. Since the beginning of 2025, the Outreach Team completed 41 visits to 13 different sites across Renfrew County & District. During those visits, 264 naloxone kits were distributed, and 181 new people were trained in their use. The Team had over 1000 interactions with clients throughout these visits. The Team continues to provide harm reduction and sexual health supplies, offer sexual health testing, and connect clients to other RCDHU services or community partners where needed.

SPRITE testing continues to be offered at Outreach Team events and at RCDHU's Pembroke office. As of April 30th, 137 tests for syphilis, HIV and hepatitis C have been completed under this program. Individuals that test positive have been successfully referred for follow-up and treatment. Most of the clients tested would be considered at high risk for acquiring sexually transmitted and blood-borne infections, and do not have a family doctor or the means to seek out testing on their own.

Indigenous Cultural Safety Training:

Two members from the Outreach Team attended "Wabano-Win: The Art of Seeing Clearly" Indigenous Cultural Safety Training at the Wabano Centre in Ottawa on March 21st. The training helped to foster a deeper understanding and respect for Indigenous perspectives on health and wellness. By incorporating the experience and information learned, the Outreach Team will provide an inclusive and supportive environment for Indigenous clients, reducing barriers to care and providing more effective, compassionate and culturally safe services.

County of Renfrew Licensed Childcare – Nutrition Support

In March, RCDHU provided a virtual educational seminar to licensed childcare providers through the County of Renfrew. The session focused on applying Canada's Food Guide (CFG) to meet the nutritional requirements outlined in the Child Care and Early Years Act and the Child Care and Menu Planning – Practical Guide developed by the Ontario Dietitians in Public Health.

This guide was recently updated in 2024 to align with the latest version of CFG and continues to support childcare staff by translating the plate-based recommendations into practical, food-based guidelines for planning daily meals and snacks. To support the implementation of this updated resource, the seminar is now being offered biannually in the evenings to accommodate the schedules of childcare staff. This ongoing partnership with the County of Renfrew promotes professional development, supports healthy eating environments, and helps ensure continued compliance with provincial standards across early years settings.





AMO's Bill 5 Standing Committee Submission

AMO has <u>submitted comments on Bill 5</u>, *Protect Ontario by Unleashing our Economy Act* to the Standing Committee on the Interior. While we understand the need to try different approaches to supporting economic projects, important objectives such as health, safety, environmental protection, community well-being, and Indigenous rights and relations must be upheld. AMO's submission outlines the importance of:

- Ensuring that the use of Special Economic Zones to override local bylaws should only occur with host municipal support, and in cases of extraordinary need;
- Ensuring continued protection for the environment, including speciesat-risk and natural habitats: and
- The critical opportunity for Ontario to demonstrate its commitment to reconciliation and stronger relationships with Indigenous rights holders.

AMO's Bill 2 Standing Committee Submission

AMO has <u>submitted comments on Bill 2</u>, *Protect Ontario Through Free Within Canada Act* to the Standing Committee on Finance and Economic Affairs. AMO applauds the government for taking action to enhance labour mobility and interprovincial trade and highlights the need for continued engagement with AMO to address any impacts on municipal standards and by-laws arising from new mutual recognition frameworks for goods and services.

Provincial Government Launches OPP Billing Review

In a letter to impacted Mayors and CAOs sent yesterday, the Ministry of the Solicitor General announced the launch of a review of the OPP cost recovery model. The review is expected to be finalized in time to inform the issuing of 2026 annual billing statements, with opportunities for engagement with municipalities in June.

AMO understands the impact of rising police costs on municipalities across Ontario, including both those with OPP and municipal police services. AMO looks forward to working closely with SOLGEN on this review and putting it within the context of the need to reform the broader provincial-municipal fiscal relationship.

Provincial Strong Mayor Powers Training

Responding to strong AMO advocacy for provincial guidance, the Ministry of Municipal Affairs and Housing is <u>offering training on the strong mayor powers framework</u> that was recently extended to 170 more municipalities.

Two training sessions will be offered in the coming weeks, targeted to elected officials, clerks, treasurers and CAOs.

Bill 6, Safe Municipalities Act, Homelessness Encampments Legislation

Today, AMO sent a <u>letter to Minister Flack</u>, sharing AMO's <u>submission on Bill 6</u>, <u>Safer Municipalities Act. 2025</u>.

The legislation includes two key components. If passed by the legislature, a new *Restricting Public Consumption of Illegal Substances Act, 2025* would further prohibit the consumption of illegal substances in public places. Additionally, amendments to the *Trespass to Property Act* would add aggravating factors to be considered by courts should someone be convicted of a charge under the act.

AMO agrees that urgent action is needed to address the 1400 encampments that now exist in all parts of Ontario across urban, rural and northern communities. While the new police and court tools may be helpful in specific circumstances, we cannot only enforce our way out of the homeless crisis. AMO will continue to advocate for investments in the root causes of homelessness, including deeply affordable housing, access to mental health and addiction supports, and improvements to income security.

New Federal Minister of Housing and Infrastructure

Today, AMO <u>sent a letter to Minister Robertson</u> congratulating him on his appointment as the Minister of Housing and Infrastructure. AMO will continue working with partners at the province and the Federation of Canadian Municipalities to convey the unique role that Ontario municipalities play. We will also look forward to advancing meaningful solutions to improve the current tools and systems municipalities have to build infrastructure and housing, including social housing.

Ontario Launches Trade-Impacted Communities Program

As announced in the 2025 Ontario Budget, the Ministry of Economic Development, Job Creation and Trad is launching a new <u>Trade-Impacted Communities Program (TCIP)</u> to provide up to \$40 million in funding to support communities and local industries that are facing economic challenges arising from ongoing US trade disruptions. Stream 1: Community Economic Development is open for applications on a continuing basis while funding is available. Stream 2: Transformation projects will be open until September 11, 2025.

Policy Update - Province Introduces Bill 30

Province Introduces Bill 30, Working For Workers Seven Act, 2025

Yesterday, the Ontario government tabled its seventh <u>Working for Workers</u> <u>Act</u> (Bill 30). While the stated objective of supporting workers amidst potential job losses arising from the US-Canada trade dynamic is noted, one of its proposals raises significant concerns -- exempting Skills Development Fund Capital Stream-supported capital projects from the requirements of *The Municipal Act* and *The Planning Act*.

Earlier exemptions from municipal planning approvals, such as those related to public universities and "community service facilities" like K-12 schools, hospitals, and long-term care homes are aimed to expedite planning for public entities. Bill 30, however, marks a significant shift by:

- Extending expedited planning processes and exemptions from municipal authorities to private entities without the robust accountability and regulatory frameworks that characterize broader public sector bodies, solely by virtue of their qualification to access a source of provincial funding with broad eligibility; and
- Going beyond exemptions to *The Planning Act* to include exemptions
 to *The Municipal Act*. These powers could allow for waivers from
 municipal bylaws, including those related to property tax, development
 charges, and other local requirements with no clear purpose or
 rationale.

The cumulative impact of what is now the proposed ability of four separate Ministers to override municipal land use planning and other authorities also raises significant concern by increasing the likelihood of unintended consequences and diffuse accountability. Currently before the legislature are proposals to provide powers to:

- The Minister of Infrastructure to use Minister's Zoning Orders (MZOs) to override The Planning Act as part of Bill 17;
- The Minister of Economic Development, Job Creation and Trade to create Special Economic Zones (SEZs) to override *The Planning* Act and *The Municipal Act* as part of Bill 5; and
- The Minister of Labour, Immigration, Skills and Training to override *The Planning Act* and *The Municipal Act* for those in receipt of capital funding from the Skills Development Fund under Bill 30.

AMO continues to support the need for bold and innovative action to respond to unprecedented economic challenges. However, the threat of tariffs cannot be used to justify any and all proposals to override provincial and municipal laws. AMO will continue to analyze the proposal and seek opportunities to provide commentary to the legislature.

County of Renfrew Featured in Ontario Newsroom for Expanded Emergency Department

The County of Renfrew was recently featured in the Ontario Newsroom, highlighting St. Francis Memorial Hospital's largest redevelopment in history. With an \$18.6 million investment from the Ontario government, the expansion will add 6,000 square feet to the hospital's emergency department and renovate the ambulatory care clinic, significantly improving access to high-quality care for local residents.

Once complete in 2027, the new emergency department will feature a dedicated ambulance entrance, a quiet room for mental health patients, an upgraded trauma area, and enhanced infection control measures.

The expanded facility will handle 11,900 visits annually, ensuring faster, more efficient care for families in the community. Construction will not interrupt 24/7 emergency services, and the project is part of Ontario's broader efforts to modernize healthcare facilities across the province.

Donna Skelly Becomes Ontario's First Female Speaker

MPP Donna Skelly has been elected as the 43rd Speaker of the Ontario Legislature—making history as the first woman to hold the role.

A former broadcast journalist and current representative for Flamborough—Glanbrook since 2018, Skelly previously served as deputy Speaker.

She succeeds Ted Arnott, who retired after nearly seven years. Skelly aims to bring a more professional tone to the chamber as members return for the new legislative session.

Ontario Strengthens Local Governance with New Legislation

Ontario is reintroducing the Municipal Accountability Act, 2025 to enhance municipal governance and accountability. The proposed legislation aims to create a standardized municipal code of conduct, establish consistent integrity commissioner inquiry processes, and mandate training for council members and certain local boards. If passed, the act could enforce penalties, including removal from office for serious violations, upon the recommendation of municipal integrity commissioners.

Minister Rob Flack emphasized that strong local governance begins with accountability, while AMO President Robin Jones praised the bill for holding elected officials to higher standards of conduct. This legislative move promises to empower municipal leaders to uphold the trust residents place in them.

Ontario Invests \$1.3 Billion to Support Manufacturing Jobs

The Ontario government is enhancing the Ontario Made Manufacturing Investment Tax Credit, committing an additional \$1.3 billion over three years to help manufacturers lower costs and invest in buildings, machinery, and equipment.

As part of the upcoming 2025 Budget, the proposed changes will:

- Increase the tax credit rate from 10% to 15% for Canadiancontrolled private corporations;
- Extend the credit to non-Canadian-controlled private corporations as a non-refundable tax credit;

Allow eligible businesses to receive up to \$3 million annually.

The move comes amid growing concerns over job losses linked to U.S. tariffs. The government says this investment will help safeguard Ontario's 830,000 manufacturing workers and attract new investment to strengthen the province's economy.

Ontario Introduces More Convenient Care Act to Strengthen Health System

The Ontario government has re-introduced the More Convenient Care Act, 2025—a key step in its commitment to building a more connected, transparent, and patient-focused health care system.

This legislation supports better access to care, enhances hospital governance, modernizes digital health tools, and empowers health professionals across the province. From streamlining emergency services to giving Ontarians secure access to their health records online, the Act ensures the right care is delivered in the right place, at the right time.

Ontario Accelerates Home and Infrastructure Development with New Legislation and Funding

The Government of Ontario is taking bold steps to address the housing crisis and improve infrastructure by introducing the <u>Protect Ontario by Building Faster and Smarter Act, 2025</u>. This legislation aims to cut red tape, lower development costs, and fast-track construction, in close partnership with municipalities across the province.

As part of this initiative, the province is boosting its investment in housing-enabling infrastructure with an additional \$400 million, bringing the total to nearly \$2.3 billion over four years through the

Housing-Enabling Water Systems Fund (HEWSF) and Municipal Housing Infrastructure Fund (MHIP).

Key measures include:

- Simplifying development charges and municipal approval processes
- Reducing construction costs by encouraging innovation
- Harmonizing building and road standards
- Expanding fast-track approvals for transit and housing projects

Ontario is also working closely with local governments to streamline planning and unlock more housing near transit. These changes aim to get homes built faster, create jobs, and build a more affordable, efficient future for all Ontarians.

Ontario Permanently Cuts Gas Tax and Ends Tolls on Highway 407 East

As part of its ongoing effort to help families and businesses manage

rising costs, the Ontario government is making two major cost-saving moves: permanently cutting the gas tax and removing tolls from Highway 407 East.

Premier Doug Ford announced that the province will lock in its current 9-cent-per-litre gas and fuel tax rate, saving households an average of \$115 annually. Since the temporary cut was introduced in 2022, Ontarians have saved \$1.7 billion at the pumps.

In a move to improve affordability and reduce gridlock, tolls on the provincially owned section of Highway 407 East (from Brock Road to Highway 35/115) will be eliminated effective June 1, 2025. This change is expected to save commuters up to \$7,200 a year, and follows the earlier removal of tolls on Highways 412 and 418.

These initiatives are part of Ontario's broader strategy to:

- Lower the cost of living
- Support economic growth
- Improve transportation access and affordability

Ontario and Manitoba Unite to Break Down Trade Barriers

Ontario Premier Doug Ford and Manitoba Premier Wab Kinew have signed a new <u>Memorandum of Understanding (MOU) aimed at</u> eliminating interprovincial trade barriers.

The agreement will boost the flow of goods, services, investment, and workers between the two provinces—strengthening economic ties and reducing costs for families and businesses. This is the latest in a series of efforts by Ontario to enhance free trade within Canada, including MOUs with Nova Scotia and New Brunswick and the landmark Protect Ontario Through Free Trade Within Canada Act.

With over \$19.5 billion in trade between Ontario and Manitoba in 2021 alone, this partnership signals a major step toward a more unified and resilient Canadian economy.

Ontario Releases 2025 Budget: A Plan to Protect Ontario

Ontario's 2025 Budget, A Plan to Protect Ontario, outlines bold steps to strengthen the province's economy and safeguard jobs, businesses, and families amid global economic uncertainty. Finance Minister Peter Bethlenfalvy announced measures to unleash economic growth through targeted investments in workers, critical minerals, infrastructure, and Indigenous partnerships—all while maintaining a responsible path to balance by 2027–28.

Key highlights include:

- A \$500M Critical Minerals Processing Fund to boost domestic production.
- A \$3B expansion of the Indigenous Opportunities Financing Program.
- A proposed expansion of the Ontario Made Manufacturing Tax Credit, providing \$1.3B in support.
- A new \$5B Protecting Ontario Account to shield businesses from tariff shocks.
- Permanent cuts to gas and fuel taxes, saving households an

- average of \$115 annually.
- Over \$200B in infrastructure investments over 10 years, including highways, public transit, health care, and schools.

The budget reflects the government's commitment to building a resilient, self-reliant economy that protects Ontarians today and strengthens the province for the future.

Ontario Government Moves Forward with New Campbellford Memorial Hospital in Northumberland County

As part of the 2025 Ontario Budget: A Plan to Protect Ontario, the provincial government has announced the start of planning for the construction of a new Campbellford Memorial Hospital In Northumberland County. This investment will significantly improve access to high-quality, modern health care for residents in Trent Hills and across Northumberland, Peterborough, and Hastings Counties.

The project marks a major step toward building a state-of-the-art facility that will expand programs and services, increase inpatient capacity, and improve emergency and community care through a new health care campus. The new hospital will also include enhanced infection control measures and support services tailored to the needs of the region's growing and aging population.

This initiative is part of Ontario's nearly \$60 billion investment to build and upgrade more than 50 hospitals across the province, ensuring families can access care when and where they need it—close to home.

Ontario Launches Trade-Impacted Communities Program to Support Local Resilience

The Ministry of Economic Development, Job Creation and Trade has launched the Trade-Impacted Communities Program (TICP)—a new, competitive funding initiative aimed at helping Ontario communities and industries navigate economic challenges caused by U.S. trade disruptions.

With up to \$40 million in funding available, the TICP supports local projects aligned with Ontario's economic priorities, including:

- Economic resiliency Building local competitiveness and growth opportunities
- Supply-chain diversification Strengthening key sectors like manufacturing, agri-food, and critical minerals
- Trade partnerships Expanding export markets and reducing reliance on the U.S.

The program includes two streams:

- Stream 1: Community Economic Development Supporting local strategies and immediate resiliency efforts
- Stream 2: Transformational Projects Backing large-scale, collaborative projects to grow and modernize key industries

Please be advised that the Council of the Town of Plympton-Wyoming, at its Planning Council meeting on May 26h, 2025, passed the following motion calling for a pause of the enactment of BILL 5 PROTECT ONTARIO BY UNLEASHING OUR ECONOMY ACT 2025:

MOTION TO PAUSE BILL 5 PROTECT ONTARIO BY UNLEASHING OUR ECONOMY ACT 2025

Whereas the province has introduced Bill 5, Protect Ontario by unleashing our Economy 2025 which is intended to speed up housing and economic development in Ontario.

And whereas the proposed legislation will include the repeal of the Endangered Species Act of 2007 and replace it with the Conservation Species Act of 2025.

And whereas the Ministry of Environment, Conservation and Parks primarily manages the Act, The Committee on the Status of Species in Ontario (COSSARO) is responsible for assessing and classifying species.

And whereas COSSARO is comprised of experts with scientific and traditional knowledge and operates independently from the government ensuring impartial assessments of species at risk, the provincial cabinet will now decide what species will remain or be removed from endangered, concerned or at-risk status.

And whereas the current law considers the habitat to be all the areas that the species relies on for living, gathering food, migrating, hibernating and reproducing. The new law however, narrows that definition to "a dwelling place, such as a den, nest or other similar place, that is occupied or habitually occupied by one or more members of a species for the purposes of breeding, rearing, staging, wintering or hibernating"

And whereas the legislation would gut environmental assessment processes, speed mining and infrastructure development and take a "register-first, ask-questions-later" approach that would allow developers to begin projects before their environmental implications are fully known and allow for economic zones which will eliminate any environmental mitigation measures or protections.

And whereas the legislation would eliminate provincial responsibility for federally listed migratory birds and aquatic species because it says such birds and species are under federal jurisdiction, even though the province has historically administered such duties.

And whereas the government will enhance funding for the Species Conservation Program, which will see contributions more than quadruple to \$20 million each year for on the ground projects that directly support efforts to conserve and protect listed species, the funding will only go to projects in regions that would otherwise not be considered viable for housing priorities, essentially allowing for the extirpation of local ecoregions in Ontario.

And whereas while development is necessary for human progress, Bill 5 will pose significant challenges to mitigating water, soil and air pollution; will overexploit natural resources, and increase invasive species in each uniquely identified ecoregion in Ontario.

Now therefore be it resolved that the Council of Plympton-Wyoming urges the government to pause the proposed legislation and maintain strong environmental laws that prevent extinction of species and protect local ecoregions.

And furthermore, the Council of Plympton-Wyoming asks that the government recognize and give meaningful consideration to ecoregions in Ontario through their unique perspectives and preserve Ontario's natural heritage systems in the application of any proposed updated provincial legislation for the long-term growth, sustainability and well-being of our communities.

Whereas the Ontario government has fast-tracked Bill 5, Protect Ontario by Unleashing our Economy Act, 2025 (Bill 5), such that it was referred to the Standing Committee on the Interior on May 6, 2025, after being first read on April 17, 2025, and

Whereas the written submission deadline for participation on Bill 5 is May 26, 2025, at 6:00 PM (EDT), and

Whereas Bill 5 would enact the Special Economic Zones Act, 2025; amend/repeal the Endangered Species Act, 2007 and replace it by enacting the Species Conservation Act, 2025; and amend various Acts including the Ontario Heritage Act, the Mining Act, the Ontario Energy Board Act, 1998, and the Electricity Act, 1998 and to revoke various regulations in relation to development and procurement, and

Whereas Bill 5 will allow the Lieutenant Governor in Council to create zones anywhere in Ontario where municipal and provincial laws will not apply, and where projects or proponents can be exempted from requirements under provisions of an Act or of a regulation, including environmental and heritage laws, and

Whereas the provisions of Bill 5 as written include anti-democratic principles and risks undermining civil liberties, Indigenous rights, the environment and local government oversight, and

Whereas the Municipality of Kincardine believes that the provincial priorities of housing, resource development and economic development can be achieved without subverting existing laws, undermining municipal authority, threatening the environment, restricting industry growth, or undermining informed consent with Indigenous communities; now therefore be it Resolved that the Council of the Municipality of Kincardine hereby opposes Bill 5; and That Council formally express its opposition to Bill 5 in favour of preserving democracy, transparency, accountability, the environment, civil liberties, and Indigenous rights; and

That Council encourage the province to prioritize democratic principles and governance systems that support responsible development, environmental preservation, and acknowledge our responsibility to future generations; and

That Council formally request that the Ontario government reject Bill 5; and

That a copy of this motion be forwarded to the Honourable Doug Ford, Premier of Ontario, ; the Honourable Stephen Lecce, Minister of Energy and Mines; MPP Lisa Thompson; all Ontario municipalities; the Association of Municipalities of Ontario; and the Standing Committee on the Interior.

WHEREAS the Government of Ontario has introduced Bill 5: Protecting Ontario by Unleashing Our Economy Act, 2025, which proposes substantial changes to many Acts within one bill which undermine environmental protections in order to "unleash the economy"; and

WHEREAS multiple inclusions will impact habitat, biodiversity protections and environmental integrity without proper process including but not limited to:

- the repeal and replacement of the Endangered Species Act with a weaker act;
- the creation of a Special Economic Zones Act which will permit exemptions from legislated environmental protections;
- changes to provisions to the Mining Act which provide sweeping powers to the Minister of Energy and Mines that are poorly defined, subject to caprice, or possibly designed to enable exemption from environment protection; and

WHEREAS proposed changes will override local planning authority, provincial legislation, and bylaw enforcement for the benefit of specific preferred proponents over the rights of Ontarians; and

WHEREAS First Nations citizens have an enshrined right to access their own archeology and Canadians have an enshrined responsibility to seek free, prior and informed consent from First Nation neighbours regarding land use; and

WHEREAS several proposed changes could imperil the health of lands and water for which First Nations have traditional and treaty rights; and

WHEREAS the provisions of the Special Economic Zones Act are not clear enough to ensure that there are adequate legal and environmental protections to offset risks to Ontarians and First Nations members, to provide adequate safeguards against bad faith environmental practice; and protect against unsafe labour practice as identified by labour sector organizations; and

WHEREAS fairness is enshrined in both Canada's and Ontario's laws yet proposed changes seem to permit prejudicial regulatory practice (e.g. codifying permissions for "trusted proponents" over others); and

WHEREAS the wording of the changes to the Electricity Act seem to support Canadian ownership of energy suppliers but appear to potentially restrict development of specific types of energy and could impact local renewable energy development; and

WHEREAS there is no evidence that undermining of environmental protections, local legal frameworks, and the rights of First Nations communities in Ontario are a necessary step to "unleash the economy"; and

NOW THEREFORE BE IT RESOLVED THAT the Council of the County of Prince Edward supports any regulation that could encourage energy providers to Buy Canadian but urges the province to clarify the proposed provisions of the Energy Act and ensure they foster local green energy development; and

THAT the province remove the elements in Bill 5 that would reduce current environmental protections, reduce protections for species at risk, and reduce legal protection from bad faith actors in special economic zones; and

THAT the Council of the County of Prince Edward urges the Province to further define Special Economic Zones and their purpose with more clarity and ensure that activities within such zones are equally subject to the local and provincial laws that support all of Ontario and First Nations people and foster our social, cultural and environmental prosperity;

AND FURTHERMORE BE IT RESOLVED THAT the Council of the County of Prince Edward expresses solidarity with the concerns of our neighbouring community, Mohawks of the Bay of Quinte and members of the Haudenosaunee Nation and support Mohawks of the Bay of Quinte and their letter to the province of May 16th 2025, attached; and THAT this resolution be shared with the Honourable Doug Ford, Premiere of Ontario; Stephen Lecce, Minister of Energy and Mines; Rob Flack, Minister of Municipal Affairs and




