Ontario Investing \$55.8 Million to Expand Teaching Workforce

Investment will prepare students for successful futures by training 2,600 teachers in underserved regions

June 20, 2025

Colleges, Universities, Research Excellence and Security

KINGSTON — The Ontario government is investing \$55.8 million to expand teaching training seats at universities across the province to strengthen the teaching workforce and ensure Ontario has the teachers it needs in underserved and remote communities. This investment will train up to 2,600 new teachers by 2027, building a robust workforce of English and French-language teachers for Ontario's classrooms. To support the government's plan to protect Ontario by helping train students for successful careers and good-paying, in-demand jobs, the funding will be prioritized to support underserved communities as well as programs that will help students gain practical skills.

"Teachers play a vital role in ensuring our children receive a strong start to their education and future careers," said Nolan Quinn, Minister of Colleges, Universities, Research Excellence and Security. "Through this investment, our government is protecting our children's future by expanding teaching capacity and bringing more highly qualified teachers to communities across Ontario."

In advance of the fall 2025 school year, 13 of Ontario's publicly funded universities that offer a Bachelor of Education will receive funding to expand their teaching program. Funding will be prioritized to expand seats at universities with accelerated programs, French and technological education, as well as seats in northern, rural, Indigenous and remote regions to add more teachers to regions that need teachers most.

"We are focused on helping students succeed, and that begins with having qualified and ready teachers in every classroom," said Paul Calandra, Minister of Education. "By expanding teacher training seats in high-demand areas like French, technology and in rural and northern communities, we're helping schools fill gaps and giving students the support they need for the jobs of tomorrow."

Through the <u>2025 Ontario Budget: A Plan to Protect Ontario</u>, the Ontario government continues to strategically invest in Ontario's colleges and universities in order to equip students with the skills that launch them into rewarding jobs and careers that address Ontario's labour market needs. By increasing the province's pipeline of highly skilled teachers, Ontario is ensuring children across the province receive the strong start they need to lead fulfilling, successful lives.

- 12,111 full-time students are enrolled in teacher education programs at Ontario universities for the 2024-25 academic year.
- Approximately 4,500 additional teacher candidates enter the workforce every year through the Ontario government's Initial Teacher Education program that receives \$60 million annually to build the teaching workforce in the province.
- Since 2018, Ontario has added approximately 961 additional French and English language teacher education spaces on top of the 9,000 teacher seats Ontario funds annually.
- In 2025-26, the Ontario government is investing \$30.3 billion in Core Education Funding to focus key resources where they matter most: student success.

TORONTO — The Ontario government is celebrating 15 remarkable individuals and four organizations with the 2025 June Callwood Outstanding Achievement Award for Voluntarism (JCOAAV). This year's recipients have dedicated their time to a range of community causes including youth advocacy, health care and mental health, the arts, environmental sustainability, and work with vulnerable populations.

"Volunteers are essential to protecting Ontario and building stronger communities," said Graham McGregor, Minister of Citizenship and Multiculturalism. - The late June Callwood was a distinguished Canadian journalist, author, social activist, and an appointee to the Order of Ontario and the Order of Canada.

- Throughout her life, she established and co-established over fifty Canadian social action organizations.
- The Ministry of Citizenship and Multiculturalism fosters an equitable Ontario and a sense of belonging by promoting citizen engagement and unity. In 2024, over 50 recognition ceremonies celebrated the achievements of more than 7,200 recipients who make the province a better place to live.

June Callwood Award honours remarkable contributions from across the province

The Ontario government is celebrating 15 outstanding individuals and four volunteer organizations with the 2025 June Callwood Outstanding Achievement Award for Voluntarism for their exceptional contributions to their communities and the province.

The outstanding volunteer award recipients are as follows:

Outstanding Volunteer Category - Group

Arnprior Regional Health Auxiliary (Opportunity Shop), Arnprior

Founded in 1961, the Arnprior Regional Health Auxiliary is a dedicated team of 165 volunteers supporting the Arnprior Hospital, Grove Nursing Home, and Palliative Care. Through hands-on service and creative fundraising—including the Opportunity Shop—they contribute up to \$350,000 annually, funding vital medical equipment and enhancing healthcare for the entire Arnprior community.

Thorncliffe Park Urban Farmers, Toronto

Since 2011, Thorncliffe Park Urban Farmers (TPUF) has transformed underused urban spaces into vibrant gardens that promote food security, ecological restoration, and inclusive education. In 2024 alone, TPUF harvested over 2,800 pounds of culturally relevant produce and engaged youth and families through hands-on programs in gardening, composting, and environmental leadership.

Windsor Essex Bike Community, Amherstburg

Established in 2022, the Windsor Essex Bike Community (WEBC) has transformed Windsor-Essex County through volunteerism and grassroots leadership. With over 5,000 volunteer hours and \$150,000 raised, WEBC built an 8 km mountain bike trail and launched a youth program—enhancing recreation, boosting the local economy, and fostering a more connected, inclusive community.

Outstanding Volunteer Category – Individual

Stephen Boyle, Toronto

Stephen Boyle has been a transformative leader in Willowdale for over 20 years. Through events like Concerts in the Park, Sunday Serenades, and the Live Lounge series, he has fostered community connection, supported local artists with paid opportunities, and enriched the cultural life of the neighbourhood.

Sarah Dereski, Greater Toronto Area

Sarah Dereski is a passionate volunteer whose commitment to leadership and community enrichment has been evident since 2004. Her dedication to organizations such as Girl Guides of Canada, Victim Services of York Region, Critical Incident Stress Management programs, the Law Enforcement Torch Run, and Special Olympics Ontario has made a positive impact on many lives.

Kathleen Doherty, Barrie

A retired Staff Sergeant with the Ontario Provincial Police, Kathleen Doherty has devoted her post-retirement years to volunteerism. From Hospice Simcoe to international disaster relief with Global Medic and Team Rubicon Canada, her leadership in crisis response, community recovery, and health advocacy has brought hope and stability to countless individuals—locally, nationally, and around the world.

Prashant A. Jani, Thunder Bay

Dr. Prashant A. Jani has made a lasting impact on the Thunder Bay community through his volunteer leadership, championing cultural diversity and combating food insecurity. He leads the annual Festival of India and Festival of Colours, which attract over 7,000 attendees and promote inclusion and intercultural understanding. In 2009, he founded the Food for Life initiative, which now provides more than 20,000 meals each year to those in need. In response to the COVID-19 pandemic, he expanded this effort to deliver thousands of free meals and grocery packages to vulnerable community members during a time of crisis.

Jean Kerins, Toronto

For over 20 years, Jean Kerins has been a cornerstone of the Caledon Hills Bruce Trail Club, serving in key leadership roles and as editor of the Caledon Comment. Her dedication to conservation, mentorship, and community-building has inspired

over 1,200 members and preserved the Club's legacy. Jean's inclusive spirit and tireless service continue to leave a lasting impact.

Rajendra (Raj) Kothari, Toronto

Rajendra (Raj) Kothari has devoted over 35 years to volunteerism, helping raise more than \$2 billion for Ontario's health care and arts sectors. A passionate advocate for inclusion, his leadership has strengthened community connections, championed newcomer integration, and inspired a culture of giving across generations.

Ann-Marie MacDairmid, Thornbury

Ann-Marie, a resident of Thornbury, Ontario, has led the Shoreline Chorus in Owen Sound for 25 years. She founded the choir in 1999 and has managed it entirely as a volunteer. Her leadership has created meaningful opportunities for community engagement through concerts supporting local food banks, therapeutic riding programs, and church outreach initiatives.

Beulah Osei, Newmarket

Since 1996, Beulah Osei has volunteered with York Region Children's Aid Society, providing safe, compassionate transportation for children and youth across the region. More than a driver, she offers stability and care, helping young people stay connected to family, school, and community. Her dedication has touched countless lives and exemplifies the power of consistent, heartfelt service.

Susan Raynak, Thunder Bay

Since 2009, Susan Raynak has been a dedicated volunteer with Hospice Northwest Services. As liaison to the board, she shares powerful stories that deepen understanding of hospice care. Her work on promotional materials, events, and outreach has significantly expanded the organization's visibility, while her warmth and commitment continue to strengthen community connections and support for hospice services.

Dorothy Soo-Wiens, Niagara-on-the-Lake

Since 2003, Dorothy Soo-Wiens has been a cornerstone of the Niagara-on-the-Lake community. She contributes through her leadership at Cornerstone Community Church, including the Elders Board and Funeral Ministry, and as a member of the In Stitches quilting group. Her creativity and dedication shine in her work on partnerships, fundraising, public art, and community events across the region.

Richard Taylor, North Bay

For over 30 years, Richard Taylor has led the Nipissing Trackers Ski Program, opening the slopes to children with physical and developmental disabilities. Under his leadership, the free, volunteer-run program grew from 10 to over 100 participants at times—fostering inclusion, confidence, and joy for children and families across the North Bay community.

Ian White, Toronto

Ian White is a dedicated advocate and community leader for the blind and low vision community in Toronto. As founder and President of the Toronto Visionaries, he has created inclusive spaces for connection, learning, and support. Through monthly meetings, public outreach, and national advocacy, lan empowers others and fosters a stronger, more connected community.

April Zhong, Toronto

April Zhong, a high school student at the University of Toronto Schools, founded Chess for Connection, a nonprofit uniting youth and seniors through chess. Adopted by over 10 senior residences across Toronto and Ottawa, the initiative combats loneliness and fosters cognitive engagement. With over 30 youth volunteers, it creates meaningful intergenerational connections and promotes community well-being. The initiative extends beyond local impact, reaching diverse communities globally. April was also appointed as the sole youth member on the FIDE Social Commission to bring a youth perspective and champion for social change and engagement.

Excellence in Volunteer Management - Group

Artists and Lawyers for the Advancement of Creativity, Toronto

For nearly 40 years, Artists and Lawyers for the Advancement of Creativity (ALAC), through its Artists' Legal Advice Services (ALAS), has empowered Ontario's arts community with free legal advice and education. Driven by a dedicated team of volunteer lawyers and law students, ALAC champions equity, compassion, and access to justice for artists across the province.

Excellence in Volunteer Management - Individual

Marcy Marchuk, Whitby

Marcy Marchuk has been a key leader in volunteer engagement at Community Care Durham since 2009, driving recruitment, training, and recognition across vital programs. Her innovative efforts—including volunteer fairs, corporate

partnerships, and appreciation events—have helped sustain a strong, dedicated volunteer community that supports clients across the region.

Jane Weiland, Huntsville

For over a decade, Jane Weiland was the heart of Hospice Huntsville, leading both the Visiting Volunteer and Grief and Bereavement programs. She introduced vital Complementary Therapies and built partnerships with hospitals and care homes to ensure no one faced the end of life alone. Her leadership, compassion, and innovation profoundly shaped hospice care in her community.

Ontario Connecting 300,000 More People to Primary Care

Province launching over 130 new and expanded primary care teams across Ontario to connect people in underserved communities to care

June 23, 2025

TORONTO — As part of its \$2.1 billion <u>Primary Care Action Plan</u> to connect everyone in Ontario to a publicly funded family doctor or primary care team, the Ontario government has announced a \$235 million investment to support over 130 new and expanded primary care teams that will connect 300,000 people to primary care this year.

"We are continuing to build on our government's record investments, which have helped secure Ontario the highest rate of access to a regular health-care provider in the country," said Sylvia Jones, Deputy Premier and Minister of Health. "We are protecting Ontario's health-care system and people's access to convenient care by funding new and expanded primary care teams across the province, helping connect everyone in Ontario to a primary care provider."

The over 130 primary care teams were selected through a recent <u>call for proposals</u> focused on communities—identified by postal code—with the highest number of residents not connected to primary care, including those on the Health Care Connect waitlist. Each successful team has established a plan to attach a high proportion of unattached people in their postal codes and demonstrated readiness to achieve significant progress within a year.

"Together we are building a primary care system that is comprehensive, convenient and connected for every single person in Ontario," said Dr. Jane Philpott, Chair of Ontario's Primary Care Action Team. "Through the government's historic investments, we are making meaningful progress in expanding access to care—and this is just the beginning. In communities across Ontario, your primary care team will be your entry to care, where you will have a team of health professionals led by a family doctor or nurse practitioner to provide the care and services you need, when you need them, in a timely way."

Minister Jones and Dr. Philpott made the announcement at Flemingdon Health Centre in Toronto, which is receiving more than \$4 million annually through this allocation to help attach more than 9,600 people to primary care through the East Toronto Health Partners Ontario Health Team. Flemingdon Health Centre will focus on stabilizing the most complex patients with the greatest needs, who often struggle to navigate the health-care system. This model helps increase system capacity across East Toronto and reduces reliance on emergency services by meeting patients' needs earlier and more effectively in the community.

Through this latest investment, the province is providing primary care teams with \$142 million in operational funding over three years to recruit and retain healthcare workers. Funding can be used for non-physician team members such as nurse practitioners, registered practical nurses, physician assistants and pharmacists.

"At Flemingdon Health Centre, we have spent the last ten years building a model of community driven integrated primary health care," said Jen Quinlan, CEO of Flemingdon Health Centre. "This means prioritizing keeping people well and in the community. For the cost of a single trip to the emergency department, FHC can provide a suite of health care services to that same person for an entire year."

In addition to funding new and expanded primary care teams, the province is <u>investing \$300 million</u> to build up to 17 new and expanded community-based primary care teaching clinics in communities with high rates of unattachment to primary care, allowing up to 300,000 more people to be connected to primary care.

Through <u>Your Health: A Plan for Connected and Convenient Care</u>, the Ontario government continues to take bold and decisive action to grow the province's highly skilled health-care workforce and ensure people and their families have access to high-quality care closer to home for generations to come.

Quick Facts

- The government continues to make progress on connecting everyone on the Health Care Connect waitlist, as of January 1, 2025 (235,000 individuals) to primary care by Spring 2026. To date, the number of individuals remaining on the list has decreased by over 25 per cent.
- Ontario also recently passed the <u>Primary Care Act</u>, which establishes primary care as the foundation of Ontario's health-care system and sets out six clear objectives for Ontario's publicly funded primary care system to ensure people know what they can expect when connecting to primary care.
- Interprofessional primary care teams connect people to a range of health professionals that work together under one roof, such as registered nurses and

- registered practical nurses, physiotherapists, social workers, and pharmacists, helping patients to receive more connected and convenient care.
- Eligible teams not selected for funding in this round will be encouraged to refine and resubmit their proposals for the next call for proposals, which is expected to launch in September 2025.
- In 2024 Ontario <u>invested \$110 million</u> in primary care teams across the province, helping to connect 328,000 more people to primary care close to home.
- Since 2018, Ontario has added over 15,000 new physicians to its health-care workforce, including an over 10 per cent increase in family doctors.
- Ontario is taking significant steps to strengthen its health-care workforce by making it easier for <u>U.S.-licensed nurses and board-certified physicians</u> to move to and practise in Ontario.

Province accepting applications for new Rural Ontario Development program

June 24, 2025

CLINTON — The Ontario government is now accepting applications for the new Rural Ontario Development (ROD) program to help support economic growth, protect jobs and improve infrastructure in small communities. In January, the government announced \$20 million over the next two years to help rural communities attract investment and create new jobs and opportunities for rural workers. In the face of tariffs and economic uncertainty, this expanded funding will support the government's plan to protect rural Ontario communities by encouraging economic development and helping keep workers on the job.

"Our government has doubled its investment in the Rural Ontario Development program to drive economic growth and increase the workforce across rural Ontario," said Lisa Thompson, Minister of Rural Affairs. "The expanded program will benefit rural communities and rural businesses by attracting investment, creating jobs and building rural Ontario."

Eligible rural municipalities, not-for-profit organizations, Indigenous communities and small businesses can apply to four funding streams:

- Economic Diversification, Competitiveness and Capacity Building: building economic development capacity and implementing strategies that increase competitiveness to retain businesses, attract investment and enhance growth.
- Workforce Development, Attraction and Retention: investing in strategies and/or to undertake initiatives for attracting and retaining workers.
- Community Infrastructure Enhancements: investing in community infrastructure and improving public spaces or existing community assets.
- **Business Development:** investing in projects that support businesses to be financially sustainable and competitive, including cyber security initiatives, accessibility enhancements or expansion to new markets.

The Rural Ontario Development program is a key component of <u>Enabling</u> <u>Opportunity: Ontario's Rural Economic Development Strategy.</u>

Ontario Launches Advanced Wood Construction Action Plan

Province protecting forestry jobs and building homes and buildings faster by promoting the use of advanced wood construction

June 26, 2025

KITCHENER — The Ontario government has released the <u>Advanced Wood</u> <u>Construction Action Plan</u> to increase the manufacturing and use of high-quality made-in-Ontario wood building products. To support the government's plan to protect Ontario, the use of prefabricated and modular wood-based building materials, known as advanced wood construction, will help build more homes faster and create a more resilient forestry sector in response to U.S. tariffs by attracting investment, increasing revenues and providing economic opportunities that create and sustain local jobs.

"As our government delivers on its plan to protect and build Ontario, this action plan will help promote and prioritize wood-based building with made-in-Ontario wood construction products," said Mike Harris, Minister of Natural Resources. "Advanced wood construction is a new opportunity that can help get more homes built faster and build a stronger, more competitive forest sector that can withstand whatever comes our way."

Locally made mass timber and wood construction can be used to build modular and prefabricated buildings, including mid-rise and tall multi-family homes and a wide variety of commercial and industrial buildings. Advanced wood construction can complete projects up to 50 per cent faster and cut costs by up to 20 per cent, making it essential to achieving the government's goal of building more homes.

The <u>Advanced Wood Construction Action Plan</u> focuses on four objectives:

- Support initiatives that create awareness and encourage the use advanced wood construction
- Identify and remove barriers in codes, standards and regulations for the use of advanced wood construction

- Stimulate innovation and investment in advanced manufacturing facilities to grow Ontario's advanced wood construction sector
- Demonstrate and display examples of advanced wood construction to instill confidence in adopting new Ontario wood building products

"We're harnessing forest sector innovation to enhance how we build our homes, businesses and communities," said Kevin Holland, Associate Minister of Forestry and Forest Products. "Our government recognizes the potential of advanced wood construction – and our action plan is bringing its benefits to Ontario."

To date, Ontario has committed over \$13 million to enhance the province's advanced wood construction capacity, including:

- Over \$8 million to establish and scale up production at Element5: Ontario's first state-of-the-art, fully-automated manufacturer of cross-laminated timber
- Close to \$3M for wood-based construction education, research and training led by organizations such as the Canadian Wood Council and Canadian Wood Construction Research Network, to support building with wood
- Over \$1.5 million towards the construction of educational buildings incorporating mass timber at George Brown College and the University of Toronto
- Over \$750,000 to support FPInnovations' research and testing of wood-based construction materials and development of technical resources
- Over \$300,000 to help the University of Toronto's Mass Timber Institute develop ways to use more underused wood for advanced wood construction and study modular housing deployment to maximize environmental and economic benefit

Releasing the *Advanced Wood Construction Action Plan* advances Ontario's Forest Sector Strategy commitments to increase wood use, grow markets and encourage forest sector innovation. To learn more about the plan,

Ontario Reducing Wait Times for MRIs, CT Scans and Endoscopies

Province investing \$155 million for 57 community surgical and diagnostic centres to connect 1.2 million people to publicly funded procedures

RICHMOND HILL — The Ontario government is investing \$155 million over two years to add 57 new community surgical and diagnostic centres licensed to deliver MRI and CT scans, and gastrointestinal (GI) endoscopy services across the province. The expansion will help 1.2 million people access publicly funded procedures faster and is part of the government's plan to invest in and protect Ontario's health-care system.

"The 57 new centres we are rolling out across Ontario will make a huge difference for people in the province, helping them get the care they need, when they need it," said Premier Doug Ford. "It's all part of our plan to protect and improve our healthcare services, all while ensuring people always receive the care they need with their OHIP card."

Following a Call for Applications, licences will be issued starting this summer for:

- MRI and CT Scan Services: 35 newly licenced centres will deliver MRI and CT scans, connecting up to 828,000 more people over two years to vital diagnostic imaging more than four times the province's original goal. This expansion of services will reduce wait times and ensure patients receive scans within the medically recommended timeframe in regions where the centres will operate.
- **GI Endoscopy Services**: 22 newly licenced centres will deliver GI endoscopy procedures, adding up to 420,000 procedures over two years, more than three times the province's original goal. This expansion will ensure that every patient in the province in need of a GI endoscopy procedure receives it within the medically recommended timeframe.

The announcement was made at the Schroeder Ambulatory Centre in Richmond Hill. The Centre is receiving \$14 million to provide MRI and CT scans, as well as GI Endoscopy procedures to over 115,000 patients over two years, significantly reducing wait times in the region. The other recipients will be announced in the coming weeks.

"When it comes to wait times for surgeries and procedures, the status quo is not acceptable. That's why our government is taking bold, decisive action to protect Ontario's health-care system by boosting access to vital surgeries and diagnostic imaging so that families can conveniently access the care they need sooner," said Sylvia Jones, Deputy Premier and Minister of Health. "By licensing 57 new community surgical and diagnostic centres across Ontario, we are reducing wait times and ensuring more people can receive timely care in their community, for years to come."

As the government significantly expands the number of surgeries and procedures being done through community surgical and diagnostic centres, it is ensuring these centres are integrated and linked with the broader public-health system. This includes requiring new facilities to provide detailed staffing plans that protect the stability of staffing resources at public hospitals, report into the province's wait times information system and participate in regional central intakes, where available, to ensure people get the care they need as quickly as possible. All community surgical and diagnostic centres are under the <u>oversight of Accreditation Canada's</u> new quality assurance program, which provides the same strong requirements as public hospitals to improve quality standards at facilities and ensure consistent patient safety and quality care.

As part of <u>Your Health: A Plan for Connected and Convenient Care</u>, the government is taking action to protect Ontario by reducing surgical and diagnostic backlogs to make it easier and faster for more people to connect to publicly funded surgeries and procedures, when and where they need it.

Quick Facts

- For over 30 years, community surgical and diagnostic centres have been providing publicly funded diagnostic imaging, surgeries and procedures.
- There are currently over 900 community surgical and diagnostic centres across the province; the majority provide diagnostic imaging services.
- New community surgical and diagnostic centres build on the progress the Ontario government has made since the launch of A Plan for Connected and Convenient Care including:

- Achieving the shortest surgical wait times for key procedures of any province in Canada in 2024 with over 83 per cent of people receiving their procedure within clinically recommended target times
- Funding up to 65,568 MRI and 31,220 CT operating hours in existing community surgical and diagnostic centres over the past year
- Adding 50 new MRI machines in 43 hospitals across the province to increase
 MRI capacity and services
- Adding four new licensed cataract centres to provide more publicly funded cataract and other eye surgeries. In the past year, the government has funded 40,000 eye surgery procedures at community surgical and diagnostic centres
- Eliminating the backlog of cervical cancer screening tests at the end of August 2023. Testing turnaround times returned to the pre-pandemic standard of 10 to 14 days.
- Existing centres have transitioned to the new quality assurance (QA) program.
 Routine inspections by Accreditation Canada's new QA program began October 2024.
- No centre can refuse an insured service to a patient who chooses not to purchase uninsured upgrades and no patient can pay to receive insured services faster than anyone else.

Ontario Taking Action to Make Conservation Authorities More Effective

Province appoints Burlington Chief Administrative Officer Hassaan Basit as first-ever Chief Conservation Executive

June 27, 2025

Environment, Conservation and Parks

TORONTO — Ontario is taking action to enhance the effectiveness of the province's conservation authorities, which will create consistency, reduce costs and drive faster outcomes for the communities they serve. These changes will support the government's commitment to protect Ontario's economy by speeding up critical infrastructure and housing development, while safeguarding the environment. To lead these efforts, Hassaan Basit, a well-respected and non-partisan leader with deep experience with local conservation authorities, will serve in a newly created role as the Chief Conservation Executive, effective August 4, 2025.

"Our government recognizes the vital role that Ontario's conservation authorities play in watershed management and protecting communities from natural hazards," said Todd McCarthy, Minister of the Environment, Conservation and Parks. "I am looking forward to leading our government's efforts to bring common sense conservation principles to the role of conservation authorities and this newly created role under Hassaan's leadership will support these efforts across the province."

Since 2019, Ontario has been working to improve the operations of conservation authorities to better ensure they have the required tools to protect the communities they serve, through legislative and regulatory changes that have significantly improved governance, oversight, transparency and accountability of conservation authorities, while streamlining decision-making processes.

"I'm honoured to join the Province of Ontario at this pivotal moment for conservation," said Hassaan Basit, newly appointed Chief Conservation Executive. "Over my 20 years in the conservation sector, I've learned that effective flood protection is not just about safeguarding the environment — it's about enabling prosperous, sustainable communities. Conservation authorities were created to

strike that balance, and they have worked for decades to protect people and property while supporting economic prosperity. As we move forward, modernization is essential to ensure they remain focused, effective, and ready to meet Ontario's growing needs — whether it's mitigating flood risks, enabling housing supply or supporting long-term resilience."

Mr. Basit is currently the Chief Administrative Officer for the City of Burlington. Prior to this, Mr. Basit was President and CEO of Conservation Halton, where he led initiatives in flood risk management, environmental restoration, sustainable development, and outdoor recreation. During this time, Mr. Basit also chaired a provincial working group that advised government on the implementation of key changes to improve the ability of conservation authorities to protect Ontario's water, land and natural resources. He holds an Executive MBA in Digital Transformation and a Governance Certification from McMaster University, a Master of Science in Science Communication from Queen's University Belfast, and a Bachelor of Science in Biology and Political Science from the University of Toronto.

- Ontario is served by 36 conservation authorities.
- In Ontario, conservation authorities develop and deliver local, watershed-based resource management programs on behalf of the province and municipalities, including programs aimed at preventing floods and other natural hazards, drinking water source protection and surface water and groundwater monitoring programs.
- Conservation authorities in Ontario were established in 1946 by the *Conservation Authorities Act*.

Ontario Capping Rent Increases at the Rate of Inflation

Province protecting tenants with 2.1 per cent cap, the lowest in four years

June 30, 2025

Municipal Affairs and Housing

TORONTO — The Ontario government is protecting tenants by capping rent increases for 2026 at 2.1 per cent. This cap is based on Ontario's Consumer Price Index, a measure of inflation calculated by Statistics Canada using data that reflects economic conditions over the past year.

"Our government knows tariffs and economic uncertainty are creating challenges for many people in Ontario, including renters, which is why we are capping rent increases for 2026 at 2.1 per cent," said Rob Flack, Minister of Municipal Affairs and Housing. "This cap is the lowest in four years, which demonstrates our commitment to protecting tenants across our province as we continue searching for ways to keep costs down across the province."

From January 2025 to May 2025, Ontario saw 6,977 rental starts, an increase of 25 per cent compared to the same period in 2024. This is the second-highest level of rental starts on record for this time of the year, after 2023, and showcases the government's plan to get shovels in the ground to build more homes, faster.

Quick Facts

- Ontario's cap on rent increases, the rent increase guideline, is the maximum amount most landlords can increase rent during the year without approval from the Landlord and Tenant Board. Ontario has one of the lowest annual caps for residential rent increases across Canada.
- The rent increase guideline applies to the vast majority approximately
 1.4 million of rental households covered by the *Residential Tenancies Act*. It does not apply to rental units occupied for the first time after November 15, 2018, vacant residential units, community housing, long-term care homes or commercial properties.
- Rent increases are not automatic or mandatory. Landlords may only raise rent if they give tenants at least 90 days' written notice using the <u>correct form</u>.

 Tenants who need help to pay rent are encouraged to contact their local <u>service</u> <u>manager</u> to see what housing supports are available in their community.

Ontario's Energy Plan Unlocking Opportunities in the Digital Economy

New measures will prioritize electricity for data centres that create good-paying jobs and strengthen Ontario's economy

July 02, 2025

Energy and Mines

KITCHENER – The Ontario government is taking action to prioritize electricity for data centres that support the province's economic interests, including those that create high-quality jobs, assist in domestic data hosting and strengthen Ontario's position in the digital economy. As part of the government's plan to protect Ontario, the province is embracing the growth of the data centre sector as a strategic opportunity to drive investment, innovation and job creation. This approach is grounded in Ontario's new integrated energy plan, the province's strategy to secure the clean, reliable and affordable power needed to support economic growth in high-demand sectors like digital technology.

This Canada-first plan will prioritize and accelerate approvals for data centres that deliver measurable benefits to both local communities and to the province's long-term competitiveness. This will include good-paying jobs for Ontarians, securing local data storage and creating a stronger, more competitive economy. This new plan will:

- Ensure that data centres that support the province's economic interests, including those that create high-quality-jobs, strengthen our digital economy and support domestic data housing are quickly approved for connection to the grid.
- Ensure Canadian data stays in Canada and is protected from misuse and weaker foreign privacy regimes.
- Explicitly require approval before certain data centres can connect to Ontario's electricity grid, ending automatic approval for large energy-intensive loads so that the province can prioritize data centres that support its plan to protect Ontario.

The current load data centres requesting to be connected to Ontario's grid represents approximately 30 per cent of Ontario's peak demand in 2024, or the output of a nuclear plant the size of Bruce Power Nuclear Generating Station. With over 6,500 megawatts of data centres requesting to be connected to the grid, demand for electricity from the data centre industry, which includes artificial intelligence and cloud computing, is growing and expected to represent 13 per cent of new electricity demand in Ontario by 2035.

"Technology is the future. To ensure we are always on the leading edge as we attract good-paying jobs, we need to further protect Canadian sovereignty and data," said Stephen Lecce, Minister of Energy and Mines. "These measures will ensure we're not just plugging in servers – we're powering Canadian opportunity, protecting Canadian data and jobs and making sure energy is used where it delivers real value to our country."

As global demand for AI, cloud computing and data processing increases, the government introduced new legislative measures in the <u>Protect Ontario by Securing Affordable Energy for Generations Act, 2025</u>, that will, if passed, require data centres to obtain approval before connecting to the electricity grid. Currently, electricity utilities are required to connect all data centres indiscriminately, regardless of economic impact or energy consumption needs. These changes will welcome new investment and job creation by allowing Ontario to manage electricity connection requests and prioritizing data centres that deliver real local, strategic and economic benefits that enhances Ontario's competitiveness, energy security and long-term prosperity.

"Ontario's data centres are a vital part of our province's technology landscape, as they provide the foundation of our growing digital economy and the security of our data," said Sam Oosterhoff, Associate Minister of Energy-Intensive Industries. "As we experience increasing energy demands — not only from our energy-intensive industries, but also from the pressures of attracting new investment to the province — we have to ensure we are taking action to prioritize projects that create good jobs and get these projects connected to the energy they need. This policy will protect and promote data centres, while also protecting our ability to attract large manufacturing facilities to our province."

This initiative is part of <u>Energy for Generations</u>, the government's long-term approach to make sure Ontario has the reliable, affordable energy it needs to be energy secure and power economic growth. The government's integrated approach and record investments in energy infrastructure are also providing the certainty needed for Indigenous communities, municipalities, businesses and industry

partners to invest confidently in Ontario's future. With a clear path forward, the plan not only helps meet the demands of today but will help protect workers and the economy by keeping workers on the job and powering growth and opportunities for generations to come.

- According to the <u>National Cyber Security Index</u>, Canada scores 96.67 out of 100, ranking second in the world. The ranking is based on the nation's preparedness in preventing and managing cybersecurity threats. The exceptional ranking signals to data centre providers that Canada is a safe and dependable location for new data center developments.
- The worldwide data centre construction market is projected to reach \$49 billion by 2030. Canada is among the top ten largest data centre markets, with \$8 billion in revenue, and it has the potential to move up to the top five. Spending on servers is the fastest-growing segment of the data centre sector in Canada, and it is forecasted to grow by 66 percent by 2029, reaching approximately \$4 billion in value.
- The 2021 report '<u>Foreign Interference Threats to Canada's Democratic</u>
 <u>Process</u>' specifically noted that Canada's abundance of natural resources makes it a target for foreign interference.
- Ontario's electricity grid is one of the cleanest in the world with a diverse supply mix made up of nuclear, hydroelectric, natural gas, wind, solar and bioenergy.
- By 2035, electricity demand from electrifying Ontario's industrial sector is expected to increase by 58 per cent – the equivalent of adding 2.7 million homes to the grid.
- <u>Energy for Generations</u> builds on the 2024 vision paper <u>Ontario's Affordable</u>
 <u>Energy Future: The Pressing Case for More Power</u> that received 136 submissions to the public consultation from Indigenous communities, municipalities, utilities, stakeholders and the public.
- The <u>Protect Ontario by Securing Affordable Energy for Generations Act, 2025</u>, if passed, will support major growth in the province's energy system to meet rising demand, while keeping energy affordable, secure, reliable and clean for generations to come.

Ontario Supporting Long-Term Care Residents with Complex Needs

\$35 million Local Priorities Fund invests in specialized equipment and innovative programs

July 03, 2025

Long-Term Care

TORONTO — The Ontario government is investing \$35 million to help long-term care homes across the province support residents with complex needs. The Local Priorities Fund (LPF) is designed to support programs that connect people with the right care for them, reducing emergency department visits and hospital stays. This investment is part of the government's plan to protect Ontario by ensuring long-term care residents get the quality of care and quality of life they need and deserve.

"Our government is protecting our long-term care system by investing in the tools and training to ensure residents can get the right care in the right place," said Natalia Kusendova-Bashta, Minister of Long-Term Care. "This funding will expand the specialized equipment and innovative services available at long-term care homes across our province, so those with complex needs get the support they deserve."

Originally launched in 2022, the LPF provides specialized equipment, services and staff training to enable long-term care homes to admit new residents with specialized needs and support current residents with complex needs. Since its launch, the fund has supported approximately 2,500 projects across Ontario.

In 2024-25, the LPF supported more than 900 projects including:

- 139 projects in northern Ontario, with a \$9.5 million investment, to support residents with specialized needs including complex dementia, mobility issues and cardiovascular conditions, and improve their care.
- In the Greater Toronto Area, Women's College Hospital and the Centre for Quality Improvement and Patient Safety are receiving \$1 million to coordinate with Toronto hospitals and long-term care homes on the prevention of avoidable emergency department visits.

• In eastern Ontario, the government is investing \$500,000 to purchase bariatric equipment across 30 long-term care homes. The equipment will reduce barriers to admission for residents with weight management needs and help the staff provide high-quality care.

Helping long-term care residents with complex needs is one more way the province is taking action to meet the needs of Ontario's aging population and their caregivers by improving and expanding supports for seniors living in long-term care, congregate settings and in the community. The government's plan to improve long-term care for residents is built on four pillars: staffing and care; quality and enforcement; building modern, safe, and comfortable homes; and connecting seniors with faster, more convenient access to the services they need.

Quick Facts

- The Local Priorities Fund is administered by Ontario Health.
- Seniors people age 65 and older make up the fastest growing age group in the province.
- More than 60% of long-term care residents have a dementia diagnosis.
- As part of its plan to fix long-term care and address waitlists, the government is building 58,000 new and upgraded long-term care beds across the province.
- Ontario is offering <u>incentives of up to \$35,400</u> to PSW students and eligible PSWs to launch careers in long-term care homes and in the home and community care sector.
- The Ontario government invested up to \$4.9 billion between 2021 and 2025 to create thousands of new positions for personal support workers, nurses, and allied health professionals in long-term care.

Ontario Building More Accessible Communities

Applications now open for \$2.2 million in community accessibility grants

July 04, 2025

Seniors and Accessibility

TORONTO — The Ontario government is investing \$2.2 million to help protect and strengthen access to inclusive spaces for all Ontarians. The Enhancing Access to Spaces for Everyone (EASE) Grant awards up to \$60,000 for projects that improve accessibility and support active lifestyles for people with disabilities and older adults.

"With the launch of the EASE Grant, we are taking action to ensure more seniors and people with disabilities can participate fully in their communities," said Raymond Cho, Minister for Seniors and Accessibility. "Under the leadership of Premier Ford, our government will continue to protect Ontario by investing in infrastructure projects that create jobs and allow people to live healthy and active lifestyles."

EASE Grants will provide municipalities, non-profit organizations and Indigenous governing bodies funding for capital projects and retrofits that help older adults and people with disabilities participate in community life. Examples of potential projects include installing charging stations for mobility devices, installing mobility mats at beaches and building accessible washrooms at parks.

To protect seniors, the Ontario government is investing in a <u>historic number of community programs</u> and active living centres that support healthy and socially connected living. This includes an additional \$1 million designated for programs dedicated to improving the quality of life for senior veterans and expanding Seniors Active Living Centres (SALCs) to over 400 sites to increase access to services that connect seniors to activities and programs close to home.

Applications for EASE Grants are now open at Ontario.ca/GetFunding. Eligible organizations have until August 14, 2025, to submit their applications.

Ontario and Alberta Working Together to Build New Energy and Trade Infrastructure

Provinces sign agreements to get Ontario's critical minerals and Western Canada's oil and gas to new markets

July 07, 2025

CALGARY — Today, Ontario Premier Doug Ford and Alberta Premier Danielle Smith signed two Memorandums of Understanding (MOUs) to support Canadian workers by <u>building new pipelines</u>, <u>rail lines and other energy and trade infrastructure</u> that will diversify Canada's trading partners by unlocking new markets for Ontario's critical minerals and Western Canada's oil and gas. Built using Ontario steel, new pipelines will connect western Canadian oil and gas to new and existing refineries in southern Ontario and will expand export opportunities, including by way of a new James Bay deep-sea port in northern Ontario. New rail lines, also built using Ontario steel, will connect Ontario's Ring of Fire region, critical mineral mining projects and processing facilities to western Canadian ports as Ontario builds an end-to-end critical minerals supply chain.

"In the face of President Trump's tariffs and ongoing economic uncertainty, Canadians need to work together to build the infrastructure that will diversify our trading partners and end our dependence on the United States," said Premier Ford. "By building pipelines, rail lines and the energy and trade infrastructure that connects our country, we will build a more competitive, more resilient and more self-reliant economy and country. Together, we are building the infrastructure we need to protect Canada, our workers, businesses and communities. Let's build Canada."

"Alberta and Ontario are joining forces to get shovels in the ground and resources to market," said Premier Smith. "These MOUs are about building pipelines and boosting trade that connect Canadian energy and products to the world, while advocating for the right conditions to get it done. Government must get out of the way, partner with industry and support the projects this country needs to grow. I

look forward to working with Premier Doug Ford to unleash the full potential of our economy and build the future people across Alberta and across the country have been waiting far too long for."

To move these projects forward, Ontario and Alberta will soon launch a joint feasibility study to help determine the optimal route and endpoints for new economic and energy corridors, what financing or commercial tools may be necessary and how to best leverage home-grown supply chains to build these projects, including Ontario steel. As these projects advance, Ontario and Alberta will continue to fulfill their duty to consult with Indigenous communities.

As part of the MOUs, <u>Ontario and Alberta agreed</u> to advocate for a federal regulatory environment that encourages private-sector investments in new energy and trade infrastructure projects, as well as to cooperate to advance the development of nuclear energy, including sharing of technologies and expertise in small-modular and large-scale reactors to support new nuclear facilities in Alberta and Ontario to meet growing needs of the electricity grid and industrial energy needs for power and steam. Ontario and Alberta also agreed to support the prioritization of made-in-Canada vehicles for the Alberta government's fleet of vehicles and to support the increased presence of Alberta beer, wine, liquor and other alcoholic beverages on Ontario store shelves. These measures build on the MOU that was signed between Ontario and Alberta on June 1, 2025 in Saskatoon, with the aim of tearing down trade barriers between the two provinces.

Since April 2025, Ontario has signed agreements supporting the removal of interprovincial trade barriers with six provinces. Ontario also passed the *Protect Ontario Through Free Trade Within Canada Act,* which received royal assent on June 5, 2025, and was the first jurisdiction in Canada to eliminate all of its party-specific exceptions under the <u>Canadian Free Trade Agreement</u>. With this new legislation and growing number of signed MOUs, Ontario is leading the country in expanding the trade of goods and services across Canadian jurisdictions, cutting the unnecessary red tape holding back Canadian businesses and opening new pathways for the movement of qualified, in-demand workers throughout the country.

Two-way trade in goods and services between Ontario and other provinces and territories was valued at more than \$326 billion in 2023. The Ontario government will continue to work with its federal, provincial and territorial partners through the Canadian Free Trade Agreement and other trade-enhancing initiatives to advance interprovincial trade across Canada.

- The total value of annual interprovincial trade between Ontario and Alberta for 2021 (the most recent year for which figures are available) was \$62.4 billion.
- In 2023, Ontario exported \$183.9 billion of goods and services to other provinces and territories and imported \$142.7 billion, resulting in two-way trade of \$326.6 billion and a trade surplus of \$41.2 billion.
- Ontario recently launched its \$50 million <u>Ontario Together Trade Fund</u> to assist local businesses in taking advantage of new interprovincial trade opportunities.
- Thirty-five per cent of Canada's overall trade takes place within its own borders.
- Ontario is committed to fulfilling its duty to consult with Indigenous partners and communities, while supporting their involvement in nation-building projects with <u>historic funding</u> to help First Nations become equity partners.

Council and Committee Monthly Summary

June 2025

Below you will find highlights of the County of Renfrew County Council and Committee meetings held June 12 and June 25, 2025.

Warden's Address

Key highlights

- On June 12, Warden Peter Emon welcomed Councillor Rob Tripp as an alternate member of Council representing Greater Madawaska; he congratulated Councillor Glenn Doncaster on his appointment to the FCM Board of directors; he congratulated Councillor Lori Hoddinott on receiving the Academic Excellence Award in Municipal Law at the recent AMCTO conference and he congratulated the Township of Greater Madawaska on the tremendous success of their inaugural Guitars and Gasoline Music Festival.
- The Warden acknowledged June as Pride Month, a time to celebrate the diversity, resilience, and contributions of 2SLGBTQI+ communities across our region and beyond; as National Indigenous History Month, which offers an opportunity to honour the rich history, heritage, and ongoing contributions of Indigenous peoples across Canada; as Seniors Month, a time to honour the amazing seniors and to recognize the hard work that they have done all their lives to make the County of Renfrew into the great place it is today.
- The 18th Annual Renfrew County Warden's Golf Tournament was held on June 20th at Dragonfly Golf Links. He shared that the event raised over \$8,500 in support of two local charities: the Family and Children's Services of Renfrew County Darlene Aikens Memorial Fund, and the County of Renfrew's Homelessness and Housing Fund. He thanked the generous sponsors and supporters, County of Renfrew staff, and staff at Dragonfly Golf Links for making this fundraiser a success. Congratulations to Team Sweetness on winning the tournament.
- The Warden also attended John Yakabuski's retirement dinner, where he had the opportunity to thank him for his 22 years of dedicated service representing the people of Renfrew–Nipissing–Pembroke and wish him all the best in his well-earned retirement.
- This summer he encouraged everyone to THINK about their activities and buying power and to support our local businesses, noting every dollar spent in Renfrew County helps sustain local jobs, strengthens our economy, and preserves the unique identity and vibrancy of our communities.



Delegations

- Michael Nolan, Director of Emergency Services/Chief, Paramedic Service, presented the Ontario Medal for Paramedic Bravery to retired Paramedic Brad Smith for his heroic actions on February 12, 2012. On that day, a snowmobiler had fallen through the ice on Calabogie Lake. Brad was among the first to respond. With no time to spare and no thought for his own safety, he located a nearby canoe, entered the icy waters, and paddled out using only his hands. Upon reaching the stranded individual who was being supported by another courageous citizen Brad worked to bring them to safety. During the rescue, Brad himself ended up in the freezing water. Despite this, he remained focused, resilient, and determined.
- Shanna Armstrong, member, and Jennifer Doelman, vice-chair, made a presentation on behalf
 of the Renfrew County Agriculture Economic Development Committee. This Committee provides
 guidance and feedback on the state of the agriculture sector within Renfrew County and
 recommends and assists with possible initiatives in support of agricultural economic and
 business development. They highlighted economic contributions of the local agricultural
 community and noted challenges and opportunities for the industry.
- Darren Waters and Ryan Vandenbert, from the Ministry of Transportation, provided an update
 on several MTO projects in Renfrew County, including the twinning of Highway 17, Highway 148
 in the Township of Laurentian Valley and City of Pembroke, and the preliminary design of
 Highway 60 and County Roads 30 and 60 in North Algona Wilberforce Township.
- MPP Billy Denault made his first official visit to County Council. Looking forward to his role as the Parliamentary Assistant to the Ministry of Tourism, Culture and Gaming, a position that is applicable to the riding in terms of local economic development, working to build relationships with local councils necessary to assist where issues arise. He spoke about the Provincial Government's focus on health care with the Primary Care Action Plan headed by Dr. Jane Philpott. He acknowledged it has been a learning curve since taking office, but he called it a privilege and honour to advocate for the riding of Renfrew-Nipissing-Pembroke at Queen's Park.
- At the June 12 Community Services Committee, County of Renfrew Chief Administrative Officer Craig Kelley and Sabine Mersmann, CEO of Pembroke Regional Hospital, provided an update on the activities to date towards the establishment of the Renfrew County Mesa HART Hub in Pembroke. The HART Hub will provide low-barrier access to services, ensuring that clients can receive support regardless of their current stage of readiness for change; eliminate common barriers to care, such as rigid requirements or limited access points; offer immediate access to intensive wellness supports, such as stabilization services and onsite care for individuals with complex needs and lead comprehensive care planning by conducting physical and mental health assessments and delivering treatments based on those assessments.

Announcements

• County Councillor Jennifer Murphy stated her intention to run for Renfrew County Warden for 2026. She thanked Warden Peter Emon for his support in the past six months in helping her to prepare for the role, which she previously held from 2017-2019.



Development & Property Committee

Presented by: James Brose, Chair

- County Council adopted a by-law to enter into a lease agreement with the Ontario Addiction Treatment Centre (OATC), located at 156 John Street, Pembroke, Ontario, for a three-year term commencing May 1, 2025, for the purpose of a warming/cooling centre as part of the Renfrew County Mesa HART Hub.
- County Council approved the implementation of a regional incentive program, referred to as the Helping Your Place Excel (HYPE) program.
- County Council adopted a by-law to approve Official Plan Amendment No. 47, which allows the County to provide grants/loans to local municipalities that support their Community Improvement Plans (CIPs).
- County Council has approved moving forward with the new Pembroke Paramedic Base at 330 Boundary Road. A consulting firm, Greenview Environmental Management, of Bancroft, Ontario, has been hired to help design and plan the project. The total cost for their services is \$227,970 plus taxes. The County will apply to Infrastructure Ontario to help fund the renovations.
- County Council has approved the construction of a new paramedic base in the Township of Whitewater Region. The project will be led by R.K. Porter General Contracting Inc. (Perth), working with J.L. Richards and Associates (Ottawa) and Egis Group (Kanata). The total cost is \$3.25 million (plus rebatable taxes). Funding will come through a financing arrangement with Infrastructure Ontario.
- A total of 13 applications were received to fill the 7 available spots in the <u>2025 Summer Company program</u>. The successful participants are Jazmin Clark (Whitewater Region) Pottery; Page Hodgson (Arnprior) Crochet products and clothing; Noah Obrien (Madawaska Valley) Apparel brand; Hunter Prince (Horton) 3D Printing; Minnah Rehn (Arnprior) Henna services and products; Nella Rosandic (Killaloe-Hagarty-Richards) Handmade stickers and buttons and Emmanuel Young (Arnprior) Lawn care business.
 - The Summer Company program supports students aged 15-29 who start and run their own summer business. Students are provided with business planning and operational guidance, in addition to a \$1,500 non-repayable grant at the start of the program. Upon program completion, students are awarded an additional \$1,500 non-repayable grant.

Operations Committee

• County Council adopted a revised by-law to Regulate the Operation of Off-Road Vehicles on County of Renfrew Roads. The amendment permits Off-Road Vehicles on the following sections of County Roads in the Town of Petawawa: County Road 16 (Victoria Street), between Laurentian Drive and Petawawa Boulevard; County Road 25 (Laurentian Drive), between Victoria Street and Petawawa Boulevard; County Road 26 (Doran Road), between Petawawa Boulevard and Highway 17; County Road 37 (Murphy Road), between Petawawa Boulevard and Highway 17; County Road 51 (Petawawa Boulevard), between B-Line Road and civic address 2991 Petawawa Boulevard. Crossings of County Road 51 (Petawawa Boulevard) at the Fred Street/Norman Street and Victoria Street/Portage Road intersection is also permitted.

County Council authorized County of Renfrew staff to undertake all necessary actions to
implement the Renfrew County Mesa HART Hub project as outlined, including but not limited to
executing the Transfer Payment Agreement with the Ontario Ministry of Health, Ontario
Ministry of Municipal Affairs and Housing, Ontario Health, and any other designated ministry or
agency with responsibility for funding of the HART hub(s), fulfilling reporting obligations, hiring
or assigning staff as appropriate, entering into agreements with partner agencies, procuring
goods and services within approved budgets, and performing any other activities necessary to
bring the project to fruition.



- As part of the Renfrew County Housing Corporation Annual General Meeting, Jennifer
 Dombroskie, Manager of Community Housing, and Kevin Raddatz, Manager of Real Estate,
 highlighted aspects of the 2024 Renfrew County Housing Corporation Annual Report. Mr.
 Raddatz overviewed the RCHC portfolio, which includes 1,029 Residential Units across
 apartments, townhouses, and single/semi-detached homes. He highlighted some capital
 projects completed, noted some emergency repairs required for some units and in looking
 ahead noted the 2025 priority of long-term stability for the RCHC. Ms. Dombroskie highlighted
 the Collaborative Model of Care when it comes to Community Housing in Renfrew County –
 from Community Housing Caseworkers, to maintenance staff and the Community
 Paramedic/RCHC collaboration towards improved health and wellness for tenants.
- A new Canada-Wide Early Learning and Child Care (CWELCC) Agreement was executed with Paradise Children's Programs Inc., myFM Centre Recreation Complex, Renfrew, Ontario. In accordance with the County of Renfrew's Directed Growth Strategy, the three non-CWELCC centres (Paradise Children's Programs Inc., myFM Centre Recreation Complex), Kinder Connection Nursery School, and Deep Roots Nature & Nursery School) were given the first opportunity to opt in, followed by an application-based process to determine the allocation of remaining spaces.

Health Committee

- County Council directed staff to establish a volunteer-based Disaster and Emergency Local Team
 Activation (DELTA) Program within the County of Renfrew, including the development of
 operational supports necessary for implementation. This strategy aims to build a robust
 infrastructure of trained, skilled, and community-based volunteers who can respond effectively
 alongside professional emergency services during times of crisis.
- County Council authorized County of Renfrew to undertake all necessary actions to implement
 the Renfrew County Substance Use, Mental Health and Housing Mesa Systems Integrated
 Navigational Tool, including but not limited to executing the Transfer Payment Agreement with
 Health Canada, fulfilling reporting obligations, entering into agreements with partner agencies,
 procuring goods and services within approved budgets, and performing any other activities
 necessary to bring the project to fruition.
- County Council adopted a by-law authorizing the Warden and Chief Administrative Officer to sign the Lease Agreement between the County of Renfrew and Carefor Health and Community Services, 425 Cecelia Street, Pembroke, Ontario, for tenant office space for the Renfrew County Virtual Triage and Assessment Centre (RC VTAC) for a one-year term commencing April 1, 2025.

Corporate Services Committee

 County Council approved the Audited Financial Statements for the County of Renfrew for the year ended December 31, 2024. At the beginning of the meeting, Lori Huber, Partner KPMG, provided a high-level overview of the clean audit report.

County of Renfrew Paramedics respond to surge in emergencies during extreme weather events

The County of Renfrew Paramedic Service faced significant operational demands during the extreme heat wave that impacted the region from Sunday, June 22 to Tuesday, June 24.

Compared to call volumes from June 2024, this year's heat wave led to a marked increase in emergency responses, with Paramedics treating seven patients for heat-related illnesses – six serious and one critical. This surge highlights the growing strain on vulnerable populations and the frontline crews providing care.

An Imperfect Storm: In anticipation of the risks posed by the extreme heat and severe storm activity on the evening of June 21 into June 22, the Community Paramedic Program mobilized quickly. Their proactive outreach included 30 phone check-ins for clients experiencing power outages, 30 for heat-related concerns, and 77 in-person wellness visits to vulnerable Mesa and Community Paramedic clients. Paramedics also visited local cooling centres 17 times to support access to hydration and relief from the heat.

The County's Sierra Team also responded to six remote and complex incidents during this period. These included serious injuries at the Eagles Nest lookout in Greater Madawaska, a double medical response on the shoreline of Gun Lake in Madawaska Valley and overnight extractions, the first of a youth with multisystem trauma at North Depot Lake and the second an adult male impaled by a falling tree at Opeongo Lake in Algonquin Park.

The team also led a large-scale multi-person response following tornadic storm activity at Opeongo Lake, where multiple individuals were assessed and assisted.

Additional responses included supporting a multi-agency, mass casualty incident operation at Samuel de Champlain Provincial Park and a skydiving accident near Lanark County at Road 29/Upper Dwyer Hill Road adjacent to the Arnprior Airport.

Working closely with partner agencies such as the Ontario Provincial Police, Ontario Parks, ORNGE, and the Joint Rescue Coordination Centre out of Trenton, the Sierra Team deployed specialized tools including rescue boats, UTVs, rope kits, hypothermia gear, and thermal imaging drones.

Ongoing and increasing community needs demonstrate the vital role that specialized Paramedic programs play and their impact in ensuring specialized medical care across Renfrew County's diverse area and adventure activities.

Public Health Units Unite to Promote Summer Safety Across the Eastern Region

As summer temperatures rise, Renfrew County and District Health Unit (RCDHU), Ottawa Public Health (OPH), and Eastern Ontario Health Unit (EOHU) are uniting to promote seasonal summer safety messaging. This regional collaboration aims to provide residents across the region with clear, consistent guidance on staying safe and healthy during the summer months.

Stay safe during extreme heat

Summer heat can be enjoyable, but it is important to stay safe when it turns extreme. Watch for the effects of heat illness including swelling, rash, cramps, fainting, heat exhaustion, heat stroke and the worsening of some health conditions. Extreme heat affects everyone, but the risks are higher for young children, pregnant individuals, older adults, people with chronic illnesses, those who work or exercise outdoors, individuals without air conditioning, and people experiencing homelessness. Heat-related illnesses and deaths are preventable.

During extreme heat events, stay up to date with local weather forecasts and alerts - tune in to local news, radio, and download the WeatherCAN app. Drink plenty of water to stay hydrated and eat fruits and vegetables with higher water content. Limit alcohol and caffeine. Avoid strenuous outdoor activity, especially during peak heat hours. Dress in light, loose-fitting clothing, wear a hat and sunscreen, and carry water and an umbrella if you need to be outside. Cool off in air-conditioned places like malls, libraries, or community centers, or find shade in parks and green spaces. Use fans, take cool showers, or soak your hands and feet in cool water. If you're breastfeeding, follow your child's cues and stay well-hydrated. Check in on people at higher risk, like older adults, people with chronic medical conditions, and anyone living alone.

During extreme heat and a power outage, stay cool by keeping blinds closed, using battery-powered fans, avoiding heat-generating appliances, staying in the coolest area of your home or visiting a local mall, library, or community centre with air conditioning.

Protect yourself during poor air quality events

Poor air quality poses serious health risks, even at relatively low levels. Exposure to pollutants can cause a variety of health problems, ranging from mild symptoms such as dry or irritated eyes, nose, throat, or skin, and coughing or difficulty breathing, to more serious health

complications. Individuals most at risk during poor air quality events include older adults, pregnant individuals, young children, people with heart or lung conditions, and those who work or exercise outdoors.

Download the <u>WeatherCAN app</u> to receive real-time alerts about air quality, extreme heat, and other weather-related risks. Check the <u>Air Quality Health Index (AQHI)</u> for your region and follow public health recommendations. For up-to-date health guidance during wildfire smoke events, visit the <u>Special Air Quality Statement website</u>.

When air quality is poor, stay indoors and keep windows closed, if possible use your HVAC system to help filter indoor air, limit outdoor activities and plan your day accordingly.

Sun safety

While enjoying the sun, it's important to protect yourself from harmful UV rays. The <u>UV Index</u> is a helpful tool - when it's 3 or higher, sun protection is strongly recommended for all skin types. Overexposure to UV radiation can lead to sunburn, premature skin aging, eye damage, and an increased risk of skin cancer which is the most common and most preventable type of cancer. Individuals most at risk include babies and young children, whose skin is especially sensitive, as well as people who spend extended time outdoors for work or recreation.

To stay informed, check the daily <u>UV Index</u> in your local weather forecast or through apps like <u>WeatherCAN</u>. One of the most effective ways to protect your skin is by using <u>sunscreen</u>. Choose a broad-spectrum, water-resistant sunscreen with an SPF of 30 or higher. Apply it generously at least 20 minutes before going outside, and reapply every two hours, or more often if you're swimming or sweating. However, sunscreen alone isn't enough - it's best used in combination with other protective measures.

Wearing protective clothing is another way to protect oneself. Wear light-coloured, long-sleeved shirts, long pants, and a wide-brimmed hat to shield your skin. Sunglasses that block 100% of UVA and UVB rays are essential for protecting your eyes. During peak sun hours - typically between 11 a.m. and 3 p.m. - try to stay indoors or in the shade.

Whenever possible, seek shade under trees, umbrellas, or shelters, especially during midday. Additional precautions should be taken with babies and young children; keep infants out of direct sunlight, dress them in protective clothing, and use baby-safe sunscreen on small exposed areas if necessary.

Water safety

Our region has beautiful water ways to enjoy and pools provide a fun seasonal way to cool off. Water safety is everyone's responsibility and essential to ensure a safe experience. Drowning can happen quickly and silently. Be prepared for emergencies by learning CPR and knowing how to call 9-1-1. Stay alert to changing weather conditions such as lightning, strong winds, and heavy rain as they can develop quickly and pose a serious risk.

Where possible, swim in areas supervised by lifeguards, and keep children within arm's reach at all times around water - never leave children unattended, even for a moment. Ensure that children and less experienced swimmers wear properly fitted life jackets or personal flotation

devices. Avoid alcohol, cannabis, or drugs when swimming or supervising others, as these substances can impair judgment and reaction time. While swimming lessons are valuable, they do not eliminate the risk of drowning, constant supervision remains critical - avoid swimming alone.

To help prevent illness and injury from recreational water use, Public Health Units inspect and test public beaches during swimming season. Municipal beaches are tested regularly, and other popular public-access beaches may be tested if there's a health risk. Water is tested for E. coli, which signals recent contamination from sources like swimmers, weather, wildlife, runoff, sewage, or boats. Check online ahead to see if the beach you are interested in visiting is either open, or posted. When the beach is "posted", a sign is put up. The sign is removed when further tests show that the water is safe for swimming again.

Vector-borne disease prevention

Spending time outdoors in the warmer months is something to look forward to, but it's important to protect yourself from the risks that come with <u>ticks and mosquitoes</u>. Ticks and mosquitos present some unique risks - they can carry vector-borne diseases like <u>West Nile virus</u> and <u>Lyme disease</u>. Mosquitoes and ticks are most active from spring through fall, especially in wooded or grassy areas. Populations most at risk include individuals who spend a lot of time outdoors, such as hikers, campers, gardeners, and outdoor workers. To stay informed, check local public health updates and resources for information on tick and mosquito activity in your area.

To reduce your risk, apply a Health Canada approved <u>insect repellent</u> containing DEET or icaridin to exposed skin and clothing. Wear long sleeves, pants, socks, and closed shoes when spending time outside, particularly at dawn and dusk when mosquitoes are most active. Light-colored clothing can help you spot ticks more easily, and tucking your pants into your socks adds an extra layer of protection. After outdoor activities, do a full-body tick check and shower within two hours to help remove any ticks that may have latched on. Keep mosquitoes away by repairing window screens and eliminating standing water around your home.

Policy Update - Response on Bill 17, Province Releases Integrated Energy Plan

AMO's Response on Bill 17 – Protect Ontario by Building Faster and Smarter Act

AMO has <u>submitted comments</u> to the province on legislative changes made under Bill 17, which was fast-tracked through the legislature and has received Royal Assent.

The legislation incorporates several joint recommendations from AMO and the Ontario Home Builders' Association (OHBA) regarding development charge (DC) modernization. Bill 17 contrasts significantly with the broad, across-the-board reductions introduced by Bill 23, offering instead a framework for changes with details to be developed through further consultation. AMO supports this collaborative approach, as it provides municipalities a valuable opportunity to apply their expertise and shape effective on-the-ground implementation. AMO will structure further collaboration with the municipal sector and OBHA to advise government on successful implementation. Advice will focus on these elements of the DC regime included in the bill for later regulatory implementation, which modernize calculations and their transparency:

- Merging DC service categories for credit purposes
- Defining a local service
- Deferring payment of DCs for residential developments
- · Limiting recoverable capital costs
- Prescribing methodologies for calculating the benefit of new infrastructure to existing development, and

Various measures to increase transparency

The ongoing housing crisis and challenging development market create an imperative for the province to act quickly. AMO will need to be nimble, working quickly and efficiently with our sector and home builders to influence regulations. We will jointly develop initial advice to support broader subsequent municipal engagement.

In our Bill 17 comments and in its broader advocacy, AMO continues to call on the province for predictable, sustainable, and adequate funding for municipal infrastructure to support unprecedented growth, address aging assets, and increase climate resilience.

AMOs' comments on Bill 17 also included implementation advice on other elements including:

- Planning regime changes, e.g. expanding as-of-right permissions, how to determine what constitutes a complete planning application, considerations for relying on stamps by certified professionals, etc.
- A recommendation that the new Minister of Infrastructure's Minister's Zoning Order authority for transit-oriented communities is only used in collaboration with municipalities, including securing a formal council resolution
- Balancing the standardization and streamlining of building approvals with a strong green building and energy efficiency standards, and
- Recommending ongoing engagement with the municipal sector in support of provincial consultations announced with the bill on new water and wastewater services governance and technology as well as road construction standardization.

Province Releases Integrated Energy Plan for Ontario

The Minister of Energy and Mines has released Ontario's first Integrated Energy Plan which outlines the province's vision to meet energy demand while prioritizing affordability, reliability, energy security, and clean energy. This plan gives municipalities a framework to inform local decisions about energy projects, and reinforces the role of municipalities in the energy system. The plan reflects AMO's advocacy to the province on energy including committing to:

• Continuing to ensure project proponents in competitive electricity procurements are required to obtain a supportive municipal council

- resolution for new projects, and encouraging projects to provide meaningful local benefit agreements
- Maintaining a mix of energy sources including renewable electricity, nuclear, hydroelectric, natural gas, and low-carbon fuels to balance the goal of a clean energy supply with flexibility for residents and businesses to use the energy type that fits their needs
- Ensuring reliability and affordability, particularly in rural and northern communities, including through expanded electricity transmission infrastructure
- Working with local distribution corporations (LDCs) to modernize the
 electricity distribution grid including identifying new infrastructure
 funding approaches, and technology to ensure residents can connect
 and access electricity when and where they need it

Policy Update - IESO Releases Final LT2 Documents, Trade and Tariff Webinar

IESO Launches Second Long-Term Electricity Procurement

The Independent Electricity System Operator (IESO) has <u>posted the final</u> <u>documents</u> for the second long-term procurement (LT2) of electricity generation and storage projects. This marks the official launch of LT2 during which municipalities will be asked to make decisions about local support for projects in advance of the project submission deadlines. LT2 is divided into two separate streams with different deadlines. The deadline for Energy Stream projects (e.g. renewable electricity generation) is October 16, 2025. The deadline for Capacity Stream projects (e.g. battery energy storage sites) is December 18, 2025.

The IESO has forwarded a letter to municipal officials with context about LT2 and the municipal role, and has released a guide about the requirements for municipalities and developers during the LT2 process. The IESO is also hosting a webinar on July 10 to review the LT2 guidelines. They are also hosting a webinar for municipalities and Indigenous communities, along with a dedicated municipal breakout session on July 17.

Earlier this year, AMO released <u>Guidance Resources for Electricity</u>

<u>Procurements</u> to support municipalities in their important decision making role as part of the province's ongoing electricity procurements.



Subject: Opposition to Bill 5 and Request to Repeal

The Council of The Corporation of the City of Pickering considered the above matter at a Meeting held on June 23, 2025 and adopted the following resolution:

WHEREAS, on April 17, 2025, the Government of Ontario brought forth Bill 5: *Protect Ontario by Unleashing Our Economy Act*, 2025, a broad omnibus legislation that proposes to make various changes to existing planning, consultation, approval, authority, and protection frameworks found in Provincial statutes in relation to major infrastructure, mining and resource development projects;

And Whereas, on June 4, 2025, Bill 5 passed its third and final reading in the Ontario legislature, but has not yet come into force;

And Whereas, Bill 5 granted broad powers by creating provincial "authority to designate special economic zones", which allows for the suspension of constitutionally protected rights of Indigenous peoples and the suspension of powers of municipal governments and environmental authorities;

And Whereas, Bill 5 provides powers for the Province that First Nations governments in Ontario have stated would be contrary to Treaty agreements with the Crown;

And Whereas, amendments to the Ontario Heritage Act, 1990, fail to address systemic issues in archaeological resource management, such as delayed consultation with Indigenous communities and unilateral provincial control over Indigenous artifacts and cultural heritage. Additionally, the amendments exacerbate already weakened heritage protections brought in Report #2025-CG-7 Page 2 of 10 through Bill 23. Any exemptions under the Ontario Heritage Act could result in negative impacts, including the destruction of Indigenous artifacts and burial sites;

And Whereas, Bill 5 repeals the Endangered Species Act (ESA) and degrades protections for the environment and circumvents policies that have kept Ontarians safe

and healthy for decades, including regulations that prevent the contamination of Ontario's water and the means by which water contamination is identified;

And Whereas, the new regime for endangered species and at-risk species is designed for more flexible permitting and registry-based approvals, rather than automatic prohibitions on activities that harm listed species or their habitats. Additionally, narrowing the definition of habitat in the ESA to just the immediate area surrounding dwelling sites excludes protection of broader ecosystems that endangered and at-risk species rely on for survival. There are more than 230 species at risk in Ontario, many of which are in Durham, including numerous birds, fish, insects, reptiles and plant species. These species have experienced population declines over the past several decades and are at risk of being lost completely. While these changes could expedite development approvals, they may also reduce environmental oversight resulting in devastation to populations of endangered species;

And Whereas, the 'trusted proponent' model under the Special Economic Zones Act, 2025, may create a two-tier development system, favouring select private businesses with fewer regulations, thereby undermining labour standards and enabling potentially exploitative and unsafe working conditions;

And Whereas, Bill 5 enables the Province to override municipal authorities and planning activities without consultation or warning, including the ability to upend planning processes already long underway and future planning processes being considered or yet to be contemplated;

And Whereas, Bill 5 undermines the practice and spirit of democracy and a rights- based system in the Province of Ontario, and to date has garnered the public opposition of the Chiefs of Ontario, Nishnawbe Aski Nation, Anishinabek Nation, Association of Iroquois and Allied Indians, Sandy Lake First Nation, Neskantaga First Nation, Grassy Narrows First Nation, the Canadian Civil Liberties Association, Amnesty International Canada, the Canadian Environmental Law Association, World Wildlife Fund – Canada, David Suzuki Foundation, The Canadian Parks and Wilderness Society, Ontario Biodiversity Council, Ontario Nature, Legal Advocates for Nature's Defence, Environmental Defense, Wildlands League, Wildlife Preservation Canada, Ecojustice, the Toronto Zoo, Mining Watch Canada, Democracy Watch, municipalities in Ontario, and numerous other pan-regional and local organizations across Ontario;

Now therefore be it resolved that the Council of The Corporation for the City of Pickering:

 Opposes the Government of Ontario's Bill 5 due to its infringement on Indigenous rights, assignment of powers to arbitrarily override and ignore long-established areas of municipal government authorities, risks to the long- term health of important ecosystems and the environment generally, and circumvention of numerous democratic rights and oversight responsibilities;

- 2. Calls upon the Government of Ontario to immediately repeal Bill 5;
- 3. Urges the Government of Ontario, in accordance with the recommendation of Grand Chief Joel Abram of the Association of Iroquois and Allied Indians, to "engage in a comprehensive redrafting process with full First Nations participation" and to likewise engage with municipalities and other affected stakeholders in the same comprehensive redrafting process, maintaining a rights-based foundation, inclusive of an evidence-based approach to environmental protections;
- 4. Supports efforts to streamline the approvals process for mining projects in Ontario when it does not come at the expense of safeguarding against environmental and community impacts, nor negate or remove the duty to consult with our Indigenous stakeholders such as the Mississauga's of Scugog Island First nation (MSIFN), and those Indigenous Nations adjacent to the designated "Ring of Fire" mining zone;
- 5. Is supportive of mechanisms that would result in increased local procurement in the electricity sector; however, we wish it to be noted that limiting competition could increase costs if local or preferred suppliers are more expensive than international alternatives, which may result in increased electricity prices for ratepayers; and,
- 6. Re: Regulatory Registry Proposal 25-MMAH011 Comments – Assessment of Proposed Regulatory Changes to Ontario Regulation 82/98 under the Development Charges Act, 1997

In our continued efforts to keep our clients up to date on legislative changes that may impact them, we are writing to inform you of proposed regulatory changes to Ontario Regulation 82/98 under the *Development Charges Act, 1997* (D.C.A.). This letter provides a summary of the proposed changes and commentary on potential impacts to municipalities.

The Province is seeking comments via the Regulatory Registry at the following link: https://www.regulatoryregistry.gov.on.ca/proposal/50953. We will be submitting our comments prior to the deadline of July 23, 2025.

Overview

There are two proposed changes to Ontario Regulation 82/98:

- Enable Use of the Statistics Canada Non-Residential Building Construction Price Index for London; and
- 2. Expand the Requirement for Municipalities to Spend or Allocate 60% of Development Charge Reserve Funds to all Eligible Services.

The proposal only provides a summary of the proposed changes and not the exact wording to be included in the regulation. As such, the following commentary is based on the summary provided by the Province and will be further reviewed upon release of the actual amendment to the regulation.

Furthermore, no implementation dates for the proposed regulatory changes have been provided.

Enable Use of the Statistics Canada Non-Residential Building Construction Price Index for London

Currently, municipalities with development charge (D.C.) by-laws may include provisions in the by-law to index the charge to reflect changes in construction costs. Section 7 of Ontario Regulation 82/98 provides the prescribed index to be used for indexing a D.C. The Ottawa-Gatineau or Toronto series of the Statistics Canada Non-

Residential Building Construction Price Index is to be used by municipalities as appropriate.

The proposed changes would allow for the London series (recently added by Statistics Canada) to be utilized as an index for municipalities in Southwestern Ontario who elect to index their D.C. by-laws. This series would also be available for use by municipalities whose D.C. by-law does not specify a series (i.e., Ottawa-Gatineau vs. Toronto series). A D.C. by-law amendment, however, would be required to facilitate the use of the London series for municipalities in Southwestern Ontario whose D.C. by-laws currently specify the use of the Ottawa-Gatineau or Toronto series. Alternatively, the municipality could continue to use the Ottawa-Gatineau or Toronto series until a new D.C. by-law is adopted.

This appears to be a reasonable addition to the legislation as it will better align the D.C. with the underlying changes in capital costs within the area.

Expand the Requirement for Municipalities to Spend or Allocate 60% of Development Charge Reserve Funds to all Eligible Services

Section 35 of the D.C.A. requires municipalities to annually spend or allocate at least 60% of the balance in the D.C. reserve fund for water services, wastewater services, and services related to a highway. The proposed regulatory change would impose the same requirements for all D.C.-eligible services. This change would increase reporting transparency, better aligning reserve fund balances with specific capital projects in the D.C. background study and capital budget. The additional reporting, however, will impose an administrative burden on municipal staff to ensure adherence to this requirement for all D.C. services.

Although this change appears to simply include all D.C. services in the current practice of spending or allocating 60% of the reserve fund balances, the exact wording of the regulations will need to be reviewed to ensure no variation in current processes will be required.

4. Concluding Remarks

The proposed changes to Ontario Regulation 82/98 appear to be minimal; however, they do provide for improved alignment of charges with underlying capital costs and increased transparency regarding the planned use of D.C. funds collected. There will be an additional administrative burden for municipalities, however, due to the increased reserve fund reporting. As noted, we will be submitting our comments on the proposed regulation to the Province via the Regulatory Registry.



We anticipate further regulatory changes to the D.C.A., as noted by the Province's release of Bill 17, *Protect Ontario by Building Faster and Smarter Act, 2025.* We will continue to monitor any changes and inform you of the potential impacts to municipalities.
